Some minor officials with a bureaucratic trend, in some of the county relief organizations, did a degree of Int Harvester . harm to the pending bond issue relief proposal before they got straightened out.


Specificially, voters in one county who were being asked to help the bond issue saw fit to inquire what money was being spent in relief employes' salaries in that county. A rather dictatorially-minded minor official told them in effect it was none of their business, and that they shouldn't be snooping around. The citizens appealed to Col. Lawrence Westbrook. His reply was that the information should come from local sources. This left the citizens wholly dissatisfied, and the matter went back to Westbrook.

The result is the entirely commendable showing that the cost of administering relief is less than 5 cents on the dollar, and that by setting up a trained administrative personnel of responsible employes, far more than 5 per cent is being saved.

The result showed that the county administrator of one of the three or four largest counties, a \$10,000-a-year man in normal times is working for \$300 a month, and handling many hundreds of thousands of dollars and thousands of relief cases.

It showed that in the second rank counties of up to around 100,000 population, administrators are being hired for \$150 a month. There can, and could have been on obvection to disclosing that these people are paid these small Worthington . salaries-small as compared with the volume of work, the special training required, and the calibre of these in the jobs.



# **Needed to Repeal 18th Amendment**

The electorate of 22 states has voted in favor of repeal of the 18th amendment before Texans went to the polls today. The 21st amendment, which calls for repeal

of the national prohibition amendment, is one of two liquor issues presented to Texas voters Saturlav.

Fourteen more repeal votes must be had before the 18th amendment can be taken from the statute books.

Formal repeal of the 18th amendment is not anticipated, by even the most ambitious repealists, before December when convenions will be held to give effect to the outcome of the vote in Maine, Ohio, Pennsylvania and North and South Carolina.

Formal action on the vote in state convention is held. The states in which dates have een set for action follow: Washington-Votes Aug. 29. Colorado-Votes Sept. 12. Vermont-Votes Sept. 5.
