

#### **EBAA** Iron, Eastland Countians **Facing Foundry Growth Decisions**

the Eastland County firm EBAA Iron is so successful and the demand for its products so great, the company is going to have

to expand drastically to keep up with demand.

The bad news is that the major expansion might not be in Eastland County although the company's growth would be reflected in more jobs at the local facility as a result of the planned expansion.

A great number of entities and individuals are concerned, naturally preferring that the expansion be in this county, and plans are being discussed to help make it happen. A proposal aimed at encouraging the company to expand within the confines of the county is expected to be completed within 30 days or sooner. Many are working together to hammer out details of what can be done to "keep the local company here."

They've looked in Shackelford and Callahan Counties, and talked with West Texas Utilities and Comanche County Electric Co-Operative regarding rates. Naturally Texas Utilities (the present supplier) is attempting to do what they can for the

The drawing to determine the order of names on the ballot will be on Thursday, March 23. The last day for a Write-in candidate to declare his or her candidacy is 5 p.m., Thursday, April 6, which is also the last day a person can register to vote in the Saturday, May 6, election. Tuesday, March 7. is the first day to apply for a mail ballot in the City Election but March 22, is the first day when the City Secretary may mail the early ballots and Friday, April 28, 1995 is the last day to receive applications for early voting ballots to be voted by mail.

Early voting will begin on Monday, April 17, and end at 5 p.m. on Tuesday, May 2, at City Hall, 416 S. Seaman. The election will be held on Saturday, May 6, 1995 at the Eastland High School Library from 7:00 a.m. to 7:00 p.m.

Monday when the Economic Development Board hosted members of the Industrial Foundation, the Eastland Chamber of Commerce, the City of Eastland, interested individuals and principals of EBAA.

E.D.B. Chairman Jim Moylan presided. From EBAA, were President Earl Bradley, chief executive officer, and Earl Bradley Jr. and John Bolt.

Mr. Bradley was asked to give a brief report on the decisions being faced by the company at this time. He explained that the company needs to double it foundry production capacity to keep up with sales, and that new equipment to accomplish this goal is now on order, and should lift the production from 60 tons per shift up to 120 tons. "But the new equipment will not be delivered until July of,1996," he said, "and the meantime, EBAA has got

to make some important decisions."

"The facility was moved to the old Texas Electric, Plant at the Power Plant Lake about 20 years ago, and grown phenomenally since. The property was made available to the Eastland Industrial Foundation when it was no longer needed by TESCO, and the Foundation made it available to the Bradley firm, which relocated there. Mr. Bradley and his family moved here as did a number of his key people. The company also operates a plant in Georgia.

Their primary products are large utility line connector devices which are firm. Available labor is another important factor, and more than half of the EBAA work force comes from outside Eastland, it was pointed out. Could you get the labor force somewhere else? EBAA was asked. We have to be selective, they answered, but with our pay scale, they'll come. Workers start at \$5.15 an hour and can get up to \$8 to \$10 an hour, with some five hours of overtime a week. Some are up to \$12.50 and most net from \$300 to \$500 a week, Mr. Bradley said.

A dissatisfaction was also registered against the county government, which was described as being "100 years behind the times." The company official spoke in favor of the unitized county government system rather than the "four commission" system practiced here. (The unitized system is used by a number of counties in the state). The displeasure with the county government obviously came as the result of the method used last year in upgrading the county road leading from farm-to-market road 570 to the plant at the old power plant. The state and county were asked to pave the road because of

the heavy daily traffic which was a dangerous condition. The road is also used by heavy materials trucks so it has extensive wear and tear. The State couldn't pave the road because it is a county road, and the Commissioner for that precinct couldn't, within his budget bear the expense of the paving, so an agreement was reached to get the road made safe. #### McCLESKEY NO.1 DISCOVERY WELL MEMORIAL WALKWAY

On June 3rd, 1995, the Ranger Historical Preservation Society plans to dedicate and celebrate the McCleskey No.1 Discovery Oil Well site. Equipment from two sites owned by North Ridge Corporation has been generously donated to the Society and will be used to recreate the well. But before the dedication, there is still a lot of work to be done and you, the citizens of Eastland County, your family and others can still be a part of it all.

The brick walkway, which will be at the site, is to be paved with Thurber bricks. The engraved bricks will begin at each of the two, possibly three, historical markers and will wind back to the entrance of the site. This "Memorial Walkway" not only will help restore an important part of history for generations to come, it is also a way for citizens to participate and become a permanent part of the project, for a minimum donation of \$25.00 for each brick, which includes the engraving of up to three lines, fifteen spaces per line. This engraving can either be your name, the name of your family, your business, or in honor of the same. It can also be a memorial to a loved one, living or deceased.

There have been 81 bricks already purchased and there are many more bricks waiting. May 10, 1995 is deadline for bricks purchased to be in the walkway for June 3rd dedication. Bricks will remain on sale after the dedication, but if you would like the brick(s) you have purchased to be in the walkway for the dedication, remember May 10th!
