

Annual Race Meet Opens April 28

With 2 Weekends Of Top Racing

Improvements currently being completed at the race track to ready the installations for the forthcoming race meet include the construction of a new roof designed to shade both grandstand and box seats from two o'clock in the afternoon on. Sonora's annual spring race meet will open here at two o'clock Saturday afternoon, April 28, with a minimum of six races scheduled daily. The event, which runs this weekend and next, will include the fourth annual West Texas Quarter Horse Futurity. Finals in the event are slated for Saturday afternoon, May 5.

RECORD ENTRIES

At least 160 horses, both Quarter Horses and Thoroughbreds, will be here, many of them consistent winners throughout the nation. This is the largest number of entries and the best qualified in the history of the event. Entries come from all parts of Texas and from several states.

A capacity crowd is expected both weekends.

FUTURITIES More than 80 promising young race horses are entered in the Quarter Horse Futurity. The Sonora Park and Horse Show Association, which sponsors the annual meet, will award a blanket to the Futurity winner.

Winner in last year's Futurity was Barblo Twist, owned by David Seeley of Osage, Wyoming.

This year's purse is expected to be in the neighborhood of \$15,000.00.

DERBIES The Ruidoso Downs Sprint will be run Sunday, April 29, with a blanket to be awarded the winner of the event. The Sonora Thoroughbred Derby and the Sutton County Derby will be run Sunday afternoon, May 6, with \$200 in added purses in each event. Regular races will have \$100 in added purses. Special attractions will be two matched races slated for this weekend. Saturday will find Chain Truckle, owned by Weldon Fisher of San Antonio, matched against Coe Badger 89, owned by Harper Cattle Company of Eagle Pass, for a purse of \$4,000. Sunday's matched event will be between Coe Badger 89 and Lady Miers, owned by W. L. Miers of Sonora, also for a \$4,000 purse. Both races will be for 300 yards. DANCES Dances are to be held Saturday nights, April 28 and May 5, with Adolph Hofner and his orchestra furnishing the music. Admission will be \$1.50 per person and will start at nine o'clock.

Persons exempt from poll tax payment (those over 60 years of age as of January 1, 1962) will not be required to present an exemption certificate under the election code. In making application for wool incentive payments, producers will be expected to furnish this information: marketing charges including transportation charges, handling charges, commission, and grading or scouring charges.

In applying for payment on inshorn lambs this information will be necessary: purchases; number of head, weight and date of purchase of any unshorn lambs previously purchased by applicant; and purchases of unshorn lambs later sheared by purchaser and wool incentive applied for; and county in which sheep and lambs were pastured.

Incentive payment rates will be announced in late June and incentive payments made after July 1.



Sutton County's rating of 12.34 committed for each 1,000 of its population indicates that 167 counties of the state sent more persons for each 1,000 of its period.

The five counties in Texas where the commitment ratio is the highest are all found in West and Northwest Texas. Dallam County has the state's highest ratio with 46 persons for each 1,000 in the population during the 40 year period. Koeninger suggests that one of the most revealing aspects of the study is that of the 50 counties where the rate of commitments to prison has increased, 43 are in the Western half of the state. "It would appear that as the population moves west, commitments ratios from the west tend to increase."
