



Electrical consumption for the past month was the greatest in the history of the 21-year old municipal light plant. Electrical




Even then, people came for miles to shop Sonora first. Note the crowds of people, the horses, the buggy on Main Street before the days of fast autos, paved streets, and the tourist trade. There were no power lines or electrical systems, no paved or even board sidewalks in this era. There was no traffic problem around the post office. Horses and buggies behaved better than autos . . . except on New Years. One January 1st Sonora awoke to find a cart with horse, all harnessed and ready to go, perched on a narrow upstairs porch, downtown. Pictured is James Morris, manager of Evans Foodway, one of the busiest spots along Highway 290 today. The building that houses the grocery was built by Bob Hallum on what was then Sonora Sheriff J. L. Davis' back lot. The grocery was first operated by G. E. "Bud" Smith. Evans has had the business since December 1954.

Manager of Evans for over three years, James Morris is a veteran groceryman with 25 years in the retail food business. He began delivering groceries in a Model-T truck, as a teenager in East Texas in 1931. He was later in the Soil Service in Arizona, then in grocery businesses in Uvalde, Bracketville, and Del Rio.


