





Osborn and Mike Miller, directors from the Parmer County Soil and Water Conservation District, along with their spouces, Ann Osborn and Pamela Miller, were on South Padre Island, October 13-15, 1997 to the fifty-seventh annual state meeting of Texas State Soil and Water Conservation District Directors.

Others attending were Thomas Reed, District Conservationist, along with his spouse Lisa Reed and Tamra Turley, District Technician and spouse, Elton Turley.

Approximately 1,000 were in attendance at the meeting. Key speakers addressing the group included Guillermo "Memo" Benavidez of Laredo, President of the Association; Dr. Gary Margheim of Washington, D.C., Associate Chief for the USDA-Natural Resources Conservation Service and Congressman Charles Stenholm of Stamford.

Dr. Margheim discussed the USDA-Natural Resources Conservation Service budget and its effect on conservation, while Congressman Stenholm addressed pertinent issues affecting agriculture.

The main focus of the meeting, issues related to strengthening conservation district programs on the state and national levels, was addressed on Wednesday morning by Ronald Geddes, Washington representative for the National Association of State Conservation Agencies and Judy Johnson, Regional Conservationist for the USDA-Resourses Natural Conservation Service.

Dutton Gets Army Medal

Army Spec. Latigo S. Dutton has been awarded the Army Achievement Medal for having participated in "Operation Joint Endeavor/ Guard" in support of the NATO-sponsored multinational peacekeeping mission in Bosnia-Herzegovina, a republic of the former Yugoslavia.

The medal is awarded to soldiers who have served in any capacity in a noncombat area authorized by the Secretary of the Army. The recipients have distinguished themselves by meritorious service or achievement and accomplished the act with distinction.

Soldiers from 25 countries are supporting the effort designed to promote and speed the peace process inked in December 1995 at Wright-Patterson Air Force Base. Dayton, Ohio. The U.S. Soldiers serve at various mission support bases and camps in Bosnia-Herzegovina.

The five members serving on the district board are M.C. Osborn, chairman; Troy Christian, vice-chairman; Kevin Welch, secretary; Mike Beauchamp, member; and Mike Miller, member.

Miller currently holds a position on the Muleshoe Area Hospital District and has previously held a position as trustee on the Lazbuddie I.S.D. board.

In Texas there are 216 Soil and Water Conservation Districts. Each is a legal subdivision of state government organized by local agricultural landowners with the assitance of the Texas State Soil and Water Conservation board. Unlike most other legal subdivisions of state government, SWCD's do not have powers of taxation or eminent domain. All conservation programs managed by the district are of a voluntary nature to the landowner or operator or other potential users of the SWCD's programs.



That is why the ladies in the back nag me about my column. It takes up a lot of space and they want to know as early as possible how much I am going to use. Well, this was a hectic


week for me. Trying to get football pictures developed, contact some of our advertisers, grade the weekly football contest.



Texas Comptroller John Sharp said Wednesday he will not accept a \$12,970 annual pay raise granted to elected officials by the Legislature earlier this year. Gov. George W. Bush led

the way, saying publicly he will not accept the Legislature's pay raise. electronic benefit if think Governor Bush harder to cheat.

set a terrific example for those of us who hold elective office in Texas," Sharp said. "If we're going to ask others to tighten their belts--and my agency is famous for doing that--then it's only fair that I tighten my own belt.

"If you're going to say you're a fiscal conservative, you have to act like one," he

Sharp, a candidate for Lieutenant Governor, will continue to be paid \$79,247 annually after the pay raises take effect on September 1. Others who accept the pay raise will see their pay jump to \$92,217 a year.

Sharp's opponent in the race has said he will take the

"It's a personal decision each of us has to make" Sharp said. "I'm glad the Legislature thinks I'm doing a good job, but I have decided to keep my pay right where it was when I was

"It doesn't seem fair to me give the top officials a \$12,970 raise while we're giving state employees a paltry \$100 a month," he

Sharp's reputation as a fiscal conservative is underscored by his Texas Performance Review, which has saved \$8.5 billion over the last six-and-a-half years by recommending cuts and efficiencies designed to make government work better while cutting wasteful spending.

The private sector confirmed that reputation by giving Sharp its prestigious Texas Quality Award for efficiency (based on the Malcolm Baldridge Award), the only time it has ever been bestowed on a government agency. He's also been able to

hold spending and employment in his agency in check, even as the Comptroller of Public Accounts has taken on new projects and duties. Since Sharp took office in 1991, his agency has absorbed two other state agencies--the State Property Tax Board and the Texas Treasury.

The agency has taken administration of tobacco, liquor and insurance taxes, started the Texas Performance Review and the Texas School Performance Review and pioneered the Lone Star Card, which cut fraud, waste and abuse by replacing the old paper food stamp system with an electronic benefits card that's

Sharp ran a successful pilot of a computer technology that will save the state tens of millions in Medicaid fraud, started the Texas Tomorrow Fund to help middle-class families save for college, and began Family Pathfinders,

which helps people come off of welfare by teaming them with churches and civic groups who can provide guidance and help them become self-sufficient.

In its most recent session, the Legislature asked the Comptroller to oversee enforcement of tough new anti-tobacco laws, a program that will begin in the next few weeks.

In spite of those new duties, the agency has been able to operate with about the same number of employees it had when Sharp took over in 1991.



Parmer Co. Bazaar Set




