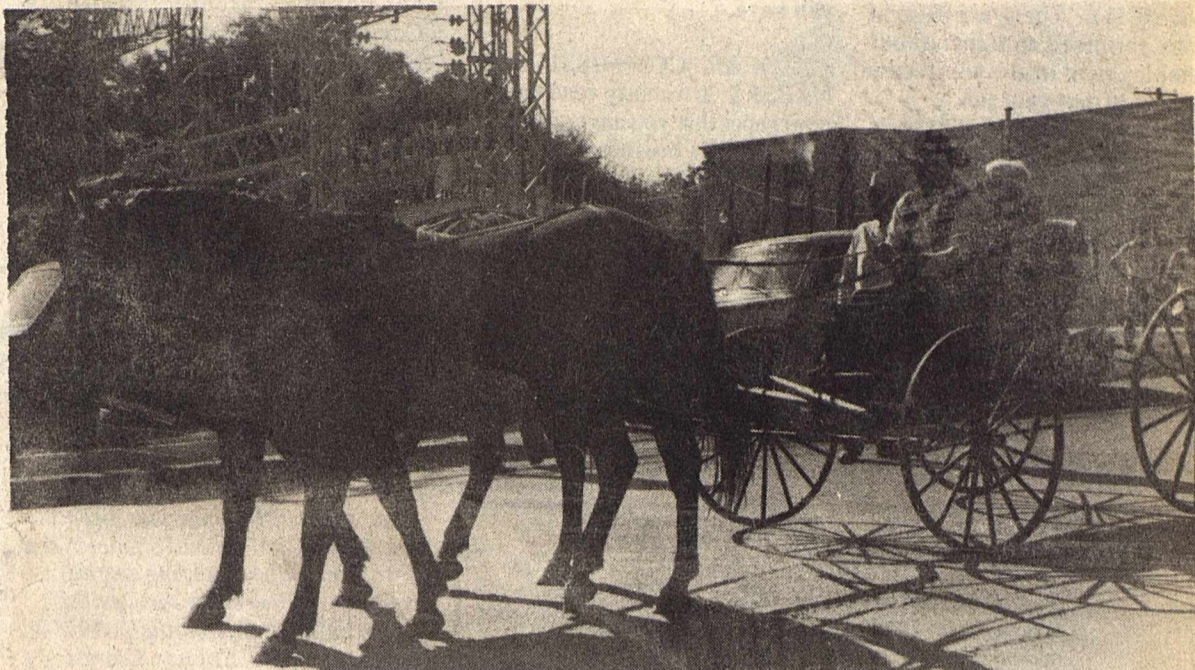
## Belle rings in another birthday

The parade which Belle watched included the Girl Scouts, the Eldorado Town Band, two groups of Sutton County 4-H youth, high school cheerleaders, Carolyn Earwood's Dance School, and the Mighty Bronco Band and Flags. Each entrant made a presentation as they reached the Courthouse in honor of Belle. Sandra Cooper was in charge of the parade and did a magnificent job.

Between four and five hundred well wishers were on hand to view the parade and to join in the fun.

## Home Tour scheduled

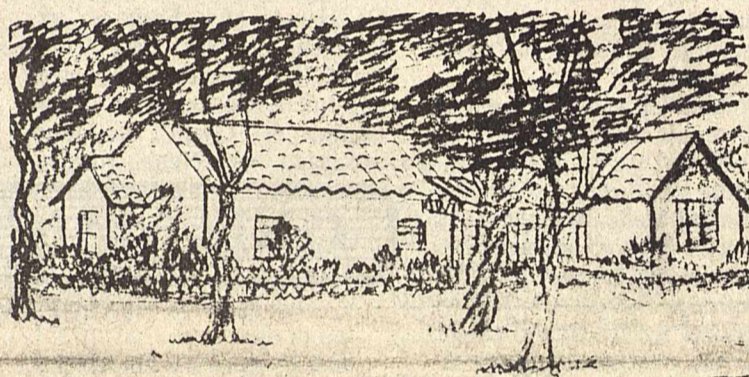
The Sutton County Historical Society is sponsoring the Second Annual Home Tour and Crafts Fair to be held on Saturday, October 17, 1987.

DEAR COMMISSIONER NABERS: I may have to quit my job due to my health. I am on Worker's Compensation at the present. My doctors have stated I may have to change careers, due to the fact my job has caused the trouble. I am concerned about this for I have five children to be responsible for and the way jobs are it may take a while to find suitable employment.

DEAR R.B: There are several things you need to know about unemployment insurance in case you have to quit your job.

First, unless your Worker's Compensation payments are for a permanent, partial disability, you CANNOT draw unemployment benefits and Worker's Compensation at the same time.

Second, if your doctor requires you to change careers altogether, you should get a written statement from him and give a copy to your employer prior to resigning your job.

Third, you should be prepared to

present a written release for work from your doctor if and when you file for unemployment benefits. The release should specify any physical limitations you might still have.

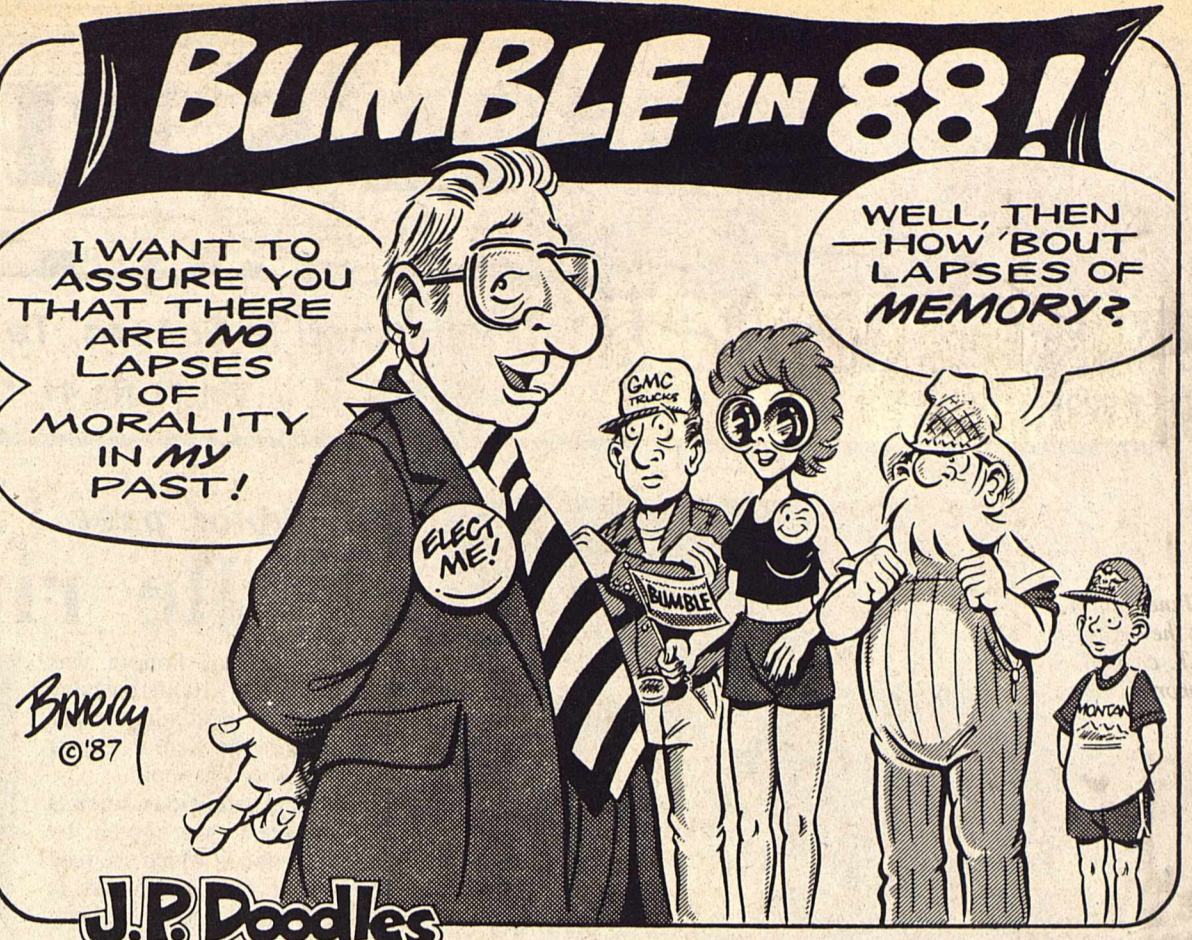

### NOTICE OF NEW TARIFF OFFERING CENTRANET<sup>SM</sup> SERVICE

General Telephone Company of the Southwest gives notice of its proposed new tariff offering, Centranet<sup>SM</sup> Service, which is to be offered in all company wire centers where such facilities exist to provide the service.

Centranet is a central office based service which provides PBX type features to multi-line business customers. Basic operating features include Direct Inward Dialing (DID), Direct Outward Dialing (DOD), Station-to-Station Dialing, Automatic Identified Outward Dialing (AIOD), and Touch Calling. The tariff is designed for Centranet customers with a minimum of 2 and maximum of 100 main station lines.

Effective with this tariff, ECENTREX Service will be limited to existing installations only.

The proposed new tariff offering has been assigned Docket No. 7652, and will become effective upon approval of the Public Utility Commission of Texas.

Rates for service will be applicable to customers who subscribe to the service, therefore, there will be no effect on any other rates of the company. The new offering will increase the company's gross annual revenues by approximately \$423,013 or less than one percent annually.

The proposed rates are on file with the Public Utility Commission of Texas, and are available for public inspection at the offices of General Telephone Company of the Southwest. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission within fifteen (15) days of the date of this notice. The deadline to intervene in this docket is November 9, 1987.

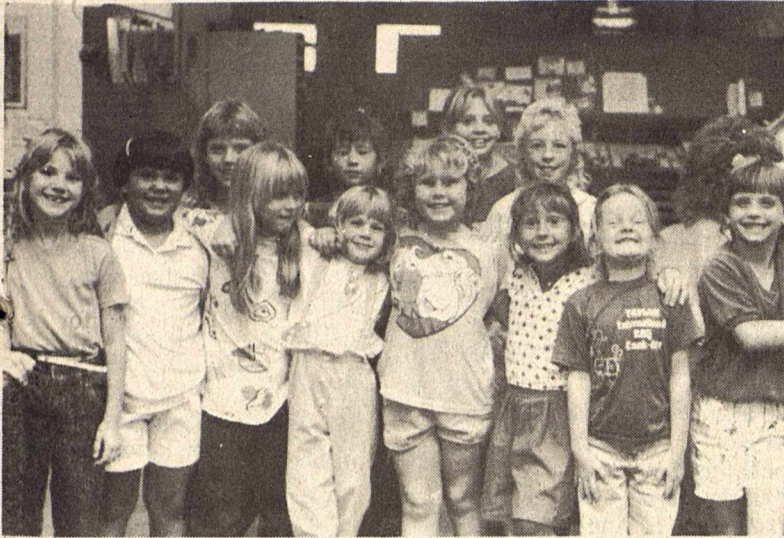

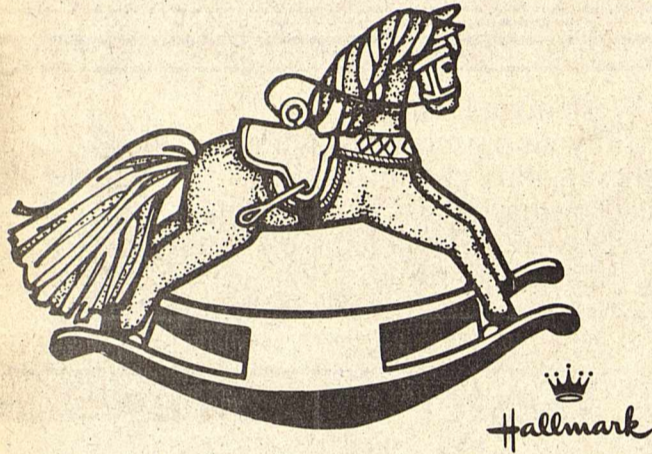

## Do not merely listen

"Do not merely listen to the word, and so deceive yourselves. Do what it says." James 1:22

The difference between hearing and doing is as great as black and white. We live in an age of spectators not participants. In fact the thought of participation in almost anything causes many to "break out in a cold sweat". We have become accustomed to being judges and critics but not taking part. Too often the world of God

has fallen into this type of thinking, perhaps motivated by the attitude of the day or maybe from laziness. Whatever the reason the result is the same...inaction. Whether it comes from watching T.V. or laziness in unknown, however, it amounts to disinterest to the observer.

The word James used here means that when we hear, it inspires us to action. God's word is to inspire and we should listen to Him with the expectation that we will be doing His will. If we listen out of curiosity we miss the

mark. If we hear through our disinterest we waste time. But if we listen with the purpose of doing, then we really hear. Children sometime say they hear and do nothing about what they are told and it brings the response from parents "Did you hear me?" I'm sure God would like to ask us at times "Did you hear me?" James admonished the Christian people of his day to rise above the lethargic attitude, that to hear was enough and to rise to the occasion, that action is required. So he calls us to not just be

satisfied with hearing but that we go that next step and put into action what we hear. The parable of the Good Samaritan is a classic of calling to action. It was not enough to know of the man's need. It was necessary to meet the man's needs to satisfy what God wants of us. So hearing is necessary, but doing is vital, for without doing, hearing is to no avail. In the words of Paul in his letter to the church at Philippi, "Only let us live up to what we have already attained." (Philippians 3:16)

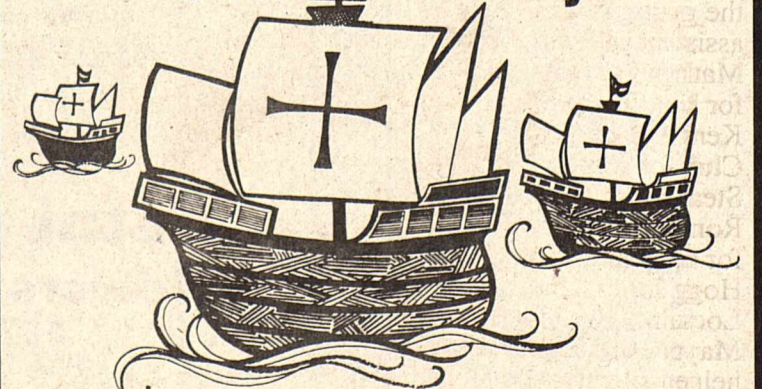

### WTU issues another fuel refund

West Texas Utilities Co. customers will receive another fuel cost refund this month.

The refund, requested by the Company, was approved by the Public Utility Commission of Texas and will total about \$4.6 million. This includes actual over-collections of fuel costs from December 1986 through July 1987, plus interest.

The refunds will be credited to customer bills. A typical residential customer will receive a little more than \$7. This is the sixth refund made to WTU retail customers since the summer of 1985.

The fuel rate charged to customers have been adusted with every refund, but the price of natural gas, WTU's main power plant boiler fuel during the period, has continued to decline.

Meanwhile, WTU is expecting a decision by the PUC in November regarding the Company's request to increase its base rates. A hearing in the case ended September 16 and a final order from the three-member PUC is expected in time to apply any rate change on December bills.

The Company had requested an increase to add \$50.3 million in annual revenues, which would bring the new coal-fired Oklaunion Power Station into the rate base.

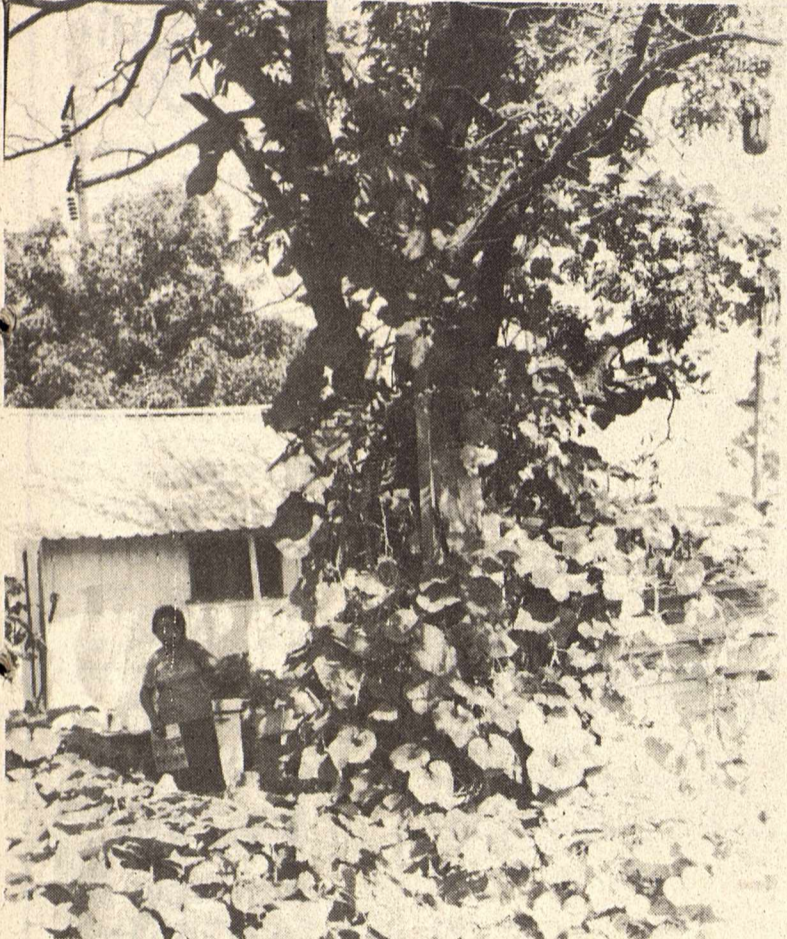

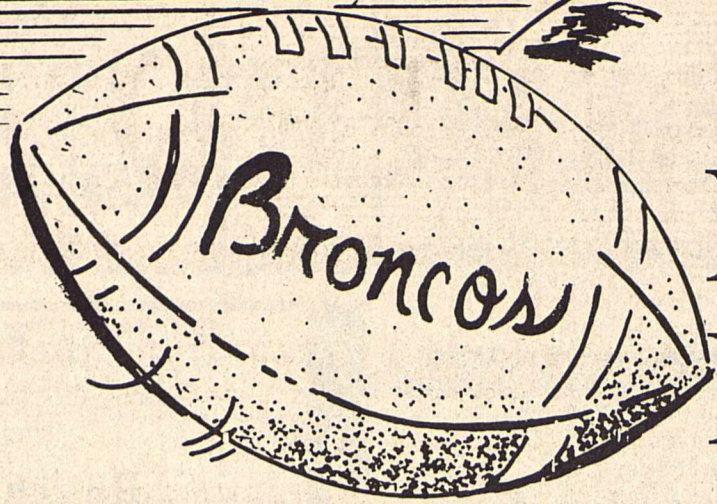

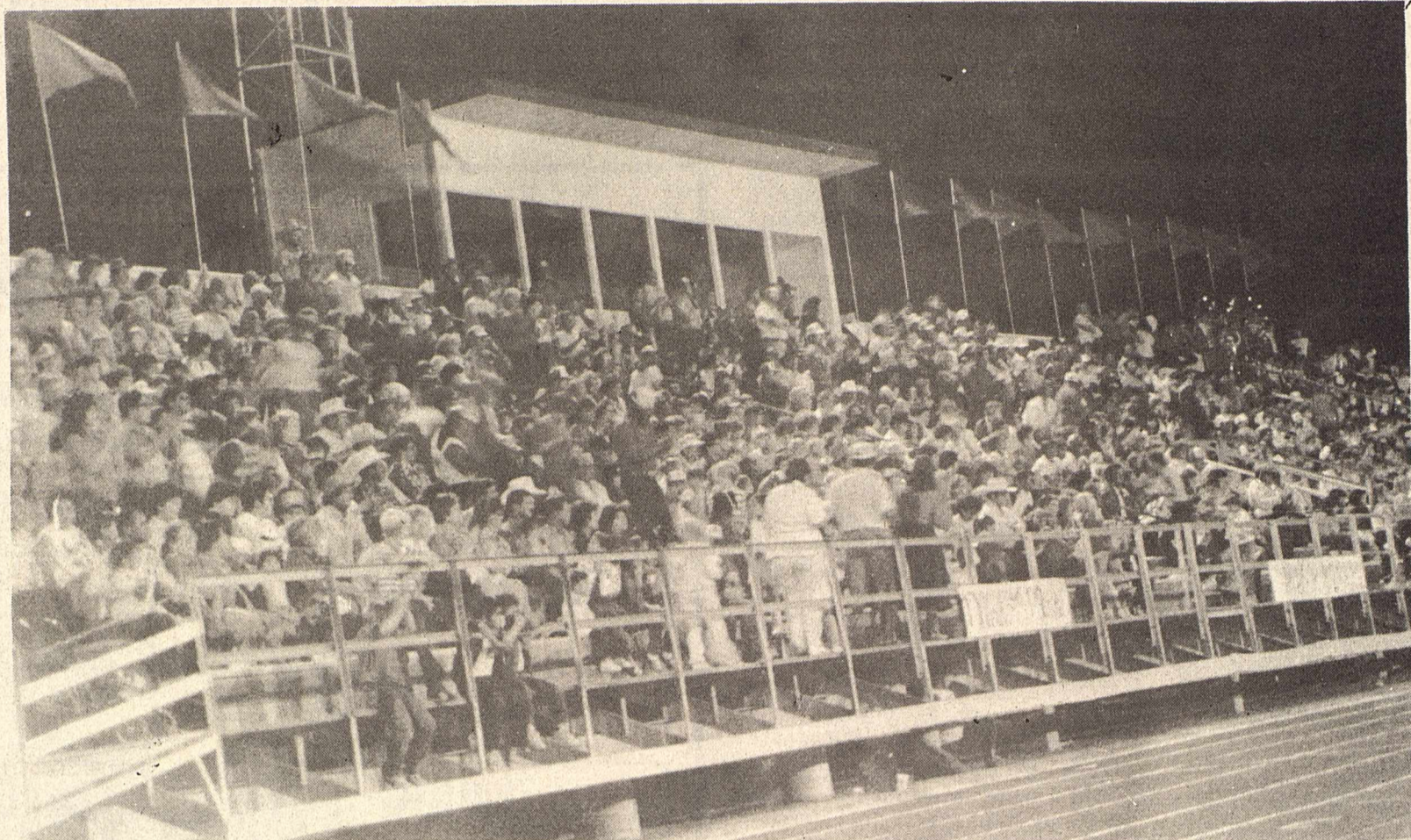

The 3A Sonora Colts did an outstanding job against the 5A Del Rio Rams.

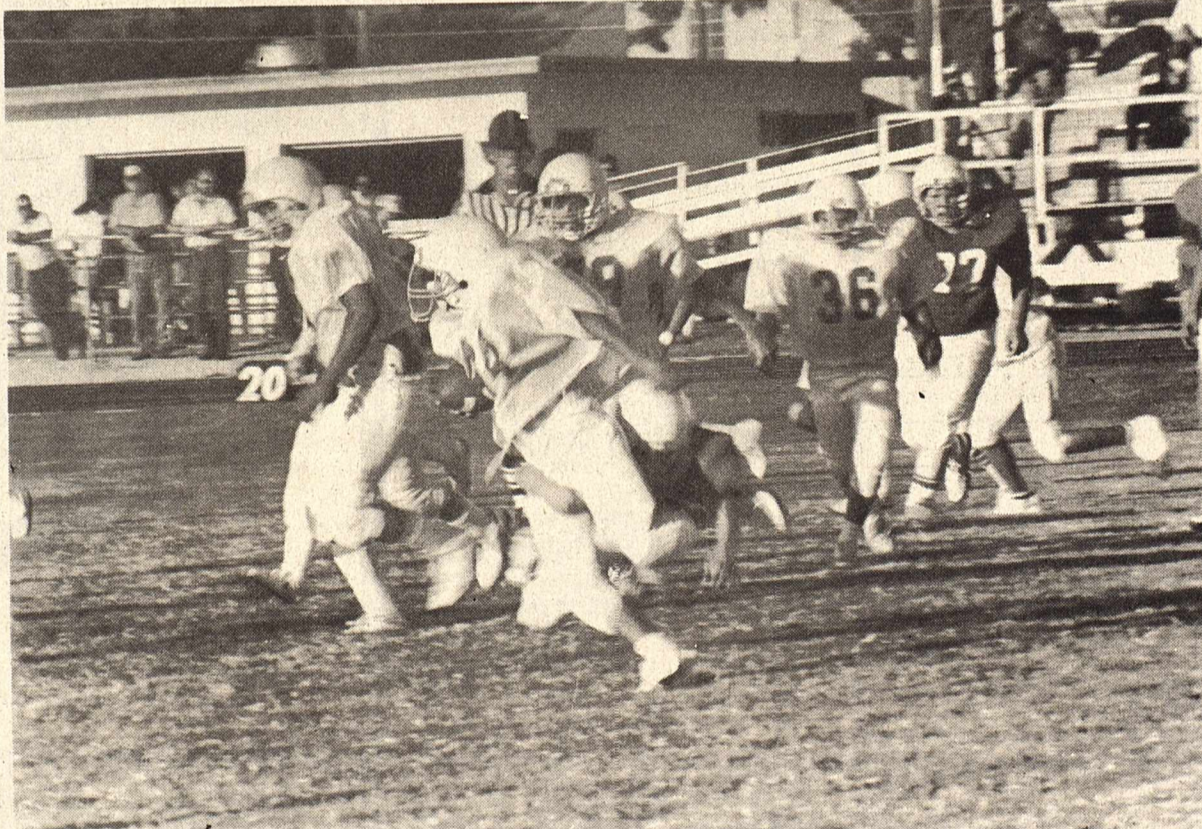

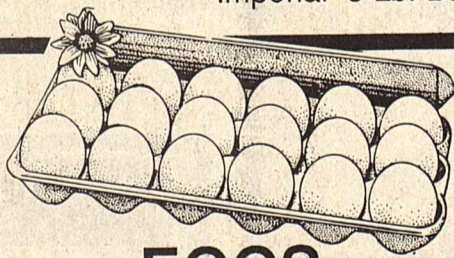

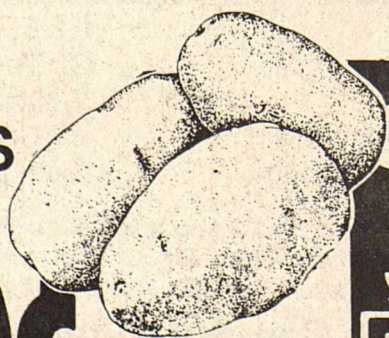
