Guillermo Trust Fund Established

A trust fund has been set up for the Guillermo Sanchez family. This family was involved in a serious automobile accident on January 16th, 1994. The husband, Guill, the main provider for the family was seriously injured and will be out of work for a period of time. This fund was established to help with medical expenses for the family and for funeral costs for the child that they lost in the accident.

Donations are requested and can be made at the First National Bank of Sonora.

Recycling Center Expands

Sonora's Recycling Center has again been expanded and is now accepting used tires. The used tire recycling area is located in a fenced compound next to the aluminum can receptacles.

The recycling of waste tires has been added because stringent new federal regulations prohibit the dumping of tires in the city landfill. Tires deposited in the recycling center will be collected by Safe Tire Disposal of Texas on a regular basis at no cost to

taxpayers.

"Since we are no longer allowed to accept tires at the landfill, we felt a strong obligation to provide a safe, environmentally responsible alternative," City Manager John Pape explained. "Without a means to dispose of used tires, we were concerned that some people might be tempted to illegally dump them."

Pape noted that the center is permitted by the Texas Natural Resource Conservation Commission

(TNRCC), and exceeds all current state and federal standards. He also stressed that the recycling effort is for private citizens, and commercial tire disposal is not permitted.

Additionally, a beautification program will also be initiated at the Recycling Center in the Spring. The project will involve landscaping in order to make the city-owned facility more attractive and to provide a buffer between the recycling operation and nearby residences.

Officials Work To Extend I-27

Sonora city officials are actively working to ensure that any extension of Interstate 27 would include Sutton County. Local leaders such as Mayor Lemuel Lopez and City Manager John Pape have publicly stated their support for an interstate expansion that includes San Angelo, and then linking with Interstate 10 in Sonora.

With the increased commercial traffic resulting from passage of the North American Free Trade Agreement (NAFTA), I-27

could then be continued south to the International Port of Entry in Del Rio. Routing an interstate loop around Sonora would have the added benefit of solving traffic flow problems through downtown Sonora.

"We believe that bringing I-27 to San Angelo, and then through Sonora to Del Rio is the most logical choice," Pape said. "Not only does it provide easy access to Mexico, it puts Sonora in the enviable position to be located at the juncture of two interstate highways."

Lopez and Pape have been actively working for the past six months to promote the Sonora route. They have had meetings with state and federal transportation officials, as well as community leaders from other cities along the proposed route.

"This will be a major focus of our efforts for the foreseeable future," Mayor Lopez explained. "Transportation has a direct effect on the prosperity of any city, and we intend to do everything possible to ensure the future of Sonora."

The regular meeting of the Sutton County Hospital District, Board of Directors, was held Monday, January 10, 1994, at 7:00 P.M., in the conference room of the Hospital. The following Directors were present:

Alvis Johnson, Jr., President; Smith Neal, President; Ray Smith; Carol Parker; Lee Bloodworth; Claire Powers: Lewis Allen

Also present were Paul Adams, Shannon Hospital, Gavin Russo, representative of Enron Corp.; Dr. and Mrs. Charles Pajestka; Mrs. Gene Rogers; Heidi Rogers; Gary Smith, Devil's River News; John Hempel, Administrator; Kathy Knight, Board Secretary; and employees of the District.

Dr Johnson called the meeting to order. Dr. Johnson stated that Sonora had suffered a tremendous loss in losing Dr. Rogers this week. He asked that a moment of silence be observed in memory of Dr. Rogers.

Smith Neal made the motion to approve the regular meeting minutes of December 13, 1993, with one correction on page one - 4th sentence from the bottom of the page, to read "Mr. Hempel advised that the Hospital was \$55,000 labove where he thought we would be at this time". Lee Bloodworth seconded the motion. Motion carried unanimously.

Dr. Johnson advised that an addendum to the agenda had been added at this point to let Mrs. Rogers address the b3oard.

P Mrs. Rogers addressed the regoard with a request for 90 lays to remain in the office in Whe Medical Clinic Building to cclear up things in the office. rShe advised that she was tlgoing to try and sell Dr. plogers' practice. She advised se at no transfers of any stredical records to any other sysician will be allowed thout her permission. She asked that no one enter the office when no one is there inless it is an emergency. Mrs. Rogers advised she was concerned about the dictation that Dr. Rogers had done, but not signed. She advised she could not be sure it was his. She advised that Heidi and she would be staying in Sonora. Rogers thanked everyone involved with Dr. Rogers. Mrs. Rogers advised the Board of her concern for the Nursing Home. Mrs. Rogers asked that she be given a copy of the CLIA report when a decision is made on the blood banking since Dr. Rogers was involved with this. Mrs. Rogers advised that Dr. Rogers had been working on obtaining a donation from the Cauthorn Trust for a blood pressure monitor/oximeter for the Hospital and she would continue to work on this. Mrs.
Rogers asked that the employee payroll deducts be

continued to clear up these accounts. She asked that the requests made today be answered.

Dr. Johnson addressed the Board concerning the 90 days for Mrs. Rogers to remain in the Medical Clinic office. It will be addressed at a later date.

Dr. Johnson advised that the tax collections for 1993 were running ahead of collections at this time last

Gavin Russo. representative of Enron Corp. addressed the Board concerning a new gas plant facility. Mr. Russo advised that the new plant would replace the plant that is now in operation on the Bond Road. Mr. Russo advised that the estimated cost of the facility would be in the 7-10 million dollar range. Our estimated taxes receivable for this plant would be in excess of \$100,000.00.

Mr. Russo advised that the county had approved the abatement for Enron Corp. for the years 1995-1999. Mr. Russo requested that the Sutton County Hospital District grant Enron Corp. a tax abatement similar to the one granted by the County. (See exhibit A) Discussion was held regarding the tax abatement. Lee Bloodworth made the motion to table any action until the March 14, 1994, meeting. Claire Powers seconded the motion. Motion carried unanimously.

Mr. Hempel advised the Board that an increase in the Tile reimbursement for State patients in the Nursing Home is being considered by the State. In the past, the private pay patients charge per day has been an average of our patients Medicaid reimbursement rate per day. Discussion was held regarding the increase in the room rate for the private pay patients. Lewis Allen made the motion to raise the room fates from \$50 to 52.50 per day for the semi-private room and from \$74.00 to \$76.50 per day for a private room. Ray Smith seconded the motion. Motion carried with Dr. Johnson and Mrs. Parker voting nay.

Discussion was held regarding the Community Needs Assessment meeting. It Needs Assessment meeting. It was the consensus of the Board that the different societies (for example-the Cancer Society) in the Community should take care of this . (See example B)

The Board then went into Executive Session under Article #6252-17 (VATS) as amended by Citation #496. Purpose of said Session -Personnel Salaries - John Hempel.

The Board reconvened into open session.

Upon motion by Lewis Allen, seconded by Ray Smith, the Board approved a \$4,000 a year raise for Mr.

Paul Adams, with Shannon Hospital. Mr. Adams addressed the Board advising that he would try and get some physicians lined up for some interim help. He advised that they would assist in helping to recruit a physician. Mr. Hempel advised that Mr. Adams, Dr. Johnson, Dr. Pajestka and he would be working closely with recruitment and physician coverage for weekends. The Board thanked Mr. Adams for coming and they do appreciate the help they can provide the District.

Mr. Hempel introduced

Mr. Hempel gave the Quarterly Quality Assurance Report. (See exhibit C) Ray Smith gave the Joint

Conference Committee report. (See exhibit D)

Mr. Hempel gave the Financial report for November. He advised that the Nursing Home had a loss of \$13,849 and the Hospital had a \$22,410 loss.

Upon motion by Smith Neal, seconded by Claire Powers, the Board approved the December expenditures.

BOARD MEMBER COMMENTS: Claire Powers advised the Board that she had some complaints voiced to her concerning the cat in the Nursing Home. Discussion was held regarding the cat and. will be brought up later.

With no further business, Claire Powers made the motion to adjourn. Lee Bloodworth seconded the motion. Motion carried.

Jordan's Market Report January 13 and 17, 1994

Receipts totaled 3417 head. Several special consignments of feeder yearlings added to the run Thursday and brought the attention of some volume buyers that made for a very strong and very active market. On Thursday and Monday the fancy light weight steers and bull calves sold steady to \$2 higher. Light and medium weight heifers sold steady to strong on the better kinds, with a few plainer heifers selling \$1 lower. The medium weight steer and heifer calves sold steady to strong. Heavy feeder steers sold \$2 to \$3 higher with a lot of quality being offered on Thursday. Slaughter cows and bulls sold steady. Volunteers are always welcome and needed.

We can all have pride in our community for support given to worthy causes and needs that arise in the area. As you know, organizations entering the cancer field today are willing to exploit the good name and reputation of the American Cancer Society and other worthwhile,

legitimate organizations to raise money for questionable uses. Lookalikes are a major problem and should be considered a legitimate concern.

These look-alike and sound-alike organizations adopt names similar to the ACS and other reputable charities. Look-Alikes have discovered that people will donate to any cancer organization. Long-time supporters of the American Cancer Society and other worthwhile organizations often contribute in the mistaken belief that they are giving to the American Cancer Society. Usually, however, the public supports causes, not organizations. If an organization can portray itself as one which shares the donor's concern for his/her cause, then it can convince the donor to support it.

Cancer is the number one health concern of Americans. The greater the public's concern about cancer, the

greater the opportunity for abuse and exploitation. Donors who are concerned about a cause can usually make distinctions between a legitimate and non-legitimate appeal, and can make fairly good judgments. But this is not always the case.

Most donors do not have the time to analyze the charities they are contributing to. Unless an individual has personal knowledge of an organization, there is no realistic way to distinguish a bonafide, efficient organization from an unscrupulous, inefficient organization. Please check the American Cancer Society for it's past record. Supporting the ACS is the most productive way of making a personal statement about cancer control.

Helicopter Service To Begin

Shannon Medical Center will begin a locally based emergency medical service helicopter program this spring, according to an announcement by Shannon President/CEO Tom Alexander.

Called "Medivac 1," the helicopter will be available around May 1 to Shannon's 16-county service area.

"As our referral area expands, we need the capability to transfer trauma and critical patients back to San Angelo," Alexander said. "The best and fastest way to do that is with a helicopter."

According to Shannon Senior Vice President Lawrence Leonard, the aircraft is an American Eurocopter AS350 BA manufactured by American Eurocopter Corporation in Grand Prairie. It has a cruising speed of about 150 mph. "We'll be able to pick up patients within a 160 mile radius and return to San Angelo without refueling, " he

Charles Benham, MD, medical director of Shannon's Medivac 1, said the helicopter will be an extension of the Emergency Department, "This aircraft has the same capabilities as our emergency department," he said.
"Because of the level of technology incorporated into the equipment and the advanced training of personnel, as soon as a patient is put on board, the quality of care immediately matches that emergency our department."

Having the helicopter available undoubtedly will mean a life-and-death difference in some instances. according to Rod Gardner, director of Shannon's Emergency Department who said it will not be used for routine cases. "We will follow specified criteria in

dispatching the helicopter" he said. Such conditions include the determination that a patient is critically ill or has suffered severe trauma or conditions that would slow or prevent a ground ambulance from transporting a patient such as a situation involving a remote or difficult location within the service area.

Gardner said Shannon will provide a special Medivac 1 telephone number for use by law enforcement officials, EMS dispatchers, physicians or their designees from hospitals or clinics. He said the public should still call 911 in emergencies.

Medivac 1's night crew will include a pilot, a paramedic and a registered nurse. The helicopter accommodates various seating arrangements of up to three passengers. All paramedics and RNs will have Advanced Cardiac Life Support, trauma and pediatric emergency care certification. Flight training is also required.

Wayne Williams, MD, medical director of Shannon Regional Health Service, said the new air service will be used to "augment the already excellent emergency services in the outlying areas," he said. "We'll need good people on the ground to stabilize and maintain until we can get there. It will be a full partnership, focused entirely on the patient between Shannon's Medivac 1 and health care providers in our service area. "

The helicopter's landing site in San Angelo will be at an as vet undetermined location on the Medical Center's downtown campus.



Ask The Historical Society

by The Sutton County Historical Society

Q. We are looking for detailed information on when and who built the current City Hall, can you help us?

A. The best source of information we could find was a booklet called "Your New Banking Home First National Bank Sonora, Texas" that was published and distributed for the formal opening of the building on January 7, 1928.

"The new home and office building of the First National Bank, of Sonora, erected at a cost of \$75,000, stands out as the most modern banking structure in any city of similar size in the United States.

The new building faces 35 feet on the city's main street, siding 90 feet on Concho. It consists of a basement, first floor, mezzanine floor, and a second floor for offices, practically making it a fourstory structure.

The main banking floor is spacious and dignified, 35 feet wide, 50 feet long, and has a ceiling height of 21 feet. There is a commodious office space at the right side of the entrance, to be used by officials of the bank. The remainder of the right side is occupied by offices for tellers, while to the left is a public foyer. Safety deposit vaults, of modern burglar proof construction, are located in the rear of the banking room on the first floor. Record vaults are provided in the basement. The mezzanine floor is especially large for a bank of this size and is at present used as a director's

Marble, bronze and walnut are used exclusively in constructing the banking room interior. The floor of the main foyer is of a pleasing pattern of terrazzo. There is a separate entrance from the street to the offices on the upper floor, reached by means of a polished terrazzo stair vay. Four modern offices are provided on the floor.

The building, as a whole, presents a distinctively local setting. On either side of the magnificently arched entrance are carved stone plaques, on one side a sheep's head and on the other a goat's head, typifying industries which have made the new building



D. Harrison of San Angelo, lumber and mason's materials from the West Texas Lumber Company of San Angelo and Sonora, hardware by the Corbin Company through Findlater Hardware Company of San Angelo, and plate glass from the Pittsburg Plate Glass Company through its Dallas agency.

The building was remodeled in 1959, enlarged

and modernized. The Hamilton Grocery store next door to the bank had been purchased and was used to enlarge the bank's office space. The ceiling was lowered and the mezzanine floor, used for directors and stockholders meetings, was enlarged. A new lighting system was installed as well as carpeting, drapes, and central heating and cooling. The bank's interior was repainted and another teller's cage was

Since City Hall has occupied the building the interior of the building has been further modernized and all asbestos removed.







Motion approving the minutes of the prior meeting was made by Commissioner Wade and seconded by Commissioner Villanueva.

Motion carried by unanimous vote.

Then came on for examination a n'd consideration, the various claims and accounts against Sutton County since the last term of court.

Motion approving for payment the accounts as listed on Exhibit "A" attached hereto, including the J. P.'s school bill for \$150.80, was made by Commissioner Wade and seconded by Commissioner Villanueva. Motion carried by unanimous

Approval of a bill in the amount of \$311.00 to Doug Lutz, Probation department was made by Commissioner Barrera to be included with the accounts and seconded by Commissioner Wade. This motion was approved unanimously.

Following presentation of the monthly report from the Justice of the Peace, the motion approving was made by Commissioner Keel and seconded by Commissioner Wade. Motion carried

unanimously. The Jailer's report was approved unanimously on motion by Commissioner Villanueva and second by Commissioner Wade.

Sheriff Webster reported the jail is being re-painted while he has cheap labor.

The monthly report of the Treasurer was unanimously approved on motion by Commissioner Barrera and second by Commissioner Wade.

Rex Ann Friess, Sutton County Appraisal District, reported 10% collections of the current tax levy, which report was accepted.

The report received from the Extension office was approved as presented.

E. J. Wipff's report for the Road and Bridge Department was approved as presented. Commissioner Villanueva requested bracing of the shade at the County Park, and E. J. agreed to have his crew do this work.

The next item of business was the opening of the bid for the sheriff's vehicle, being the bid from Broncho Ford Inc for \$13,254.25 without tradein. Sheriff Webster stated he would like to keep the old car as a backup. Motion to accept this bid was made by Commissioner Keel and seconded by Commissioner Wade. Motion carried by

unanimous vote. A report concerning the grandstand at the County Park was presented by Judge Garner. She stated that Tommy Love will meet with the court in January for a report from the Sutton County Days Association. He had reported they were short on funds and would need sand and new wiring for the slab. He also reported that the Association could replace the bad wood but not the metal. Further information will be presented in January.

A brief report on the Library situation was that the committee had looked at the Eddie Smith building at \$150,000.00 and the school buildings which needed to be brought up to standards for the handicapped. More information will be available after the school board

meeting. Russo, Gavin representative from Enron Co. was then recognized for the purpose of presenting his request for a tax abatement as an incentive to Enron for construction of a new plant facility. He stated that Sutton County is the preferred location and the new plant would be built next to the old plant at the location on Bond road. He advised the court that this construction would be a contribution to the growth and industry of Sutton County. He emphasized his request that the Court set a policy for tax abatement for a

period of six years only at 100% to encourage industry due to the long range benefit of increased valuation.

Following this discussion, the motion to adopt a tax abatement of 100% for the first year and decreasing by 20% for five years for a minimum of a five million dollars capital investment was made by Commissioner Keel. This motion was seconded by Commissioner Villanueva and carried by unanimous vote.

The County Attorney's report was approved as presented.

The County & District Clerk's report was accepted as presented.

The County Judge reported that the Driver's License representative needs space for the many applicants and will be using the office now used on Thursdays and Fridays and that the Social Security representative could use the meeting room for their clients. The court approved this report. She also announced that the Senior Citizens Christmas party was scheduled for December 21st. She further reported that Dreyfus Co. had requested permission to place a cover on the slab at the County park at their expense, which was duly accepted by the court.

County Auditor Charles Graves requested approval for payment of the Probation office expenses for Doug Lutz in the amount of \$311.00. Motion approving payment was made by Commissioner Barrera and seconded by Commissioner Wade. Motion carried by unanimous vote and this account was included in with the itemized accounts.

With no further business at hand, the motion to adjourn until the next regular or special session, was made by Commissioner Villanueva. Motion was seconded by Commissioner Wade and court adjourned unanimous vote at 10:10

The meeting was called to order by President Gloria Lopez and the invocation was given by Superintendent Charles Russell.

NO. 3 APPROVAL OF MINUTES: The minutes of December 14, 1993 were unanimously approved as written after a motion by Donald Patton and a second by Jesse Bustamante.

NO. 4 COMMENTS FROM VISITORS: President Lopez welcomed visitors to the meeting and asked for comments. There being none, she proceeded to the next item on the agenda.

NO. 5 TAX
ASSESSOR/COLLECTOR:
Chief Appraiser Rex Ann
Friess reported that 21% of
the current levy had been
collected, a 2% increase from
the same time in 1993.

NO. 6 Superintendents REPORT: Superintendent Charles Russell stated that the comp day requested by teachers for working at the Speech Meet would be addressed in the Community/School Survey and would be presented to the Board at a later date.

SUPT'S. REPORT: He also gave information on upcoming board training

and presented a brief report on the Community/School Survey which will be sent to the Campus Committees for their recommendations. Principals will present the information at the March meeting and the Board will take action in April.

The Superintendent concluded his report by stating that enrollment was staying steady and he listed the figures as follows:

High School, 297; Junior High School, 237; Intermediate School, 198; Primary School, 286. TOTAL: 1018 NO. 7 CURRICULUM

NO. 7 CURRICULUM REPORT: D'Arcy Poulson of Concho Valley Tech Prep Consortium was welcomed to the meeting and presented information concerning the program. She stated that Tech Prep courses not only enable a student to graduate from high school with up to 18-21 hours of college credit but also with a skill which makes them employable while they continue their education. She listed the five goals of Tech Prep which are as follows:

1) provide students with a broad based education; 2) make knowledge relevant to the world of work; 3) lead students to employment opportunities; 4) give students a path to college; and 4) offer a complete career development system.

Ms. Poulson further commented that Tech Prep had been very easy to implement at Sonora High School because of the willingness and commitment of the teachers.

After a short discussion, President Lopez thanked Ms. Poulson for her informative presentation.

NO. 8 PAYMENT OF CURRENT BILLS: After the Superintendent reviewed the bills in detail, board members unanimously authorized payment in the amount of \$221,378.31 after a motion by Sam David Hernandez and a second by Donald Patton.

TAX ABATEMENT: Gavin Russo, Enron tax representative, was present to request a tax abatement for a new facility which his company plans to build. He commented that Sutton county was required to set the guidelines for the abatement

and that they had done so at their December meeting. After a discussion, the Board unanimously approved the tax abatement on motion of Sam David Hernandez and a second by Michelle Anderson.

Mr. Russo expressed his thanks to the members of the Board and commented that Enron would continue to be a good corporate citizen of the community.

CONSIDERATION OF A CEI
LAB: Special Programs
Director Lori Solis and
Principals Donna Hill and
Janet Patton presented
detailed information on the
CEI Lab. Mrs. Solis went over
the contract, including cost,
personnel needed, supplies,
etc., and further stated that the
CEI Lab would be a plus not
only for the district's students
but also for the adult
education program.

Board member Michelle Anderson stated that she had viewed a similar lab in the Ballinger ISD and she and member Preston Faris agreed that the addition of the lab would be a step forward for the district.

The Board unanimously approved the installation of the CEI Lab after a motion by Jesse Bustamante and a second by Donald Patton.

NO. 11 DISCUSSION OF LEASE AGREEMENT FOR METAL BUILDING: Superintendent Charles Russell stated that plans for leasing the metal building to house all Child Protective Service Agencies in a central location was proceeding slowly and that it would be necessary to have a set of blueprints drawn up before the necessary renovations could be let out for bids.

After a discussion, the Board was in agreement to continue with the proposal. However, they directed that, as part of the negotiations, the stipulation be made that all recovery of the district's funds (for renovations) should be completed within a three year period after

the lease agreement is completed.

NO. 12 DISCUSSION OF LEASE OF 2ND METAL BUILDING: The Superintendent reported that he had attended the County Commission meeting on January 10 and that the Commissioners were still interested in leasing the 2nd metal building for use as a library. However, the Commissioners had agreed to allow the Library Committee 3 more months in which to obtain funds and/or grants for building a new library so, at this time, there were no immediate plans for a lease agreement.

NO. 13 SPANISH (ORAL PROFICIENCY) PROGRAM: The Superintendent reported on a proposed plan for expanding the Spanish Oral Proficiency Program. He stated that the program had been very successful in 3rd and 4th grades and that Intermediate Principal Donna Hill was ready to implement it in 5th grade at this time. He further stated that, because of scheduling, Primary and Junior High Schools preferred to wait until the Fall of 1994 to add the program.

Mr. Russell commented that a complete Spanish program such as this one was innovative and would take a strong commitment on the part of the Board but that such a program would insure that all students graduating from Sonora High School would be bilingual.

The Board directed the Superintendent to add the program to 5th grade immediately and to implement it in grades K-2 and 6-8 in the fall.

NO CONSIDERATION WAIVERS FOR TAAS TEST SEMESTER AND **EXEMPTIONS:** Waivers pertaining to the TAAS Test in Junior High and semester exemptions in High School were presented. After a discussion, the Board unanimously approved both waivers after a motion by Preston Faris and a second by Jesse Bustamante. The waivers will be sent to the Texas Education Agency for final approval.

NO. 15 VO AG FARM: Ag teacher Dale Caddell was present to discuss the

possibility of finding land to house an ag farm. He stated that he had found acreage that the City of Sonora was willing to lease long term and that the property was very suitable for an ag farm. Mr. Caddell further commented that all improvements and construction on the property could be performed by his various classes, thus serving as an additional teaching tool.

an additional teaching tool.

After a discussion, the Board directed Mr. Caddell to pursue a long term lease agreement with the city and to report back to them when he had more detailed information.

NO. 16 REVIEW OF SNAPSHOT '93 RESULTS: The Superintendent and Board reviewed the results of Snapshot '93. The report compares various components of the Sonora ISD, including test scores, expenditures per student, revenue, staff, etc., to other districts across the state.

17 BOARD NO. MEMBER COMMENTS: Member Sam David Hernandez requested an update concerning the number of seniors who still had to pass the TAAS Test in order to graduate. The Superintendent gave Mr. Hernandez the information and then they, along with other members of the Board, discussed their philosophy which allows seniors who meet all graduation requirements except passing the TAAS to walk across the stage at graduation. Members were in agreement that this particular solution had been quite satisfactory.






