



HISTORY OF THE LUTHERAN CHURCH

This begins a series of articles on the Lutheran Church that people might understand it better since it is less known in Southwest Texas. First, we consider its history. The Lutheran Church was a historical accident. It was born out of a search for a "forgiving God" and a "spiritual peace of mind" by a loyal priest, Martin Luther. His search led him deeper into the Bible and prayer. It ended in nailing the 95 theses (on what he believed was wrong with the church) on the Wittenburg Church door hoping to cleanse the church from within. The papal bull of 1521 rejected his attempt to revive the church, labeled him as a heretic and excommunicated him from the official church.

Luther was out of the church but his 95 theses were out in the hands of the common people. His beliefs spread like wildfire with the invention of the printing press. Those who agreed with him were called "Lutherans" by the official church. Luther objected saying, "Please do not call yourselves

Lutheran but Christian".

This was the beginning of the Reformation, the Protestant and the Lutheran Church. Luther's loyalty to "What Does The Bible Say" led him to keep things that were Scripturally correct and change things that were not in accordance with the Bible. He not only wrote the 95 theses but formulated Christian doctrine in the form of a catechism, especially for the common people and

Luther's loyalty to the Bible led him to formulate distinctive beliefs which will be presented in

Jackie and Virgil Polocek had a Christmas visit from son Mike and his wife April and daughter


