The construction of the new Sutton County Public Library is progressing as scheduled. An estimated \$47,000 is still needed for new shelving and furnishings. Unless these funds are raised by the end of August, the dibrary will not be fully functional when the building is completed. The Sutton County Public Library Committee is issuing a plea for additional, immediate contributions for appropriately furnishing the new library.

The current shelving does not meet the design requirements of the new facility. The furniture being used now consists of one adult table, one youth table, and one child's table. This obviously will not meet the projected use and need for this community.

The committee initially raised funds based on the construction and furnishing estimates received from the project's architect, Denelle Wrightson, of PSA. Mrs. Wrightson based estimates on

costs received from San Angelo this point, no Sutton County contractors. When bids were tax dollars have been received by the county, no San specifically budgeted for Angelo contractors bid on the construction or furnishings. project. Therefore, construction costs exceeded the amount of funds raised. Monies allocated for shelving and furnishings were shifted to construction.



#### SIGNS OF A GOOD SCHOOL

The first day of school. Thousands of excited children will start first grade and swarms of teenagers trying desperately to fit in - or to stand out - will begin high school.

The grown-up secret about this annual ritual is that their parents are more nervous than all of them. Will she be successful? Will he be happy? Is this the right place for my child? How can we as parents know if this school is good?

Parents who have consciously prepared their little ones for school - by reading and talking and playing and exploring - and those who have been a part of the academic lives of their older children can approach the back-to-school season a little more calmly and confidently. But all parents need to think about how to evaluate the schools their sons and daughters attend.

I visit dozens of schools each year and find them marvelously different from one another - different academic focuses, campus climates and physical settings. As you visit your child's school, you might want to look for some of the same signals of strength I always try to find.

First of all, schools must be safe. Second, they must be serious about education, setting high standards for every child and providing the support the students need to meet those expectations. There are many signs of academic seriousness.

I look for children involved in their learning, who really know what the assignment is. I ask "What are you doing?" whenever I can. If a student answers "This is what I'm doing, and this is how I'm doing it and this is why I'm doing it" then I know that there is effective communication between the teacher and the child.

When I visit schools - both elementary and secondary schools I always hope to see some time dedicated to cooperative learning, with students working together on a common project. I like to find some uncertainty and risk-taking too, situations where the teachers and the students aren't quite certain the experiment or the choreography or the design is going to work. That way everyone can learn to learn from mistakes and move on from

Strong teachers in strong schools reach beyond their classrooms to collaborate with other teachers and step out beyond

## Dear Editor,

On August 10, 1995, President Clinton made an announcement to our nation regarding the sale of tobacco and tobacco products to our children. Having made little or no progress with our congressmen to regulate this danger to the health of our children and therefore our public, he has given the FDA authority to enforce strict guidelines prohibiting the sale of tobacco and tobacco products to our children. He has also instituted efforts to eliminate much of the influence that the tobacco companies have had on our children in the way of advertising near or in areas where our children meet. Promotional items such as duffle bags, tshirts, or other items of interest to our children will also be prohibited.

After Mr. Clinton's address, a question was directed to him by a reporter suggesting that he might have completely written off the support of the southern states. Mr. Clinton confidently stated that upon weighing the urgency of the consequences of his political career along with the health of our children and our nation, he could not morally choose his political future over the latter. He committed that whatever the consequences he had to suffer, he felt a serious obligation to halt the influence of the tobacco companies encouragement of our children to use their products. The estimate of new tobacco users among our population 18 years or younger per year stands at about one million.

I have personally been discouraged about our choice of presidential candidates of late having leaned heavily upon the ravings of our Christian right. Mr. Clinton's address brought to my mind the wave of apathy that has tried to engulf our fellowships

My husband and I have been in the ministry of the church of our Lord for several years. Instead of striving for spiritual riches, our Christian families have focused their efforts on material wealth calling it "etching out a living". The amount of financial income doesn't matter, because whatever it is, it's never enough. We have

because our standard of living has reached far beyond what we all absolutely need to live on.



## LETTER TO HOUSEHOLDS (MULTI-CHILD) - NATIONAL SCHOOL LUNCH PROGRAM/SCHOOL BREAKFAST PROGRAM

Parent/Guardian:

The Sonora school serves meals each school day. Children may buy lunch for K-5 - \$1.35, 6-12 - \$1.50 and breakfast for 60¢. Children may also get meals free or at a reduced price.

If you now get food stamps or AFDC for your children, your children can get free meals. If your total household income is the same or less than the amounts on the Income Chart below, your children can get free meals or reduced-price meals. A foster child may get free or reduced-price meals regardless of your income. The reduced price is 40¢ for lunch and 30¢ for breakfast.

TO GET FREE OR REDUCED-PRICE MEALS FOR YOUR CHILDREN, YOU MUST COMPLETE AN APPLICATION AND RETURN IT TO THE SCHOOL. WE CANNOT APPROVE AN APPLICATION THAT IS NOT COMPLETE. HOW TO APPLY

If you now get food stamps or AFDC for the children you are applying for, the application must have the children's names, a food stamp or AFDC case number for each child, and the signature of an adult household member.

If you are applying for a foster child, the application must have the child' name, the child's "personal use" income,

and an adult signature.

If you do not list a food stamp or AFDC case number for all children you are applying for, then the application must have the children's names, the names of all household members, the amount of income each person got last month and where it came from, the signature of an adult household member, and the adult's social security number or the word "none" if the adult does not have a social security number.

Verification: Your eligibility may be checked at any time during the school year. School officials may ask you to send papers showing that your children should get free or reduced-price meals.

Fair Hearing: You may talk to school officials if you do not agree with the school's decision on your application or the results of verification. You may also ask for a fair hearing. You may do this by calling or

Reporting Changes: If your children get free or reducedprice meals because of your income, you must tell the school if your household size decreases or your income increases by more than \$50 per month or \$600 per year. If your children get meals because you get food stamps or AFDC, you must tell the school when you are not getting AFDC or food stamps for them. You may then fill out another giving income information.

Confidentiality: School

the application only to decide if your children should get free or reduced-price meals.

Reapplication: You may apply for meals anytime during the school year. If you are not eligible now but have a change in status, like a decrease in household income, an increase in household size, become unemployed or get food stamps or AFDC for your children, you may then complete an application.

Handicapped: Meal substitutions at no additional cost for children who meet the definition of "handicapped" officials use the information on will be served, provided a





If you keep hitting a dead end with one census report check several more to make sure the information is accurate.

We had a reader write and tell us that we were wrong in our column on E.S. "Lige" Briant. We said he was born in Kentucky yet a census record shows he was born in Texas.

In the Friday, January 6, 1933 issue of the Devil's river News we found that Judge E.S. Briant, died at his home in San Angelo on December 22, 1932. It further states that he


Articles by J. Marvin Hunter on E.S. Briant all indicated that Lige came from Kentucky.
