

The Sonora Outlaw Pro Rodeo was a great success with a total payoff of \$42,198.80. Roy Cooper won All Around with proceeds of \$1,549.61. The All Around ranger buckle set was made by Lee Silver Company.

In the bareback riding competition, Jon Brockway, won with a score of 79. James Boudreaux took second scoring 78, Eric Swenson and Jeff King tied for third, each scoring 76.

Cole Hardin won saddle bronc riding with a score of 79. Marty McCloy was second with 76, Joe Dean Weatherby third with 74, and Justin Lane and Gary McDaniel split fourth with 73

Reed Corder rode Copenhagen Wild Thing and won the bull riding event with a score of 89. 



Ask The Historical Society



This is a picture of 2nd grade Sonora 1937-38 with Mrs. Hildreth teacher. We need your help, readers. Please call us if you can identify any of these students.

O. I am working on my family tree and have come across an old card dated December 1897 showing a relative J.M. Odie living in Sonora. The family bible says I.M. died in 1898 but no other date or explanation of this death can be found nor entry of who J.M. is or J.M's sex. Did he/she die in Sonora? What did he/she die from?

A. We found the following in The Devil's River News of January 22, 1898: Ballinger Texas, Jan. 12 - A man by the name of J.M. Odie who came here from Sonora last Sunday morning for treatment, being in the last stages of consumption, was found dead in his room at the Pearce hotel, having died in the early morning with a severe hemorrhage. He was an entire stranger here, but has a brother in Macedonia, III., who has been notified.

We suggest you contact Ballinger to get any further information regarding death certificate or place of burial.

Someone asked me once if I had any information on the murder of Jack Adams in Temple, but they didn't have any date for the murder. We just happened to come across it in the same issue of The Devil's River News: Temple, Tx., Jan. 13 - The city was startled this

morning by the news of the killing of Jack Adams by T.M. Keith. Mr. Adams with Mrs. Keith and Mrs. Con Sullivan were in a surrey going to Belton, Mrs. Keith as complainant and Mr. Adams as a witness in divorce proceedings, the case being docketed for trial today. When just at the city limits, at the reservoir, Mr. Keith stepped from behind a telephone pole and fired twice a shotgun loaded with buckshot. One load struck Mr. Adams in the left head and arm, the other entering the breast. The horse ran and the body of the dead man fell over the wheel, upsetting the vehicle. The ladies ran screaming to the house of Mr. C.C. Dickson, who was close by, and Keith mounted his horse and rode up there and called for his wife. She refused to come out and he rode away, but in a few minutes returned and again called for his wife, promising to surrender his gun to Mr. Dickson if she would come out, but she refused. He then galloped back to town and took refuge under the house of Jeff Leak, where he had formerly made his home. Marshal Williams and Constable Roper went after him and Keith proposed to surrender if the marshal would pledge not to put him in jail. The promise was made and Keith came out and surrendered and he was







1995 BRONCOS LOOK FAST

The 1995 Bronco football season got off to a big start with a hamburger supper-intrasquad scrimmage held at Bronco Stadium on Friday, August 18. The scrimmage was preceded by comments from Cory Turner, team trainer, and Head Coach Bob Bellard. Bellard spoke to a very nice crowd of close to 100 parents and Bronco Booster Club members, all of whom braved hot temperatures to get a glimpse of the 1995 edition of the Sonora Broncos.

The Broncos, coming off a sterling 1994 campaign, demonstrated impressive team speed, which appears to be their most dangerous weapon in the coming season. Recent Bronco teams have showcased very fine athletes, and the Broncos have had large, talented linemen; this team also looked to have a significant degree of talent, but quickness, not size, appears to be the Bronco strength this season. The Bronco defense was particularly effective in shutting down the offensive plays run against it, and the defense's speed was demonstrated in gang tackling; few plays run against the 1st team defense gained any yardage, and most were stopped in the backfield by more than one 1st team defender.

The Bronco 1st team offense started the scrimmage passing, and was marginally successful moving the football. Josh Burnham started with the 1st team at quarterback, with Mike House at fullback and Justin House at tailback. Burnham showed a strong passing arm in his pass attempts, but due to some good play on the part of the defensive secondary there were several incompletions and the Broncos went back to their running game to get themselves moving. During the Broncos' first offensive series Justin House had a 4 yard run and Mike House had a 1 yard dive after a Burnham incomplete pass, and the Broncos were forced to start over from their 30 yard line.

The Bronco second offensive series was more successful. Two incomplete passes started the series, but Adrian Mata, replacing Justin House at tailback, ripped off a 10 yard gain on 3rd and 10, energizing the offensive effort. On 1st and 10 from the 40 yard line Mike House gained 6 yards on a fullback dive, but his effort was followed by two incompletions, bringing up 4th and 4. Mata again sprang free in a clutch situation, gaining 7 yards on the 4th down play. This would be the last play for the 1st team offense, and the 1st team Bronco defense took the field.

The Broncos are employing a split defense this year, very similar to last year's defense, which should again help their outstanding linebackers, Josh Burnham and Levi Pool, to chase down more ball carriers outside the immediate line of scrimmage. If this scrimmage was any indication the strategy appears to be working; both were in on many stops, along with cornerback Caleb Barker, lineman Ben Taylor, and end Raymond Hubble, all of whom looked very effective shutting down running lanes and pursuing to the ball.

The offense attempted an off-tackle right play on 1st and 10 from the 30 yard line, but Hubble, Barker, and Pool shut it down for no gain. The left side of the Bronco line appeared a bit less stable on second down as an off-tackle left play broke for 13 yards. At the 43 yard line, however, the offense being run against the Bronco 1st team defense ran into a brick wall, and gained no more yardage the rest of the evening.

The Bronco defense stopped everything; Davis Hale defended a pass attempt on 1st and 10 causing an incompletion, Caleb Barker and Hubble stuffed a sweep right attempt on 2nd down, Pool and Barker stopped an off-tackle right play on 3rd down, and Alex Gonzales delivered a crushing sack on the 4th down pass attempt. Ben Taylor also recorded several tackles during the following series against the Bronco defense, including a tackle and resulting loss of 5 yards on an option play left.

The scrimmage was, by all accounts, a success. The Broncos were able to see what needed work offensively and evaluate some personnel on defense while still looking very impressive in their 1995 debut. The Broncos' next outing will be another controlled scrimmage on Friday, August 25, against the Iraan Braves, who are picked to finish first in their district this year, and have some team speed of their own. The scrimmage should be entertaining and a good early-season test for the Broncos. The Iraan scrimmage will be held at Bronco Stadium, and all fans are encouraged to attend and support the Broncos in their efforts during the 1995 season.
