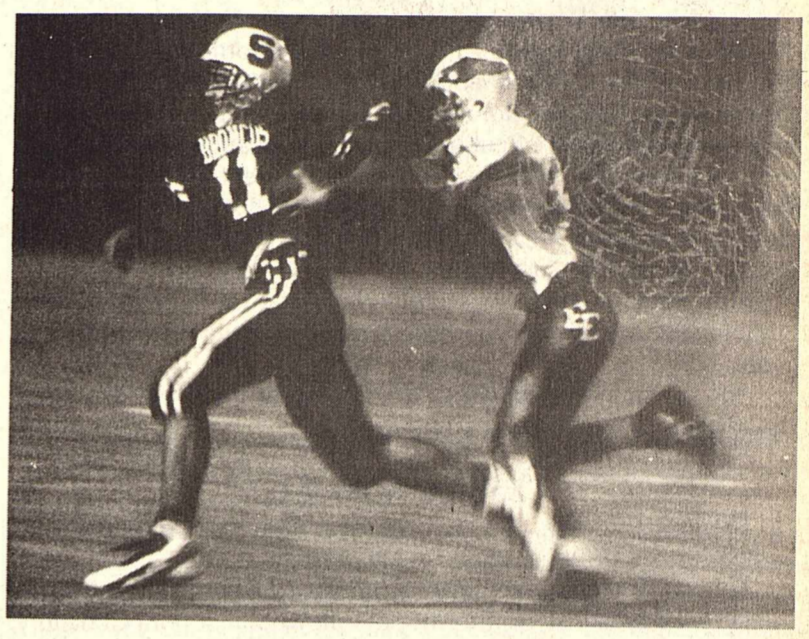
**GANG AWARENESS PROGRAM**

**GRAMM STAFF TO DISCUSS PRIVATE PROPERTY RIGHTS BILL**

 U.S. Senator Phil Gramm has introduced legislation to protect property owners from the avalanche of federal regulations and restrictions that can strip private property of its value without compensation to the owners. Gramm's "Private Property Rights Restoration Act" safeguards the rights of individuals whose land is the target of government regulations or policies which reduce or destroy the value of the property. The bill requires compensation to be paid when such a "taking" has reduced property value by at least 25 percent or \$10,000. Mr. Luis Saenz, director of Gramm's South Texas regional office, will deliver remarks to concerned residents of Sutton County on Friday, September 29, 1995 at 9:00 a.m. at City Hall. Mr. Saenz will discuss Senator Gramm's bill, as well as take their concerns over the issue. "This property rights legislation reaffirms the Senate's commitment to private property, and it says in the clearest possible terms that while Bill Clinton and interior Secretary Bruce Babbitt may view private property as being an outmoded concept, the Congress disagrees because the Constitution disagrees," Gramm said.

## BRONCOS ROUT ELDORADO, 30-7 Eagles Lose Game, Composure in Blowout

 The Eldorado High Eagles had undoubtedly prepared well for Friday night's game at Bronco Stadium, but what they found as the game drew to a close was something I'll bet they hadn't prepared for; the Eagles were down by 23 points to a team they had taken delight in beating last year, with precious few minutes left on the clock, and having been thoroughly outplayed most of the evening. The game was a convincing Bronco victory, but part of the credit for the win has to go to the Eagles, whose errors allowed a keyed-up Bronco team to dominate both lines of scrimmage and dictate the course of the game, as well as the outcome. The Broncos were able to roll up 342 yards of total offense during the evening against an outmanned Eagle defense. Caleb Barker had a great night at quarterback, both running the option and passing the ball to Davis Hale, Raymond Rainer, and Colely Thompson. Barker's pitch man also had a big night; tailback Justin House shredded the Eagle defense for 190 yards on 15 carries, consistently breaking big runs throughout the evening behind the excellent blocking of a fast-improving offensive line. The Bronco defense was also superlative; Adrian Mata, subbing for the injured Josh Burnham at linebacker, had a big night and was able to make many tackles against a rushing attack that gave the Broncos fits last year. Linebacker Levi Pool, linemen Ben Taylor, Scott Perez, and John Jones, and defensive secondary players Justin House, Andy Mirike, and Caleb Barker all recorded multiple stops and were outstanding on a night when the entire defensive team played well.

The game started as though it would be a tightly contested affair between two teams who really don't like each other. Eldorado's first series of downs after the opening kickoff went nowhere, as John Jones, Andy Mirike, and Adrian Mata stuffed Eagle attempts to crack the defensive line, and after the Eagle punt on 4th & 12 at the Eldorado 16, the Broncos had excellent field position to begin their initial drive of the night at the Eldorado 42. The Broncos, behind the fine option work of quarterback Barker and pitch man Justin House, moved down the field rapidly to the 24 yard line, but there the Eagle defense stiffened and the Broncos were forced to give the ball over on downs. Eldorado was able to move the ball better on its next series, but thanks to the efforts of Broncos Adrian Mata, Raymond Hubble, Levi Pool, and Jeff Floyd, along with the rest of the swarming Bronco defense, the Eagles again had to punt, and the ball was fair-caught by Andy Mirike at the Bronco 20 yard line. What followed caught everyone by surprise; on 1st and 10 from their 20, the Broncos ran a simple sweep left play, but Justin House was able to elude several tacklers down the Eldorado sideline and outrun everyone on an 80-yard touchdown run, giving the Broncos an early 0-6 lead.

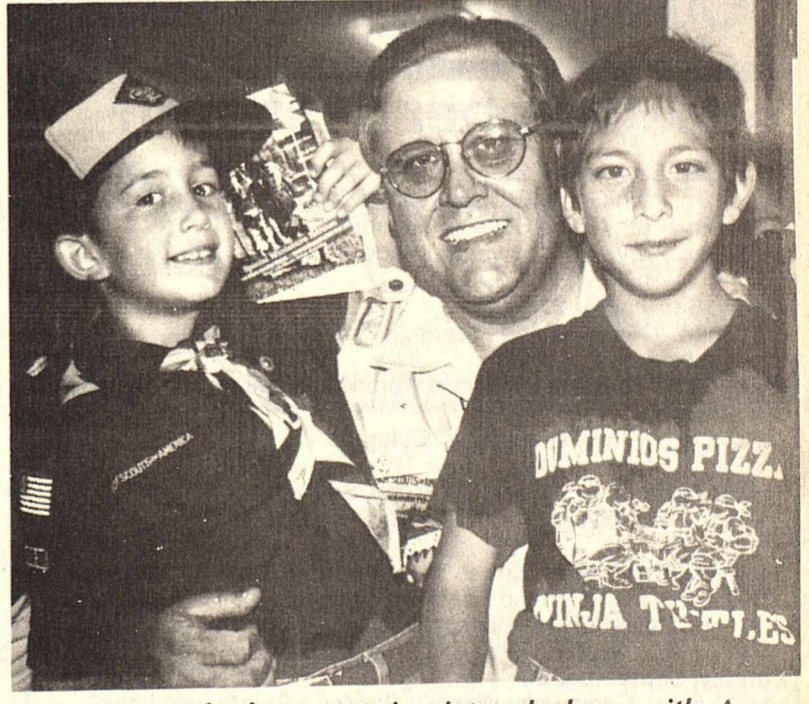
a Bronco defense that had previously held them in check, and with 9:16 left in the second quarter the Eagles scored the go-ahead touchdown and PAT, giving Eldorado a 7-6 lead. The generosity of the Bronco defense, however, was over for the evening; the Eagles would not threaten to score again until late in the game. The Bronco offense took the field at the Sonora 19 after the Eldorado kickoff and took the game with it. The Broncos, using a very effective combination of running and passing plays, drove 81 yards in 8 plays to take a 14-7 lead. The drive was highlighted by an excellent run by tailback House and a pass completion from Barker to Colely Thompson on a 3rd and 9 play from the Eagle 30 that earned the Broncos a first and 10 at the 13, and from there it took just one well-executed option play to get into the end zone. Barker took the snap from center, turned to his right, and had to pitch immediately under heavy pressure, but the pitch was perfect and House sprinted into the end zone untouched. The two-point pass play from Barker to Hale was good, and the Broncos had reclaimed the lead permanently with 5:15 left in the first half.

The Eagles were up to this challenge, and on their next series of downs, starting at their own 33 yard line, drove the field against

The Bronco defense forced the Eagles into a 3-and-out series on their possession after the Bronco kickoff, and the Eagle punt was fielded at the Sonora 33. The Broncos went to the air this series, and a 22-yard completion to Davis Hale from Barker was quickly followed by a 17-yard completion to Raymond Rainer. These passes loosened up the Eldorado defense, which had started to key on House at tailback, and on 1st and 10 from the Eldorado 24 House was again able to exploit the Eldorado defense for 11 yards, Barker took the ball to the 4 yard line on the next play, and

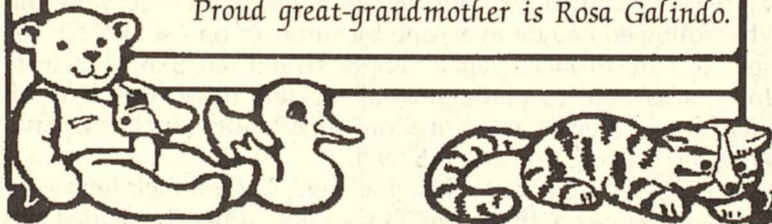
### It's A Girl!!!

# Ask The Historical Society



This brief cold spell reminded me of this double overview of Sonora taken in the early 1920's after a little snowstorm. See if you can find the jail, courthouse, Miers home, art building, Sonora Motor Company, Baptist Church and McDonald Hotel.

Q. Do you have anything on an altercation between Nath Davis and a Mr. Allen?

A. In a 1930's edition of the Devil's River News we found a story by Mason L. Rountree about Nath and Cottoneye and are editing it and reprinting portions below.

Most of you have heard about the disastrous fire that swept the west side of Sonora's Main Street, wiping out one whole block -- the Mayfield Store, The First National Bank, and most of the other buildings many of which were saloons. Two of these were the Maud S, named after that famous race horse, and the Ranch Saloon. On the front of the saloon that bore her name was a life size painting of Maud S. There were two big mulberry trees in front of that saloon. I've seen fifty cow ponies standing under those trees at one time, waiting for the boys to get tanked up. I remember playing many a game of marbles under those trees.

Anyway, Cottoneye Allen was helping to rebuild the bank and other buildings that had been destroyed by fire and Nath was working for him. There had been bad blood between the two, and Nath had dropped a remark that he intended to "dress Cottoneye down" the first chance that came his way. Nath was to do the dressing with his old "smoke stick." Someone told Cottoneye what Nath had said and he went home and buckled on his .38 Smith & Wesson, kissed his wife and children goodbye, and went out to settle things with Nath. Cottoneye decided to make a little stop first at the Maude S for possibly a last bracer with the boys. But Cottoneye didn't stop at one, he took several, in fact, about all he was able to navigate with.

Now Nath Thompson, the Methodist minister, was holding a revival meeting under a tabernacle on the courthouse square and Cottoneye heard people singing the good old hymns. He went up to and under the tabernacle and told Bro. Nath that he had come to confess religion as he only had a few hours to live and wanted to be prepared to die. Now he wasn't afraid to die, but just wanted to be prepared in case he did.

Cottoneye was wobbling about like a newborn calf, so Bro. Nath took him by the arm and led him to the "mourners' bench" and asked the choir to sing "Throw Out the Life Line."

Just as the choir was getting warmed up real good, Cottoneye stood up and motioned them to sit down. He told them he wanted to make a speech. He told them what a bad man he had been in his day, and about the wild and woolly hombres he had associated with but that he was through with that kind of life and wanted to confess religion and ask forgiveness for all the sins he had committed. He knelt down and prayed he be allowed to live a few hours longer - just long enough for him to beat the hell out of Nath Davis.

It seemed to the good brothers that it was about time to get Cottoneye out of the tabernacle and head him down the street to his more familiar haunts. So, Cottoneye left and stopped at the Ranch Saloon and had another bracer and was informed by the boys that Nath Davis was looking for him and had just left, walking down the street.

By now, Cottoneye was full of "courage" so he went out looking for Nath Davis. They accidentally met in front of the old Red Front livery stable. Cottoneye was carrying his trusty .38 in his hand, so if he met Nath he could get the drop on him. The only problem was, Cottoneye was so blown out of his socks he didn't recognize Nath Davis and Nath was able to biff Cottoneye over the head with his .45. Just as Nath hit Cottoneye over the head,

Cottoneye's double-action went off and shot a hole in the ground right by his foot. Nath Davis thought it was his gun that had gone off and that he had killed Cottoneye. Nath Davis left the scene immediately.

The moon was shining brightly and some of the boys up in town saw Nath running away and what appeared to be a dead man lying in the street. They ran and picked up Cottoneye and took him to the Ranch Saloon where they laid him out on a billiard table and began pouring water on him to bring him around. At the same time they were examining him for bullet wounds. Cottoneye's head was a mass of blood and the boys thought he was a goner until he came to and started yelling that Nath Davis had killed him.

Meanwhile, Charlie Adams had started out to find Sheriff J.L. Davis. As Charlie turned the corner of the Decker Hotel he met Mike O'Mera and told him about Nath Davis killing Cottoneye Allen. Suddenly it dawned on Charlie that O'Mera in his haste to dress and get to town to see what the trouble was, had put on his coat but failed to put on his pants. O'Mera had a tremendously large "bay window" and could not see under it, and couldn't see that he didn't have his pants on.

Anyhow, back to the story. The search for Nath Davis was on and he was finally located in a little room behind the Bank Saloon, in bed and covered up to his ears. Nath was snoring when Sheriff Davis, Pat Nelson, Sam Woodward and one or two others who had been

deputized found him. They had a pretty hard time waking him up and when they did he was pretty sore about them waking him up at that time of night. Sheriff Davis drew back the blanket and found Nath was fully clothed, boots and all. They took Nath and Cottoneye up and locked them in the same cell in the jail. After all the commotion they had caused at that time of night, the deputies didn't much care if Nath and Cottoneye finished each other off.

The next morning old Nath Davis and Cottoneye Allen were let out of jail and strolled off arm-in-arm to the Maud S for a few drinks together. They found Nath's .45 in a beer barrel covered with straw. The cylinder contained five loaded shells, and the hammer down on an empty chamber. Upon seeing this they had another drink to celebrate the fact that they were both still alive.

It happened back sometime in the early 1900's. I don't remember the exact date. Since the fire on Main Street was in 1902 and Nath Thompson served as minister from 1902 until 1904 we can pretty much guess that this story takes place some time in 1903.

# Kelly's Column

Through the past decades, persons with diabetes have been given a variety of rules about what they can and cannot eat.

In the 1920's, they were told to eat high fat, low carbohydrate in their diet. Then they were told to reduce fat and eat more complex carbohydrate, but to avoid any candy or sugar-containing products. Now the last word from the experts is that the diabetes diet is not that different from an ordinary, healthful diet or eating plan.

Recent research conducted by the Diabetes Care and Complications Trial has emphasized the need to individualize the care for persons with diabetes, which includes lifestyle changes such as increasing exercise, monitoring glucose, eating healthfully and drinking plenty of fluids. These lifestyle changes can prevent the onset of debilitation complications of the eye, kidney, and nervous system.

These new recommendations by the American Diabetes Association and the American Dietetic Association include:

- Looser the rules that move away any rigid single diabetes diet to a more individualized meal plan of reduced fat content and increased complex carbohydrates.

- Sugar is no longer the villain if eaten within the context of a normal diet. Sucrose as well as other sugar sources such as fructose or honey should be less than 10 percent of total carbohydrate calories. Studies proved that sucrose had no more effect on increasing blood glucose levels than did fructose. So both fructose and sucrose are allowed in reasonable amounts.

- Monounsaturated fatty acids such as olive, peanut or canola oils have been shown to control blood sugar levels better than the fat recommended by the conventional diabetes diet while lowering insulin and triglyceride levels. The trick is to not increase total calorie intake when increasing consumption of monounsaturated fatty acids to prevent weight gain. Also, persons with diabetes still need to limit their total fat intake, particularly saturated fatty acids, since they are prone to coronary artery disease.

- Overweight persons with diabetes should still try to work towards a healthy weight to improve blood sugar control. So take in fewer calories and start increasing your activities.

- Increase antioxidant nutrient such as vitamins E and C that help to neutralize the cell-damaging free radicals and help to reduce the risk of diabetic complications. Eat at least "5 A Day" of fruits and vegetables.

If you have diabetes, talk to your physician about these new recommendations for eating more healthfully based on the latest research. Just remember no single meal plan or approach to eating exists. Your local dietitian can help with an individualized meal plan just for you.

Contact your local county Extension agent for more information about future diabetes programs to help you better control your blood glucose levels and learn more about making necessary lifestyle changes to prevent complications, or call Consumer Nutrition Hot Line, 800-366-1655.

Eldorado tried to salvage some points as the half came to an end, but excellent defensive secondary play from Barker, Mirike and Hale, added to a sack by Raymond Hubble and Kris Wood, stopped the drive before intermission.

The Bronco coaching staff came out of halftime looking as though they had decided to substitute a great deal during the second half, but it didn't matter - the results were the same as with the starting teams. The Broncos took the second half kickoff and drove from the Sonora 38 to the Eldorado 10, where they were forced to try a Wood field goal instead of the touchdown. The field goal was good, and with barely 4 minutes gone in the second half, the Broncos had increased their lead to 23-7.

Eldorado did not have as opportune a beginning to their second half. On their first play from scrimmage after the Bronco kickoff, Levi Pool leveled the Eldorado ball carrier, knocking the ball loose to be recovered by Raymond Rainer at the Eldorado 41. The Broncos needed only 5 plays to drive into the end zone after the turnover, with Justin House scoring his third touchdown of the night on a well-executed option left play. The Broncos had taken a 30-7 lead with 4:57 left in the quarter, and for all intents and purposes all that was left to do was run out the clock.

The Eldorado offense was held in check during the fourth quarter by the efforts of Broncos Taylor, Rainer, Scott Perez, Pool, Louis Massey, and Anthony Mungia. The Bronco defense swarmed to the ball and was effective in tackling and hitting hard most of the evening. # J.V. BRONCOS FALL TO EAGLES

The Sonora J.V. Broncos traveled to Eldorado Saturday to seek their third straight shut-out of the season. They found it, all right, but not the one they had in mind. Eldorado turned a couple of fluke plays and some crucial Bronco errors into an 18-0 win for the Eagles.

The Broncos stuffed Eldorado on their first possession, with a sack by defensive guard Chris Braly, forcing a punt fielded by Enrique Lopez and returned to Sonora's 30. A crisp drive took the ball down to the Eldorado 11. The Broncos then shifted into reverse, eventually winding up at the 35 where a fumbled reverse attempt gave Eldorado the ball as the 1st quarter ended.

The Eagles made one first down, but were halted short of mid-field on excellent plays by tackle Blaine Wilkinson and linebacker Mayer Anderson. Lopez returned the punt to the Sonora 29. From there, Sonora drove to the Eldorado 40, where they were bogged down by blitzing linebackers. Eldorado took over on downs.

With time running out in the half, a quarterback scramble brought the ball to Sonora's 42. On the last play before halftime, a halfback option pass, wobbling like a wounded duck, fell into the hands of the Eagle split end, who carried it into the end zone for a 6-0 lead. The point after attempt was no good.

A long kick-off and a short return left Sonora on their own 10 yard line as play resumed after halftime. A fumbled center snap stalled the drive at Sonora's 30. The Broncos' punt attempt was blocked, then recovered by Eldorado at the Sonora 17. One play later, a hand-off over right tackle, and the score stood at 12-0, where it remained as Braly snuffed the extra point try.

On the next series, fickle fortune teased, then taunted Sonora. An out-of-bounds kick-off gave the Broncos possession at their own 30. Justin Morley rolled to the right for 6 yards. On the next play, a routine-looking drive over left tackle, tail back Brad Legan burst through the line and into the secondary. The footrace was on. As the yard lines flew by, a lone Eldorado safety closed the gap. At the 5 he made his bid. Leaping, he landed on Legan's back, stripping the ball free as both players tumbled into the end zone. Trailing Eagles pounced on it for the touchback.

That mishap pretty much took the wind out of Sonora's sails. Though the Broncos stopped the ensuing Eldorado drive, thanks to a fumble recovery by Robert Carl Teaff, their own drive was snuffed at the Eagle after a bobbled center snap.

On Sonora's next possession, an intercepted pass and long return set Eldorado up on the Bronco 33. From there, the Eagles eked out a series of small, but sufficient, gains to the Bronco 18. A roll-out pass for the touchdown sealed Sonora's fate with 3:49 left to play.

The final Bronco drive ended on an interception at mid-field. Statistically, Anthony Renfro was the workhorse for the Broncos, carrying 19 times for 71 yards. Lopez chipped in 18 yards on three carries, Jason Jacoby had 10 yards on two carries, Tanner Fields had two yards on five carries, Justin Morley had one yard on two carries, and Legan ended up with 64 yards on three carries.

In the air, Fields had one completion on attempt for five yards. Morley threw six, completed two for 29 yards and suffered two interceptions. Shiloh Sykes caught two of the Bronco completions for 26 yards. Dustin Karris caught one pass for nine yards.

Defensively, Braly consistently turned in good plays. Linebackers Sykes, Anderson, Legan and Lupe Ramon did some good hitting, as did cornerback Jacoby, tackle Wilkinson and guard Nathan Favila.

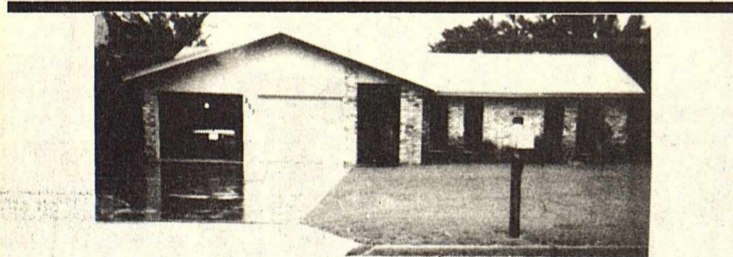
