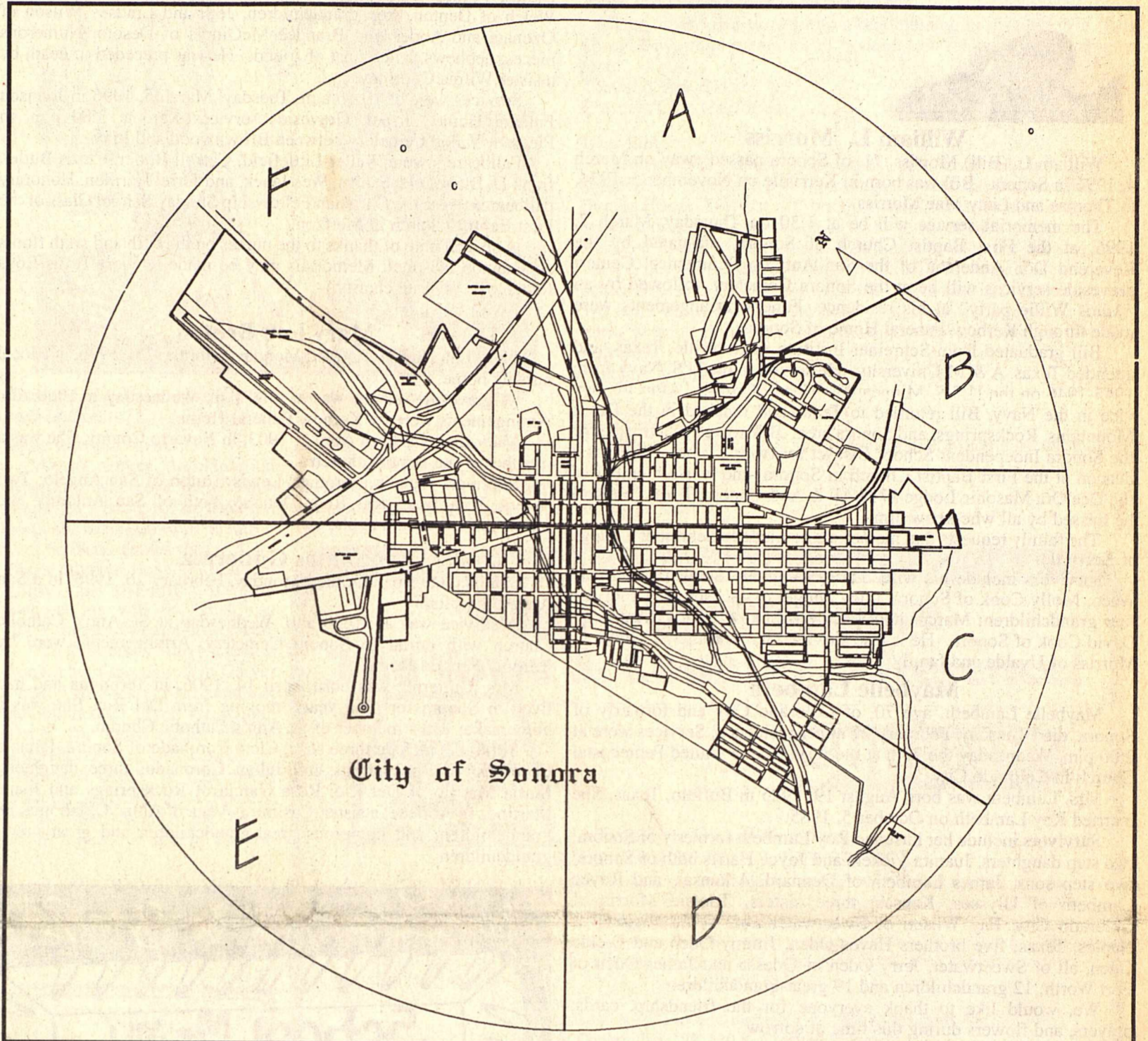

ed at the Chamber officer at 387-2880.

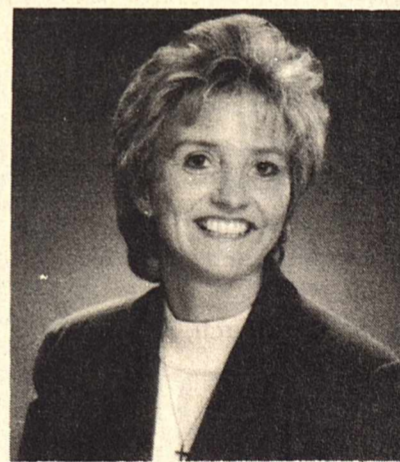
Everyone is also encouraged to recycle. The recycling center is located on Water Avenue, across from the EMS Building.

## Fort McKavett Presents Living History

Fort McKavett State Historical Park, an 1850's-1880's era frontier fort, will come to life on Saturday, March 16, 1996 with the sound of bugles, cannons and the jingling of cavalry riding gear as a historic reenactment program is presented.

Fort McKavett State

Historical Park is located in Menard County, 23 miles west of Menard on Ranch Road 864. The living history event will include reenactment groups from all over the state and will portray a day in the working life of Fort McKavett of the 1870's. This one day event will feature a flag cer-

emony, formations, roll calls, infantry and cavalry drills, firing of cannons, a civilian Buffalo Hunter camp and a portrayal of "Scabtown". Weapons and uniform demonstrations will occur throughout the day with knowledgeable personnel on hand to answer questions.

Units participating will include Fort Concho's Co. F 16th Infantry Regt., Co. D 4th Cavalry Regt., teamsters and mule teams, laundresses and cannon crew. The 1880's Saddletamps and the Apple Creek Buffalo Hunters will also be in attendance. In addition, Menard's Ranch House Meat Co. will provide a food vending booth available to the public and re-enactors.

Fort McKavett, features a museum in the 1874 hospital building, a State Park Store, restrooms, snacks and sodas and several picnic sites. A short hiking trail to the Government Springs, rock quarry and lime kiln is also available to visitors. The Park is open from 8:00 a.m. to 5:00 p.m. with scheduled activities occurring throughout the day. Entrance fees are \$3.00 for adults and \$2.00 for children between ages 6 and 12. Children under six years are free. Individual holders of the Texas Conservation passport, Parkland Passport will be admitted free. # Ask The Historical Society

Q. Did the Butterfield Stage or San Antonio Stage go through Sonora in the 1850's?

A. First, Sonora did not exist in the 1850's. Second, according to maps of the Frontier of the Fifties and routes of the Butterfield Overland Mail and San Antonio-San Diego Mail neither came through what is now Sonora.

The Butterfield Overland Mail crossed the Red River at Preston then went to Gainesville, Fort Belknap, Ft. Phantom Hill, Ft. Chadbourne, crossing the Colorado River to Camp Johnston then the Concho River and on to the Pecos River via Nat. Rock Ponds where it would swing north to Popes at the Pecos river just north of Ft. Stockton and go into Ft. Stockton, Ft. Davis, through the Eagle Mountains, to Ft. Quilman, San Elizario and into Ft. Bliss on its southerly route.

The San Antonio-San Diego Mail ran from San Antonio through Castroville to Fort Clark, up to Camp Hudson, then crossed the Pecos River below Ft. Lancaster to Ft. Stockton. It also ran through Ft. Davis, Ft. Quilman, San Elizario, and Ft. Bliss then on to Las Cruces and out to San Diego.

Both of these routes definitely do not come through what would become Sonora or Sutton County, remember Ft. Concho was not established until 1867. Ft. McKavett was established in 1852 but was not serviced by either one of these main stage lines in the 1850's.

Jewell and Buster Jennings wanted to know who St. Patrick was and why the Lillian M. Hudspeth Hospital and Nursing Home Auxiliary decorated for his day with shamrocks?

St. Patrick, the patron saint

and apostle of Ireland lived from approximately 389 to 461. He overcame Druid opposition and in 444, founded a church and monastery at Armagh as the seat of his Irish bishopric.

There are many legends about St. Patrick. It is said he used the three leaves of the shamrock, three little leaves of Irish green, to illustrate the doctrine of the Trinity. Another legend says he drove the snakes from Ireland. His feast day is March 17 and is a national holiday in Ireland. The Irish love a hero and have created many and glorified them in their stories and songs.

Just as Columbus day is a big day for the Italians, and the Spanish have several different feast days of saints and holidays depending on what country they are from, the Irish have their St. Patrick Day. In areas where there is a large Irish population there are parades, green beer, green bagels, green bread and cream cheese. One sniff and you can tell you are in an Irish neighborhood on St. Patrick day by the tantalizing odor of corned beef and cabbage simmering away on the stoves.

Boston and Holyoke Massachusetts have very large concentrations of Irish descendants. In Holyoke they paint the white line down the center of the street green and have large shamrocks painted at each intersection along the parade route. John F. Kennedy and other prominent politicians of Irish descent have marched in the Holyoke Parade on St. Patrick Day.

In other areas we recognize this as a day for the Irish. We try to wear a little bit of green and try to avoid people with great big pins that say "Kiss Me I'm Irish." Knowing how much the Irish have suffered through the years in Ireland; and how much Irish immigrants have done to help the settlement of America, I think here in America we set this day

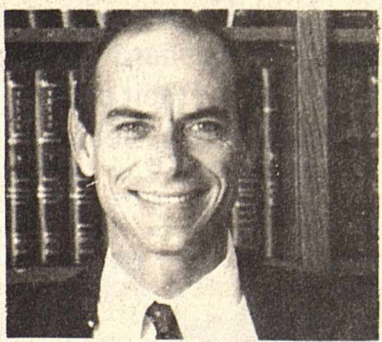

# Valiant Effort

The cold snap was deadly to many newly sheared goats in Sutton County. Ranchers who were unlucky enough to have sheared just before the little storm, lost many goats to the cold. Jerry Don and Mary Adele Balch were among those surprised by the cold, wet weather. Their goats were not shorn slick, but even with tops on them, there was some loss. Many goats were also lost by ranchmen when their goats tried to pack into sheds. They pack in so tightly that they smother each other. Many ranchers are lamenting the fate of a goat raiser. Goats just seem to be looking for a place to die.

Weather is not the only problem for ranchmen now. Dry weather and low prices are a problem, but predators are gaining a foothold in Sutton County. It is serious factor in trying to ranch. Coyotes, bobcats, and mountain lions are being seen quite often in the pastures. Exotic hogs that have been brought into game ranches have crossed with javalinas and domestic hogs. They go through fences and end up in many pastures where lambs and goats become their prey. One rancher in the eastern part of the county has trapped almost 200 hogs in the last two years. Two hundred hogs can eat a lot of lambs and kids. It is a continuing problem that will probably get worse. Wolves and bears are being protected in the Big Bend Park. It is possible that we may have them in our back yard in a few years.

Our house still has a strong skunk odor, and I have not been able to spend a night there since the skunk visited us during the icy days of early February. Dean is still working on the problem. He is an optimist and still expects us to be able to get rid of the odor. I am not so sure. Most things that we have used have reduced the odor temporarily, but none have eliminated it.

Proposed officers of the new year are Kim Price - president, Janelle Sparks - vice-president, Ebbie Sutton - recording secretary, Camille Ross - corresponding secretary, Beth Wallace - treasurer, Anita Lane - parliamentarian, and Leona Bishop - auditor.

Anita returned this week from West Virginia. She and Joe were gone almost a month. Joe Lane is working for FEMA. He is one of the engineers who assesses damages done after floods or storms. A card from them says that they have had very cold weather that has delayed some of the inspections.

Bridge last Thursday was hosted by dean and Marti McLain at the Sutton County Steak House. Italian food was served to three tables of guests. Prizes were a dozen silk bluebonnets, in honor of Texas independence Day. A.W. and Leona Bishop won high and Ralph Mayer won the slam prize. Barbara and Bill Savell won Bingo.

Saturday was an exciting event in front of the Alamo, honoring Texas Independence. Members of the Texas Army participated in the celebration of the daughters of the Republic of Texas. Col. Preston Love, Col. Jim Stephen, Col. Dean McLain, and Col. John Stephen along with several members of the West Texas Border Scouts of the Texas Army presented a patriotic program in front of the Alamo. The Lackland Air Force Band played patriotic music before the ceremony. The men presented eight of the Battle Flags of Texas. We all know the six flags that flew over Texas, representing the Texas governments, but few people recognize the flags that were used in some of the major battles of the Republic of Texas. One presented is the famous white flag with black letters, a star, and a cannon. The words say "Come and Take It". This is the flag flown at Gonzales in response to General Cos' request for the Texans to surrender the cannon. Another famous flag contains the last word in the message sent out by Col. Travis. His message is a plea for help, but was also a firm resolve to fight even though they were outnumbered by Santa Anna's army. The message on that flag is "VICTORY OR DEATH". The flag that flew over the Alamo during the thirteen day siege was red, white, and green. The white field was lettered, 1824. The Texans were at that time fighting for the Constitution of Mexico of 1824. Santa Anna had declared himself dictator or emperor. He had abolished the Constitution of 1824. The Texans were not willing to live under a dictator. They came to Texas expecting the government to abide by the Constitution of 1824. They were not willing to give up their freedom. When the men and women took refuge in the Alamo on February 23, 1836, Independence had not been declared. Independence was declared on March 2, 1836 in a blacksmith's shop at Washington on the Brazos. The defenders of the Alamo held Santa Anna at bay for 13 days. Those days gave Gen. Houston time to raise an army and begin the march that would end in victory at San Jacinto,

April 21, near Houston.

Following the presentation of the flags, Jim Stephen gave an in-speech on freedom and the sacrifices that must be made to have it. The Scottish Pipers played several selections, including Amazing Grace, which is wonderful played on the bagpipes. A young ranger, who works at the Alamo sang Texas, Our Texas, the state song. It was a wonderful ceremony, and you really get a sense of history at services held in front of the Alamo.

The West Texas Border Scouts of the Texas Army will be in Sonora this weekend. If you see some men in strange costumes, you will probably be seeing the members of the Texas Army in uniform. They will be having a fund raiser between 2:00 and 4:00 p.m. on Saturday at the Sutton County Steak House. It will be an auction, and many handmade items similar to the public, and anyone who is interested in history would enjoy seeing the items. Many of you may want to buy some of the items. Around 30 people may participate in the activities.

The modern Battle of the Alamo is still being waged and this time the attacker is not Santa Anna, but George Will, a news commentator. About a year ago, he made a remark on the TV show, This Week with David Brinkley. He said that he was quoting Sen. Paul Simon of Illinois who said, "The reason that there was so much heroism at the Alamo is that there was no back door." He of course made the comment, not as a mistaken idea of Simon's, but something that he believed. I realize that people in other states do not study Texas history the way we do, but I always believed that American history was required in all states. It would be difficult to teach American history and ignore the Battle of the Alamo. The Texas Revolution is considered one of the ten most significant events in U.S. history. It opened the west to exploration, added huge amounts of land and natural resources, and made the quest for freedom a solid belief of Americans wherever they live. The Battle of the Alamo bought the time needed to bring the Revolution to a successful conclusion. Even people educated in Illinois, or wherever Will was educated must have been taught the importance of the battle to the U.S. Will and Simon did not understand what was happening in San Antonio in 1836.

The whole point of the Alamo story is that there was a back door. It was open and inviting. There was a side door and a front door. all were possible exits for escape. The walls of the Alamo were easily scaled on both sides. Anyone who wanted to leave could go. Couriers took messages out and brought messages back to the defenders. What is remarkable about the Alamo is that all of the men stayed, except one. They could have escaped, surrendered, or just made a break for the prairie. The Mexican rifles were not very accurate, except at close range. Thirty-two men from Gonzales arrived and came into the Alamo to help with its defense. They certainly were not trapped with no escape. The men of the Alamo were heroes because they stayed, knowing that victory was probably hopeless, freedom was worth everything.

If you are a fan of George Will, you might want to drop him a note explaining his ignorance in slandering men who were heroes. He spoke last week at Trinity University, and he had said that he would apologize for his insensitive and ignorant remark. His apology did not happen. He said that he was quoting Sen. Paul Simon, and he quoted Simon correctly. He did not explain where Simon was wrong. It would have been simple for him to recognize his lack of understanding of history and apologize. He could not face being wrong, nor could he admit it. I have lost respect for him, but it seems that the fashion now is to take history and revise it to fit our own ideas. I guess that we know though that both Paul Simon and George Will are the kind of men who would be looking for a back door escape and would use it. If you are men like Paul Simon or George Will, you probably would never be able to understand how a small group of men chose willingly to die for freedom. Some people do not look for backdoors; they do what is right. These people are heroes, and I wish we had more like them today.

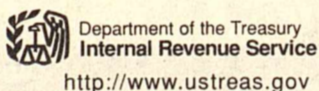

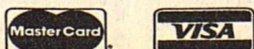

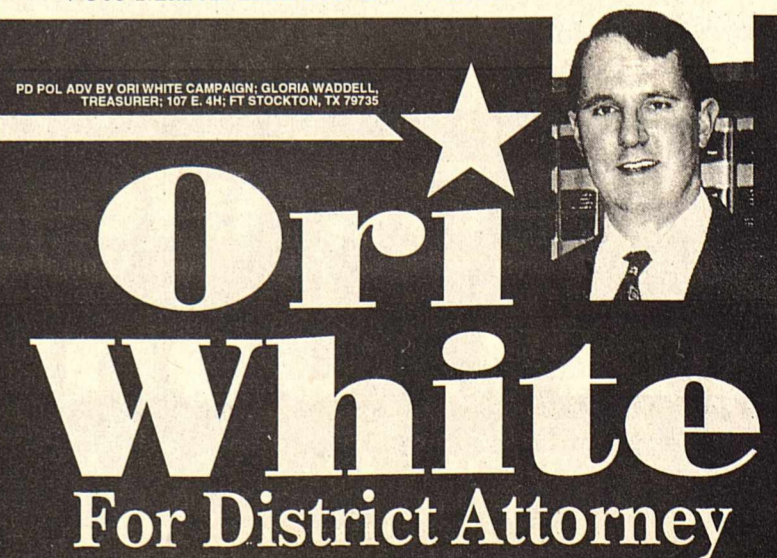

## Lillian M. Hudspeth Memorial Hospital Adopts Patient Records Policy

In recognition of and respect for patients' rights, Lillian M.M. Hudspeth Memorial Hospital historically has adhered to established policies and mechanisms to safeguard patients' confidential health care information. Beginning January 1, 1996, a new Texas law clarifies that confidential health care information may be released only upon written authorization of the patient or his legal representative or if a specific legal exception is met.

Sen. Frank Madla (D-San Antonio) was the author of the legislation which establishes parameters for all Texas hospitals to follow when releasing patient health care information. Senate Bill 667, passed in May by the Texas Legislature, defines patients' rights concerning release of their health care information, including assuring patients access to their own medical records. The law requires hospitals to obtain the written authorization of a patient or legal representative to release information relating to the patient's medical history, treatment, diagnosis or prognosis.

In general, patients may choose what types of information may be disclosed and designate to whom disclosure is allowed. The patient's decision will affect how visitors, deliveries, telephone calls and requests for information from family, friends and others are handled. The law allows unauthorized disclosure of health care information to specified people or entities, such as to those caring for the patient, to third-party payers for purposes of hospital reimbursement, to governmental agencies as authorized or required by law, and to a court, upon court order or court subpoena.

A hospital may acknowledge an adult patient's presence and provide a one-word condition or status report without written consent. However, patients have the right to request that no information or limited information be released, and these requests must be honored. Under the new law, all patient information, including that related to public figures and those involved in matters of public record, is treated equally. The hospital will release no information about patients under certain circumstances, such as rape, sexual abuse, child or elderly abuse, chemical dependency and attempted suicide. No information is provided on inmates in the Texas Department of Criminal Justice or those in protective custody.

Lillian M. Hudspeth Memorial Hospital recognizes its responsibility to keep the citizens of Sonora and Sutton County informed of hospital activities. However, protecting a patient's privacy and maintaining confidentiality of health care information is of paramount importance. More information about this new law and the hospital's policies is available by contacting the hospital business office at 915-387-2521.

Another area that Senate Bill 667 addressed is State guidelines for fees for copies of medical records. The Board of Directors of Lillian M. Hudspeth Memorial Hospital has approved the State recommended charges for providing copies of medical records. These rates are as follows:

Pages  
1-10 = \$30.00  
11-60 = \$1.00 each  
61-400 = 50¢ each  
400+ = 25¢ each

Copies of medical records will not be provided until the appropriate fee has been paid.

**Special Report:**  
**1st Annual Stockholders Meeting of United Emu**

**A United Emu Member**

On January 27, 1996, United Emu held its 1st Annual Stockholder Meeting in Waco, Texas. The following outline is based off of the accomplishments of United Emu which were presented at this meeting. The following is a summary by Sheila Hemphill and is NOT intended to be an official briefing from United Emu.

**I. PROCESSING**

As of January 27, 1996, United Emu has signed a contract with CORE (Castleway, Ostrich, Rhea and Emu) Processing to process birds exclusively for United Emu. CORE Processing representatives, Chad Hall and Bob Van Home have already purchased 385 acres in Waxahachie, Texas where they will build a technologically advanced USDA approved processing plant. Plans for this plant have already been approved by Washington and can be used to build other approved plants wherever the number of birds deems it necessary. The 200' X 50' facility would be able to process 300 birds per 16 hour shift. The completion of this facility is scheduled for May 15, 1996. United Emu has an arrangement with CORE processing to furnish 100 birds per day for at least 250 days out of the year. If an area has a high enough concentration of birds to meet this requirement, United Emu would consider having CORE processing build a plant in that area.

An oil processing facility will be on site where they will utilize the United Emu process for rendering oil. (see section under oil). Plans include 15,000 egg incubation facility and 35,000 bird grow out facilities. There are 4 methods of bird delivery which includes eggs, 3 month old chicks, 9 month old chicks and yearlings. Shipping methods would be to a local central drop off station where United Emu would come and pick up birds.

**II. OIL**

Dr. J.P. Hsu and Jo Ann Boyd of Southwest Research in San Antonio have been conducting research on the oil properties. As part of their research, they have developed a very cost effective process for rendering the fat which results into two different products. The first product is a clear, non-greasy oil and the other is a smooth, satiny cream. The oil has not shown any bacterial growth after 24 days. United Emu has received a provisional patent on the fat rendering process and on the two products. A provisional patent secures the proprietary rights of this process and product and gives United Emu 1 year to conclude the paperwork necessary to secure a patent. A second provisional patent has been received for the emu patch and wrap. Potential uses of this wrap would be to overlay on burns or over skin grafts or the emu patch as a means to carry nicotine, hormones or various other types of medications. The yellow pigmentation in the emu skin contains many healing properties. Due to the nature of this product, it would not have to receive FDA approval in order for it to be marketed. In essence, this would allow our emu hides to be sold by the square inch instead of the square foot. Research of the emu oil properties has revealed many similarities to that of sperm whale oil. Sperm whales are an endangered species therefore sperm whale oil is no longer available. It was in great demand and the preferred oil for many industrial applications including dual stroke engines. United Emu has been contacted by treadmill manufactures for potential use of emu oil in treadmills.

During their December trip to the Pacific Rim countries, Dick McCauley and Dennis Davis made many contacts with people who are now coming to United Emu in hopes of negotiating contracts for oil. On January 28, Dr. Hsu of Southwest Research and Dick McCauley traveled back to the Pacific Rim countries in hopes of securing oil contracts. The response was spectacular! The prices for the oil that United Emu requested were acceptable.

**III. FEED**

United Emu has been approached from individuals in China to produce feed for export. This feed ration would also be available for local production and distribution.

**IV. MEAT**

On December 18, Dick McCauley met with representatives of the Kroger Meat Department. Kroger is the largest retail grocery chain in the nation. United Emu has entered into a retail agreement with Kroger to have UE emu meat distributed in the Dallas area 20 to 30

stores with the potential to grow to the others stores nation wide. United Emu will develop a brand for their meat and it will be sold in the red meat section. CORE Processing will use a packaging technique which provides a 3 week shelf life of the meat. United Emu has been working with the American Heart Association in hopes of receiving the "Heart Healthy" seal on UE meats.

**V. OTHER BI- PRODUCTS**

During the Pacific Rim tour, there was a great interest in the scaly leg skin of the emu. There is also great interest in the "paws" of the bird. "Paws" are the part of the bird from the knee to the foot without the skin on it. There is a jewelry manufacturer in the Philippines, who is producing beautiful jewelry out of the toenails. Dick McCauley knows of people who are interested in the bones, organs, blood and feathers off of this bird.

**VI. ADVERTISEMENT**

Dwight Roberts, Director of International Marketing for the Texas Department of Agriculture spoke about southern US Trade programs which are available for businesses which have branded products. Since United Emu's meat would be a branded product, UE would be eligible to receive approximately \$125,000 to be used for marketing research, advertising etc. This program would also assist with foreign trade shows, the exportation of products and the clearing of products through customs.

**VII. FUNDING**

Chad Hall with CORE processing is seeking approval to open a Community Development Center (CDC) in Dallas, Texas. A CDC is a non-profit organization which coordinates with the Small Business Administration to assist loan applicants in securing funding. In order to receive a loan, the applicant would have to provide 10% of the loan in cash. Forty percent (40%) of the loan would have to be secured by a private bank and 50% of the loan would be secured by the Small Business Administration. The United States Government would secure the entire note and the CDC would sell this note on the open market. In essence, the CDC provide a place for emu ranchers to receive loans.

**VIII. A PERSONAL SUMMARY**

United Emu prudently did not discuss purchase price of the birds or sale price of the products. United Emu is conducting careful negotiations in order to secure the best possible arrangements for their members. The purchase price of the birds will be what the market will provide and will result in immediate cash payments. You can be assured that the sale price of the products will be profitable for all of United Emu members and result in dividend and participation income.

In a little over one year, United Emu has been able to accomplish all of this with approximately 300 members who purchased stock for a one time fee of \$1500. United Emu has accomplished so much and still has over \$200,000 in the bank. This is a glowing example of what can be accomplished when "a house is united" and they "seek wise counsel."

United Emu's goal is to be a national cooperative for ALL emu ranchers. I believe that this report proves the validity of this coop and it is time for ALL emu ranchers to be members. As of February 1, the payment plan consist of \$300 down and \$400 for three months with no interest. I thank my LORD Jesus Christ for the accomplishments of United Emu. It has been an answer to prayer for me and many other people.
