New GTE Services

GTE has announced new services that (1) notify customers when service requests are completed and (2) offer automated information about what services are available in the customer's area and how the services work. These new services are available at no charge.

The notification system calls a customer when the requested work is completed so the customer will know the service is working or has been repaired.

Notification calls will be made from 7 a.m. until 8 p.m. Monday through Saturday, and seven days a week for repair work. Ten attempts will be made to reach the customer.

The other new service provides customers a 24-hour tollfree number (800-483-6855) to call to learn what services are available locally. The information also tells how those services work and provides some of the benefits of the service. Customers may transfer to a customer service representative if they need additional information or want to place an order.

"Our objectives are to guide our customers in finding the services that will meet their communication needs and to make it easy for them to get that help," said Charles E. Watlins, Public Affairs Manager for GTE.

customers that a service request is completed will be a tremendous benefit to them, letting them know when the work has been completed," he said. Families who host for P.I.E. are also eligible to claim a \$50.00 per month charitable contribution deduction on their itemized tax returns for each month they host a sponsored student.

For the upcoming programs, P.I.E. has students from Spain, Denmark, Germany, Poland, Russia, Finland, Denmark, Argentina, Brazil, Colombia, Paraguay, Australia, New Zealand, Croatia, and many other countries. P.I.E. has also been invited to participate in a special government-funded program to bring scholarship students from the newly independent states of the former Soviet Union to the United States. P.I.E. is a non-profit educational organization that has sponsored more than 18,000 students from 40 countries since its founding in 1975. The organization is designated by the United States

Information Agency and is listed by the Council on Standards for International Educational Travel (CSIET), certifying that the organization complies with the standards set forth in CSIET's Standards for International Educational Travel

The Consumer Credit Counseling Service opened its office fulltime in Sonora in October. The Chamber of Commerce recognized the CCCS, a non-profit community service, as Sonora's December Business of the Month. She sees clients, conducts phone counseling, and makes educational presentations to promote consumer awareness of money management and the wise use of credit. Sonora's branch office is one of 1,100 counseling centers nationwide that provide professional and confidential consumer debt assistance to individuals and families.

The Consumer Credit Counseling Service is headquartered in Ft. Worth. The service's Debt Management Program

ing to help people with their money and credit problems. According to Mrs. Strubhart, "They feel better when they leave here. I help them focus and feel better and even calmer about their financial situation." In West Texas, women are 9% more likely to seek help than men. Fifty percent are married with at least one dependent and have an average gross income of \$2,135 a month. The average outstanding debt is \$19,000 with 11 creditors, and they spend an average of 19 months on the DMP. Fifty-two percent of all financial problems are caused by overspending and financial mismanagement. Other reasons include reduced income or unemployment, divorce or separation, and medical expenditures. CCCS provides relief for individual and family economic pressures, and financial independence gained.







A recently disclosed Environmental Protection Agency (EPA) memo reveals the Clinton administration's desire to raise the tax on a gallon of gas by a whopping 50 cents! In addition, the EPA memo pushes more state and local gas taxes, other energy taxes on oil, and a new \$40 federal fee for your car or truck's emission tests.

What's more, the Clinton administration apparently is thinking of doing all of this without approval of Congress. The EPA says they can do this just by issuing regulations. Well, the EPA should forget it. We're not about to let the EPA-or any other agency-interpret the Constitution for us. Congress isn't going to roll over and play dead.

This secret tax plan is another classic case of big government liberals in Washington trying to control the way we live. To them, no matter how small the degree of pollution, any regulation is worth the costs. The EPA's own estimate of the costs of the new gas tax alone is \$47 billion in the year 2000.

We all want a clean environment and a healthy population. Throwing more regulations and more government at the problem is not the solution. The EPA's

own Clean Air Scientific Advisory Committee has declared the existing ozone standards to be sufficient and has stated that no public health threat exists.

Instead of more regulations, what we need are common sense solutions. The best way to protect our environment is through programs that give people incentives, not disincentives, to protect the environment. The government needs to work with he people, not against them in determining our environmental

More taxes, new taxes-either way, it's government out of control. The EPA apparently disguised their new energy taxes by calling them "revenue recycling policies." As if we wouldn't figure out that they were taxes. Fancy names won't hide the fact that it is still money coming out of your pocket.

Our environment is much cleaner than it was twenty years ago, and we should continue that trend. But the American taxpayer shouldn't foot the bill for a back-door environmental tax plan. if the administration believes in what they're doing, they should be up front and open with the American people with what's really going on.

Benefit Increase For 1997

Social Security and Supplemental Security Income (SSI) benefits will increase 2.9 percent, beginning with the payments that Social Security beneficiaries receive January 3 and SSI recipients receive on December 31. The automatic cost-of-living adjustment is made annually. For Social Security beneficiaries, the average monthly benefit amount for all retired workers will rise from \$724 to \$745. The maximum federal SSI monthly payments to an individual will rise from \$470 to \$484. For a couple, the maximum federal SSI payment will rise from \$705 to \$726.





Marfa rancher named to nationwide task force

FORT WORTH, Texas, Dec. 20, 1996-Rancher J.E. White Jr. of Marfa, Texas, has been named to a nationwide beef industry task force that will study the feasibility of privatizing the grading of cattle. Texas and Southwestern Cattle Raisers Association nominated White to serve on the 17-member group of ranchers, feeders and other cattle marketing specialists appointed by the National Cattlemen's Beef Association (NCBA).

The task force has been directed to study the current U.S. Department of Agriculture's grading system to determine if the system is slowing the industry's progress toward developing high-quality branded products and whether private industry can develop a system that will better meet consumer needs for consistent quality beef.

The task force will also study the status of instrument carcass grading systems and evaluate alternatives that will speed up commercial application of instrument grading.

The group will prepare an interim report for NCBA's annual meeting in Kansas City which begins January 29.

Gramm Plans To Preserve Medicare

U.S. Sen. Phil Gramm has agreed to chair the Senate's Medicare subcommittee in the 105th Congress, saying that "preserving Medicare for both our parents and our children will be the top priority of the next Congress."

"Under the current pay-as-you-go system, Medicare is already \$4.5 billion in the hole," the senator said. "The system which finances Medicare assures that each successive generation will be shortchanged, and that must change if Medicare is to survive."
"Medicare's trustees project that without a short-term repair, the hospital insurance fund will lose more than \$39.3 billion in the next two years alone and cease paying benefits to senior citizens in just over four years," he said. "And even the best short term fix only postpones the day of reckoning when Medicare faces bankruptcy all over again."

"So far, politics has dominated the debate over Medicare reform, swaying the elections without solving the problem. And while Democrats and Republicans will certainly have different views of what to do, it is my hope that-we can now set partisanship aside and work together to save the Medicare system;." Gramm said.
