Invasion to Victory in the ETO

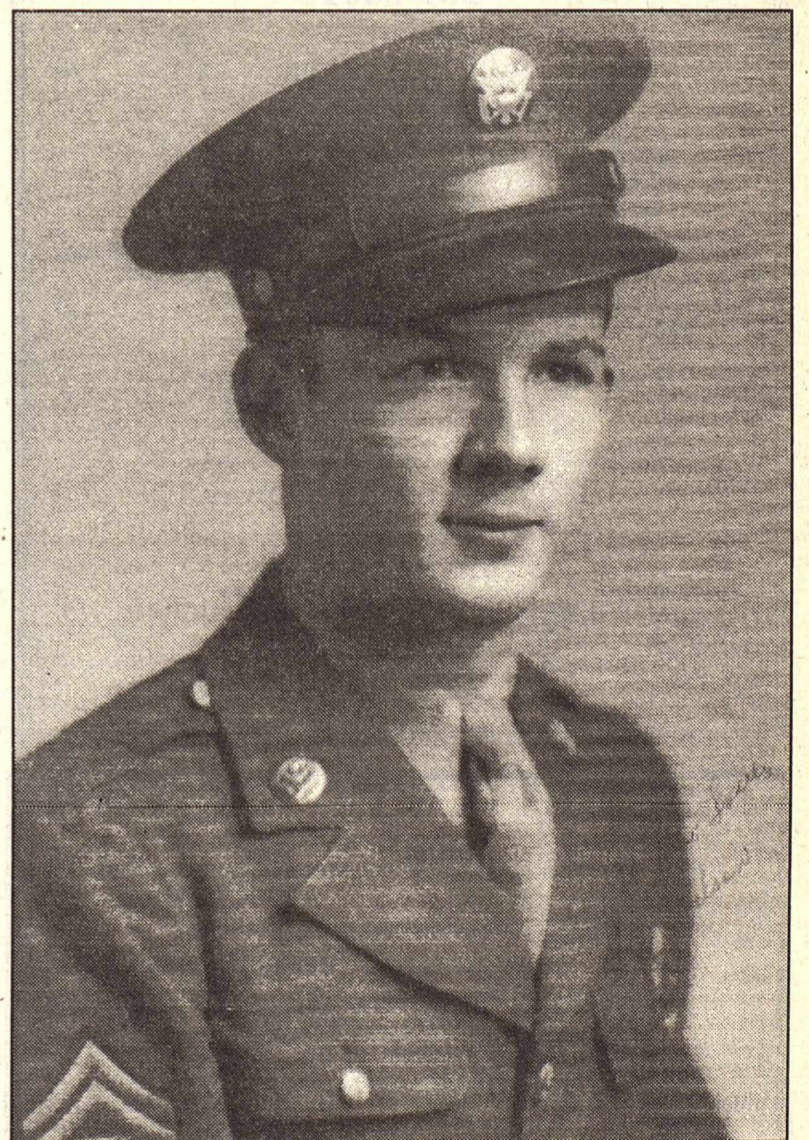


Nelson Stubblefield - No. 3 of 3 brothers serving in the military during World War II, was born in San Angelo, Tx. on August 4, 1923.

"I completed Elementary School in the Sherwood School and completed all four years of high school in Sonora. I worked in a store for the next two years.

On July 9th, 1942 I entered the U.S. Army at Fort Sam Houston I was accompanied by my brother Wayland in this endeavor. We both were ordered to Camp Crowder Missouri - A Signal Corp training Base. After 3 & 1/2 months of Radio School in Kansas City Mo. and 3 & 1/2 months of RADAR School at Camp Murphy, Florida, I found my way to Laurel Army Air Base in Mississippi. There I joined the 1074th Signal Co. of the 84th Air Service Group. We received 3 months of rigorous training under Field Conditions in steamy, tropical mid-summer Mississippi."

"After a long train trip, we arrived at Camp Shanks, N.Y. the POE to all points East. On August 4th 1943 we Waved "Good Bye" to the "Great Lady" in New York Harbor. My 20th birthday!!!! After a nine day unescorted cruise across the North Atlantic, the beautiful harbor of Greenock, Scotland was so very welcome. Our destination was Greenham Common Air Base, in South Wales England. We were attached to the Eighth Air Force for pay and sustenance and were not operational for sometime. During this period we each took secondary jobs. I chose Teletype operation and learned the ETO procedure form the Canadian Airmen on that base. Ultimately I helped organize a Signal Center for an Advance Air Depot Unit which was necessary for

From June 18th, 1944 to May 8th, 1945 VE Day Team "B" moved eight times in support of the First & Third U.S. Armies as well as British and Canadian Forces.

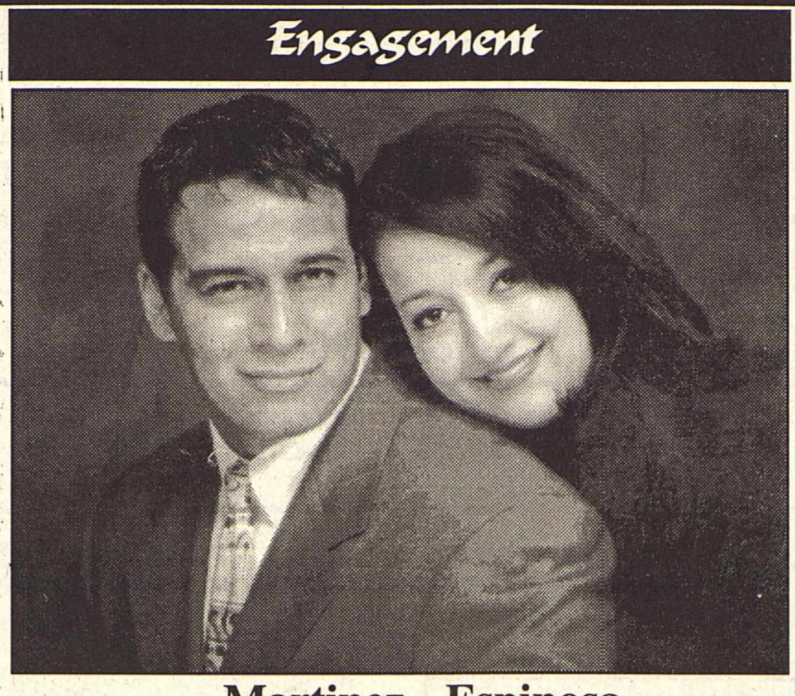

Kimble Electric Cooperative Calls Special Meeting

The Board of Directors of Kimble Electric Cooperative (KEC) has called a special membership meeting for 5:30 p.m. March 21, 2000, at the Stevenson Memorial building in Junction to consider revisions to the Cooperative's Articles of Incorporation.

The revisions to the 1940 document are needed to allow KEC the flexibility to meet the challenges and opportunities presented by the restructuring of the electric industry approved by the Texas Legislature last year.

The membership will be asked to consider two proposals. The first removes prohibitions against proxy voting. The second changes the requirements for disposition of Cooperative property and facilities from approval by two-thirds of the membership to approval by a simple majority of members voting in person or by proxy at a meeting.

Because of the rapid changes that are expected to take place in the electric industry when the marketplace becomes deregulated in January, 2002, smaller cooperatives such as the approximately 5,000 meter KEC, are exploring alternatives to preserve the reliable and affordable local service that cooperatives have traditionally provided rural Texans.

In addition to equitable rates and reliability of service for its members, priorities for KEC officials are maintaining a local presence in the delivery of electric services, preserving local input into decisions and providing job stability for cooperative employees.

Options for Kimble could include joining with other electric cooperatives such as the Johnson City based Pedernales Electric Cooperative (PEC) - the state's largest cooperative. PEC enjoys a solid reputation for its rate structure, reliability of power, superior consumer service and strong local presence in the communities it serves throughout the Texas Hill Country.

If the revisions to KEC's Articles of Incorporation are approved by the members attending the March 21st meeting, future options could then be presented to the membership in a manner that allows the Cooperative to move more expeditiously and with wider member participation.

Ask the Historical Society

Q. Do you have any information on W. H. Cooper? He is buried in the Sonora Cemetery and his stone says he was born in 1818 and died in 1896.

A. William Hosea Cooper was the son of Thomas T. Cooper of Virginia. William was born in Virginia as were his brothers Sidney and Townsend. The family moved to Tennessee where two other children, Terissa and Susan were born. Around 1852 William married Nancy and Thomas T. Cooper deeded some land to William, possibly as a wedding gift. William farmed the land from 1852 to 1870 and it was during this time William and Nancy had the following children: Mary S. 1852, Richard H. 1854, James B. 1857, Thomas M. 1860, John Thomas 1862, Nancy J. 1867, Sarah Frances 1870.

In 1872 William moved to Texas with his wife and 3 youngest children, John T. age 10, Nancy J. age 5 and Sarah F. age 2. Remaining behind were daughter Mary S. age 20, sons Richard age 18, James age 15 and Thomas age 12. Coleman County records indicate that Nancy J. married Perry Davis in 1882; J. T. Cooper married Martha S. Brannan in 1887 and Sarah F. married James H. Brannan in 1889.

The eldest daughter, Mary S. married B. F. Vantrees and with her brother James and his family they settled in Fannin, Texas. Family correspondence shows Mary living in Taylor Co. in 1890 and the 1910 census shows her and her family living in Jones County.

Around 1875, James B. Cooper married Sarah L. Jernigan and had sons William A., J. R. and R. D. Cooper. Richard Cooper remained on the farm in Tennessee and died unmarried in 1876 of pneumonia. We have found no record of what happened to Thomas M. Cooper.

We know that William Hosea and his wife lived in Coleman County from at least 1881 to 1890. From 1895 until his death in 1896, W. H. and Nancy Catherine Williams Cooper lived with their son J. T. Cooper and his wife Martha Serena Brannan Cooper on their ranch near Sonora, Texas. W. H. Cooper died in 1896 and his wife Nancy died in 1899. They are both

buried in the Sonora Cemetery.

Thanks to William J. and Richard C. Clark we have on file a copy of "History and Work Sheets of the Brannan and Cooper Families - Coleman, Schleicher and Sutton Counties" that was compiled in June of 1991. If anyone is working on these family trees we will be happy to allow you to make copies from our records. These also contain entries on the Fiveash, Hughs and Wall families and many others that married into the Cooper family.

Thanks to Frederica Burt Wyatt for a copy of "Peace in the Valley - A Chronicle of Kimble County Cemeteries" and "The Cemetery at Fort McKavett" that was obtained from her in a recent large exchange of information. I purchased the books "Val Verde County Cemeteries," "A History of Edwards County," "Families of Kimble County," "A History of Schleicher County, Texas," "F. E. and Oscar Ruffini, Texas Architects 1877-1917" and "History of Mason County Texas Through 1964." A copy of "The Halberts of West Texas" was donated. We also just received a copy of "Descendants of Richard Potter 1799 - 1852" donated by Virginia Lee Cowherd of Houston. Between these books, the files I have compiled over ten years and the Eaton files my little house is overflowing with Sutton Co. Historical Society material. I am looking forward to the day our new offices are finished and all this moved into them.

Q. There was an obituary recently for a Jesse Peitchinsky, I did not recognize the name or family. Who was Fred Peitchinsky?

A. Fred Herman Peitchinsky was born in Brennan, Texas on September 28, 1892 and moved to Sonora in 1939. He married Bonnie Livingston Peitchinsky on January 28, 1932 in Casa Grande, Arizona. They had three sons, Raymond Johnson, Herman and Jesse Peitchinsky and two daughters Cleo and Mrs. Lloyd Mayberry. Fred Peitchinsky died on November 28, 1953 and was buried in the Sonora Cemetery. Fred Peitchinsky was the son of Gus and Louise Peitchinsky. This is all I have on file except for the fact that he was a Baptist and

died at home.

Q. Who designed the Sutton County Courthouse and how much did it cost?

A. Devil's River News, June 27, 1891 - Oscar Ruffini, the San Angelo architect, and architect for Sutton's \$30,000 court house, was in Sonora a few days this week.

Q. Do you have any information on a Mrs. O. Savage?

A. Only a funeral notice dated August 20, 1911 which states: Died, Saturday, August 19, 1911, at 8:30 P.M. Mrs. Oscar Savage, age 26 years. Funeral services will take place at 11:00 o'clock A. M., at the Sonora Cemetery. Friends and acquaintances of the family are invited to attend. In the Sonora Cemetery her stone reads Ella E. Savage 12-15-1884 to 8-19-1911.

Q. I am looking for a copy of an obituary from a death in Sept. of 1898 can you help me?

the invasion.

In February 1944 the 368th Fighter Group came from North Africa. We became a part of the Ninth Air Force - thus operational. We became Team "B" 84th Service Group, IX Air Force Service Command.

At Winchester and Chilbolton, in England, we water-proofed our supplies and equipment - boarded that Liberty Ship and landed on Omaha Red in France June 18th 1944. Went to Advance Air Strip #3 - scratched out a hole to sleep in and began operations of the First unit IX Air Force Service Command on the continent of Europe, keeping those P47's doing their bombing and strafing. Very shortly our Team "B" Signal Section perfected tank to plane radio com-

Q. When did Dutch Wardlaw serve as president of the National Wool Growers Association?

A. C. B. "Dutch" Wardlaw was the first Texan to serve as president of the National Wool Growers Association and was elected at the 75th annual convention in January of 1940. He served from 1940 to 1943.

Q. Where did Ferdinand Mayer die?

A. Ferdinand Mayer, born August 6, 1832 in Baden, Germany, died April 11, 1913 in San Antonio, Texas and is buried there.

munications, which paid off so greatly in the Battle across France and into Germany.

I received the EAME Campaign Medal with four Bronze Campaign Stars. (Normandy - Northern France - Rhineland - Central Europe).

The Good Conduct Medal, 1 Service Stripe and four Over Seas Bars. I served Stateside one year, one month, two days. Foreign Service - two years, two months, 12 days, and was Honorably Discharged on October 22, 1945."

Water 2000 Plus

College Station-Experts will be putting the pieces of the water puzzle together for city and county officials and interested citizens at a workshop on April 19th at the San Marcos Activity Center.

Its purpose is to provide decision makers with information enabling them to make effective management decisions concerning their communities future water needs. According to Dr. Bruce Lesikar, "We're in the middle of the regional planning process that will decide how we're going to manage our water in the future." "Policy makers need to understand all of their options when making decisions. For instance, they can see how other states have approached this planning effort. They can take advantage of what's already known," Lesikar said.

The workshop begins at 8:30 a.m. Concurrent sessions will be held in the afternoon so participants can gain the most information about supply and demand issues.

Private planners and public officials will discuss wise water planning, recycling and reuse of waste water, legal responsibilities, marketing groundwater, supply options, conveyance devices, brush removal, home conservation, land management planning, drought

management and subdivision restrictions.

Speakers have been drawn from the State of Florida, Texas Water Development Board, Texas A&M University System, Texas Parks and Wildlife, Texas Natural Resource Conservation

Commission, Edwards Aquifer Research and Data Center, Plateau Integrated Land and Wildlife Management, the Extension service and private industry. Additionally, representatives from Travis and Bexar Counties will address how officials plan to address their water demands.

County commissioner continuing education units are available.

Pre-registration is \$40 if paid before April 1st. After that date, the registration fee is \$50. The workshop is sponsored by the Texas Agricultural Extension Service, City of San Marcos, Southwest Texas State University, Texas Parks and Wildlife and the Heart of Texas Chapter of the Soil and Water Conservation Society.

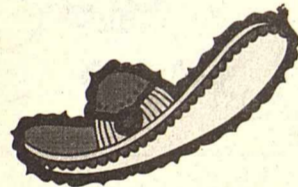

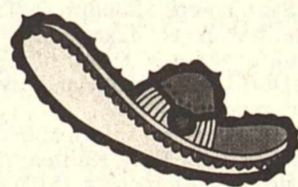

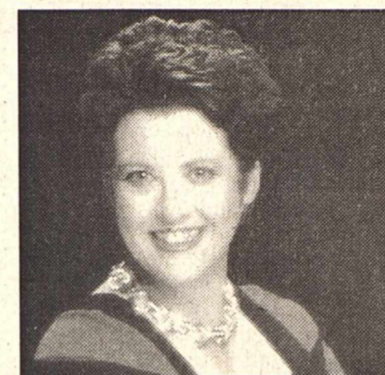
sons, Michael 14, and Dillon 5.

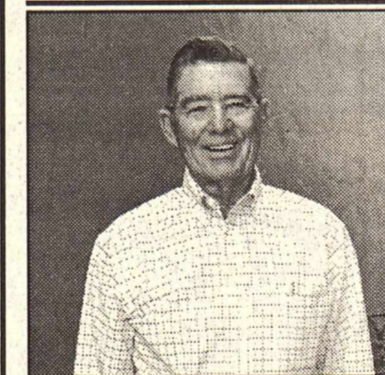

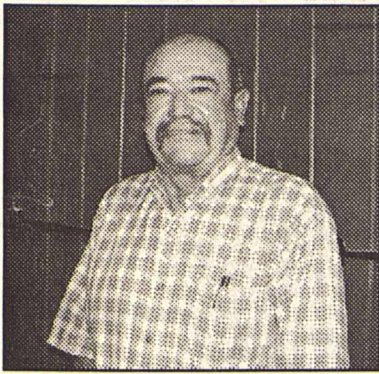

We are faced with a continuous-shrinking tax base which could

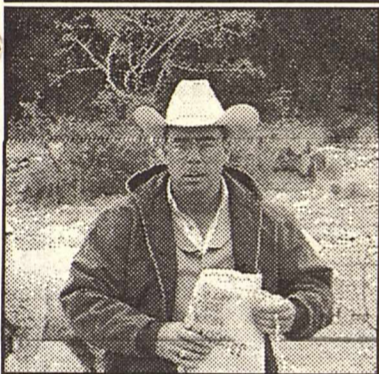

Rangeland Academy Workshop

Ranch owners wanting to learn more about rangeland management practices have the opportunity to take part in a comprehensive, three-day workshop April 6-8.

The Academy for Ranch Management, which will be held at the Texas Agricultural Research Station south of Sonora, will feature discussion of the basics of range science and management. Topics include inventory and evaluation of rangeland, developing management goals and developing a monitoring program.

Enhancing management skills, planning livestock nutrition and management, restoring degraded rangeland and developing drought strategies will also be discussed.

"Over time, our clientele is shifting from the traditional rancher to those that have inherited or purchased ranch lands for various reasons, whether it be recreation, hunting, or a getaway destination," said Ray Hinnant, a senior rangeland research associate with the Texas Agricultural Experiment Station. "These folks are generally professionals who don't have a background in the natural resource sciences. What we're trying to offer is a set of courses that can provide them with a background of the biology involved."

Cost for the three-day event is \$350 per person, which includes six meals and lodging. However, lodging at the station is limited and available on a first-come, first-served basis. Duplexes are available for couples, and additional separate sleeping arrangements are available for men and women.

"We like to do this in an outdoor setting so they can get a feel for the important plants out there, proper grazing and get a good idea of what good stewardship means," Hinnant said.

Instructors are Hinnant, Dr. Mort Kothmann, professor of rangeland ecology and management at Texas A&M University, Dr. Charles "Butch" Taylor, director of the Sonora Experiment Station, and Kent Mills, consultant with Ezell Key Grain, in Snyder.

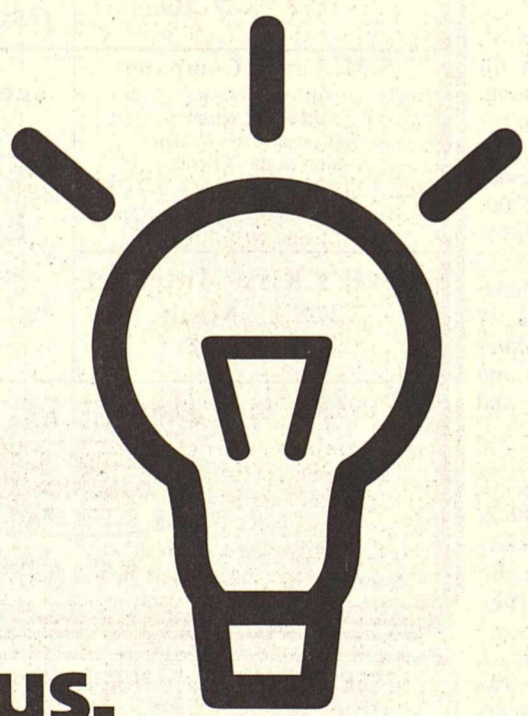
