Commissioners Approve Redistricting Plan

sioners voted on and approved the new redistricting plan at Monday's Commissioner's court. By approv-ing the new plan, the polling loca-tion for Precinct 2 will have to be moved. The Pct. 2 polling place was in the Elementary school gymnasium, which is no longer a part of that precinct. There will also be classes held in the gym next year, posing another problem. Sutton County Judge Carla Garner suggested asking the Hospital District for use of the Nursing Home lobby as the new polling place.

Adelita Alvarez, Justice of the Peace reported 850 criminal cases filed in the month of May. \$22,114.25 was collected in fees, with \$8368.25 going to the County. Alvarez then reported that she had received the applications for the clerical position in her office. She will begin interviews this week. She then asked the court to consider letting her hire two positions for the office, with the higher starting salary pay level since both would have to be sworn in as court clerks. The commissioners discussed this request and decided that the hiring of an additional position would have to be made during the budget hearings. The court did approve the hiring of the one position at the higher salary pay rate.



County Tax Appraiser, Rex Ann The Sutton County Commis- Friess, reported that taxes were 97% collected for the 2000 tax levy. She informed the court that everyone who had not paid as of yet had been sent their second notices. Friess also reported that there is an estimated increase in value that will be confirmed on July 25.

Mrs. Cynthia Petty, visitor, expressed displeasure with the handling of hiring cleaning crews at the Civic Center. Judge Garner explained that there had been some miscommunication about how the situation was going to be handled. It had been discussed at the April meeting, to look for several crews interested in rotating the schedule, so that no one crew was responsible for every weekend. New Teachers Hired at School Board Meeting

The Sonora I.S.D. Board of Trustees met on Monday, June 11, 2001. After newly appointed President, Tryon Fields called the meeting to order, County Tax Appraiser, Rex Ann Friess reported that 98% of school taxes have been collected. Friess reported that historically, this is about average for this time of year. She also informed the Board that second delinquent notices have been sent out. Friess told those present that it is estimated that local values will be up this year, possibly at \$94 million. This amount will not be certified until after July 25th. This increase could have major effects on the school district and the amount of money received by the State.

Alice Cox was present to give the Special Education report. Cox shared this year's parent surveys most of the comments were positive a Special Education teacher and an

Sixty-Fourth Annual Sonora Wool & Mohair Show

Writer: Steve Byrns, SONORA-The 64th Annual Wool and Mohair Show and the 42nd Annual National 4-H Wool Judging Contest are set for June 19-21. Activities for both events are set for the Sonora Wool and Mohair Company Warehouse and the Sutton County 4-H Civic Center.

The Sonora Wool and Mohair Show is open to sheep and goat exhibitors of all ages and is considered the premier event of its type in the world. The accompanying contests have attracted the top youth teams from across the nation since 1947.

The show is sponsored by the Sonora Lions Club and Chamber of Commerce in cooperation with the Sonora Wool and Mohair Company and the Texas Agricultural Extension Service.

A host of activities fill the three-day event. Included are an All-Texas Show for 4-H Clubs and FFA Chapters, an open show for all U.S. producers and the featured event: the National 4-H Wool Judging Contest.

The national contest will be expanded this year to include the first National FFA Wool Judging Contest. Other changes in this year's contests include:

a special emphasis on individual fiber fineness in the wool and mohair fleece shows;

the commercial class for individual wool fleeces is limited to non-registered animals only;

there is no longer a commercial mohair fleece show in the junior or

\$113.8 Billion Biennium Budget Doesn't Need Tax Hike To Meet State Needs

In spite of the demands of a growing population, a tight economy and rising health care costs, the 77th Texas Legislature made ends meet for the next two years without raising taxes.

The \$113.8 billion budget for 2002-03, which includes federal funds, is an 11.6 percent increase over the 2001-02 budget. Unlike 1999, when a strong economy and \$458 million tobacco settlement provided the state with a large budget surplus, the members of this session's Senate Finance and House Appropriations Committees were working with a budget that necessitated difficult funding decisions.

Three days before the session ended on May 28, the Legislature sent Governor Rick Perry a budget that focused on the priorities of public education, health and human services, state employee pay raise, school employee health insurance and higher education.

To meet escalating health care costs, Texas legislators earmarked \$5.1 billion more money for health care. Health and human services programs will receive more than \$34.9 billion, or 30.8 percent of the budget. A large share of the money will fund services such as the Children's Health Insurance Program (CHIP) and Medicaid.

The budget dedicates \$13.4 billion to higher education, including \$71.7 million to fund enrollment increases, \$33.7 million for research, \$110.6 million for healthrelated institutions and \$200 million for the TEXAS Grant program. The \$100 million increase in TEXAS Grant program's appropriation will expand the program from 11,000 grants to almost 100,000. College students from families whose annual total family income is \$40,000 or less are eligible for TEXAS college

Help Prevent **Grass** Fires

With conditions in West Texas being so dry, grass fires are a big threat. The following hints are given to help Prevent Grass Fires:

 Don't throw cigarette or cigar butts on the ground or out of a vehicle. Dispose of them properly and make sure they are completely extinguished.

• Keep a 30-foot "safety zone" surrounding the home clear of brush and cedar, especially for those living in a woodland area. Grass should be cut short in this area as well. For homes that sit on a steep slope, the safety zone should be increased accordingly.

 Stack firewood at least 15 feet and uphill from the home.

Rake leaves, cut off dead limbs and twigs, and mow grass regularly. • Cut tree limbs within 15 feet of the ground and remove dead branches that extend over the roof.

· Don't park cars, trucks, or recreational vehicles on dry grass or The Ladies Golf Auxiliary shrubs. Exhaust systems on vehicles would like to extend our thanks and can reach a temperature of more than 1000 degrees; it only takes about 500 degrees to start a brush fire in the summer.

· Homeowners who barbeque Neville, Team Graphics, Multi- should maintain a 10-foot area free of brush and shrubbery around grills and propane tanks. Non-flammable screens should be placed over the grill (with mesh no coarser than 1/4 inch thick). Never leave a grill unattended. After use, place grill ashes in a metal bucket and soak in water. Keep a shovel, bucket of water, fire extinguisher, or other fire suppression tools on hand.

A. We have several people named James Martin listed in our files:

James Henry Martin was born on 8th Sept 1826 at Cape Girardeau Co., Missouri to Andrew and Sallie Martin. He died on the 19th of October 1849 and was buried at Gentry Cemetery Kimble County. Gentry Cemetery is six miles below Junction on the Mason Road.

He had been married on 31st of October 1849 in the home of Harris Rowland in Saline Co., Arkansas to Mary Lee Rowland daughter of Harris Rowland and Francis Willis. He resided in Missouri until a short time before the War, when he moved to Little Rock, Ark. James Henry Martin served throughout the war in the Confederate Army. He immigrated to Clarksville, Red River Co, TX, immediately after the war. While in the army he contracted stomach trouble which caused his death. James and Mary Lee Rowland had the following children:

Andrew Harris Martin born: 20-9-1852 at Saline Co. Ark. married Annie Sandherr. He died 1928 in Comstock, Val Verde, Texas.

Martha Jane Martin born 2-7-1855 Saline Co. Ark married Joe Terry. She Died in 1934 at Matador, Motley Co., Texas.

John J. or T. Martin 27-2-1858 Saline Co., Ark. Died in infancy

Francis Emily Martin 30-7-1860 Ripley Co, Missouri married James Monroe Brotherton 30-4-1876. She died 24-9-1936 in Del Rio, Val Verde Co., Texas.



Note: James Henry Martin was married first to Martha Hammond. They married in 1847 in Saline Co., Ark. Martha died in 1848.

Chairman Bonilla Says Agriculture Bill Will Fund Important Texas Programs

WASHINGTON, D.C. - U.S. Representative Henry Bonilla (R-TX) Chairman Henry

Bonilla today presented the Agriculture Appropriations Sub-

committee with the agriculture funding bill for 2002. The legislation was approved by the subcommittee and is expected to gain full approval by the House of Representatives by the end of June.

This is an excellent budget that both sides of the aisle can agree upon," said Chairman Bonilla. "It's perfect example of responsible spending: we're taking care of our nation's farmers and ranchers while keeping our nation's consumers healthy and happy.'

The appropriations bill funds \$15.519 billion in discretionary Budget Authority, which is just above the request made by the president. The bill includes an increase of \$119 million for the Farm Service Agency; an increase of \$765 million for the Agricultural Credit Programs; an increase of \$70.2 million for conservation operations; and an increase of \$79.4 million for the Agricultural Research Service. The bill also includes funding increases for the Food Safety and Inspection Service, Child Nutrition Programs, Food Stamp Program and Food for Peace Program.

'In addition to funding a wide range of important, traditional programs, we're also looking ahead to prevent future problems our nation may face, including foot and mouth disease," said Chairman Bonilla. "Agriculture fuels our nation's economy. This appropriations bill is going to help keep the agriculture industry strong and prosperous."

The legislation provides funding to combat possible outbreaks of Foot and Mouth Disease and Bovine. Spongiform Encephalopathy (BSE). The Food and Drug Administration, which oversees Foot and Mouth Disease prevention, will receive an increase of \$120.4 million. This additional funding is intended to aid the FDA's prevention exercises and prepare them for any outbreaks. The subcommittee also provided \$5 million for BSE research that will help with detection and diagnosis of the

disease as well as safe disposal of carcasses.


Important Texas projects will also receive funding from the appropriations bill. The subcommittee will provide continued funding for the Weslaco bee research program; bovine genetics research will receive a funding increase of \$900,000; the plant germplasm research at College Station will receive a funding increase of \$1.5 million; and nutritional requirements research at the ARS Human Nutrition Center in Houston will receive an increase of \$500,000.

Additional programs based in Texas that will receive funding support include: the new U.S. Plant Stress and Water Conservation Laboratory in Lubbock will receive \$750,00 for staffing needs; Dairy and meat goat research, wool research and livestock and dairy policy research will receive funding through the Cooperative State Research, Education and Extension Service; and the boll weevil and cattle tick pest management programs will receive funding through the Animal and Plant Health Inspection Service

Other Texas programs that will receive funding include: the Texas Wildlife Services Program will receive a funding increase of \$1 million; Texas pecan research will receive an increase of \$300,000; the Grazing Lands Conservation Initiative will receive an increase of \$2 million bringing the total funding to \$20 million; the Natural Resources Conservation Service (NRCS) will receive \$500,000 to facilitate water conservation and efficient irrigation activities in the Bexar, Medina and Uvalde counties of the Edwards Aquifer; and additional funding through NRCS for the Bexar-Medina-Atascosa Watershed Project.

"I'm proud to help make a difference for farmers and ranchers across Texas and the nation," said Rep. Bonilla. "This bill is going to mean a safer, better informed and more advanced agriculture industry. That can only mean positive things for the consumer and for the industry as a whole.

Rep. Bonilla is chairman of the House Agriculture Appropriations Subcommittee, which oversee all of the nation's agriculture funding.


ranches, partnerships and corporations will be discussed in the context of the gift and estate tax rules.

Flea collars and tick treatments are commonly found on store ate climate, Texas is considered shelves this time of year, but you may want to think twice before purchasing, says Dr. Bonnie Beaver, a veterinarian in the Small Animal Clinic at Texas A&M University.

Most of the flea collars and treatments found at drug and grocery stores are not nearly as effective as those obtained from a veterinarian, Beaver says.

"The over-the-counter products tend to be very safe, but not necessarily very effective," Beaver explains.

You may be itching to get rid of the same but are much more effective. But best of all, a veterinarian can give the owner a total treatment plan for controlling fleas, and that's what is needed most."




