The "Dancing Cowboy" Returns to Sutton County

Conjunto Accordionist, Mingo Saldivar will make his return to Sutton County on Saturday, August 18 when he takes the Main Stage at the Sutton County Days Celebration.

Mingo first rocked Sonora earlier this year when he entertained crowds all over town for a week. During his stay he also visited Sonora schools and held several "jam sessions" with local musicians.

Mingo Saldivar's music represents one of many aspects of traditional Mexican-American culture, also known as Anglo-American folklife.

Saldivar is an established hit producing artist who is considered a pioneer by his peers and countless fans. He formed Los Tremendos 4 Espadas in 1975. Today, the band consists of Mingo Saldivar on

accordion & vocals, Jesse Garza on bass, Charlie Torres on drums and Alex Delgado on bajo sexto.

Up-to-Date Immunization Records Needed For Children In Schools and Child-Care Facilities

While back-to-school needs often include notebooks, pencils and paper, clothing, shoes, backpacks and lunch boxes, one of the top items required is an up-to-date immunization record for children in schools and child-care facilities.

Immunization requirements remain the same for this school year with one exception, said Monica Gamez of the Immunization Division at the Texas Department of Health (TDH). "TDH is deferring for one school year the requirement that students have a booster dose of tetanus and diphtheria (Td)." This 10-year booster is usually given to students at about 14.

The action applies to Texas schools from July 1, 2001, to August 1, 2002. Once the deferral is lifted, all students will be required to show proof of a Td booster. The deferral is due to a national shortage of adult tetanus and diphtheria vaccine that resulted when one of two manufacturers discontinued production.

Vaccines required at various ages for all children are polio; diphtheria, tetanus and pertussis or acellular pertussis (DTP/DaP); Haemophilus influenza type b (Hib); measles, mumps and rubella (MMR); chickenpox (varicella); and hepatitis B.

A hepatitis A vaccine requirement affects only children attending school or child-care facilities in 32 counties along the Texas-Mexico border. Children with proof of a previous hepatitis A infection do not need to be vaccinated.

All children attending public or private schools or licensed, certified

or registered child-care facilities must have the required immunizations for their age group completed by the first day of attendance. State law gives local school districts and child-care facilities the option of allowing children to attend if at least one immunization in each series has been received, but the remaining required immunizations must be received as soon as medically possible.

Children ages 5 and 6, for example, should have had the following immunizations to enter school:

* 3 doses of polio vaccine, including one on or after the fourth birthday;

* 4 doses of DTP/DaP vaccine, including one on or after the fourth birthday (proof of pertussis vaccination not required for children 5 years or older);

* 1 dose MMR vaccine on or after the first birthday and one additional dose of measles vaccine that may be received as part of a second MMR;

* 3 doses hepatitis B vaccine;

* 2 doses hepatitis A vaccine (32 border counties only);

* 1 dose varicella vaccine on or after the first birthday for children born on or after Sept. 2, 1994.

Soaring Through Sonora Skies

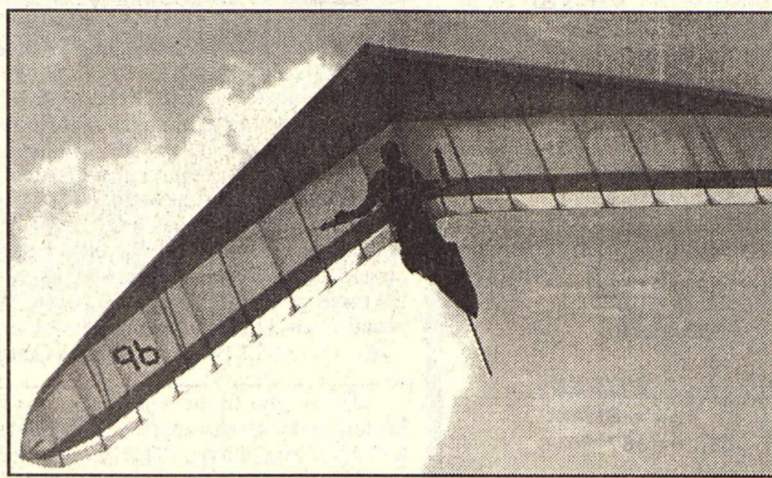

Local rancher, Ruth Shurley had an unexpected visitor last week, when hang glider, Curt Warren landed on her ranch. Warren, who is originally from Venice Florida, calls Chattanooga, TN home in the Summer and Australia home in the winter. While in Australia he makes a living doing what he loves to do, teaching others to hang glide.

He began the occupation/hobby 7 years ago and was trying to break the current distance world record when he landed about 1/2 mile from Shurley's house.

Warren began his trip in Zapata, Texas, along with about 15 other gliders from all over the world, all after the same goal. The old record of 308 miles had been broke a couple of weeks ago, when a glider traveled 432 miles before coming back to earth. The gliders chose to start in Zapata because of the great winds that can be caught there.

In order to get started on a glid-

ing trip, a glider is towed up behind a small airplane, where he is released anywhere from 1,000 to 3,000 feet up. It is all up to the pilot then to control the craft and defy gravity for as long as possible. Warren said that they have to catch rides on a wind draft, up to the clouds and point the glider in the desired direction of travel. They then ride the currents like birds, spi-

raling back up with the drafts.

Warren said the ride is "like a rodeo," with plenty of lifts and drops.

These long distance trips are tricky, lasting sometimes from 8 to 10 hours or longer. A pilot must navigate and decide how many supplies to use along the way. How

Mutton Bustin' and Team Roping Kick Off Sutton County Days Fun

Outlaws of all ages will invade the Sutton County arena this weekend, where the Sonora Outlaw Pre-Rodeo events will kick off on Saturday, August 11th with the Kids Mutton Bustin', sponsored by The Pennington Family and Duke Energy.

Kids, ages 4 to 7 years old, (with a weight limit of 55 lbs) should check in by 4:45 and be ready to ride at 5:00 p.m. A protective vest and helmet will be provided for each rider. There is a \$10 entry fee for each contestant. To enter, a parent or guardian can go by image apparel at 210 E. Main St to sign up before August 11 or you can enter, starting at 4:30 p.m. at the arena the day of the event. A parent must sign a release in order for a child to ride. Top contestants from Saturday will be eligible to compete in the Mutton Bustin' finals during the Sonora Outlaw Pro Rodeo on Friday, August 17th at 7:30 p.m. For more information on the Mutton Bustin' call 387-5189.

After the little ones have dusted off their britches and made their way out of the arena, the big boys and girls will stir up the dust.

The Sutton County Outlaw Team Roping Challenge will start immediately following the Mutton Bustin'. Sign up begins at 5:00 p.m. Books close and teams will be drawn at 6:00 p.m. Roping should begin at 6:30 p.m.

The entry fees are \$80, enter once, draw four. Everyone is asked to please enter with a partner. The roping is open to all residents of Sutton and surrounding counties, as well as any rodeo sponsors.

The top 24 teams will advance to the Short Go, which will be held during the Sonora Outlaw Pro Rodeo, August 16-18. Eight teams will come back each night. Buckles and plaques will be awarded to the winners of the 4 head average.

The top money winners from each County Team Roping Challenge will advance to the Bad Co. Rodeo Finale in Brady, Texas on October 12-13. The top team will win a "Stayin' Alive" Tour Buckle and the Top County wins the "County Championship" plaque.

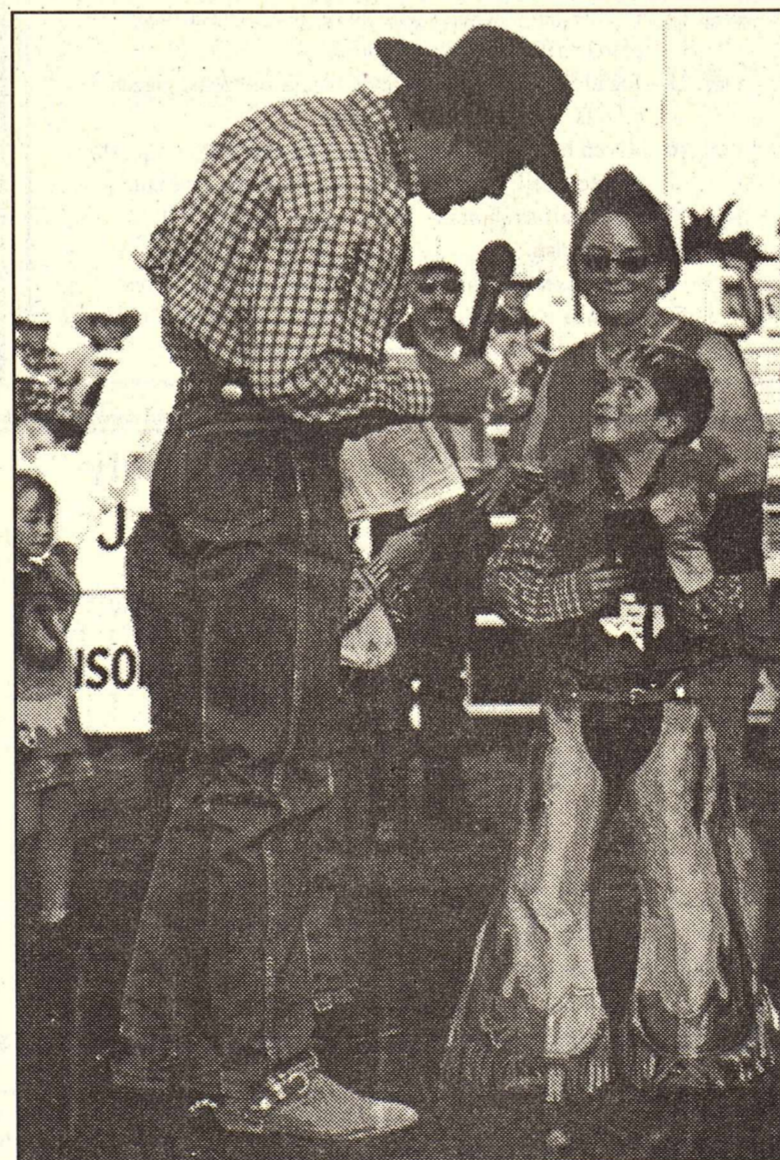

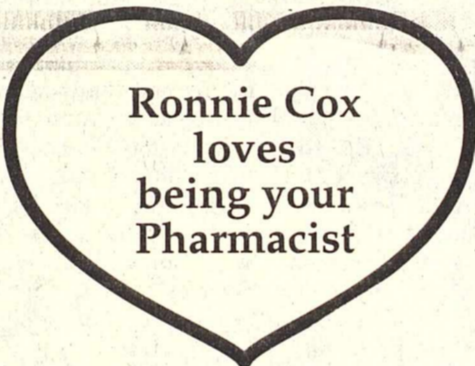

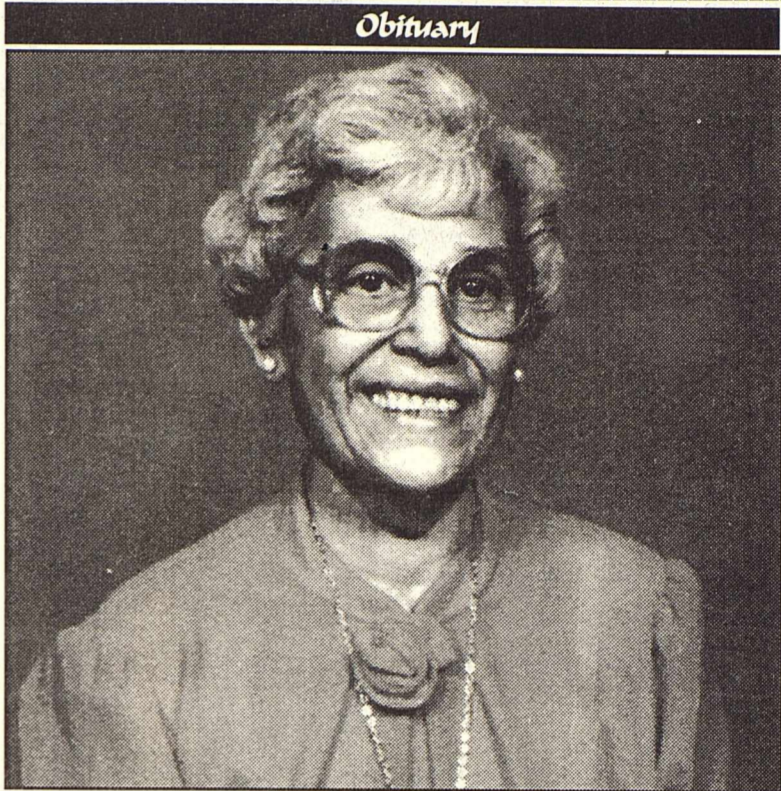

Ask the Historical Society

Mrs. Maggie Giles at 2828 CR 4301, Omaha, TX 75571-9724 wants more information on the burial place of Jasper Newton Mabry/Mabray. He died December 31, 1852 and was buried in the Sonora Cemetery. We know that Jasper Newton Mabry was born July 17, 1822 in Florence, Alabama. He married Mary Ann Hudson in Rusk Co, Texas, November 27, 1851. She was the daughter of Cuthbert Gibson Hudson (1700-1851) and Pherbia Wooten Alford (1809-1878).

Jasper N. Mabry's parents were David Mabry (b. 1792 in South Carolina) and Cynthia Mabry (b. 1796 in Georgia); who came to Bosque Co. from Rusk Co. in approximately 1851 with their sons Jasper N. and Jesse H., and their son-in-law J. D. Helton, who was married to Lucinda Mabry. David Mabry and Lucinda Mabry died and are buried in Bosque Cemetery.

Jasper Newton Mabry got his commission as a Notary Public in McLennan Co. He helped organize Bosque Co. and was elected the first county clerk. He served in the Mexican War of 1848. He also took part in battles against Indians after their raids on isolated settlers.

Jasper Newton Mabry is buried near his nephew W. C. Mabry and his wife Sarah Elizabeth in the row behind Will Carver.

Q. Were convicts ever used as labor in Sutton County?

A. Yes they were. I found mention of prisoners being used for road work in Sutton County back in the February 1893 minutes of the Commissioner Court. "The Sheriff is ordered to work said convicts, in accordance with law in such case...on the public road and to employ guards for same. Compensation of such guards shall not exceed \$1.50 per day and that one guard shall be employed for every 3 such convicts or less number.

Q. Did the children in the Elliott School have any type of band or after school activities?

A. Yes! An example is listed in the March 12, 1948 Devil's River News: A thirty piece band from the San Felipe School in Del Rio will present a concert Tuesday night at 7 o'clock at the Elliott School auditorium. The Spanish Class of the school will present two skits. Admissions are 15 and 25 cents. The San Felipe students are under the direction of Gilberto Cerda, Superintendent.

Monday night, March 19, the Elliott School will hold its Spring Carnival, the proceeds of which will go to pay the school back for a 16 mm motion picture projector. A Goddess of Spring and Court of Honor will be elected.

The Elliott School had its own Parent-Teacher Association and they were very, very active in supporting the school.

Q. Where were baseball games played in the early days of Sonora?

A. Most of the games were held at the playground where the Elementary School now stands. In 1948 when the school was accepted in to a league S. H. Allison gave the Sonora Independent School District Team and the Sonora Bronco High School Team permission to fence off and use as a baseball field a section of his pasture which adjoined the football field on the south side. The field was cleared and fenced off and a permanent back stop was erected on the site. Portable stands were built along first and third baselines in preparation for the school to play in the Concho Basin League.

October 8, 1948 - Reburial services were held Wednesday afternoon at St. Ann's Church, Sonora, for Private Geronimo S. Munoz of this city, who was killed in action while serving with the armed forces of the nation in World War II. His body arrived here Wednesday morning and lay in state at the home of Mrs. Tita Almaguer until the services.

Private Munoz, who was a member of Co. K of the 359th Infantry Division, lost his life in France on November 13, 1944 while in active combat. He was in the first wave of men to hit the beaches on D-Day in 1944.

He was a native of Minera, Texas, born there July 20, 1913, and had lived in Sonora since 1933. While here he was employed on several ranches, being employed on the Nettie Word ranch at the time of his induction into the Army in October of 1943.

Private Munoz was stationed at Fort Sam Houston while in the states. During his army service he was awarded the Purple Heart Medal, Good Conduct Ribbon and Expert Rifleman's Badge.

He is survived by his wife, Mrs. Juanita Munoz of Sonora, two sisters and four brothers all of Laredo.

The Rev. Father Cyril Herman conducted services, and interment was in the Sonora Cemetery. Ratliff Funeral Home was in charge of arrangements.

In the same issue we found the following: Aurelia Lira, age 11, was the first child to contract Infantile Paralysis (Polio) in 1948. It was reported that she had passed the dangerous stage of the disease and would return home as soon as arrangements could be made here for her care.

Mr. and Mrs. Gene Wallace of Alpine became the parents of an 8 pound 4 ounce son who they named Libb Mills Wallace.

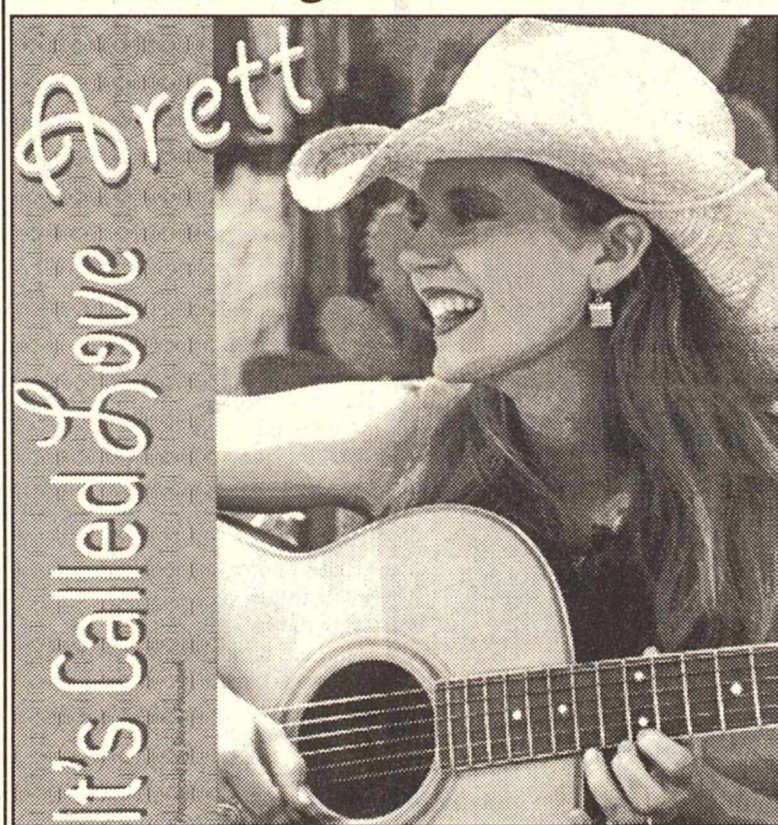
Miss Tris Speaker Scott, a teacher in the Sonora School system, was the guest of her Uncle Tris Speaker at the World Series. Her uncle played in the outfield with Babe Ruth when the Bambino was starting in the game in Boston and later went on to play under the equally famous Connie Mack at Philadelphia then Cleveland where he finished his playing days and earned the reputation as the greatest center fielder of all time. He was one of the first five men elected to Baseball's Hall of Fame at Cooperstown, New York.

At McAllister Foods at phone #4, you could get a 1 pound tin of Admiration Coffee for 53 cents and short ribs for 43 cents a pound.



Above: an "old photo" sample entry. Below: a "children/babies" sample entry for the Sutton Co. Days Photo contest

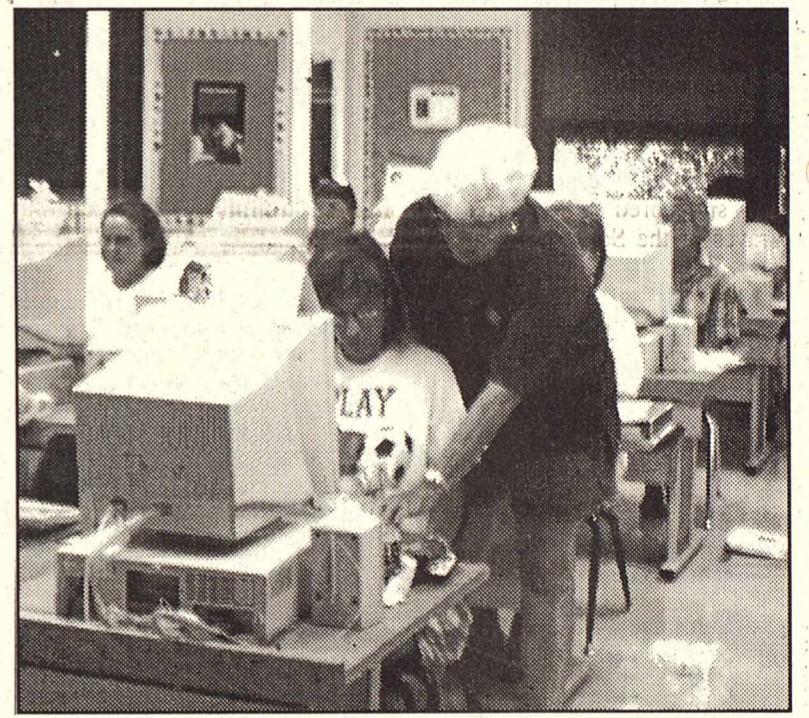


Sonora Teachers Complete Computer Training Sessions

2 through 3 months - 1 dose polio vaccine, 1 dose DTP/DTaP vaccine, 1 dose Hib vaccine

4 through 5 months - 2 doses polio vaccine, 2 doses DTP/DTaP vaccine, 2 doses Hib vaccine

6 through 11 months - 2 doses polio vaccine, 2 doses Hib vaccine, 3 doses DTP/DTaP vaccine

12 through 14 months- 1 dose MMR vaccine received on or after 1st birthday, 2 doses Hib vaccine, 3 doses polio vaccine, 3 doses DTP/DTaP vaccine, 1 dose varicella vaccine on or after 1st birthday

15 months through 4 years - 1 dose MMR vaccine on or after 1st birthday years, 1 dose Hib vaccine on or after 15 months of age (unless a primary series and booster are completed), 3 doses polio vaccine, 4 doses DTP/DTaP vaccine (4th dose required at 18 months), 1 dose varicella vaccine on or after 1st birthday

2 years - 1 dose hepatitis A vaccine (32 border counties only)

3 through 4 years - 2 doses hepatitis A vaccine (32 border counties only)

5 through 6 years - 3 doses polio vaccine, including 1 on or after 4th birthday, 4 doses DTP/DTaP vaccine, including 1 on or after 4th birthday. (Proof of pertussis vaccination not required for children 5 years or older.), 1 dose MMR vaccine on or after 1st birthday and 1 additional dose of measles vaccine may be received as part of a second MMR), 3 doses hepatitis B vaccine, 2 doses hepatitis A vaccine (32 border counties only), 1 dose varicella vaccine on or after 1st birthday for children born on or after Sept. 2, 1994

Bronco Football Legends

The best time of the year is finally here again. Bronco football has started. Over the years, Sonora has been blessed with some of the best football teams and players in the state of Texas. I am sure each of us has memories of past Bronco Legends. Who could ever forget watching Manuel "Soapy" Lopez, Primo Gonzales, Eddie Howell, Bruce Kerbow, Ricky Street, Milton Noel, Adam Youngblood, and (our newest legend) Tom Jacoby run with the football.

Of all the Bronco Legends, there are three runners whose careers were extraordinary and can be classified as Bronco superstars. These three runners each made All State in their junior and senior years and one made it as a sophomore. Two of them made All American. Each of these runners took his team past district and into the playoffs.

George Wright played for the Broncos from 1951 to 1954. He played tailback, quarterback, and linebacker. He was named All District three times and All State twice. In 1952 as a sophomore, he carried the ball 250 times for 1,320 yards and scored 13 TD's and 9 extra points. (The records do not indicate whether the PAT's were kicks or runs.)

In 1953, he carried the ball 251 times for 1627 yards and scored 15 TD's and 20 extra points. The Broncos were district champions. In 1954, he carried 237 times for 2029 yards and scored 31 TD's and 40 extra points leading the Broncos to their first bi-district championship. His totals are 59 touchdowns and 69 PAT's. During his career, he also passed for 32 touchdowns. So, for total offense, George Wright accounted for 91 touchdowns. I used the certificate that is in the Sonora Public Library for George Wright's data. Everybody should stop by to take a look at it.

George Johnson played for the Broncos from 1954 to 1956. He was honorable mention All State as a sophomore, All State as a junior and senior, and All American as a

senior. Unfortunately, there are no rushing statistics available for George's remarkable career. I have vague memories of watching George run. I remember him as a "broken field" runner where he would often reverse his field several times before he was tackled. He scored four or more touchdowns in a game eight times. He scored six touchdowns in a game three times. Since he was also the place kicker, he scored every Bronco point in four games. Against Bandera in 1956, he scored all 42 of Sonora's points and in the deciding district game against Eldorado, he scored all 37 points. In the 1956 playoff games, he scored all of the points in each game. In the Eldorado game, he threw a pass that was intercepted. George caught the defender, took the ball away from him, and then ran for a touchdown. By going through the newspaper articles, George scored 26 TD's and 2

PAT's in 1954, 26 TD's and 19 PAT's in 1955. In 1956, he had the best single season of any Bronco when he scored 40 TD's, 28 PAT's, and 4 field goals for 286 points. For his career, George Johnson scored 92 touchdowns for the Sonora Broncos.

Ed Lee Renfro played for the Broncos from 1965 to 1968. He made All State three times and in 1968, he was selected to three high school All American teams. Interestingly, he only made All District twice. During his career, Sonora lost to Class A schools twice and both times, Ed Lee was injured. He played on the undefeated 1966 State Championship team and on the 1968 State Championship team. Fortunately, accurate statistics and a highlight video tape are still available. When he was a freshman, Ed Lee carried the ball 53 times for 358 yards. He scored 100 points on 15 TD's and five two point conversions. As a

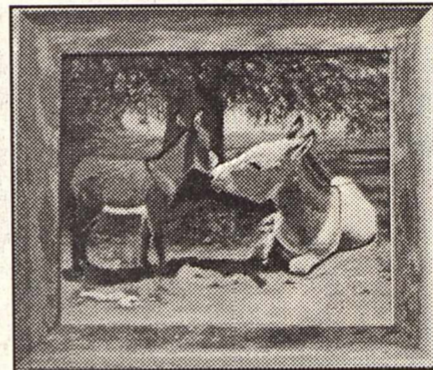
sophomore, he gained 1687 yards on 146 carries (11.5 yards per carry), scored 25 TD's and kicked one extra point for 151 points. In the 11th grade, he rushed 171 times gaining 1468 yards. He scored 151 points on 22 TD's, one field goal, and 16 extra points. As a senior, he rushed for 1799 yards on 259 carries. He scored 21 TD's and 22 extra points for 148 points. For his career, Ed Lee scored 83 TD's and rushed for 5,312 yards on 629 carries and scored 550 points.

Interestingly, George Johnson and Ed Lee were very similar in size and speed. Each was 5'11", 175 pounds, and ran in the 10.1 to 10.2 range.

Texas Agricultural Extension Service Changing Name, Keeping Commitments

PRAIRIE VIEW - The Board of Regents of The Texas A&M University System on Friday (July 27) approved changing the name of the Texas Agricultural Extension Service to Texas Cooperative Extension.

"The new name ties the agency's roots to the broader services it currently offers and will offer in the future," said Chancellor Howard Graves. "Our hope is that more Texans will take advantage of the variety of programs and services available through Extension."

Citing the state's tremendous urban growth, among other changing demographics, Dr. Ed Hiler, vice chancellor and director of Texas Cooperative Extension, explained that the change was necessary to maintain and improve service to all Texans.

"Our mission always has been to provide education to help farmers and ranchers increase their productivity, to help families succeed, to empower young people to grow into productive citizens, and to help communities develop economically," Hiler said. "But some people, especially in our urban centers, never realized we offered all those opportunities because our name seemed to emphasize only one area."

"We are very pleased to make this change and to renew our commitment to serving all Texans."

Despite the change in the name, Extension leaders affirmed that the agency's commitment to Texas' \$15 billion agriculture industry will remain as strong as ever.

"Throughout our history, agriculture has been an integral part of what we do, one of the primary reasons for our work - and that won't

change," Deputy Director Chester Fehlis said. "However, our mission has always been broader than just agriculture, and we want all Texans to feel comfortable requesting assistance for the wide array of Extension educational programs designed to serve their needs."

Why the word "cooperative"? Texas Cooperative Extension is an agency founded on the cooperation of federal, state, and county governments, Fehlis said.

"The U.S. Department of Agriculture, The Texas A&M University System, and the County Commissioners Courts of Texas are the funding partners that make Extension possible. We are also part of the National Cooperative Extension System found in every state and U.S. territory."

"We're also pleased that our new name emphasizes our close relationship with our sister program, the Cooperative Extension Program at Prairie View A&M University," he added. "We work together in so many ways; it's good to share the 'family name.'"

With more than 1,500 employees statewide and 250 offices serving Texas' 254 counties, Texas Cooperative Extension has provided informal education to Texans for 86 years. Established by federal legislation in 1914, the National Cooperative Extension program was designed to extend the educational opportunities and the scientific research of the nation's land-grant universities to the people. Texas Cooperative Extension is a member of The Texas A&M University System.

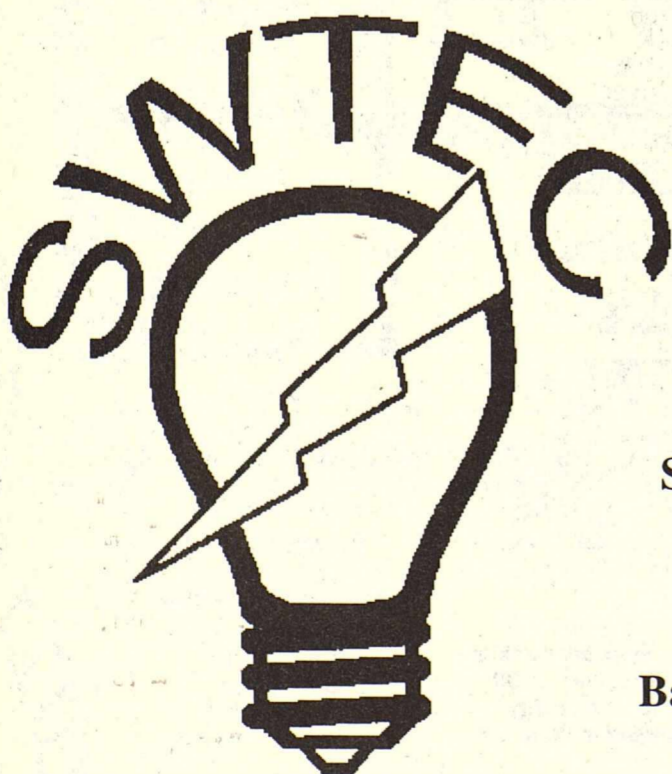

much water is left will sometimes help the landing decision, since one doesn't want to get stuck in the middle of nowhere without water.

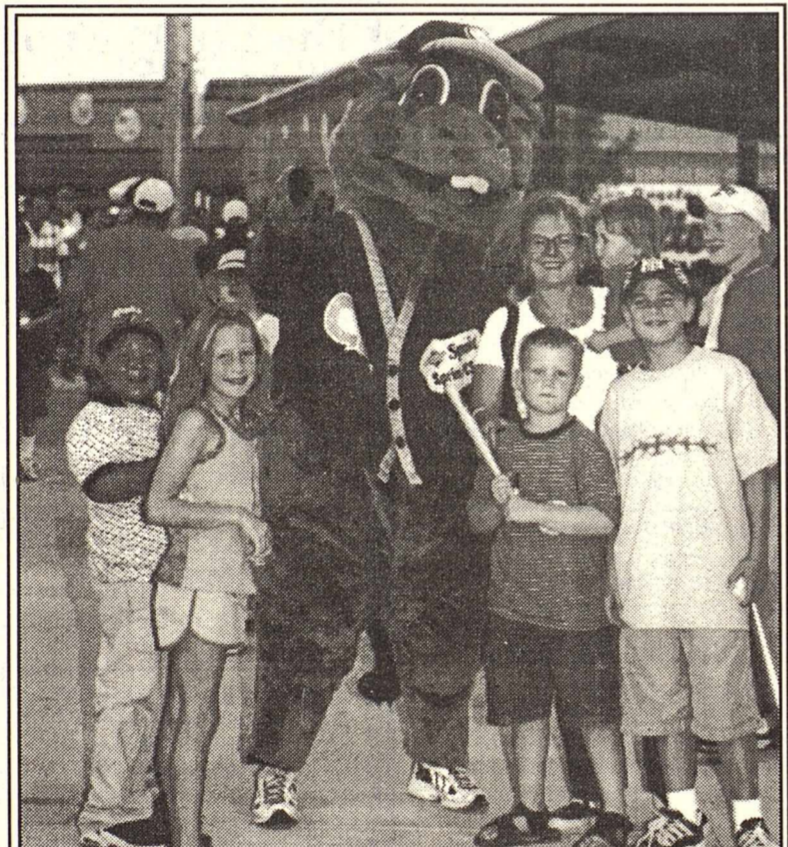
Once Warren lands he can fold up his glider and equipment, which totals about 75 lbs., to carry to the nearest phone. Most pilots have a driver chasing them, to recover them when they land. Warren did not have one when he landed at the Shurley Ranch. He made the hike to Ruth's house and said that she was an exceptional host. Not only did she take him to town to catch a ride, she provided him with a meal and a place to stay. He then hitched rides back to Uvalde, where he hooked up with another glider's driver and finally made it back to his car two days later. Warren said that it's not too hard to get rides when you tell people your story and how you got to where you are. He compared the trip to "hopping a train, you never know exactly where you are going or where you are going to land," he said.

This trip took Warren 260 miles, spending about 8 1/2 hours in the air before landing in Sutton County. His longest trip prior had been 95 miles.

Curt said that gliding really isn't too physical, in fact he called it "gentle and peaceful". Fingertip controls are used to guide the glider. "The challenge is to relax and read the glider," Warren stated. He assured me that gliding is very safe, actually safer than riding in a car. "The only real danger is bad conditions," he said. He added that landing can also be a bit tricky, depending on where you go down. It just takes practice to get good.

Warren will spend the next few weeks in Austin, where he will attend the Gliding Nationals next weekend. The Nationals involve 80-90 gliders racing a course at the same time. Definitely a sight to see.

Curt concluded that he plans to stay in touch with Mrs. Shurley, who was such a gracious host.

ble changes to stay in compliance with the new laws. Action taken included entering an agreement by and between the Sutton/Crockett County Juvenile Probation Department, the Justice of the Peace and Municipal Court to provide case management services for juveniles under justice and municipal court orders. In return, the probation department will seek grant funding from the Governor's Office to pay for the costs of case management services rendered. The panel then discussed at length problems encountered by the school system when dealing with truant or children who fail to attend school. In accordance with new provisions that apply to "failure to attend school," school officials in Sonora have at their discretion several options when filing for this offense. Those options include but are not limited to filing all or part of "failure to attend" offenses in municipal court, justice of the peace court, or the juvenile court. This year legislature enhanced municipal and justice courts range of punishment by allowing them to additionally:

- * Fine up to \$500
- * Order non-secure custody for a single period of up to 6 hours
- * Driver's license suspension for violation of a court order

The Panel then discussed the possibility of the Sonora Independent School District, Sonora Police Department, Municipal Court, Justice of the Peace, Sutton County Sheriff's Department and the Juvenile Probation Department entering a Memorandum of Understanding to effectively impact the rate and financial costs of school truancy.

The Next Community Justice Panel Meeting is scheduled for Tuesday November 6th at 6:00 pm to be held at the High School.
