IF YOU HAVEN'T enjoyed the weather we have had in this area for the past week or two, then you probably don't enjoy Christmas and the Fourth of July, either.

What an ideal stretch of weather, especially for the month of November. If you have lived on the Plains of Texas most of your life, then you know without our bringing up the fact that at this time of year you can have just about anything from the ideal summer-like conditions, to a howling blizzard.

In fact, it was pointed out that while Monday's high temperature was 78 in the area, exactly a year earlier, the high had been only 28 degrees, complete with a goodly amount of snow.

Cotton farmers are keeping their fingers crossed, hoping that the snow will hold off for awhile longer, so they may get their late cotton crop harvested. The weather so far in November has been just right, and at this point, farmers are working from early until late, taking advantage of the warm, dry conditions.

A cooler trend was being predicted for the middle of this week, but hopefully it will not include moisture, so that the work on the cotton harvest may continue.

It is still too early to tell, although it appears that the yield in some cases may be pretty good, all things considered. The grades on some of the earlier-stripped cotton were somewhat low, but seemed to be improving as the season progresses, and the conditions improve.

Mainly, the farmers are still needing a break from the marketplace, where the price for cotton, as well as other commodities, is just not what it needs to be, in order for the farmer to show a profit.

We have said it before, and it bears repeating--It is a sad commentary when the farmers can get everything going for them otherwise--having a much better than average year from the moisture standpoint--and have yields as high as they could expect, and not be able to come out with a profit on their crops.

Something is wrong with our system, to allow this situation to occur, year in and year out. And--even if the situation should correct itself, it will come too late for some farmers, who were depending upon a profitable year, in order to pay off their bank notes and get out of debt.

Any help you can give us on this project will be greatly appreciated.

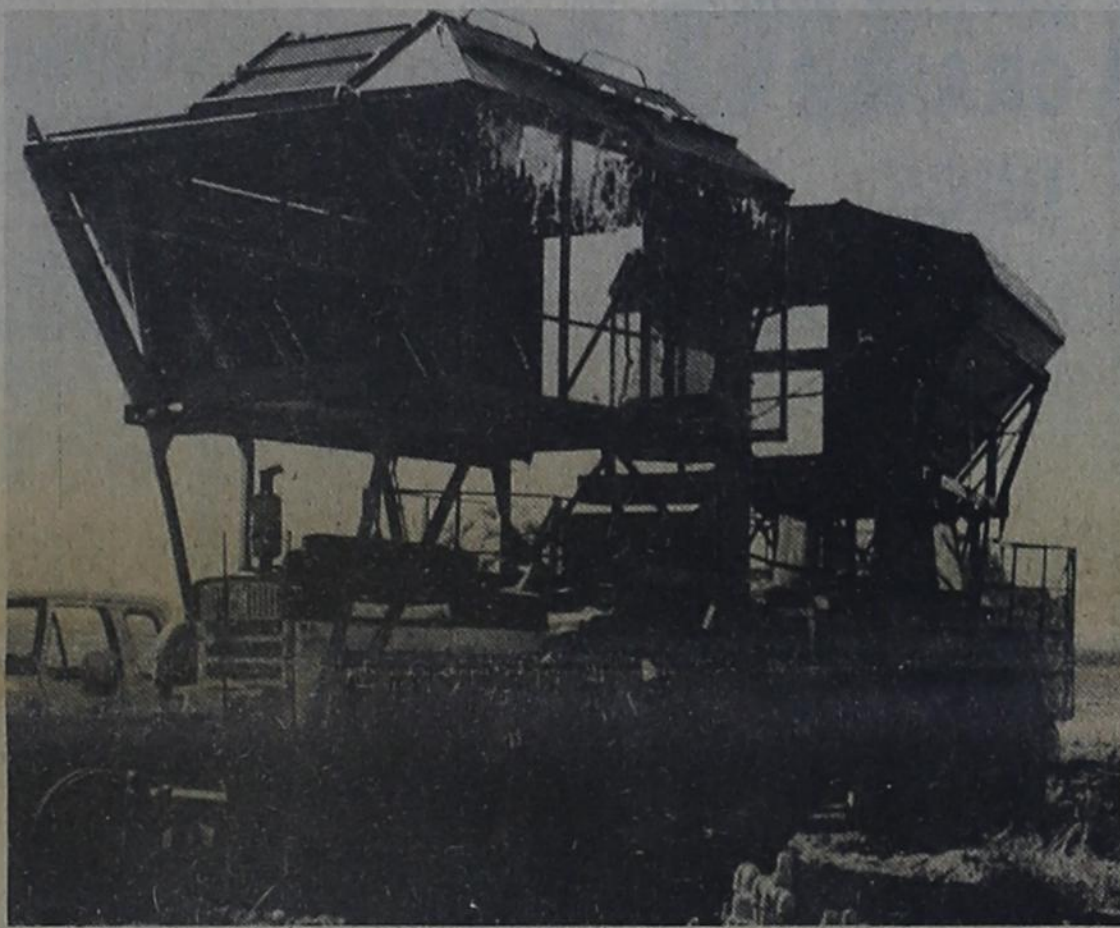

Motorists Are Urged To Take Precautions

Major C.W. Bell, DPS Regional Commander, is asking drivers to be cautious during the Thanksgiving holidays.

"Thanksgiving is a time for us to rest and be grateful for many things. Each individual has his own feelings about Thanksgiving, but those drivers who practice good driving habits can be truly thankful that they were not involved in a traffic accident during the year," he said.

Major Bell pointed out that Texas is well on its way to a record number of traffic fatalities this year. "Last year 4,424 people were killed and 1981 is going to be another record year unless motorists take special precautions to protect themselves and others," he said.

"Many of these deaths could have been avoided if people would stay sober, drive at reasonable speeds and use their seat belts," said Bell. "Putting on a seat belt only takes a few seconds, but that simple act can add years to one's life," he emphasized.

DPS statistics show that last year, about 1200 lives would have been saved if all drivers and their passengers would have clicked their seat belts on. "It's better to be safe than sorry," Bell concluded.

During last year's Thanksgiving holiday period, 63 persons were killed in traffic accidents in Texas. The DPS regional commander said that the Operation Motorcade traffic death count is not conducted during Thanksgiving, but that doesn't mean that drivers should be less cautious. Bell said DPS Troopers would be active during the holiday trying to cut down on needless traffic fatalities.

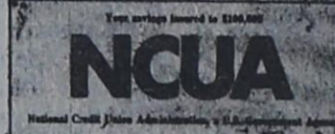

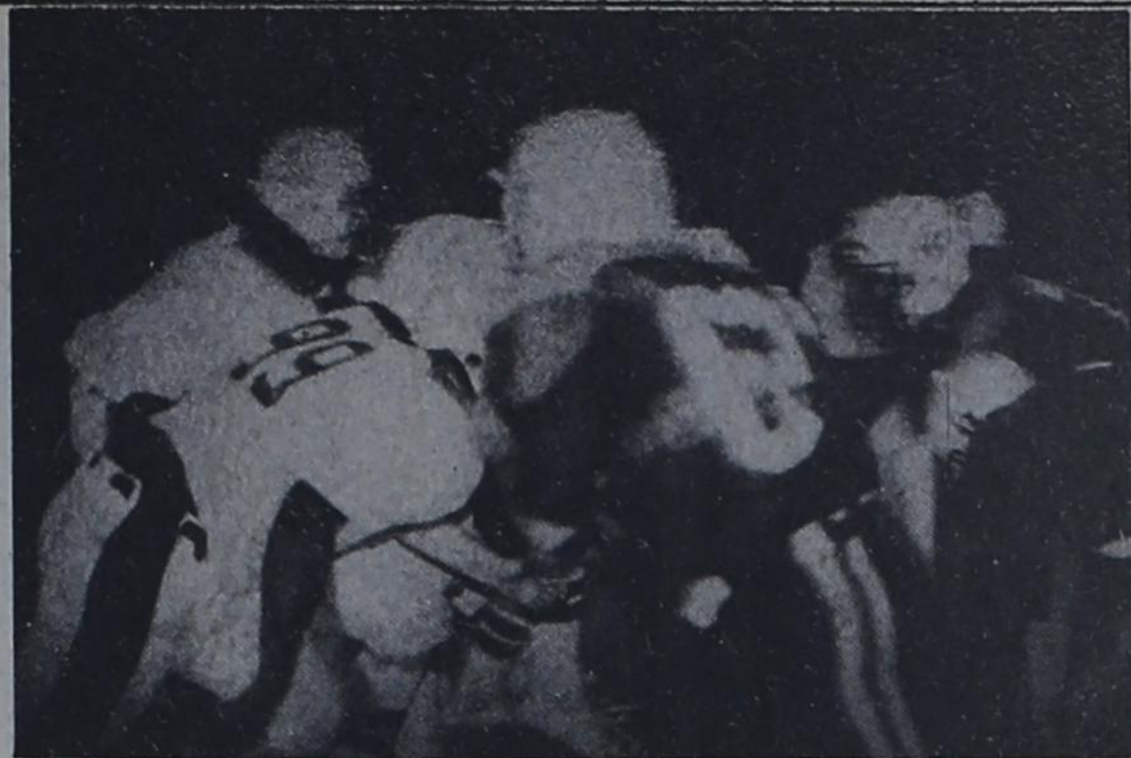

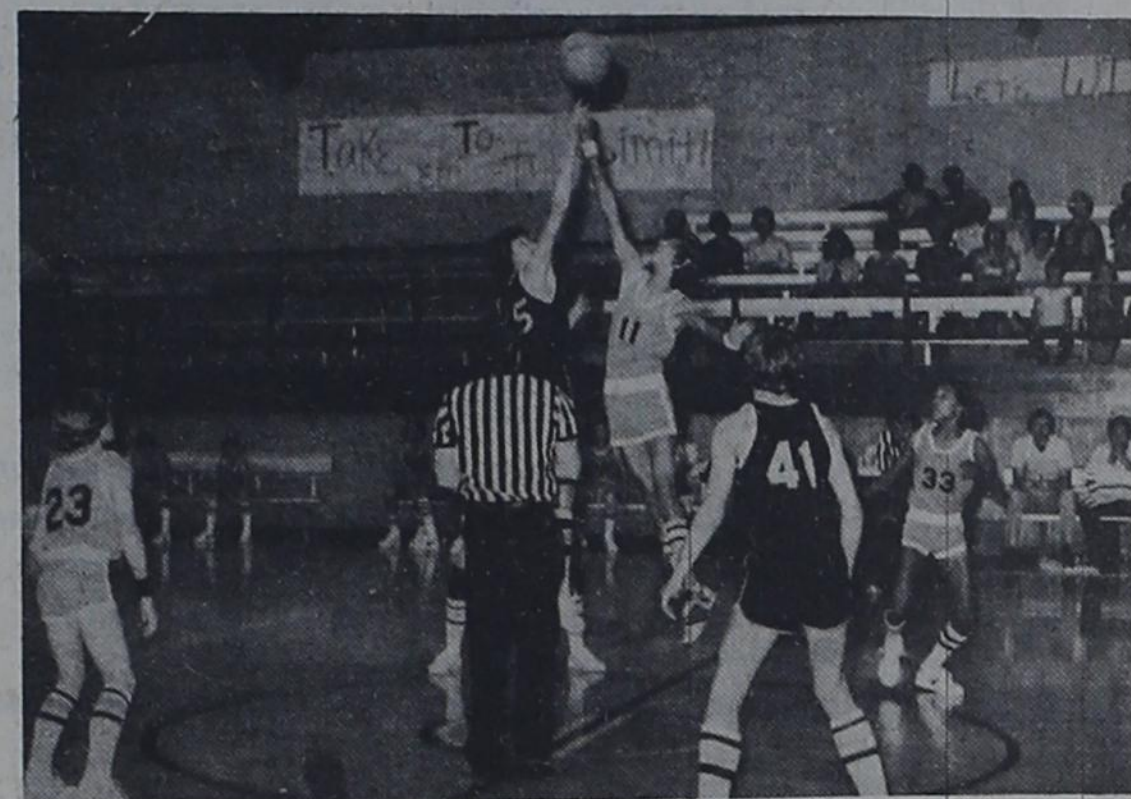

Steers Surprise Mustangs With Last Second Rally

Well, the score was not even close to 100 points, as was predicted by the Amarillo Globe-News, but the Mustangs were left having to settle for a tie against Farwell Friday night, as the Steers came on strong in the last second of the game to make it a 20-20 tie.

With the score 20-12 in favor of the Mustangs and with one second left on the scoreboard, the Steers completed a 13 yard pass into the endzone and the score stood at 20-18 at the final buzzer. But, Farwell still had an extra point try to attempt.

So, quarterback Eubanks decided to take the off-tackle run into the endzone for the tie and the two point conversion worked with a shell-shocked Bovina team watching.

In stats, Bovina made 29 first downs, as opposed to Farwell's 18.

Bovina had 192 yards rushing, and 169 yards passing for a total of 361 total yardage.

Farwell had 367 yards on the ground, with 13 in the air for a total of 380 yards.

Bovina attempted 28 passes and completed 13, with Farwell attempting 3 and completing one.

Bovina intercepted one Steer pass, but Farwell picked off four Bovina passes.

Bovina averaged 43.5 yards in

punting for two punts, and Farwell averaged 26.5 yards per punt.

Bovina recovered three Steer fumbles, while Farwell never recovered a Mustang fumble.

Bovina was penalized for 80 yards on 9 infractions, while Farwell was called on five times for 60 yards.

In scoring, the first Bovina touchdown came from a Richard Shepherd to Joe Black 17 yard try, with Robledo kicking the extra point, but Farwell found a way into the endzone also, as Seguro carried in a 7 yard try but the point after failed.

In the second quarter, quarterback Eubanks from Farwell carried the ball in from the one yard line but the point after failed as the score stood at Farwell 12, Bovina 7.

But in the third quarter, Bovina scored on a Dale Gilbreath pass to Joe Black for 11 yards and a touchdown with the point after try unsuccessful. But this moved the Mustangs ahead by one point, then later, in the fourth quarter, Richard Shepherd made good on a 27 yard scoring drive and Victor Robledo made the extra point for the Mustangs to go ahead of the Steers, 20-12.

But, for the Farwell players, the game wasn't over, as they made their last second attempt to score and succeeded and then ran in a two point conversion to match scores with

Bovina.

In reflecting upon the game, head coach Paul Toppliff said, "We just did not get the ball into the endzone when we had the chances. Out of five opportunities, we got the ball to where it counted twice."

Toppliff praised sophomore runningback Richard Shepherd for his efforts in this game and for the season. Richard gained 1,193 yards this year and in this game he had 22 carries for 168 yards.

"In the thirteen years that I have coached, I think Richard is probably the second best runningback I've ever had the pleasure of coaching. He has been phenomenal the past two weeks. In the Farwell game, he gave a tremendous effort," remarked Toppliff about the player.

This tie brought the season record of the Mustangs to 6-3-1 for the year. Last year's record was 6-4.

The Mustangs and Farwell will share third place in the district standings, as Kress will advance as the district champs.

In summarizing not only this game, but maybe the season, in general, coach Toppliff said, "We were disappointed in the tie with Farwell. They were pleased they tied us...but we don't teach our kids that it's okay to tie. We wanted to win, and we played to win."

Firemen Happy With Addition Of New Truck

The members of the Lazbuddie Volunteer Fire Department are pleased with the newest addition to their department... a new fire truck. It is an addition which, they hope, will enable them to reach fires more quickly and perhaps save valuable property and lives.

According to Fire Chief Glenn Lust, the department received the cab and chassis in May, with the pump for the truck's water system arriving in June. They were also busy purchasing lights and other emergency equipment, but have finally gotten all the necessary

SS Changes Death Clause

The Omnibus Reconciliation Act of 1981, signed into law on August 31, 1981, by President Reagan, contained a provision that affects payment of the lump sum death payment from Social Security.

Benefits will no longer be paid to funeral homes or to individuals who paid for the burial of the deceased wage earner effective for deaths occurring after August 31, 1981. The lump sum death payment will be paid to a surviving spouse living with the wage earner at the time of death, or if there is no such spouse, then it would be paid to a spouse eligible for benefits on the wage earner's record the month of his death. Divorced spouses are not eligible for the payment.

If there is no eligible husband or wife, then the payment would be made to children who are eligible for monthly benefits in the month of death. This provision has not changed the amount of the lump sum death payment.

Free Arbor Day Kits Available

To help teachers and organizations conduct more meaningful Arbor Day programs, the Texas Forest Service is offering free program kits.

Each kit includes a loblolly pine seed packet with planting instructions, program aids for a local Arbor Day observance, suggested classroom activities for teachers, and a copy of Governor Clements' proclamation.

Quantities are limited. Only one kit per teacher or organization will be distributed.

Arbor Day, to be observed January 15, 1982 in Texas, has been an annual celebration on the third Friday in January in Texas since 1889.

Program chairpersons and teachers should address requests for Arbor Day kits to the Texas Forest Service, College Station, Texas 77843. Distribution, on a first-come, first-serve basis, will begin in mid-November.

equipment together and were able to make two runs in the new truck this month.

The money for the purchase of the fire truck came from profits that the Lazbuddie firemen made from a pheasant hunt they sponsored in 1979 and 1980. The total cost of the truck and equipment ranged close to \$17,000, with \$8,000 borrowed to make up for what they did not make from their pheasant hunt.

It was also stated that the county did not make a contribution to the fire truck fund in Lazbuddie, but the volunteer fire department there does receive about \$3,500 yearly from the county to carry on regular fire department business.

The new equipment includes a 1981 GMC one-ton truck with a 454 engine, automatic transmission and dual tires on the rear. The equipment on the truck includes one 330 gallon water tank, with a Darley pump which will pump 50 gallons of water per minute with 250 pounds of water pressure per square inch.

Also included is a 20 horsepower Onan engine to operate the pump and two hose reels with 150 feet of one inch hose on each.

The fire fighting equipment was purchased from Fire Appliance Company of Texas, which is located in Wichita Falls and the truck was purchased from Robert Green GMC in Muleshoe.

The usual call a Lazbuddie fireman receives will involve runs mainly in a 15 mile radius of Lazbuddie, but the volunteers will go wherever their assistance is required. They have made runs to Earth, Dimmitt and Muleshoe in the course of a call, says Lust.

The firemen sponsor a pheasant hunt annually, in which area farmers in the past have donated up to 13,000 acres of their land for the volunteers to lease for their annual hunt.

The hunt is usually December 12-26 or whenever pheasant season comes and on the first day of the season, the firefighters sponsor a breakfast for all hunters. The breakfast is held in the Lazbuddie school cafeteria. Hunters can secure their permits from

a member of the department, at \$25.00 for the weekend or \$50.00 for the season.

Lust stressed the importance of the farmer's part in this venture, stating that without the farmer's land being donated to the firemen, the pheasant hunt would not be possible.

In the past season, Lust said they had approximately 350 hunters in the peak of the season and many of the hunters came from locations far from Lazbuddie to do their pheasant hunting. Lust said there were even some hunters from as far away as Mississippi and Alabama.

And, with the department still owing \$8,000, there will still be the need for the firemen to depend on the donations of land from the area farmers in order to meet their financial obligations on this new truck.

The truck has already been a help to the residents in and around Lazbuddie, as on September 2, and also on September 5, the volunteers were called out to two grain dryer fires, one at the Sherley-Anderson Elevator in Lazbuddie and then a second one at the Bill Hunt farm.

There are about 20 volunteer firemen working in Lazbuddie and the requirements for becoming a volunteer are to be between the ages of 18-65, express an interest in becoming a fire fighter, and attend the meetings, which are held every second and fourth Mondays of each month. Additional training is required, also.

Volunteers in the Lazbuddie department are Chief Glenn Lust, Assistant Chief Joe Bryan Jennings, Nicky Nichols, Gilbert Lueras, Oren McBroom, Jack Finley Smith, Robert Gallman, Jerry Don Glover, Claude Gregory, Jr., Ted, Brad and Stan Treider, Rick Copp, Harrol Redwine, Tim Smith, Tommy Hill, David Lasiter and Bob Davison.

Three of the firemen are Texas Certified Emergency Care Attendants, who were trained by members of the Bovina Ambulance Service and tested by the Amarillo area Department of Health.

One fire fighter, Gilbert Lueras, attended a fire fighter's school at Texas A&M this past summer. His expenses were partially paid for by the Texas Farm Bureau in Parmer County. The county will send one fire fighter each year from a different location in the county and so the cities of Bovina, Lazbuddie, Farwell and Friona rotate sending a fire fighter to school every year.

Members of the Lazbuddie FFA class is currently working on tool boxes for the new truck and they are donating their time and labor with the department paying for the materials.

While fires in the Lazbuddie area are not all that common, it is nice to know that if a fire should break out, there will be a volunteer fire service in the area on which residents can call.

Icy Roads Pose Driving Problem

"Driving on icy, snow covered, or wet roads takes skill and patience. Drivers need to adjust their driving habits to weather conditions and winterize their vehicles," said Major C.W. Bell, Regional Commander of the Texas Department of Public Safety.

Major Bell stated, "Many accidents and deaths are caused by driving too fast for existing conditions and losing control of the vehicle. Allow yourself more time to arrive at your destination since winter driving requires more following and stopping distance than normal driving. If a skid occurs, do not panic and hit your brakes, ease off the accelerator and turn into the skid. If the rear end skids right, turn wheels to the right; if the rear end skids left, turn the wheels to the left. Tap your brakes lightly, don't lock them."

Vehicles should be winterized by replacing worn windshield wiper blades, weak batteries, tires with thin threads, and repairing malfunctioning heaters and leaks in exhaust systems.

Major Bell emphasized getting in a hurry will not get you to your destination any faster, but slowing down and taking your time will get you there safely.

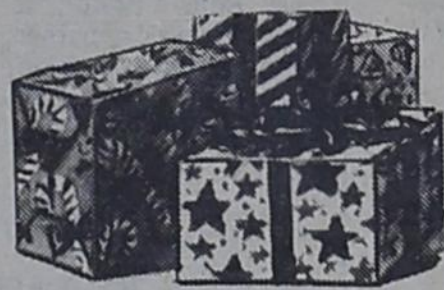

Parmer County Law Report

SHERIFF'S REPORT

In reports made to the Parmer County sheriff's office the following incidents were reported:

Jimmy Heard of Bovina had four tires punctured on a trailer November 11. The damage was estimated at about \$60 for repairs.

Mrs. Dollie Young of Friona reported that her home had been broken into. It was discovered November 12. Police officials are still investigating this incident.

On November 12, Farwell High School's ag shop, the junior high school principal's office, and the field house were broken into and about \$50 in cash was reported taken in the incident.

Tri-County Tire Company of Farwell was the scene of a weekend break-in. Four tires were taken in the

break-in, and a value of \$160 was placed on the tires.

Only one arrest was recorded as pled guilty in the sheriff's office the past week and that was on the arrest of Domingo Vasquez, 51, of Muleshoe, who was charged with DWI, and pled guilty. He was fined \$150, plus court costs and was sentenced to 20 days in jail, with six month deferred adjudication. His arrest was November 15.

DPS REPORT

One report was filed by the DPS the past week on DWLS charges.

Edward Bishop, 31, of Clovis, was charged with DWLS and was stopped in Bailey County for the violation November 12 by Trooper Steve Talkington.

FIRE AND EMERGENCY CALLS

We had no report of emergency calls for the ambulance service for the past week, and as far as we were informed there was only one fire call for the Bovina Fire Department. That was a call at 708 Avenue K, at the Ted King residence, where a yard and fence fire was reported by Mrs. King on Monday.

Last Friday, it was reported that T.C. Wiseman's pickup caught on fire, and the fire department was called to extinguish the fire.

New Law Requires Insurance Proof

Beginning January 1, 1982, Texas drivers contacted by Department of Public Safety officers during traffic stops and vehicle accident investigations will be required to furnish proof of compliance with the new compulsory liability insurance law.

Under House Bill 197, an amendment to the Safety Responsibility Act approved this year by the Texas Legislature, all drivers must carry minimum liability coverage for medical expenses of \$10,000 per person (\$20,000 for two or more persons) and property damages of \$5,000.

Colonel Jim Adams, DPS director, said troopers will accept as evidence of insurance coverage the policy for the vehicle being operated or a document issued by the insurance company.

"Such a document must contain a statement that the liability coverage for the motor vehicle is the minimum prescribed by the law," Adams said. "The document must also include the name of the insurance company, name of the insured person, policy period and policy number. This document may take the form of a letter or a card, depending upon the preference of the insuring company."

Adams pointed out that DPS troopers will be enforcing the provisions of this law along highways and rural roads.

"Local police officers and sheriff's deputies also have the authority to request this information from drivers," the DPS director said. "I am sure most law enforcement agencies in our state will also be enforcing this statute in their respective jurisdiction."

Drivers who do not maintain the specified coverage risk being fined at least \$75 for the first offense and a minimum of \$200 for subsequent violations. In addition, a conviction under this new law will result in the suspension of the violator's driver license and motor vehicle registration unless the violator establishes and maintains proof of financial responsibility for five years from the conviction date.

Adams also said vehicles which are to be used in the driving test by new

driver license applicants must be covered by the minimum liability insurance specified by the law. Applicants will have to certify on the license application that the minimum coverage is in effect for the vehicle before they will be permitted to take the driving test.

The DPS director predicted that more Texans will obtain the required liability coverage when the new law goes into effect.

"Current figures show that approximately 74 per cent of the drivers involved in accidents carry liability insurance," Adams said. "This indicates that a substantial number of people must secure the required coverage or face the possibility of heavy fines and loss of driving privileges."

Out-of-state, government-owned and self-insured vehicles are exempt from the insurance requirements of the new law. However, drivers of self-insured vehicles will be asked by DPS officers to produce evidence of self-insurance at accident scenes and traffic stops.

P. Johnson Re-Elected To SWCD Board

Phillip Johnson of Friona was recently re-elected to the Parmer County Soil and Water Conservation District board of directors October 6. Johnson represents Zone III of the district.

The purpose of the Parmer County S.W.C.D., with headquarters in Friona, is to promote sound soil and water conservation programs on farm and ranch lands within the district and to serve as a voice for farmers and ranchers on conservation matters and other issues affecting private property rights of landowners.

The board of directors coordinates the conservation efforts of various local, state and federal agencies and other organizations and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.

The agency notes the insulation retrofit market is booming. Consumers need to know about R-value to make an informed choice among all the products available.

"If you don't know the R-value of your insulation, you really don't know what you're buying," says the FTC. "Don't shop for inches...it's R-value that counts."
