Grand Opening for the Haskell County Experienced Citizens Center was attended by about 200 persons in Haskell Sunday, February 15. Judge John Wayne McDermett

presided over the day of activities.

The ceremonies opened with the invocation given by Jim Compton, Assistance Director of West Central Texas Council of Government and Program Developer of Haskell County ECC.

Judge McDermett introduced Bobbie T. Gallagher, Executive Director of the W.C.T.C.O.G. of Abilene as day speaker. Other special guests were: Commissioners Honorable C. E. "Chunky" Tidwell, Precinct 1 and Honorable C. A. "Bud" Turnbow, Precinct 4.

The high spot of the day was the ribbon cutting by ninety-one year old senior citizen, Mrs. Henry King. This officially opened the ECC of Haskell County.

Judge McDermett in his remarks about the history of the center told how in early 1977, the Center was formated from plans and dreams of the former Judge B. O. Roberson and the late Aubrey Headstream, then the Director of the now Headstream Memorial Center. Judge McDermett told how Aubrey Majorie Headstream and introduced Marsha Whittemore to Judge Roberson and to the program. Together with Chunky Tidwell and Jim Compton, program developer of W.C.T.C.O.G. of Abilene, a building was rented from Doyle High in Haskell and the Aging Program was began November 1977. Judge Roberson is credited with the naming of the Center. His belief is persons of this time in life are "Experienced."

Judge McDermett formated the Nutrition Meals Program which did not begin until February 26, 1980 With the help of Chunky Tidwell and his men the kitchen at the Fair Grounds was equipped that meals could be cooked there and brought to the old center to be served.

Plans for the new building were designed and drawn up by Marsha Whittemore in June. This was a joint project of the Haskell County

work and the foundation was poured on August 19, 1980. Don Bevins designed and welded the frame work.

With the work of all county men the building was erected and made ready for the finish work by October 24, The last paneling was hung by volunteers Slover Bledsoe, George Klose, Leon Parson. Work on the building by County men was done during the rains.

Chunky Tidwell, Cooter Boles, Author Patton and son volunteered their Saturday to lay vinyl in the kitchen and entry. Rev. Randy Hatfield of Rule with Boles laid the 210 yards of carpet in that following week. The deadline of November 1 had been met.

Moving day came with help of volunteers Karen Smith, Marie Bartley and Viola Tidwell with ECC staff Dorthy Stout and Eula Arend: Commissioner Tidwell and Commissioner Turnbow with their men.

November 10, 1980, eighty-three days from the pouring of the foundation, the first meal was served in the new building with much work yet to be done.

A total of 19 entrants caught 12 fish, with Claude Payne winning first place.


Payne caught a 5 pound, 11/2 ounce bass to defeat Randell Graham with 3-91/2 and Bill Letterman with 2-121/2.



ers who want a direct input into the 1981 Farm Bill will have their chance Saturday, February 21 when a Farmer's Town Hall Meeting will be held with Congressman Charles Stenholm (D), Stamford, the representative of the

17th Congressional District. The open meeting will be held from 11 a.m. until 3 p.m. at the Fine Arts Building of the Cisco Junior College in Cisco and will include a question and answer session with the congressman.

The Farmer's Town Hall Meeting is a result of a 14 county tour and grass roots meetings last month with farmers and ranchers sponsored by the Texas Farmers Union. Newly elected Texas Farmers Union President Mike Moeller said the culmination of the series of local meetings held the week of January 20th to 27th "will provide the opportunity to directly present to Congressman Stenholm the views of those people whose livelihoods depend on agriculture.'

Moeller urged those family farmers and ranchers who attended previous county meetings and those who were unable to make the previous sessions to attend the open meeting Saturday. "Instead of having the 1981 Farm Bill written by economists, staff members and lobbyists in Washington, we can have input into the process while the legislation is being formed," Moeller said. "This way, we can let our opinions be known before the law is adopted rather than having to wait and find out how it will affect family farmers and ranchers after the legislation is approved," the Texas Farmers Union President added.

The Farmer's Town Hall Meeting will begin at 11 a.m. with an open meeting to draft resolutions to present to Congressman Stenholm. A dutch treat lunch will be available from noon to 12:30 p.m. The Congressman will deliver a prepared talk at 12:30 p.m. immediately following will be a question and answer session beginning at 1 p.m. The meeting should be complete by 3 p.m.

Farm Leader To Speak Saturday

The National Chairman of the American Agriculture Movement will be in Littlefield Saturday night, February 21, to give a special address on the critical FmHA foreclosure situation and other farm problems.

Marvin Meek, a Plainview farmer, has just been re-elected to chair the very active farm group for the second year. Under Meek's guidance, the AAM has gained a prominent position in Washington politics, with a reputation for telling the farmer's side of the story in plain and outspoken terms.


Meek comes fresh from meetings with President Reagan and new Agriculture Secretary John Block. Meek earlier served on President Regan's Transition Team.

One of the American Agriculture Movement's pressing concerns is massive FmHA foreclosures on farmers.



Take a look at the size of your average American piggy bank to see how lean it has gotten lately; its ribs are showing for want of savings.

The Japanese, in contrast, have managed to fatten up theirs. Japanese citizens presently save 25.3 percent of their disposable income; Americans save a scant 4.1 percent, the lowest rate in 28 years.

And why should Americans bother to "set aside for a rainy day" when saving has become a losing proposition? For example, a savings account in the United States yields roughly 4-5 percent interest a year, yet it must keep pace with an inflation rate that was 13.3 percent last year. By the time federal taxes are tacked on to all this, savers are losing a lot of money.

Early last year, we took a major step to reverse this downhill trend when the Bentsen Small Savers Tax Exemption was signed into law. When you fill out your income tax return next year, it means you won't pay any income taxes on the first \$200 a year in savings account interest or dividends for 1981. That goes up to \$400 a year for a married couple filing a joint return.

This is a step in the right direction for a number of reasons.

Americans approaching retirement are keenly aware of the need to have their savings make money, not lose it.

Younger savers trying to put money aside for that first home would like to see their dream house come within closer reach. Increased savings would spur the flow of capital to savings and loan associations and provide a more stable source of funds for home building.

All Americans can identify with the need to hold down the cost of living. One of the most effective ways to do this is by boosting productivity, or output per man hour, which has shrunk recently. Increased savings and investment would make it possible to put the newest, most efficient tools in the hands of the American worker.

I want to take the fight to boost savings a step further.

Recently I introduced legislation that would expand the Bentsen Small Savers Provision. This bill would raise the amount of tax-free interest or dividends from \$200 to \$1,000 for a single person and from \$400 to \$2,000 for a married couple filing a joint return. I will work to have it swiftly passed to take effect this year.

My proposal would replace the "stick" of double taxation with the "carrot" or incentives for savings and investment. It is a non-inflationary tax cut that will encourage millions of small savers to invest in the future of America. It will permit millions of senior citizens living on fixed incomes to cope more efficiently in an era of double-digit inflation.

Suppose you earn between \$20,000 and \$25,000 a year. According to figures provided by the National Association of Realtors, the average American in that salary category manages to save enough to earn up to \$1,000 in interest income each year. If my bill passes, it means you won't pay any tax on that interest.

The federal government has been in the awkward position of rewarding waste and penalizing thrift. It's time government stopped assessing penalties against Americans who try to put a little something away for the future.

ICA Supports Tax Bill

Independent Cattlemen's credit against federal estate Association President Roy taxes for a certain amount of Wheeler of Pleasanton has praised legislation that, if passed, would effectively abolish the state inheritance tax. Wheeler said the bill, H.B. 325, was pre-filed by Texas State Rep. Gerald Geistweidt of Mason.

'We feel Rep. Geistweidt's bill is one of the most important pieces of legislation to be considered during the session," said Wheeler. "We hope that all legislators will recognize the importance in this state.'

According to Geistweidt, the bill would enable administrators of estates to use the

state inheritance tax actually paid the state. Under H.B. 325, the State of Texas would receive the amount of the federal credit which would otherwise go to the federal government. For instance, in a hypothetical case, if the federal

government assessed \$25,000 worth of taxes on an estate, and the state assessed \$6,000, the heirs might be allowed to subtract part of that \$6,000 from the \$25,000 before of its passage to land owners paying their federal tax. The state's inheritance tax bill still would be \$6,000.

If the federal government allowed a credit of \$3,000 out federal tax form in computing of the \$6,000 state tax bill, the the amount of state tax. taxpayer under current law Federal law now provides for a would end up paying \$22,000

to the federal government and \$6,000 to the state, for a total cases of \$28.000.


Under Geistweidt's proposal, the state taxes would be \$3,000 to match the federal credit. The federal taxes would remain \$22,000 for a total payment of \$25,000. (Geistweidt's legislation would reduce the state inheritance tax so that it never exceeded the amount allowed as federal credit).
