Absentee Voting Starts Monday In Local Elections

Absentee voting will start Monday in the elections which will be held on Saturday, April 2. Texas election laws provide that persons who are eligible to vote absentee are allowed to do so during a period from 20 days to five days before the regular election date.

Persons eligible to vote absentee are those who expect to be absent from the area on the day of the election or who will not be able to go to the polls for physical reasons or religious beliefs.

Persons in the above categories who are able to go to the office of the absentee voting clerk during the 15 day absentee voting period must cast their ballots in person at the place of absentee voting. Persons who are unable to get to the office of the absentee clerk during the absentee voting period may request a ballot by mail and return it by mail.



THE STATE OF TEXAS COUNTY OF COKE On this the 10th day of February, 1977, the Board of Trustees of Robert Lee Independent School District convened in special session, open to the public, with the following members present, to-wit: cincts numbered One at J. C. Wallace, Jr., President, Joe B. Flowers, John E. Stephens, Wilbern Millican, Joe R. Ash, Ben W. Bessent, Philip C. Ray and the following absent: None, constituting a quorum and among other proceedings had by said Board of Trustees was the following:

WHEREAS, the term of office of Wilbern Millican and J. C. Wallace, Jr. members of the Board of Trustees of this School District will expire on the first Saturday in April, 1977, said first Saturday being April 2, 1977, and on said date a trustee election will be held in said School District.

WHEREAS, it is necessary for this Board to pass an order establishing the procedure for filing for and conducting said trustee election;

THEREFORE, BE IT OR-DERED BY THE BOARD OF TRUSTEES OF Robert Lee INDEPENDENT SCHOOL DIS-TRICT:

1. That an election be held in said School District on April 2, 1977, for the purpose of electing to the Board of Trustees of said School District "Two Trustees".

2. That all requests by candidates to have their names placed upon the ballot for the above mentioned election shall be in writing and signed by the candidate and filed with the secretary of the Board of Trustees at the superintendent's office not later than 30 days prior to the date of said election.

All candidates shall file with said application the loyalty affidavit required by Art. 6.02 of the Election Code.

The Secretary of this Board of Trustees shall post on the bulletin board in the building where the Board of Trustees meets the names of all candidates that have filed their applications in accordance with the terms and provisions of this Order, and said Secre-

tary shall otherwise comply with the terms and provisions of Art. 13.32 of the Election Code.

3. That said election shall be held at the following places, and the following named persons are hereby appointed officers for said election:

(a) In election pre-School Building, in Robert Lee, Texas, in said School District, with Mrs. Bobby Roberts as Presiding Judge and Mrs. Freeman Clark, Mrs. Teddy Pitcock, Mrs. C. G. Walker, Clerks.

The polls at the above designated polling place shall on election day be open from 7 o'clock a.m. to 7 o'clock p.m.

4. Mrs. Reba Roberts is hereby appointed Clerk for absentee voting. The absentee voting for the above designated election shall be held at School Tax Office, 713 Austin, Robert Lee, Texas within the boundaries of the above named School District and said place of absentee voting shall remain open for at least eight hours on each day for absentee voting which is not a Saturday, a Sunday, or an official State holiday, beginning on the 20th day and concontinuing through the 4th day preceding the date of said election. Said place of voting shall remain open between the hours of 8 a.m. and 5 p.m. on each day for said absentee voting. The above described place for absentee voting is also the absentee Clerk's mailing address to which ballot applications and ballots voted by mail shall be

Absentee voting, both by personal appearance and by mail, shall be by paper ballots and shall be canvassed by Mrs. Bobby Roberts, as Presiding Judge, Mrs. Freeman Clark, Mrs. Teddy Pitcock and Mrs. C. G. Walker, as Clerks, are hereby appointed the Canvassing Board for said election.

5. The manner of holding said election shall be governed, as nearly as may be, by the Election Code of this state, and this Board of Trustees will furnish all necessary ballots and other election supplies requisite to said election.

6. Immediately after

the votes have been counted, the officers holding said election shall make and deliver the returns of said election and perform all other duties as provided by the Election Code.

7. The Board of Trustees shall give notice of said election, and this combined Election Order and Notice shall serve as Notice for said election. The President of the Board of Trustees is hereby authorized and instructed to post or cause to have posted said combined Election Order and Notice at three public places where notices are customarily posted in this school district, and said posting shall be made at least 20 days before the date of said election.

The President shall also cause a copy of this combined Election Order and Notice to be published one time in a newspaper of general circulation in the county where this school district is located. Said publication shall be not more than 30 days nor less than 10 days before the date of said election. It is further found and determined that in accordance with an order of the Board of Trustees, the Secretary furnished a notice. of the date, place and subject of this meeting to the county clerk of Coke County, Texas, the county in which most, if not all, of this school district's pupils reside.




