Most Congresmen Are Honest

Much of Washington has been preoccupied in recent weeks with speculation surrounding the extent of involvement by congressmen in illegal influence-buying by Korean businessman Tongsun Park.

One newspaper story reported that more than 100 congressmen and former congressmen were involved with Park, and a TV network said powerful leaders of Congress were also involved. The rumor mill that is always busy in the nation's capitol has kept other reports just as stunning in circulation.

In retrospect, it appears that the newspaper story implying significant involvement by large numbers of congressmen was probably based only on a list naming congressmen who, at one time or another, had either met or had received campaign contributions,

major campaign issue.

I've no way of knowing the true extent of wrongdoing, but it seems we have fallen into a relatively dangerous pattern of charges of wrongdoing receiving substantial amounts of publicity and then having the seriousness of the charges diminished upon closer scrutiny.

What we have been left with is perhaps the public view that members of Congress are less than cautious when it comes to their associations on Capitol Hill. I cannot speak. of course, of practices before I came here three years ago, but my experience has been that most congressmen I have come to know and respect are extremely conscientious regarding even their friendships. Their friendships, their supporters, their


Their friendships, their supporters, their contributors, all undergo a scrutiny that, in some cases, even seems unfair to the innocent, but at the same time essential if one is not only to avoid wrongdoing, but to also avoid the appearance of wrongdoing. Like other members of

congress, I was recently asked to complete a questionnaire prepared by the House Committee on Standards of Official Conduct. I was asked three basic questions: had I ever visited the Republic of Korea as a congressman, had I or a member of my staff ever received anything of significant value from anyone affiliated with the Pepulic of Korea and had I or my staff ever received anything from five specific persons suspected of influencepeddling. My answer was "no" to all three questions. Most of my colleagues were able to answer in the same manner.

And most members of the House are anxious to investigate fully allegations that have been made and if that investigation proves wrongdoing by some, I am confident that this body will respond quickly to any improper activity that is proven.

This is not to say that there may not be members of Congress who have participated in wrongdoing, but, with the bulk of publicity riding on negative speculation, I felt it appropriate to tell you of my position on the Korean investigation and to submit to you that it is my contention that most of the men and women with whom I serve are honest people. I hope we do not fall prey to the guilt-by-association theory that would unfairly cast dispersions on a body that, for the most part, is one of immense integrity and commitment.







Reverse migration studies under way

AUSTIN, Texas (Spl.) -Two University of Texas marketing scholars have begun a research project to try to pinpoint what causes persons to move back to small towns from large cities.

To determine the influences that contribute to "reverse migration," Drs. W. Thomas Anderson and Linda Golden will survey the life styles over time plus the buying habits and attitudes toward traditional American values of about 4,500 persons who live along an urban-rural continuum radiating from a large metropolitan city to smaller

They also will examine how the public and private sectors can adapt to provide services and goods to the small-town "migrants."

Notes From The Oil Field

Corpening Enterprises, Fort Worth, will drill two confirmations to the three-well Meadow Creek (Canyon oil) field of Coke County, nine miles north-west of Robert Lee. Both projects are

contracted to 5,200 feet.

The No. 2 I. A. Bird "B", ½ mile southwest is 660 feet from the north and 700 feet from the west lines of 467-1A-H&TC.

The No 1 I.A. Bird "A" 2,150 feet north, is 660 feet from the south and 660 feet from the east lines of the northeast quarters of 320-1a-H&TC.

Fisher-Webb, Inc., Abilene, will drill the No.1 Cargile, a 6,900-foot wildcat, 12 miles northwest of Robert Lee, 3/8 mile northwest of the depleted San Benito field and 1 5/8 miles northeast of the three-well Meadow Creek (Canyon oil) field and 12 miles northwest of Robert Lee.

Location is 1,980 feet from the north and east lines of 308-1A-HI&TC.

The San Benito field, opened in July 1948, produced at 6,495 feet.

The Jameson, North (Strawn oil and gas) field gained its current second Strawn gas producer and a 24 mile southwest extension and into Coke County will recompletion of Sun Oil Co. No. 1 Tubb-Omega, former producer in the Jameson Reef Unit, four miles southwest of Silver, for a calculated, absolute open flow of 176,000 cubic feet of gas daily, with gasliquid ratio of 20,000-1. Gravity of the condensate was 59.1 degrees.

Production was through perforations at 5,793-836 feet, which had been acidized with 500 gallons.

Location is 660 feet from the south and east lines of A.E. Wiley No. 2.

The field currently has one producer in Nolan County and formerly had one producer in Mitchell.

Red Cross Asks Assistance for Flood Victims

Red Cross reports from eight Johnstown, Pa., area counties ravaged by flooding last week reveal 6,304 homes destroyed or with major or minor damage. In addition, 200 mobile homes were destroyed or suffered major damage, along with 491 small businesses. Red Cross estimates it will spend in excess of \$2 million before this relief operation is complete.

As of this past weekend, 1,200 disaster victims were still being housed in nine Red Cross shelters, and some 3,000 disaster victims and emergency workers are being fed daily. Volunteer physicians have assisted over 120 Red Cross nurses at the shelters. Over 400 Red Cross volunteers and staff are involved in the relief operation. More rains have hit since the flash flood keeping water and mud in the homes and hampering disaster relief operations for the victims. The Red Cross Chapter itself in Johnstown suffered the loss of two disaster vehicles but the inventory of human blood in the

Red Cross blood bank was saved. Red Cross mobile feeding, first aid and communications equipment have been sent in from other Red Cross chapters in the area.

Death, injuries and loss of property, (to some all lost), has struck this community hard. Cash contributions are urgently needed to aid in the operations and help these families back to a normal way of life. Take a milk break today and every day. Get the habit. Toast your own health, daily, with a protein-powered drink that will lift sagging spirits, add a blush of good health to your cheeks, and tease jaded appetites. Milk is in plentiful supply right now. According to the U.S. Department of Agriculture, milk and dairy products have climbed to new highs for the year. Seasonal production is up and supplies are spilling over.

If you haven't learned to enjoy milk for its good taste and valuable nutrients, get acquainted. Try some of these new ways with milk drinks. They make a big hit with youngsters, but they're not exclusively for kids. They're good for any age group, anytime. Protein-Power Sipper:

Beat 2 cup creamy peanut butter and 1/3 cup honey in mixing bowl or blender. Add one quart milk gradually. Chill. Stir before serving. Yield; approximately 5 cups.

Milk Julep: Mix 4 ta-

blespoons mint jelly with 1/4 cup milk in mixer or blender. Gradually add 1-3/4 cups milk and 1-2 drops green food coloring. To serve, pour 1 cup mint mixture in each glass, add 1/2 of a 7 ounce bottle of giner ale, mixing well, Top with scoop of chocolate ice cream. Yield; two 12 ounce servings. Orange Energizer: Combine 2 eggs, 1/4 cup frozen concentrated orange juice and 1 tablespoon sugar in mixing bowl or blender. Gradually add 1-1/4 cups milk. Yield;

2 cups. Lush Lime Cooler: Beat 1/2 pint (1 cup) lime sherbet in blender or mixing bowl. Add 1 can (6 oz.) frozen concentrate for limeade. Add 3 cups milk. Pour into glasses. Top each with scoop of lime sherbet, garnishing with fresh mint or cherry. Yield; approximately 5 cups. Chocolate Orange Blos-

som: Blend 2 cups chocolate milk with 1 tablespoon frozen concentrated orange juice. Yield; 2 cups.

Vanilla Ice Milk: is another delectable summer treat suggested by USDA. It is made

with skim milk instead of cream and provides only about half the calories of ordinary ice cream. To make 26 servings of 1/2 cup each, you will need:

2 cups sugar 1/4 cups Cornstarch 1/4 teaspoon salt 8 cups (2 quarts) skim

milk 3 eggs beaten 1 tablespoon Unflavored

gelatin 1-1/2 tablespoons Va-

nilla Mix sugar, cornstarch,

and salt in the top of a double boiler. Blend! in 4 cups skim milk gradually. Cook over hot water, stirring occasionally until thickened, 12 to 15 minutes.

Stir a little of the hot cornstarch mixture into the beaten eggs; then stir the eggs into the remaining cornstarch mixture. Cook over hot water, stirring constantly 4 to 5 mintues longer, or until the mixture is about the consistency of soft custard. Soften gelatin in 1 cup skim milk. Stir

into hot mixture. Chil thoroughly. This step is essential for a smooth ice milk. Stir in vanilla and

remaining 3 cups skim milk. Pour into a 1-gallon ice cream freezer canister; fill

not more than 2/3 full. Freeze in a handcranked or electric ice cream freezer, packed with a mixture of 1 part ice cream salt to 6 parts crushed

Remove dasher. Repack ice cream freezer with a mixture of 1 part salt and 8 parts ice. Allow to ripen about 2 hours before serving. Or, pack ice cream in freezer containers and harden in a home freezer. Variation: Fruit ice




