Gary Shaffer Buys Funeral Homes from George Newby

After several weeks of negotiations, the sale of Newby Funeral Homes in Robert Lee and Bronte has been announced. George Newby has sold the two establishments to Gary Shaffer, formerly of Midland. Shaffer took over the business Thursday, Aug. 11.

Shaffer said Monday that he does not plan any radical changes in the operation of the funeral homes. He plans to continue to operate the homes in Bronte and Robert Lee and to continue to operate the ambulance service.

"It is our plan," he said, "to continue to give the same kind of efficient and sympathetic service that Mr. Newby has provided for so many years."

Shaffer and his wife both grew up in Big Spring, graduated from Big Spring High School and attended Howard

"We feel that we have rendered a vital service to the people of Coke County and the area," he said, "but mainly due to reasons of health I think it is time to let a younger man take over the business."

Both Shaffer and Newby are running ads in this week's Observer and Enterprise, with Shaffer announcing his purchase and Newby thanking everyone for their past patronage.

JOBS FOR TEXANS

The nation owes much of its warmth in winter months to Texas, and to the Texans who work hard tapping one of our greatest natural resources--natural gas.

NOTICE OF HEARING FOR REVENUE SHARING FUNDS

Notice of Proposed Use Budget for Revenue Sharing Funds Hearing is set for 10 a.m. in the Commissioners Court Room, Courthouse at Robert Lee, Texas, on August 29, 1977.

But Texans have very little hope left of fighting off what amounts to an attack on our resources. The House of Representatives has passed President Carter's energy bill with much of the original proposal intact. The provision in the bill which concerns me most today is the "fine print"--which gives the President power to allocate natural gas in times

of shortage. The President has insisted all along that he intends never to use that power. He has insisted, however, that it be there for him to use.

With that power to allocate Texas' cleanest, cheapest, most plentiful fuel, comes the power to export jobs out of our state. I am spending the month of August traveling throughout the state, explaining to both labor and management what their stake is in this new legislation. Everywhere I go, workers are startled, and dismayed to learn how the federal government can, and very likely will, affect their livelihood.

It is horrible, on the fact of it, but true, that someone up in Washington will have the power to turn off the gas to Texas industry when there are shortages of supply. That means that the federal government will have the power to say it is more important for a steel mill in Pennsylvania to stay open than for one in Texas to remain open. The legislation gives the federal government power, then, to allocate our energy, our jobs and our wealth to other states--all for no more terrible a crime than that Texas produces and uses more gas than any other state.

The House did vote against a proposal for a direct gasoline tax increase designed to

curb consumption. But by voting for a so-called wellhead equalization oil tax, the House has ensured that drivers everywhere will be paying up to seven cents more for a gallon of gas in the near future.

Texans are an independent breed, not given to whining when things seem to be going wrong. But we have been known to stand up for our rights in the face of injustice. It will take much of that independent spirit and determination, to get us through the long, cold winter ahead.

Before buying a used car, (1) check the odometer; (2) read any notice attached to the left door panel; (3) require in writing the actual odometer and reading and a statement verifying accuracy; (4) learn date of ownership transfer; (5) car identification number; (6) the seller's acknowledgement that he understands the law and his own liability for falsifying any information.

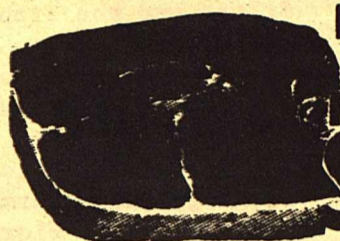

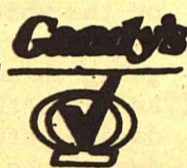

They left Nashville and headed back to West Texas, the longest leg of their trip. They said, "It rained every day we were gone till we hit Texas."

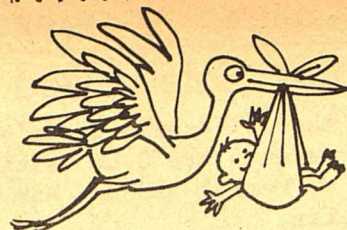
OWNERS TO REBUILD FISHING RESORT

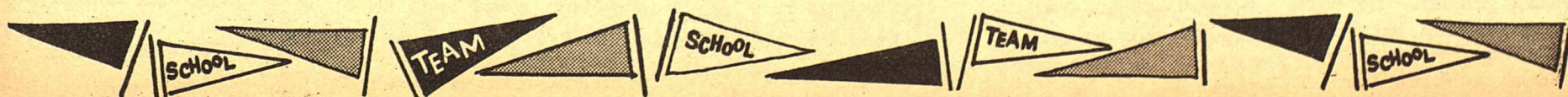

Absolute, open flow was 176,000 cubic feet of gas daily. It had a gas-liquid, hydrocarbon ratio of 20,000-1 of 59.1 gravity.

Production is from perforations at 5,793 to 5,836 feet, treated with 500 gallons of acid.

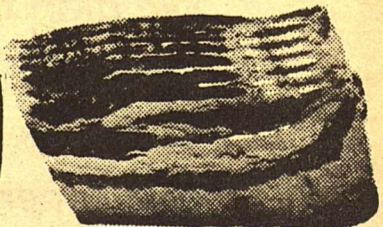
