

Held Building Thursday

Vote on

Qualified voters who reside in the West Coke County Hospital District were scheduled to go to the polls yesterday (Thursday) to decide the issue of building a new clinic building to be operated in conjunction with the district's hospital and nursing home. The proposition called on voters to decide if. the district should issue \$155,000 in bonds to finance the construction of the clinic. The proposed building will contain offices

for a doctor and dentist and space for a drug store. Dimensions of the structure will be 60 by 108 feet. If the building is approved by voters, the space will be rented and revenue will partially retire the bonds. Present revenue sources are expected to be sufficient any difference between the bond payments and rent revenue. 

Krueger Opposes Panama Treaty

U.S. Cong. Bob Krueger of Texas today announced his formal opposition to ratification of the Panama Canal Treaty recently agreed to by the Carter administration.

Voicing a position independent of that taken by many public figures, Krueger indicated he would consider support of the treaty should certain provisions be altered, provisions which,

Krueger says, "are not in the best interests of the U.S. and of U. S. citizens living in the Canal Zone.

"I cannot, in clear conscience, support an agreement that relinquishes military sovereignty of the canal," Krueger said in a statement released by

Election Called On Courthouse Annex Question

Oct. 7, 1977

Coke County Commissioners Court has called an election to determine the will of voters on the matter of building Courthouse annex on the county square in Robert Lee. Balloting has been set for Nov. 8, and the election will be held in conjunction with the constitutional amendment election set for that day

The election was called after petitions were presented calling for a referendum to determine if Coke County citizens favor construction of the building. The commissioners previously had announced their intention of building the structure and paying for it with revenue sharing funds and issuing time warrants.

The commissioners earlier had okayed the structure to provide space for federal offices now housed in the courthouse, in order to alleviate crowded conditions in the main building. It was also decided to add some space onto the annex to provide a home for the Coke County Library. County Judge W.W. Thetford said the Commissioners Court determined that rent payments for the federal offices will make payments on the time warrants proposed. "The county has always provided offices for the ASCS and SCS free of charge, but an agreement already has been reached for them to pay for space used in the new building," the judge said. Also to be housed in the annex will be offices of the two county Extension Agents.

The Bryans drove north from Coke County through Oklahoma, Kansas, and Nebraska (the Corn Belt), turning east through Michigan into Ontario, Canada.



Frank is the son of Mr. and Mrs. Terry Bryan who moved from Robert Lee a few months ago. He is the grandson of




