She had been a member of Robert Lee Baptist Church over 50 years and was active in all of the church functions. She was a 50-year member of Order of Eastern Star Chapter 187 and had served as Grand Esther and Grand Ada of OES of Texas and served twice as Deputy of District 5, Section 1. She was a housewife.

County Stock Show to Be Here Monday

The 1978 Coke County Livestock Show will be held at the County Recreation and Show Center in Robert Lee on Monday, Jan. 9. A total of 79 FFA and 4-H Club members will be exhibiting 250 animals in the show in competition for ribbons, trophies and a place in the premium sale.

Judges for the 1978 show will be Fred Igo, vocational agriculture teacher at Eldorado and Frank Hermesmeyer, vocational agriculture

teacher at Wall. Igo will judge sheep and cattle; Hermesmeyer will judge the swine classes.

The 1978 show will contain approximately 125 swine, 110 sheep and 15 head of cattle. A total of 40 club members will exhibit swine, 38 will show sheep and 11 will have cattle exhibits for a total of 79 different club members.

The public is encouraged to attend the show and see the animals exhibited. Following the show a sale will be held in which each exhibitor of a market animal will be allowed to sell one animal.

The show will be under the direction of the County Livestock Show Association board of directors. President of the association and general superintendent of the show is D.J. Walker Jr.; Jerry Gibbs, Robert Lee High School Principal, will serve as records clerk. Edward Cumbie, Farm Bureau field representative, of Bronte, will serve as auctioneer for the premium sale. City Sales Tax Figures Revealed

Coke County's two incorporated towns collected almost \$25,000 in city sales tax up to Dec. 1, 1977, according to a report released recently by the office of Comptroller Bob Bullock.

Robert Lee's total to December amounted to \$14,350.05, while Bronte received \$10,-580.32 for a total of \$24,930.37. Robert Lee's sales tax check was up same period of 1976, and Bronte showed an increase of 10 per cent.

In the same news release, Bullock sent out figures on the total sales for the second quarter (April, May and June) of last year. Gross sales in Coke County for the three months amounted to \$5,725,525. Harris County (Houston) led the state with sales amounting to \$10.5 billion. Total for the entire state during the second quarter was \$40.3 billion.



MILLICAN FINISHES POOL CO. SCHOOL

Bobby Millican of Robert Lee graduated from the Pool Company crew chief school Thursday, Dec. 22. He works out of the Laredo office and is responsible for the four-man crew which operates Rig 118, a 400 hp servicing rig.



License plate renewal notices for almost 11 million motor vehicles are in U.S. post offices throughout Texas for delivery to owners. R.W. Townsley, director of the Motor Vehicle Division, State Department of Highways and Public Transportation, said the renewal notices were stuffed into envelopes, presorted by zip code, boxed and delivered to post offices to expedite delivery. Work to get the renewal notices ready for delivery started in early October.

"The plate renewals for passenger cars and light trucks (such as pickups) will be different from last year. A new law requires that renewal dates be spread as equally as possible over 12 months, rather than have all expire at one time (April 1) each year," Townsley said.

Since the Motor Vehicle Division does not maintain records by owner's name or birth date, the license Colorado City were New number of the vehicle has been used to determine the month of registration renewal in the future.

Renewal notices have been issued to reflect the number of months and the prorated fee to be paid to register each vehicle under the new system.


