**U. S. Representative Bob Krueger Cut Taxes** 

and Spending

WASHINGTON -- As we all know, President Carter has proposed a major tax cut.

I agree with the need for it, but feel it should be coupled with a limit on government spending in order to stimulate growth in the private sector

I will introduce legislation during this spring's congressional budget discussions to achieve that end. I will propose an amendment to the First Budget Resolution which will limit increases in the federal budget for fiscal year 1979 to those required by inflation or brought about by national emergency.

If our government follows this policy this year, and continues it for several more, we will find that net increases in our gross national product go to the people, not to the government.

Establishing that new trend would, in my judgment, be strongly supported by the American people and is achievable without any direct cuts in overall government

And, coupled with a realistic, across-the-board tax cut for businesses and individuals, it would place an increasing share of disposable income in private hands.

We must encourage growth in the private sector. During the past seven years, an ever-larger share of spending has come not from the individual decisions made by private citizens, but by government—federal, state and local.

In fact, the direct share of government spending has risen so that now one in three dollars is directly spent by the government.

Statistics compiled on the economic problems of the northeastern portion of the United States substantiate the theory that an imbalance between spending in the public and private sectors triggers negative economic impact. During the years 1966-69, employment in the private sector in 30 northeastern cities rose 5.9 per cent while government employment rose only 1.8 per cent.

The trend changed during 1972-75, however, years of economic regression in these cities, and government employment began outdistancing employment in the private sector.

There are indications the same situation could develop in Texas.

Private sector employment in six Texas cities (San Antonio, Dallas, Fort Worth, Austin, El Paso and Beaumont) grew more than 12 per cent in 1966-69 while government employment grew at 3.4 per cent.

But from 1973-75, the balance between public and private sector employment began to close, with employment in the private sector increasing only slightly more than government employment.

My travels around Texas make two things clear: (1) People want to decide for themselves how to spend their money; they prefer not to delegate those decisions to government; and (2) they do not want to see federal budgets and deficits continue to increase.

One important stimulus for investment is business confidence. Establishing the principle that future real growth in the economy would go to private individuals rather than government programs would help to create that necessary confidence for such investment.

Investment, after all, only reflects our confidence in our future. And America urgently needs that confidence

A package that limits growth in government spending to inflationary increases, and that guarantees Americans that as they work more, they will be able to enjoy more, would further that end.

President Kennedy, in introducing his tax cut years ago, said that nothing is more fundamental in the United States than the principle that if one works hard, he should enjoy the fruits of his labor. That statement holds true today as well.

Coke-Sterling Farm Bureau is joining with other groups in Texas this month in a membership drive. Members have been working at signing up other persons as members of the organization.

According to Mrs. C. E. Arrott, secretarytreasurer, the Coke-Sterling FB had 508 members at the end of October 1977. She said the number has increased since that time and she expects it to increase some more during the present drive.

It was pointed out that farmers and ranchers cannot individually work with legislative and other governmental groups, but that Farm Bureau can represent them as a group with a powerful voice.



Following the business meeting, Mrs. Fred Beaty presented a book review of "Nineteen Steps to Heaven" by Joseph Blank.



It was reported that the water group is making some progress in its program of providing water to rural areas of the county. Presently members are working on Phase I of the program which is designed to provide water for an area west of Robert Lee. The line will follow Highway 158 to a site below the divide near the Sterling County line.

The group is now in the process of obtaining easements for the line.

Other phases of the water program will be studied and decided upon at a later date. Decisions as to where lines will be placed will depend to a great extent on the number of applications received from various areas.

#### City Sales Tax **Checks Arrive**

State Comptroller Bob Bullock said Wednesday that his office has mailed checks totaling \$13.7 million to Texas cities and towns as their February rebate of the one-cent city sales tax.

Bullock said 1978 city sales tax rebates to date total \$32.2 million, compared to \$30.4 million during the first two months of last year.

The biggest February check--for \$2.8 million --went to Houston. Dallas followed with \$1.4 million, San Antonio with \$795,972.

Bronte's rebate check was for \$969.00, while Robert Lee drew a return of \$1,027.68.

## **Time Approaches**

Texas motorists were advised today that the deadline for renewing 1977 motor vehicle registrations by mail is March 1.

R.W. Townsley, Director of the Motor Vehicle Division of the State Department of Highways and Public Transportation, pointed out that it is taking longer to register vehicles this year because of the new staggered registration system.

As a partial offset of slow moving registration lines, county tax offices began accepting registration applications January 1 this year instead of February 1, as in previous years. Many motorists have taken advantage of the earlier registration date to avoid waiting lines.

Renewal by mail offers a very convenient method of obtaining registrations without waiting lines or personal visits to the tax offices. Mail applications must include \$1 for each registration to cover handling and postage.

Some metropolitan counties are offering BankAmericard/Visa Card and Master Charge service for registration payments. Others have a "no check" policy which requires taking cash to the tax offices, although most accept checks for mail-order registrations.

Neighborhood substation service also is available in some metropolitan areas.

Although deadline for mail registration is March 1, final date for affixing new validation stickers to existing plates is April 1 this year, as usual.

Farmers who did not file a declaration of estimated Federal individual income tax and pay the amount of estimated tax by January 16 must file their 1977 tax return and pay all tax due by March 1 to avoid a penalty, accord- In the absence of the ing to the IRS.

By definition, farmers are those persons who earned at least twothirds of their 1977 gross income from farming.


