Probably the most interesting election in Coke County will be in the race for county judge. Present Judge W. W. Thetford, who has held the position since 1959, is being challenged by D.W. (Dub) Sims of Bronte, who is employed at West Coke County Hospital in Robert Lee.

Judge Thetford is basing his campaign on the premise that the experience and knowledge gained in nearly 20 years of presiding over the office and the commissioners court make him qualified to serve the county for another four years.

Sims, on the other hand, is campaigning on the premise that Coke County government needs a change with some new blood and a head of the county government who has some fresh ideas for promoting a regulated growth while maintaining qualities of the "good old days." Both men offer impres-

sive educational qualifications which should enable them to carry out the duties of the office.

Judge Thetford holds a bachelor and master's degree from Texas Tech and was a school teacher for some nine years his present office.

Sims, who is a specialist in the medical technology field, holds a bachelor's degree from Angelo State University and is completing work on his master's degree which will make him a registered medical technologist in biology and chemistry.

Only one other race is contested in Coke County. Present Commissioner Jerry Parker has been challenged by N.P. (Dick) Cooper for that position.

#### **County Receives** Rain Tuesday

Briscoe is being strongly challenged by Attorney General John Hill, who claims that Briscoe has basked far too long in a do-nothing administration and it is time for a change. Hill points out that if Briscoe is reelected he will have had control of the governor's office for 10 years, a new record. Other candidates for governor are former Gov. Preston Smith, Ray Allen Mayo and Donald R. Beagle. Some polls recognize that Smith could play the part of spoiler and force the two top candidates into a runoff,

U.S. SENATE Voters of Coke County and the rest of the 21st Congressional District have an extraordinary interest in the Democratic race for U.S. Senate nominee since the district's own present representative is seeking the nomination. Bob Krueger apparently will have no difficulty in carrying Coke County and the entire sprawling 21st Dis-

## Voters to Express Opinion on Propositions

Election of officials to various positions all the way from local level to house and senate of the United States is not the only questions to be voted on in Saturday's primary elections.

Both Democratic and Republican ballots have propositions on which voters may express their opinions. Two propositions appear on the Democratic ballot and three on the Republican ballot.

The proposition which has generated the most

interest appears on both the ballots. It asks voters to express their opinions as to whether or not horse racing and pari-mutuel betting should be allowed on a local option basis.

Horse breeders across the state have come out strongly in favor of the idea of making horse racing and betting on the outcomes legal in Texas on a local option basis. It would require an act of the legislature which would allow counties to vote on the matter.

Democrats also have a chance to express their opinions on increasing the interest rates loan companies are allowed to charge.

In addition, the Republican has two more referendum questions: asking the legislature to pass a law for delegates to a national political convention be elected in party primaries and placing a limit on the amount of taxes which can be levied by state and local governments.


#### May 8 Mental Health Day at RL

#### Coke Party Heads Urge Big Vote

Coke County chairmen of the Democratic and Republican parties agreed on one thing this week--they both want every qualified voter in Coke County to get out Saturday and vote. Mrs. Cumbie Ivey Jr., county Democratic chairman, said Wednesday that everyone has a deep obligation to cast his ballot on every one of the candidates and propositions listed on the ballot.

Mrs. Ivey said, "All the politicians listed on the ballot are part saint and part sinner, even as you and I. Since all the offices belong to the people, due to our form of government, it is the Christian responsibility of every voter to select a good steward to fill each office listed on the ballot"

Mrs. Ivey reflected the general opinion of Coke County voters when she said, "It is impossible for us to know

each of the candidates personally, but we can make a pretty good judgment if we will study the track record of each of those who are running".

Lynn Phillips, county Republican chairman, also wants every member of his party to get out and vote. Phillips also is making a bid for votes of independents to vote in the Republican Primary. He emphasized that many persons who don't have strong party ties may find Republican platforms and policies more to their liking than those offered by the Democrats. He invited everyone whose political philosophy does not go along with Democratic policy to vote in the Republican Primary.

Both county chairmen pointed out that voters may not participate in both elections. A voter may not cast his ballot for part of the Democratic candidates and







#### THE RIGHT TO VOTE

WASHINGTON-The statistic which disturbs me most each election year is that in this nation where Democracy is our most valued commodity, less than 50 per cent of our population chooses to exercise the right which protects democratic concepts.

That right, of course, is the right to vote.

To me, voting has always been more than a right; it is an obligation, although it is an obligation taken lightly until it is threatened.

Because we have, in essence, been a nation that has not had to defend our own borders in recent history, because we are a nation that has not had to live under dictatorship, because we are a nation privileged to practice the basic liberties that go hand in hand with human rights, the sacred privilege of the ballot box has perhaps become a privilege we mistakenly accept as "given."

Like all Americans, I am grateful that I have that assumption with which to live.

But, unlike many Americans, what I have seen across the state of Texas and across the nation during my years in public life leaves me with a sense of sadness when I know that one of every two people I meet, regardless of what they profess, will not journey to the polls on elec-

It can be said, of course, that when I urge people to vote that I am speaking from the point of view of a very special interest since I, every two years, have been asking the people who do go to the polls to cast their vote

Perhaps it is that pointed response which prevents many political people from expressing their disappointment in their constituents who choose not to exercise their voting right.

But it is not necessarily the apathy toward the ballot box that leaves me disturbed. It is a deeper apathy about the course of government, self-government in a democracy, that penetrates my spirit as I watch election returns

The complexities of modern day life, no doubt, make it easier to put aside all obligations except those necessary to survival or happiness and I will be the first to admit that voter registration laws have not always made voting as simple as perhaps the founding fathers intended.

But then, as their efforts to establish and then defend freedom so clearly display, nobody said it was going to

When one considers the lives that have been lost, the courage that has been tested, the perserverance that has been displayed, one cannot help but feel shame when one fails to exercise the simple effort it takes to cast a vote, not just for a candidate, but for the cause of democracy

Surely if we were to have a national referendum next week on whether this nation is to live under a democratic set of ideals or not, the people would flock to the polls in numbers never before witnessed.

But what those 50 per cent who stay away from the





des. In the race for lieutenant governor, the incumbent Bill Hobby is being challenged by a trio of comparatively unknowns.

The race for attorney general is interesting. Price Daniel Jr., who has a name well known to Texas voters and who has been serving as speaker of the house, is running against Mark White, former secretary of state. The outcome appears questionable.

In the state treasurer's race the question of name familiarity pops up once again. Pr-

esent Treasurer Warren G. Harding, who was appointed to fill out the term of the deceased Jesse James (another familiar name) is opposed by Harry Ledbetter and C.R. "Charlie" San-

For commissioner of agriculture, present appointee Reagan V. Brown (who was named to succeed John White when he went into President Carter's government) is opposed by Joe A. Hubenak and Don G. Sewell. Mack Wallace, present

railroad commissioner is opposed by John Thomas Henderson. .

In the race for railroad commissioner (unexpired term) the highly capable John Poerner has received opposition from Jake Johnson, Ray Lemmons and Jerry Sadler (another old time politician with a familiar name).

The remaider of the ballot consists of

justices of various courts in Texas. Important as these positions are to all citizens of the state, their identification is difficult. In one instance, it is possible that name identification is being used in the race of Jim Vollers against Sam Houston Clinton for Judge, Court of Criminal Appeals, Place 3.

REPUBLICAN TICKET Heading the ballot in the Republican Primary is Sen. John Tower, who will be a shoo-in nominee, since he is unopposed.

The next race on the ballot is different, however, where four candidates are seeking the Republican nomination for U.S. Congressman from the 21st District. Tom Loeffler of Kerrville is listed first on the Coke County ballot and all indications show that he is favored to lead the ticket in this area. However, he is opposed by Wallace R. Larson, Bobby Locke and Neil Calnan.

The Republicans also are putting up a strong fight for governor. Three candidates are seeking the party nomination for the office. They are Bill Clements, Clarence G. Thompson and Ray Hutchinson.

Running unopposed on the Republican ticket are Gaylord Marshall for lieutenant governor; and Local Labor Laws. Jim Baker for attorney general; and James W. Lacey for railroad commissioner.


