Mrs. Cumbie Ivey Jr., Coke County Democratic chairman, said the county committee voted to have only two polling places in the county. They will be at the courthouse in Robert Lee and at the city ha-11 in Bronte.

Voters who live in voting precincts 1, 3 and 9 will vote at the courthouse, while those who live in voting precincts 2, 4 and 5 will vote at the city hall in Bronte.

A number of hotly contested races are to be decided in some neighboring counties, but all county and district nominees were decided in the First Primary in Coke County. The race for railroad commissioner is the only statewide contest to

develop into a runoff. Mrs. Ivey urged all Democrats to vote. She said she would like for Coke County to have a good turnout even though there are no local races.

Burial will be in Fairview Cemetery under direction of Shaffer Funeral Home.



# **U.S. Representative Bob Krueger** IMPORT BILL

WASHINGTON-This week in Washington, I testified before the House Ways and Means Committee regarding legislation of major importance to two seemingly diverse groups of Americans: people in the meat-producing industry and the average American consumer.

The bill I have introduced and about which I testified is H.R. 8684, a bill which will provide relief to the troubled financial plight of cattle ranchers and other meat producers and which would assure consumersmeat eaters—that the meat they purchase is healthy and subject to high inspection standards.

If Congress does not soon enact legislation addressing these two major concerns, the nation faces a continuation of the economic strain that is steadily eroding the number of meat-raisers in the U.S.A. and consumers continue to run the risk of being victimized by impure meat.

The financial ramifications of this issue do not necessarily begin and end with meat-raisers, either.

In recent years, many of the nation's cattle-raisers have been forced to take losses on sale of their beef because the import of foreign beef has kept prices at relatively low levels.

Now many of those cattlemen who have not been able to make profits on cattle investments are having to mortgage their land and, unless they get relief in their battle with foreign meat importers, many will not be able to maintain their range and cropland and, at some point, the banks and financial firms which have underwritten them will be forced to foreclose. That is an awesome situation for our farmers and ranchers to have to live with.

By the same token, the same leniency which threatens the financial stability of meat producers is also exposing the consumer to possibly impure meat and meat products.

What my bill will do is bring about significant change in the 1964 Meat Import Act, changes that will at least give American meat producers equal opportunities to compete with foreign importers and will provide a form of preventive medical insurance to the people who purchase meat in supermarkets across the nation.

We all are aware of recent incidents in which impure meat, impurity brought about by inspection standards that are too lax, has resulted in, at best, recall of some meat products and, at worst, severe illness. In today's world of technology, we must not tolerate such neglect.

Perhaps the most important element in H.R. 8684 is that it calls for foreign beef imported to the U.S. to undergo the same thorough inspection that domestic meats must undergo and that all foreign meat be labeled as such so the consumer knows if he is purchasing American-raised meat or imported meat.

This legislation would also bring under the Meat Import Act meats currently exempted from regulation under that act, including processed beef, goat and

In it is also a provision dealing with another serious threat which evidence indicates is coming from imported cattle which have not undergone close inspection or quarantine. H.R. 8684 calls for imported cattle to be inspected and quarantined for brucellosis, a deadly disease spreading all too rapidly through herds of American cattle.

The balance my bill seeks is nothing more than a balance that hopefully will trigger an equity of opportunity that does not currently exist. It does not exist because we import into our country far more meat than we export, causing a significant trade deficit for meatraisers. And it does not exist because current legislation regulating beef inspection is weighted in favor of importers rather than our own domestic meat-raisers.

Already the cost of entering the meat-raising industry, or of staying in it, is a major deterrent to Americans who in the past would have been able to operate with a fair

margin of return. If action is not forthcoming on bills such as H.R. 8684, the individuals of Texas and the nation who have supplied the rest of us with meat and meat products for all of our history will face devastating consequences and that confrontation is one we in Congress must not allow to occur.

Coke County voters will cast their ballots in only one contest in the Second Democratic Primary which will be held Saturday. The only race in which we will have a vote is for Railroad Commissioner of Texas. This is a very important office, has been since oil production became a major industry of the state, and is even more important in today's energy crisis.

It seems to us there is no choice at all in the matter except to vote for John Poerner. He ran second on the ticket in the First Primary, with the old perennial and familiar name of Jerry Sadler coming in with the most votes.

It boggles my mind as to how the voters of Texas could even consider Jerry Saddler for any office at all. He has a long record of less than satisfactory service to the state. He has been reprimanded for his conduct of the office when he was Land Commissioner. He is 70 years old (which is no great liability, but neither is it an asset when compared with the mature but vigorous Poerner).

Poerner is now serving on the Railroad Commission. He has done his job with distinction and with integrity. Poerner is solid, he is intelligent, he has the interests of the state at heart and in his head; he is not seeking the office as another opportunity to feed out of the public trough for a few more years.

Texas voters seem to have a great weakness for voting for persons only because of name recognition. It should not be so. We have suffered grievously on more than one occasion in the past on account of this lack of learning about the men involved. Let's not let it happen again Satur-

The name to remember is POERNER (pronounced Purrner). If you consider qualifications, you can do nothing but place your X in his box.

Previously, all a person had to do was submit the stub of the lost card, or the old card, and a new card could be issued on the spot. This can no longer be done, Mr. Upp said.

In addition to submitting evidence of identity, the person's application will be checked against the records at social security headquarters. If all the information checks out. a new card will be is-

Mr. Upp said the new rules are intended to help protect the person's social security record, assure that it is complete and accurate, and to prevent anyone else from misusing or abusing the person's social security number.

Evidence of identity should show the person-'s picture, signature, date of birth or age, or other identifying information. All documents are subject to verification with the agency which issued them.

Since it takes 3 to 4 weeks to issue and deliver the new card after all documents have been submitted, Mr. Upp said that it is a good idea to apply for the duplicate as soon as possi-

A free leaflet, "Applying For A Social Security Number", lists the kinds of evidence that can be used to establish a person's identity. Copies can be obtained at the San Angelo Social Security Office located at 2214 Sherwood Way. The telephone is 949-4608. Residents of Ballinger, Big Lake, Brady, Junction, Mason, Ozona, Sonora, and Winters may call toll free by dialing "Operator" and asking for "Enterprise 2058".

ERRORS IN YOUR BILL INQUIRING

The Federal Truth in Lending Act requires prompt correction of billing mistakes.

1. Here's what to do in order to preserve your rights:

A. Do not write on the bill.

a. On separate sheet of paper write your name and account num-

b. A description of the error and an explanation as far as you may know.

c. The dollar amount of the suspected error. d. Any other information.

B. Send your notice to the address on the bill, mail it as soon as possible.

3. After the store has been notified they may not file any collection action against you.

4. If the store did make the mistake on the bill you do not have to pay any finance charges. 5. If the store's explanation does not salo were Mr. and Mrs. Ir- tisfy you and you notify them of this in writing within 10 days of this then they may report you but they have to say that you do not think you owe the money.

6. If the store does not follow these procedures, then they are not allowed the first \$50 of the bill or finance charges.


