DASTARDLY CRIME ATTEMPTED.

Miscreants Planned Destruction of Tunnel and Workmen at Niagara Falls.

NIAGARA FALLS, N. Y., April 26. -By the merest accident the lives of about thirty men and the tunnel work of the Canadian Niagara Power company were saved from destruction. Last night as the night shift went on duty the discovery was made of a most dastardly attempt to wreck the tunnel and kill men working 160 feet below the surface of the earth. The shaft leading down to the tunnel is 160 feet deep. From the bottom of the shaft the tunnel runs north and south and the men work at both headings. The blasts are discharged by means of batteries, which are operated at the foot of the shaft, the wires extending to the heading.

When the night shift went to work one of the "nipper" boys discovered that at a point 100 feet from the bottom of the shaft the wires from one of the batteries had been cut and a cartridge cap connected and placed in a stick of dynamite. The stick of dynamite had been placed between two boxes of dynamite containing seventyfive pounds of the material. It is customary for the day shift to arrange the blasts and the night shift sets them off when it comes on. Had the "nipper" boys failed to discover the plot the men at the headings would have been killed and imprisoned and work which had cost many thousands of dollars ruined. The object or the mo-

An Historic Battle Flag.

Greenville, Texas, April 26 .--There was on exhibition yesterday an old and faded flag that was carried throughout the war between the States by the Fortyeighth North Carolina volunteers. where the people met on May 20, 1775 and declared their independence of Great Britain. There are blood stains on the flag and a num-

ber of holes where it was pierced by minnie balls, and a large rent made by a bomb shell. This priceless relic of dark and bloody days was carried by the regiment

through the battles of Harper's Ferry, Fraiser's Farm, Sharpsburg, Richmond, Bristoe Station and Eredericksburg. At the latter place two color bearers were shot down with the flag and it was then picked up by a captain who also received a wound. He managed to roll over the breastworks and saved the flag to the regiment.
