KERRVILLE LANDS METHODIST ENCAMPMENT

Locating Committee Accepts Local Offer of 200-Acre Site From Bud Porter and Starkey Places West of City.

DRIVE STARTS TO RAISE FUND OF \$11,500

Proposition Depends on Securing Money to Purchase Land Accepted as Location by Visitors—Plan To Open Encampment Coming Summer.

Kerrville's proposition of a site of 200 acres of ground with frontage on the Guadalupe River was accepted by the locating committee of the Methodist Encampment, West Texas Assembly, subject to the raising of \$11,500 by a local committee for purchase of the land.

The site accepted for the encampment consists of the Bud Porter place of 160 acres, including a hilltop from the J. J. Starkey place adjoining, not to exceed 40 acres in extent. The location is within three miles west of the city on the Old Spanish Trail.

Final decision to accept the site was given Wednesday morning after short deliberations. The committee said Tuesday afternoon that it would accept the proposition subject to several details which were cleared up to their satisfaction.

With the decision of the locating committee in favor of Kerrville, it now remains to raise the \$11,500 necessary to purchase the land offered as a site. A board meeting of the Chamber of Commerce was held at the St. Charles Hotel last night, at which plans were arranged for a drive to raise the funds by public subscription and the campaign will get under way before the end of the week.

With the location of the Methodist Encampment near here, Kerrville and The Hill Country secure a valuable project that will be another means of broadcasting the fame and beauty of this section and drawing larger numbers of visitors here. The encampment will also mean much to moral and religious development as well as to the commercial interests of the city and its territory.

Well Pleased With Site

Members of the locating committee expressed themselves as well pleased with the location and the offer, passing a resolution of thanks for same and pledging themselves to do everything in their power to make the project a success, not only for the good the camp will receive from it but also for the benefit a successful encampment will mean to the interests of The Hill Country.

The sub-committee appointed by Chairman H. E. Draper of the main committee returned here last Thursday afternoon to review sites proposed by the Chamber of Commerce after the visit of the full body the week previous. Original sites had not met with approval due to local workers having no definite understanding of the desires of the locators.

In company with the local committee, W. H. Chambers, Rev. Arthur Moore and Rev. S. H. C. Burgin were taken to view several sites up the river and then were brought back to the Porter place. This site had met with their approval subject to obtaining an adjoining mountain on the Starkey place.

Negotiations conducted that afternoon and Friday morning made possible the securing of an option on the additional land desired and the sub-committee was offered the proposition which was finally accepted.

Final Details Arranged

These men expressed themselves as well pleased with the site and proposition and intimated they would recommend its acceptance by the full committee, which returned Tuesday afternoon and looked over the grounds.

The questions of lights and telephone service were the final details that the committee requested settlement of before making formal acceptance of the proposition. Their desires in this matter were promptly arranged to their satisfaction by the local committee and the final decision was formally announced at the Wednesday morning conference.

To Campaign for Funds

The drive to raise the funds necessary to purchase the site is to be conducted at the earliest possible moment in order to get final arrangements and deeds completed. Every business firm and individual in Kerrville and the surrounding territory is asked to contribute as liberally as possible in order to assure the success of the campaign and the location of the encampment here.

Rev. H. E. Draper, chairman of the locating committee, Wednesday morning announced the appointment of W. H. Chambers as general manager of the encampment, which is to be called the "Kerrville Methodist Encampment."

Dr. Draper also announced the appointment of a committee from the local Methodist Church to co-operate with Mr. Chambers and a committee from the Chamber of Commerce in completing details on construction work, etc.

The Methodist committee consists of D. H. Compartment, chairman; Rev. F. A. White, J. J. and A. L. Starkey, C. W. Moore, A. E. Self and H. C. Geddie.

EX-PRESIDENT WILSON PASSED AWAY AT WASHINGTON SUNDAY MORNING

End Came Peacefully at 11:15 A. M. As Climax of Struggle Against Death Which Started Before He Left the White House in 1921.

Woodrow Wilson, outstanding world figure during the late war, when men were measured by their accomplishments, is dead. His death occurred at his home in Washington, D. C., at 11:15 o'clock Sunday morning.

Fatigued and worn by the battle with death which began before he left the White House in 1921, the War President of two terms—eight of the most momentous years in the history of the world—closed his eyes and slipped peacefully away.

The end came when vitality no longer could retard the steady dissolution which set in with the stroke of paralysis that laid Mr. Wilson low on his return from the Western speaking trip in 1919 in which he declared he was glad to give his life for the League of Nations if that would make it a success.

The cause of death, as officially announced, was general arterio-sclerosis and hemophilia.

The general sclerosis had been progressively hardening Mr. Wilson's arteries since he was first stricken in 1919. The hemophilia, which referred to the paralytic condition of his left side, manifested itself principally in his left arm and leg.

A digestive disorder, which developed last Monday, hastened death by a new and vicious attack on the waning vitality of the former President. He took a sudden turn for the worse Thursday night and his physicians found that thereafter it was only a question of how long they would be able to prolong life.

The passing of the former President was announced in the following statement issued by his physician and friend, Rear Admiral Cary T. Grayson:

"Mr. Wilson died at 11:15 Sunday morning.

"His heart's action became feeble and feebler, and the heart muscles were so fatigued that they refused to act any longer. The end came peacefully.

"The remote causes of death lie in his ill health, which began more than four years ago, namely, arterio-sclerosis with hemophilia. The immediate cause of death was exhaustion following a digestive disturbance which began in the early part of last week, but did not reach an acute stage until the early morning hours of Feb. 1."

Mrs. Wilson, his daughter, Margaret, and Dr. Grayson only were in the death chamber at the end. Dr. Grayson, restraining tears with obvious difficulty, gave the formal announcement to waiting newspaper men. Worn with the strain, his voice was barely audible when he said that the former President's last moments had been peaceful.

Interment of the remains was made Wednesday afternoon in a stone vault within the great cathedral rising on the hills overlooking Washington, which will be used temporarily until a permanent resting place can be determined on.

The simplest of ceremonies were conducted at the home and at the grave, only immediate relatives and closest friends participating in the services. However, the route taken by the funeral cortege through the city was lined with silent mourners and throughout the country services were held simultaneously with those at Washington, the entire Nation paying tribute to their former chief and friend.

Local services were held in Kerrville at the U. S. Veterans' Hospital, participated in by the various former service men's organizations, the Legion Auxiliary and the churches of the city as well as people generally who wished to pay homage to the former President. The Woman's Auxiliary of the Presbyterian Church held a short memorial service in connection with their week of prayer and foreign mission study. This service was conducted by Rev. J. V. McCall, who was a student at Princeton while Mr. Wilson was president of that institution.

That a man's worth to the commonwealth is never appreciated until he has passed beyond reach of earthly tribute is demonstrated again in the death of this great man. His death had loosened men's tongues to speak their admiration even as it stifled the already dimming clamor of criticism that beat about him when his hands still firmly gripped the powers of the presidency. From friend and foe in the harsh days of the past and from those who still oppose some of the tenets of his faith, came generous, unstinted tribute to the high idealism that had ruled the heart and mind of him whose death they mourned.

A great American is dead, and in death the bickering and tragedies of misdeeds and cross-purposes have been swept away in a flood

of tribute to his greatness of heart and to his service to his country in its hour of sore trial.

Messages of sympathy poured in on Mrs. Wilson from every foreign capital. They rang with the same spirit that ruled among the Allied powers in the grim war years, when the dead man had stood like a rock of refuge, wielding his great powers to save civilization. They recalled the hours when he voiced the yearnings of humanity for lasting peace; when he spoke a vision of hope into the ears of hate-ridden peoples.

Recognized Authority on Problems of School to Speak—Local Patrons Also to Give Short Talks.

A school rally will be held at 8 o'clock Friday evening in the auditorium of Tivy High School. Every parent and others interested in the betterment of the public schools is cordially invited to attend the meeting.

The purpose of the rally is to foster and develop a better co-operation between parents, teachers and pupils and addresses bearing on that subject will be given. A speaker from San Antonio, whose knowledge of school problems is generally recognized, will deliver the principal address of the evening. Several patrons of the schools will also make short talks during the meeting.

The Parent-Teachers' Association has long been working for the general betterment of the Kerrville Public Schools, but it is believed that a better co-operation among the citizens of Kerrville will be of inestimable value in promoting the schools' interests.

The Center Point News carried an excellent article last week written by Supt. B. H. Hill, superintendent of schools in that city, and is reproduced here. The article follows:

Too many people seem to believe that schools can succeed on money alone. Many appear to believe that the school has all the support needed when it has been voted a sufficient tax on which to operate, many never enter a school room door, some seem to accept report cards as complete evidence of the child's progress and the child's report of the general progress and condition of the school as a satisfactory account on which to judge the school. Yet no other business institution is looked upon with such indifference by its stock holders or judged by a child's estimate of the business.

Teachers appreciate the confidence of parents, but they can have no real appreciation of any workshop without a knowledge of what is being done in that shop, nor can there be effective co-operation in improving the productions of any shop without knowing the plans and having an intimate acquaintance with what is going on there, which can be obtained only by actual investigation and close inspection.

The school needs the personal touch, the sympathetic voice, the kindly smile of every parent, just as the children in the home need them, for the school is a collection of children in another place than home. What kind of a parent is that who simply feeds, clothes and shelters his children—who simply finances the home? What is a home without the moral support of the father or the fine personal touches of the mother, without the presence of both at least occasionally? No, money will not pay the entire debt of the parent to the school.

Through the ages mothers have been the unfaltering friends of the school and all praise to the mothers as a group, but fathers, too, need to give personal attention to schools, especially at this time when so many attractions call the children away from school duties, this time when morals seem lax and the crowd rushes on in search for thrills of excitement. The father is needed more today than at any time in American history, needed in the home and in the school, with the boy and with the girl.

A rich banker recently gave his twelve-year-old son a deed to one hour of his time each day for the next eight years. Most boys would prize this gift far more highly than anything money can buy.

And more, the schools, if given a deed to not one hour a day, but one hour a week of the time and thought of the capable, energetic, plan-mak-

BREEDERS BEING CAUGHT FOR KERR COUNTY BASS HATCHERY

Special Permit Issued for This Work By Deputy Game and Fish Commissioner J. W. Gildart.

Deputy Game and Fish Commissioner J. W. Gildart has issued the editor of The Sun and his assistants a special permit to catch bass during the closed season for breeding purposes at the Kerr County Bass Hatchery. Under that permission advantage was taken of the warm weather the latter part of last week and twenty-three fine breeders were installed at the Hatchery. Nineteen or twenty are yet needed to complete the number required and they will be secured as soon as the weather permits.

Valuable assistance has been rendered in this work by Dr. W. H. Wood and Col. R. L. Cook of the Veterans' Hospital, Chas. Wooten of Ingram, W. G. Ward and Chester Henke, Frank E. White, the champion fisherman of Center Point, has also volunteered to help, and advantage will be taken of his kind offer at the first opportunity.

The construction work at the Hatchery is practically completed and with this installation of the breeders the first independent fish hatchery in the State will be in full operation.

Bandera New Era: As it is generally known Trail Loop No. 10, which has been marked and logged from San Antonio to Bandera and Kerrville, passes through Medina, up Wallace Creek and across the mountain to Kerrville, where it connects with the Old Spanish Trail proper. State Highway No. 27, as officially laid out, runs from San Antonio to Bandera Pass to Center Point, where it connects with the San Antonio-Kerrville highway. The State Highway Commission has been asked to change the designation of Highway No. 27 to conform to the route marked by Trail Loop No. 10 and put it through Medina and up the North Prong via Wallace Creek. This is the most scenic route and one of grandeur and beauty, and the roadbed is really in better condition than the present route. Action by the State Highway Commission can be hastened by energetic action on the part of Bandera County citizens.

Teachers appreciate the confidence of parents, but there can be no real appreciation of any workshop without a knowledge of what is being done in that shop, nor can there be effective co-operation in improving the productions of any shop without knowing the plans and having an intimate acquaintance with what is going on there, which can be obtained only by actual investigation and close inspection.

The school needs the personal touch, the excellent smile of every parent, the kindly smile of every teacher, just as the children in the home need them, for the school is a collection of children in another place than home. What kind of a parent is that who simply feeds, clothes and shelters his children—who simply finances the home? What is a home without the moral support of the father or the fine personal touches of the mother, without the presence of both at least occasionally? No, money will not pay the entire debt of the parent to the school.

Through the ages mothers have been the unfaltering friends of the school and all praise to the mothers as a group, but fathers, too, need to give personal attention to schools, especially at this time when so many attractions call the children away from school duties, this time when morals seem lax and the crowd rushes on in search for thrills of excitement. The father is needed more today than at any time in American history, needed in the home and in the school, with the boy and with the girl.

A rich banker recently gave his twelve-year-old son a deed to one hour of his time each day for the next eight years. Most boys would prize this gift far more highly than anything money can buy.

And more, the schools, if given a deed to, not one hour a day, but one hour a week of the time and thought of the capable, energetic, plan-mak-

an appropriation of \$277,600 a year; California, the same with \$577,520 a year; Nebraska, the same with \$678,388 a year; Ohio, the same with \$795,085 a year.

My experience in making appropriations for the different departments of State government and in administering the Department of Agriculture convinces me that there is inefficiency

and extravagance in the management of agricultural affairs as now administered under separate and independent agencies.

The commissioner of Agriculture is the only person administering laws who is elected by the people and certainly the agricultural work being done by appointive boards and commissions should be transferred to the Department of Agriculture and stop so much overlapping and duplication.

Livestock raising, dairying, irrigation, feed, fertilizer, forestry control, and marketing are all essential phases of agriculture and should be united under the State Department of Agriculture as they are in all the leading agricultural states.

There is no justifiable reason for having these agencies acting separately and independently of each other. They are costing the taxpayers over \$600,000 a year, and they can be administered under one directing head for \$200,000 less than they are now costing.

I know this can be done, because the Department of Agriculture has been administered the past two years for \$135,440.84 less than it cost the two years ending August 31, 1920, and all the work has been carried on that was formerly done except the Farmers' Institute work.

If the expenses of conducting the other departments and institutions had been reduced in proportion to those of the Department of Agriculture the past two years, the State would be on a cash basis now. It will do no good to create another appointive board and place it over the agricultural agencies, as advocated by jobholders to defeat real consolidation.

We have too many boards and commissions now. The clerical Department of Agriculture can do this work better and cheaper than a dozen appointive boards. The real purpose and effect of having so many boards and commissions is to keep more people on the payroll.



LET'S CALL A HALT—THE STATE'S BUSTED

Troup Banner: The Banner would like to see a good capable man in Smith and in every other county in the State get into the race for the Legislature this year with a platform whose paramount plank would be: "Let's call a halt."

This is enough for any legislative platform. Of course, it would be explained like this: Said candidate is against the creation of a single new office or court, or commission, or other instrumentality calling for the expenditure of the people's taxes. It may not be popular to say it, but we'd like to see some of the Appeals Courts killed—at least consolidated with others, and their judges and other officers, put on at least a 10-hour per day basis, with two weeks vacation. And other officers ought to be put on the same basis in these strenuous times. That would help a little; but the main help would come if about half of the State Department could be wiped out, and a whole lot of commissions and boards and clap-trap socialistic attachments, adjuncts and "fixtures" now attached to others sent into discard.

We don't need a single new law—and we need more than half we have repealed or amended. And we don't need political log-rollers and pork-barrel statesmen in the Legislature who will group themselves together and form a "bloc" to get some State institution, or State expenditure for their particular section by voting some like institution or equivalent to some other section. Where is the candidate who has got the nerve, if elected, to go to Austin and enthrone the Legislature with the notion that we ought to call a halt.

We have been playing the mischief ever since Tom Campbell's day down at Austin. It has mighty near busted the State; and it has busted a lot of tax-bearing animals. Too many men have gone to Austin merely to lay out a congressional career, or gather in a judgeship, or others elbow up to the political pie counter. Too many of them have thought more of re-election, or of political advancement, than they have of the primary interest of their constituents. We need now who will go down there and call a halt, throwing to the winds the question of re-election or future political advancement. The people will take care of the honest, faithful, efficient public servant. They did that with Hogg and Reagan and Culbertson. Let's try to get back to the ideals of these worthies in our calling of public servants.

San Antonio Express: Edwards County, with a San Antonian acting as engineer, has just let the contract for construction of 17 miles of road—all of it to be a hard-surfaced highway. Edwards voted \$400,000 in better roads bonds—a gigantic undertaking for a county of its taxable wealth—and the State Highway Commission has, and is, assisting loyally and materially. It is expected Real and Kerr Counties will let contracts for joining up with Edwards within the next two months. With all the mileage of the three counties completed, there will be another and an important highway almost finished into San Antonio—and from a section where such a road is needed. One by one, sometimes by threes and even sixes, the counties of all this wide belt are joining the "Good Roads Family." It is one of the most pleasing prospects, of all the enjoyable anticipations, facing San Antonio territory.

TURN IN CATTLE INDUSTRY

Fort Worth Star-Telegram: Well informed men in the live stock industry unite in the opinion that from the standpoint of the cattle raiser the turning point has been reached. The several years of constantly falling values have decreased the animal population of the great grass ranges of the Southwest to the point where the relation between the supply and demand can stand the pressure no longer. Buyers now are offering better prices, but are getting very little action. Ranchers are holding on to their depleted herds, with the conviction that they are much more valuable than the current quotations indicate.

The survey published in the Star-Telegram recently by a well known live stock authority quoted a competent observer to the effect that the 1924 output of steers in Texas would fall at least 30 per cent below normal crop, which is approximately 350,000 head. He also reported increased activity of buyers especially for West Coast and Mexico supply.

Cattle raising being a basic industry second in importance only to its partner in agriculture, must inevitably return to a position of soundness. Huge areas of grassland in Texas, now empty, will again sustain great herds

of steers. But, before that time, before present depleted range stock can be built up to amplitude, the world more than likely will suffer an actual shortage of meat for food. This is a penalty that must be paid for negligence in allowing the continuance of conditions that throttled so important a contributor to our economic life.

San Antonio Express: The January number of "American Highways," published at Washington for more and better roads the country over, looks like a special Texas issue. It contains the speech of former Gov. William P. Hobby, who paid a tribute to Warren G. Harding's work as President for a real American system of highways. It has an interesting article entitled "Concrete Pile Trestle Bridge Construction in Texas," by G. G. Wickline, bridge engineer for the State Highway Commission, and a third, and very readable story, on "Importance of State Highway Department Publications," by V. D. Fugler, secretary of the Texas Highway Commission and the editor of the Texas Highway Bulletin. The consequence of the Texas highway system to the country as a whole is recognized by highway officials, both State and Federal, throughout the Nation. Their spokesmen never lose an opportunity to write of the things Texas is doing with the biggest mileage of any of the American States.

INVESTIGATIONS THAT WILT

The Dearborn Independent: The public must have been impressed by the vast number of investigations which have been made in consequence of the crooked administration of war activities, and the very little that has come of them. Mountains of gross irregularities—worse than political graft, because they involve taxation distressed by war—were proved to have existed, and yet in instance after instance the investigation has been halted at just that moment when the core of the matter was about to be disclosed. When Democrats have investigated for the purpose of getting campaign material against Republicans, they have found so many of their own party involved that it was impossible to serve a partisan purpose by further inquiry; and when the Republicans came in and sought to show what a fiasco the Democrats had made of war administration, they found so many Republicans involved that their partisan purpose also failed. So the investigations have been stopped.

Then there has been a point when the next step was to uncover the "higher type" men who were not professional politicians but the financial backers of the parties, and there again the investigations have halted. Other inquiries have been dropped because the person under fire was found to be only one of such a large number that the likelihood of bringing them all to equal justice was very remote.

The total result to date is the knowledge that dishonesty prevailed to an extent that indicates a most complete organization for the purpose of robbing the people when at war. Looking at the matter as a whole it is clear that investigations failed at the outset because of the unworthy purpose that motivated them. Partisan or personal revenge is a purpose that never completes a constructive work. The loss to the people is not the failure to fasten guilt, but the failure to uncover the SYSTEM which enabled graft to be practiced on a colossal scale.

It is worth suggestion to the President and Congress that, in view of the value of such knowledge to the Nation, particularly in the recurrence of war conditions, a complete study of the grafting system be made for the purpose of being ready instantly to detect and repel its revival at another time. If necessary, let the questions of party and persons, of responsibility

and guilt, pass. Give a general amnesty in advance, if necessary. But get at the principle and practice of this dangerous thing. Congress could do worse than appoint a research committee to study and report upon the system, the philosophy, the fellowship of dishonor, which makes such combinations possible in an enlightened Nation.

About the only kick heard in regard to the closed fishing season of three months, which applies to only six counties, is that it should have been made State-wide. All who have expressed themselves regard it as a good law and that it will aid materially in keeping the streams in the six counties stocked with fish. Locally, it would be better if March, April and May constituted the closed season as the bass are still spawning in May some years, especially if there happens to be a late spring.

WIRE STAPLE REMOVED FROM BABY'S STOMACH

Fort Worth, Tex., Jan. 31.—A wire staple was removed from the stomach of a 16-month-old baby here Monday night by an operation at a local hospital.

A similar operation six weeks ago had been unsuccessful. An electric light bulb and a pair of forceps were used by the surgeon in locating and removing the staple.

JUNCTION BOY AWARDED TROPHY AT EASTERN SCHOOL

Junction, Tex., Feb. 2.—Earnest Hamer of Junction, otherwise known as "Tex" Hamer, football star at the University of Pennsylvania for the past three years, has been awarded a silver loving cup by the university for excellent scholastic work during the past year.

The cup, 18 inches in height and 22 inches in circumference, has been received here, and is on exhibit in the store of Alex J. Hamer. Only one student may win the loving cup each year. Three successive wins entitles the winner to permanently retain it. The cup was made in honor of Thomas R. Reath, who was killed in the battle of Chateau Thierry in 1918. Hamer attended local schools and went to the West Texas Military Academy at San Antonio before going to the University of Pennsylvania.

LEGION FAVORS SALE OF HOSPITAL TO UNCLE SAM

Temple, Tex., Jan. 30.—A plan favoring the sale of the American Legion Memorial Hospital at Kerrville to the Federal Government for \$1,500,000 which is said to be actual cost of construction is part of a program adopted by the Texas department of the Legion, according to Dr. M. W. Sherwood of Temple, State commander. The matter will be brought before Congress and the Texas Legislature at the most favorable opportunity.

"The obligation of the National Government to provide proper hospitalization for the disabled service man is everywhere recognized," said State Commander Sherwood, "and in various sections of the country it has spent millions in the contribution to or purchase of hospitals. When the Federal Government was tardy in providing proper facilities for tubercular veterans of Texas, effort was made, first by the Benevolent War Risk Society and later by the Legion to raise by public subscription funds to build a hospital. Failing in this the Legion went before the Legislature for funds and appropriations were made to construct the tubercular hospital at Kerrville. This institution is now under lease to the Federal Government being operated by it. It should be owned by the Federal Government and the \$1,500,000 spent for its construction turned back into the State coffers, thus helping to lighten the tax burden in Texas."

TOP-WORKING NATIVE PECAN TREES

O. S. Gray, Secretary, Texas Pecan Growers' Association: Not long ago I walked through a native pecan grove of possibly 1,000 native pecan trees, discussing with the owner the possibility of increasing its profitability. An examination of the grove, upon which the owner depended for his principal source of income, disclosed that out of the 1,000 or more trees in his grove there were possibly around 100 trees that were, in fact, furnishing by far the greater part of his nut crop.

We passed by one tree and he made the remark that he wished every tree in his grove would bear pecans like that one, stating that one man had contracted yearly for the production of this particular tree, no matter whether it produced ten pounds or 500 pounds, readily paying a premium above the price of common native nuts.

As we passed another tree, heavily loaded with pecans, he remarked: "There's a tree that always bears a good crop whenever any tree in the country bears—I wish I had some more like it, for it's a very profitable tree."

The point that is to be made is that these things are true in all native groves throughout the pecan growing belt. It is universally recognized that they have a relatively few profit makers year in and year out.

By top-working native trees to desired varieties, we can have the trees in these native groves bearing better crops of profitable varieties. When we take a native tree and cut off its top and re-work the limbs or sprouts by budding or grafting, thereby establishing a new top, the process is known as "top-working." We make use of the old trunk and roots to support our new top and save the years of time necessary to grow a good trunk and an elaborate root system.

It may safely be said that much misinformation has been published in the past dealing with the top-working of pecan trees, but this has been brought about to some extent, at least, by the fact that the practice was passing through its experimental stages. As time has passed and the results of the early efforts are meeting the test, we are able to observe enough to enable us to say that top-working has passed through its experimental stage.

Experts Save Money
Money spent for the services of an expert is money well spent. There are still so many differences of opinion in regard to some of the points that beginners are often confused in reading published information, and it pays to employ an experienced man—especially until such time as his helpers become proficient.

Size for Stock
It is the "size" of a tree rather than its "age" that is usually regarded as governing the working over of a tree. "Age" plays its most important part in determining whether or not a given tree is of proper size for its age and not a stunted tree that lacks in vigor.

It is possible to top-work any pecan tree, no matter what its size, but it seems to be the prevailing opinion among experienced operators that much time and effort are often wasted in attempting to work over the larger sized trees. Some experienced men hold that eight inches in diameter is the limit, while others set their limit as high as eighteen inches in diameter. The size of branches and type of branching of a tree has quite a bit to do with the selection of a tree for top-

often accumulates in rotted hollows and kills the trees. This severe cutting also weakens trees to such an extent that borers will attack the trunks.

Common practice has resolved itself into choosing smaller trees for top-working, avoiding large wounds and cutting down much of the expense necessary in working large trees where scaffolding is often necessary for the workmen.

Some have advocated the removal of not over two-thirds the top of a tree at any one time, stating the necessity of leaving a part of the top for carrying on the life functions of the tree. The writer, however, at this time makes a practice of removing the entire top, following the rule laid down in the following paragraph for this work, preferring to have the operation over at one working, and after an experience of some eight years, prefers this method as the usual procedure.

My own experience has led to the adoption of a rule to not cut limbs larger than four inches in diameter—and preferably two or three inches. If I am across a large tree, I find that I can apply this rule by going out far enough on the limbs to find this diameter, and by a casual inspection and mental calculation of the number of buds that would be required, I soon know whether I want to tackle it or not. I have found it very desirable and satisfactory to select trees with a diameter of six to eight inches. Only a reasonable number of buds is required for a tree of such size—it can be worked from the ground by using a stepladder—and the root system is usually large enough to grow rapidly a top of good size.

Save the Framework
It takes Nature many years to grow the framework of a tree say twelve inches in diameter, and by going out far enough on the limbs to cut them at a diameter of two to four inches, the non-bearing framework of the tree is largely preserved, and it only takes a few years to completely restore the young bearing branches. This, to my mind, completely overbalances the expense of inserting whatever extra buds may be necessary.

Properly Shaped Trees
An article appearing in The Farm and Ranch several months ago called attention to the fact that comparatively few growers were giving any attention to the proper shaping of young trees, and advising the use of the type of tree known as the "modified leader."


In the selection of trees of around six inches in diameter for top-working, the operator is usually enabled to build the general framework of his tree throughout five or ten feet before doing away with the leaders. This will give a tree highly adapted to spraying practices should they ever be necessary for the control of insects such as the nut case-bearer.

The best way to learn how to top-work is to go with an experienced man. It is almost impossible to lay down rules because every tree is an individual problem calling for its own solution. Remember that it is cheaper for you to pay what may seem to be an exorbitant price to you in order to secure a competent man rather than to have the work done free by a man who may give you wrong ideas.
