BOND ISSUE RECOMMENDED.

"The report of the secretary shows that the ordinary expenditures for the current fiscal year ending June 30, 1910, will exceed the receipts by \$34,075,620. If to this deficit is added the sum to be disbursed for the Panama canal, amounting to \$38,000,000, and \$1,000,000 to be paid on the public debt, the deficit of ordinary receipts and expenditures will be increased to a total deficit of \$73,075,620. This deficit the secretary proposes to meet by the proceeds of bonds issued to pay the cost of constructing the Panama canal. I approve this proposal."

The president says the cost of engineering and constructing the canal, which will be completed January 1, 1915, will be \$297,766,-000, as originally estimated. Other expenses increase the cost by \$75,435,000 to a total of \$375,-201, 000.

URGES POSTAL SAVINGS BANKS.

"They will furnish a satisfactory substitute for the system of a government guaranty of deposits which, with deference to those who advocate it, seems to me to have in it the seeds of demoralization to conservative banking and certain financial disaster."

The president earnestly recommended the passage of a ship subsidy bill.

Campaign Expense Publicity.

"I urgently recommend to congress that a law be passed requiring that candidates for members of the house of representatives and committees in charge of their candidacy and campaign, file in a proper office of the U. S. government, a statement of the contributions received and of the expenditures incurred in the campaign for such elections and that similar legislation be enacted in regard to all other elections which are constitutionally within the control of congress.

The Statehood Paragraph.

"The successful party in the mission as separate states of New The president says the cost of Mexico and Arizona and I recomto this end be adopted. I urge, however, that care be exercised in the preparation of the legislation affecting each territory to secure deliberation in the selection of persons as members of the convention to draft a constitution for the incoming states, and I earnestly advise that such constitution after adoption by the convention shall be submitted to the people of the territories for their approval at an election in which the sole issue shall be the merits of the proposed constitution and if the constitution is defeated by popular vote, means shall be provided in the enabling act for a new convention and the drafting of a new constitution. I think it vital that the issue as to the merits of the constitution should not be mixed up with the selection of state officers and that no election of state officers should be had until after the constitution has been fully approved and finally settled upon."

Teachers' Examination.

The regular mid-winter examination of teachers will be held in the public school building at Carrizozo, N. M., on Friday and Saturday, January 14th and 15th, 1910. All permits expire on the date of this examination, and all teachers holding permits and desiring to continue teaching are required to secure a certificate at this examination. The issuance of two permits in succession is forbidden; hence the necessity for holders of permits to secure a certificate in order to draw salary from the public school fund. The Territorial Board expects to furnish questions for first, second and third grade certificates. The examination will begin at eight o'clock, Friday morning, and a specifically allotted time will be given to each subject until the examination is completed.

BIBLE NOT ETHICAL

Thirteen Chicago University Professors O. K. the Statement.

Holy Book Is Neither the Compendium of Truth Nor Theology, Declares an Official Editorial in the Biblical World,

Chicago.-The divinity school of the University of Chicago gave the world another startling bit of advanced theplogy when the 13 editors of the Biblial World put their O. K. on the statement that the Bible is not a compenlium of ethics and never was intended to be.

The argument appeared in the form of an editorial in the magazine, of which Prof. Ernest DeWitt Burton, D. D., head of the department of New Testament literature and interpreta-

tion, is the editor-in-chief. The associate editors are members of the faculty, and their unanimous approval is necessary before an editorial goes to the printer. Often two or three collaborate on an article.

The editorial makes the argument that the ethical methods of Jesus were ideal in that they were elastic and adjusted to fit conditions as they were

In an interview Dr. Burton elaborated on the presentments made in the editorial in a manner to emphasize what many persons had read between the lines, viz., that Sunday baseball and other personal enjoyment of the Sabbath were not necessarily sinful, in the minds of the 13 professors. Dr. Burton did not mention baseball in his discourse nor did he mention saloons, but he left room for some very plain inferences. As did the editorial, he held that the Bible was not an ironclad depository of truth and arbitrary rules of conduct, but a historical record. And no less an authority than Jesus himself was cited in support of his position.

"The Bible is not a compendium of truth, nor even of theology," said Dr. Burton. "It is a record of religious and ethical experiences rather than the last authority and a composition of all theological truth, such as it is held to be by most churches.

"Taking the Bible at the beginning and following it through, we find it ever-changing, according to the conception of the times. We cannot take It as a compendium and opening it say: 'There is the law; there is the truth."

Parts of the editorial read as follows:

"What shall we say concerning the commands of Jehovah in the Old Testament to exterminate the women and children of a vanquished foe? How shall we account for the fact that the Old Testament heroes indulged in polygamy, forbidden by our modern laws? How can we teach total abstinence from a Bible which repre- company imaginable.

sents Jesus as partaking of wine at feasts, and which even tells how he miraculously produced wine from water on one occasion when the supply fell short?"

"How, for example, can a Christian gain in intelligent understanding of the issues at stake in the modern conflict between capital and labor if he simply confine himself to a reading of the Bible? How shall he gain defensible moral convictions concerning the ethics of child labor if he confine his attention to a literature which never dreamed of the possibility of modern factories and machinery?

"When one turns to the Gospels one cannot fail to be impressed with the way in which Jesus taught morality directly from life rather than by the methods of the scribes. He determined what was right in any instance by examining the situation itself. When sickness needed to be healed the interests of suffering humanity were of more importance to him than the Jewish legislation concerning the Sabbath.

"Is it not time that we should cease to apologize for this method of Biblical study which has been universally adopted in our seminaries?"

London. - Mrs. George Cornwallis-West, formerly Lady Randolph Churchill and mother of Winston Spencer Churchill, is reported to be planning a new shock for British aristocracy. This beautiful, talented American woman, whose ambition and ability made her first husband one of of England's foremost statesmen, and who, as a widow, married a man about the age of her son, according to the latest report is preparing to raise bullfrogs on a large scale for the London market.





HALLEY'S COMET IN SIGHT

How Astronomers Have Predicted Coming of Astral Derelict Accurately-Some Strange Facts.

Halley's comet again is approaching the earth after an absence of 75 years. While swinging around in space it visited a region that is perhaps 50,000,000 miles more distant than the outermost planet of the solar system. Although it is not scheduled to arrive at its perihelion—the point least distant from the sun-until July 19, 1912, or possibly the latter part of 1911, depending on the amount of planetary disturbance, it probably will be visible to the naked eye in a short time.

After an exposure of an hour recently in Heidelberg, Germany, a photographic plate showed the comet as a nebula of the sixteenth magnitude. Another photograph has just been secured of the comet at the Yerkes observatory, near Williams Bay, Wis.



Course of Comet.

Solar bodies above the seventh magnitude cannot be seen without the aid of a telescope.

Extraordinary attention is being paid to the return of this celebrated comet. It is of particular interest to scientists because it was the first known to travel in a closed orbit. Its brilliancy, sensational size, records of its returns—the consternation once spread through the world by the belief that it would destroy the earth make it the most famous comet in history.

In 1682, in the reign of Charles II. of England, a comet of extraordinary size appeared, which was observed by Newton, Halley and other astronomers of the time. Halley followed its course among the stars and, comparing his observations with the records of previous comets, came to the conclusion that the cornets of 1456, 1531 and 1607 were only different appearances of the same object. He staked his reputation on a prediction that the comet would return in about 75 years. True to this prediction, it did appear in 1758, when Edmund Halley had been sleeping in his grave for 16 years. The reason the name of Palitsch, a Saxon peasant, has been preserved to posterity is that his eye was the first to catch sight of the reurning comet. It was on Christmas light, 1758, he saw the comet and year.

cheated the professional astronomers of the honor.

The first recorded appearance of Halley's comet was B. C. 130, when it was believed to herald the birth of Mithridates. In 1066 it was seen equal to the full moon in size. In its appearance in 1456 its tail reached from the horizon to the zenith.

Halley's comet, perhaps, has received more scientific attention than any of the others. In its last revolution, in 1835, it was influenced appreciably by the attraction of the four outer planets, Jupiter, Saturn, Uranus and the earth, and, of course, the sun. Damoiseau and Pontecouland, French astronomers, undertook the task of calculating the amount of such influences. It was found that the action of Jupiter, as compared with the last revolution of the comet, would accelerate it 135.34 days; that of Saturn retard it 51.53 days; that of Uranus retard it 6.07 days, and that of the earth retard it 11.7 days, the latter dating back as far as 1759, or the very beginning of its revolution, at which time it passed very near the earth.

The following facts connected with the appearance of the comet in 1835 are taken from Herschel's "Outlines of Astronomy:"

It developed no tail until October 2 and on that day the nucleus was observed to become suddenly brighter and to throw out a jet of light from its interior part.

Its tail attained the greatest length of 20 degrees October 15, and had entirely disappeared before its perihelion passage of November 16.

At the anterior luminous jet, meanwhile, singular and capricious changes succeeded one another with such rapidity that on no two successive nights were the appearances alike. At one time it was single, at another time fan-shaped or swallowtailed, while at other times two, three or even more jets were darted from the comet in different directions.

In receding from the sun it passed through a series of changes scarcely less remarkable and finally disappeared May 5, 1836.

Power of Increase.

The remarkable power of increase of plants and animals, insuring their continuance through long ages with the production of new forms by adaptation, was noted by Dr. A. R. Wallace in his late Royal institution address on Darwin's work. A single common weed, the Sisymbrium Sohpia, yields three-fourth of a million seeds, and if all grew and multiplied, the land of the globe would be covered in three years. One pair of elephants, the slowest breeding animals, would produce 19,000,000 individuals in 750 years. The prolific rabbits, the national pest of Australia, would have a progeny of 1,000,000 from a single pair in four or five years.

High-Explosive Shells.

The French battleship Iena, which a few years ago was wrecked by an explosion of the smokeless powder in her magazines, is being used as a target, and several important problems are to be determined relating to the effect of shell fire. Recently, after caged animals had been placed on board the ship, she was attacked by the cruiser Latouche Trouville with high-explosive shells. The deadly effect of the gases of the explosion was shown by the asphyxiation of several of the animals.

Veterinarian Pine, of this place, is assisting him. The inspectors yesterday visited the dairy of Sam Potts and found four of his dairy cows infected with tuberculosis, which they condemned and ordered killed. They also found a cow of Charles Spence's infected and the same measures were followed.

The inspectors will test any work. Owners of condemned cattle will receive from the territory two-thirds of their appraised value, not, however, to exceed \$60.

CAUSES OF TYPHOID.

Autumnal typhoid still has a way of uppearing at customary seasons in well nigh every region of the country. The health authorities in New York and it this year rather worse than isual, it appears in the dwellings of the well-to-do as freely as in the shacks of the poor. Sanitation does not prevent it, that is, not what we generally call sanitation. It is an inestinal disease, conveyed by drink or food. The old theories of bad air, sewer gas and damp houses have not now much standing. It is feared that some of the later theories do not explain all the points about autumn yphoid. The housefly does not. The condition of the water supply, as beng different in summer and winter, loes not. A plausible explanation is that the profuse perspiration with which in summer the body eliminates a large amount of disease breeding matter, is reduced to a minimum almost instantly when the cool days begin. The kidneys and bowels, unaccustomed to the task, are burdened with dangerous materials and unable to perform the task of elimination. It is at least common knowledge that typhoid is most prevalent when the cool weather sets in.

The premier set forth plans for developing the resources of the empire and avoiding unnecessary expenditure. This peaceful program contained nothing to which objection can be taken anywhere. On the contrary, the plans deserve the warmest approval. Japan has had enough of war for the present, and sees that her highest interests will be served by promoting prosperity at home and strengthening friendly relations abroad.

If the cave man lived to-day he could hardly repeat his now famous declaration: "Romance is dead," says Collier's Weekly. By science, contrary to many fears, wonder and mystery have been increased.

DARING RESCUE

CARRIES AN INVALID WOMAN FROM HER HOUSE THROUGH FLAMES.

HIS FRIEND SAVES CHILDREN

John Kold, a 19-Year-Old Philadelphia Youth, Braves Fire to Save Woman Who Seemed Doomed.

Philadelphia. - Bedridden through long illness, Mrs. Nathan Tiekoff was a helpless prisoner in her room in the third story of the fire-swept house at No. 2531 Lombard street, until John Kold, a 19-year-old boy, fought his way through the smoke and flames to her side and carried her to safety.

Mrs. Tiekoff, who is 60 years old, was awakened about three o'clock in the morning by smoke. She tried to sit up in her bed and called to her sons and daughters sleeping in the room behind her. The children were sleeping too soundly to be roused and the aged woman was compelled to watch in agony the slow curl of smoke under the doorway and hear the roar of the flames eat the lower stairways.

The smoke attracted the attention of a passerby and Kold and Harry Beckman broke down the front door. Kold knew of Mrs. Tiekoff's condition and hastily tying a handkerchief over

When Beckman ran into the house his attention was centered upon Rose and Jane, aged 19 and 16, respectively. Both girls were in their nightgowns and tried to jump from the second-story window to escape the fire.

Beckman persuaded them to try the stairs and, although their nightdresses caught once from sparks, the descent was accomplished. But Lombard street was dreary and cold in such light costumes and the girls were taken into the home of Mrs. Margaret Clifford and clothed. The loss was about \$1,500. NUN MASTERS A MAD BULL

Brave Woman Rescues an Aged Herdsman and Puts Two Men to Shame.

Berlin.-The Cologne Volkszeitung vouches for the accuracy of a remarkable story of a nun's encounter with a bull.





THE "SIMPLE LIFE"

MUCH IS IN ITS APPLICATION TO THE KITCHEN.

"New Thought" Cooking Really Is

Nothing More Than the Application of Brains to the Work

of Every Day.

The advent of the "simple life" has proved to be more than a passing fad. The cluster of useless bric-a-brac is now seldom seen, and our new homes are waiting for a thorough change of heart of those who demand the old-time cooking. The influence of the simple life has reached the kitchen last, but it is there, and it has come to stay, so that in a few years we shall find dyspepsia classed as an old-fashioned disease.

Those who are pleased to interpret the rules of right living under the name of New Thought are especially interested in a simplified way of cooking and eating. Not necessarily vegetarians, but willing to make their appetites subservient to their good judgment. A very practical idea of such living was lately given by Adelaide Keen in the Nautilus. She says: "The French take few medicines and need few. They have gotten food and meals down to a science, which we benighted Americans with our horrid fried pork, hash stews and other messy, greasy, indigestible dishes are only getting a glimpse of. Why, even in rich families, unless the father came of cultured stock, they often live exactly on the foods of poor men who live miserably in crowded tenements.

In colonial times corn mush, salt fish and pork were the principal fares of our new countrymen; now, we know better.

For breakfast have taked eggs in tiny earthen dishes, costing but ten cents each, and which, with a cream sauce, make the individual egg taste delicious; then coffee, with buttered toast, a raw or a prepared cereal, already cooked, and a bowl of stewed fruit complete the breakfast.

Try having a well polished table covered with clean doylies at breakfast and lunch, and try eating meat but once a day, when you have the large clean table cover on and a perfect, but not elaborate meal. It will repay you to wash, iron and embroider that old linen or duck skirt into round mats, one for each plate, one for each large dish and for every cup or tumbler.

Linseed oil and wax will polish your table and two pretty candles, with sticks and shades, used instead of gas, give just the quaint, dainty touch to the dinner for a change. The old silver castor you have in the attic can be cleaned with a mixture of whiting and ammonia and filled with tiny thumb pots, green with ferns. It gives an air of elegance and makes the dinner taste better.

An Oiled Dust Brush.

Carved furniture, which is the bane of the housekeeper's life, may be kept somewhat free from dust by weekly or bi-weekly treatment with an oiled brush kept for the purpose.

The cotton or woolen duster will make no impression on its ornate surface, but will have much to do with

the disposition of the housewife.

The brush used in the decorators' shops for the very purposes of keeping their finest furniture in order look very different from the feather duster. It is a large soft paint brush in appearance, and having been oiled, it absorbs on its soft bristles a certain amount of dust instead of sending it flying about the room.

Celery Catsup.

Take 15 large tomatoes, five bunches of celery and six small onions. Chop fine and add a cupful of vinegar, seven tablespoonfuls of sugar, two of salt and a saltspoonful of cayenne pepper. Cook slowly together for an hour and a half. Bottle and seal tightly.—Housekeeper.



The Cattle Sanitary Board furnishes the following:

the provisions of this law.

The Cattle Sanitary Board has secured the co-operation of the U. S. Bureau of Animal Industry the dairy cattle of the Territory. The work has been organized and the testing is now being done by competent veterinarians. During the winter all dairy cattle in towns having a population of 500 or more inhabitants, and all dairy cattle from which products are sold in said towns, will be tested for tuberculosis.

The symptons of tuberculosis are not sufficiently prominent, except in advanced stages, to enable one to diagnose the disease by physical examination. The cattle may be in apparently good health and yet have tuberculosis in such form that they are capable of spreading the disease.

The tuberculin used in making the tests is the sterilized and filtered glycerin extract of pure cultures of tuberculosis germs. It is the cooked product of the germs but does not contain any of the germs. It cannot, therefore produce the disease and is as harmless as so much distilled water. When injected into a healthy animal no results whatever follow, but if the animal has any tuberculosis, a decided reaction takes place and the temperature of the animal rises.

All animals which are found to be tuberculous will be condemned and destroyed and the owner paid for such animals on a basis provided for in the law.

This is a matter in which every inhabitant is interested and the public should fully support and co-operate with the authorities in the work.
