The action of the World's Fair commissioners to the effect that no form of gambling will be permitted on the exposition grounds is commendable. It would be a serious blunder for the management of this great enterprise to take any other position than this. It would be an unwise policy for our government to permit any of its enterprises to be used to promote gambling—an evil that is daily growing in this country.

There seems no indications of any stop in the rapid extensions of the City of Mexico, which is growing fast in all directions, but mainly toward the west and southwest. Many hundred new houses are building, and plans for a large number more are accepted. Business is excellent, and reports from all parts of the Republic show a high degree of prosperity. There will be a large increase in the area devoted to coffee culture this year, and great attention is also being paid to sugar cane culture, and many new plantations are being set out.

The Denver Republican says: "We should be glad to believe that the management of the Denver & Rio Grande railway company is seriously considering the matter of extending its line southward in New Mexico. But it is not probable that it is doing so. The most feasible plan by which to secure such an extension is for the people of the interested New Mexico towns to organize a company and build a line northward to connect with the Rio Grande. It is highly probable that if such a company were organized the Rio Grande stockholders would render the New Mexico company valuable aid in raising the money which would be needed."

A Catlettsburg, Ky., dispatch says: "Particulars of a tragedy reached here the other day from Gager, McDowell County, W. Va. On Saturday the four Hall boys and two of the Steeles met at Squire Murphy's office to transact some legal business. Each was armed with rifle and revolver. One of the Hall boys was on the witness stand and contradicted a statement by a Steele. The lie was given and the battle opened. The court room was quickly emptied of its occupants not interested in the trouble. About forty shots were fired, and when the smoke of the cleared away, the Steele boys—Samuel and Hiram—were found to have been killed outright. L. W. Hall had a rifle ball through his brain, and his brother Lewis was badly wounded." McDowell County, West Va., is strongly Republican.

Women and Ladies.

There have been some amusing instances of the misapplication of the word lady, which custom has decreed to mean social culture instead of its original meaning, "loaf-giver."

A girl waiter in a large hotel in an eastern city approached a guest with this query:

"Has any other lady taken your order?"

This was equivalent to the politeness of the little girl who surprised the family by announcing:

"Mamma, the swill lady is at the back door."

There is a story of the mistress of a fashionable house who, on being left without any servant, answered the door bell and was confronted by a stout girl, who asked:

"Are ye the woman that wanted a lady to work for ye?"

When Harriet Martineau visited America she asked the warden of a prison reformatory in Tennessee to show her though the women's ward.

"I am very sorry, ma'am, that I cannot accommodate you, but we have no ladies here at present."

A minister who was very polite changed a portion of Scripture to read, "Ladies and gentlemen created He them;" and a lecturer who cared more for the sweet phrases of politeness than for the plain statements of the truth, rung this query upon an astonished audience, as he discoursed on the characteristics of women:

"Who were the last at the cross? Ladies. Who were first at the sepulcher? Ladies."

But even he was outdone by the exquisite divine who, as he concluded marrying a couple, said gallantly:

"I now pronounced you husband and lady."

The movement of cattle from along the line of the Santa Fe in New Mexico and Arizona has commenced and the first trainload bound for the Montana pastures will arrive in Denver on the 5th or 6th inst. The movement will be fully inaugurated. The first shipment the Santa Fe will tackle will 10,000 head belonging to J. M. Holt, at Wilcox, Arizona. These will be shipped to Wendover, Wyo., and thence driven to the grazing grounds in Montana. To move the bunch of cattle will require over 400 cars. It will cost more than \$20,000 to ship them. The Santa Fe expects to handle several hundred thousand head this season. In addition to those sent to Montana many stockmen will ship to Kansas and Nebraska, where the cattle will graze until fall and then return fed.—Denver News.

Regarding Population.

The decline of the birth rate in Europe seems to be general and steady. In France the births are now very little in excess of the deaths, and in other countries the decline is marked.

Germany and Austria have the highest birth rate, but Germany shows a greater falling off since 1875 than any other nation except England. Hungary and Italy alone show an increase in the birth rate, and that not a heavy one. The United States have no very accurate statistics on the subject, but it is well known that even in this country the birth rate is decreasing and gradually approaching the death rate. It would seem that in civilized countries the matter of food and population may easily regulate itself along other lines than those laid down in the malthusian theory. By the time the waste places of the world are occupied and settled, neither war, pestilence nor famine may be needed to preserve the balance between power of production and need for consumption.—Ex.

San Pedro Looking Up.

Despite the assault made upon the Santa Fe Copper company in a recent issue of the New York Mining Record, the stock seems to be holding its own pretty well and affairs at the mines and furnaces at San Pedro, as well as at the company's Boston office, are moving on with much activity. The German expert, Mr. Schaeffer, originally sent out to report on the extent and value of the concentrating ores for the Luhring Concentrator company of London, is again at San Pedro, and his presence is deemed as indicating that the Luhring's proposition to put up a 500-ton concentrator is in a fair way to go into effect. The Mining and Engineering Journal at hand from New York says:

The Santa Fe Copper company's new concentrator is at work. The amount of matte produced from March 15th to April 30th is reported to have amounted to 437,000 pounds. The directors of the company, at a meeting held in Boston, Mass., on the 14th of May, voted to issue \$42,000 10 per cent. five-year scrip with which to take up the coupons on the \$300,000 7 per cent. mortgage bonds matured in June and December, 1890, and to mature in the same months of 1891. Holders of over three-quarters of the bonds have consented to accept the scrip. The next coupon due for payment in cash will be that of June, 1892. This will give the company a full year in which to demonstrate its earning capacity.—New Mexican.

From the El Paso Times.
New For the White Oaks.

The press of Denver, El Paso, Pueblo, Las Vegas, Trinidad and White Oaks has for the past twelve months been agitating the question of an air line road between El Paso and Denver, running through the towns above mentioned and opening up a country rich in coal, timber and silver and lead ores.

That such a road would be of incalculable benefit to the cities mentioned is thoroughly understood among the business men, but understanding and talking will not build the road. Money is needed and that money can be found at the east, and its investment in the proposed railroad can be secured if the matter was properly presented to the eastern capitalist who do not understand the inducements offered. Now in order to get to work in a manner holding out encouragements of success, the Times calls for a convention to be held in El Paso, on the 30th of the present month, at 10 o'clock a. m. and invites the business men of Denver, Pueblo, Las Vegas, Trinidad and White Oaks, each to send ten delegates to the convention, where they will be joined by ten El Paso delegates, and let that convention consider the best method of securing the construction of the road and appoint a commission, to be composed of one representative from each interested city, to go east and secure capital to build the road.

Now, gentlemen, if you mean business, act, and if you fail to do so, El Paso will call in Kansas City to assist her.

From Denver Mining Industry and Tradesman.

White Oaks, New Mexico, which has been pretty well noted for some years for its rich gold bearing ore, is rapidly coming to the front as a producer. It has passed through its fever age of prospectors' boom, and reached the period when working instead of scheming is relied upon to furnish a living. When this period in the life of a mining town arrives, it has just reached bed rock and begins to construct a future on a solid foundation. There are now two stamp mills running, one a 10-stamp and the other a 20-stamp, as well as two Huntingtons, and the ore is reported to yield from

\$16 to \$50 per ton. There is water, fuel, good climate and good mining property there. More energy, more money and better transportation facilities are all that are required to make White Oaks a great mining town.

A Frontier's Trials.

Among the citizens of Eddy county who have handed in claims for Indian depredations is R. M. Gilbert. He has had a thrilling experience with the red skins. While ranching in Arizona many years ago a band of fifty dashed down upon him and killed his companion, one Barnes. Single handed and alone he fought the Indians until they prepared to set fire to the house, when he made a dash for a tule swamp. The Indians pursued him and kept up a constant fire, but he managed to gain the swamp where he concealed himself until the enemy decamped. Then he walked all the way to Fort Bowie, where he lay in bed two months recovering from a wound which he got while fighting the Indians at the ranch.

After getting well, he started for New Mexico and finally arrived at Seven Rivers, where he took up a claim. Receiving some money from his father's estate in Texas, he bought some horses and implements and commenced farming. He put in a good crop of stuff, but before it was ready to harvest the Indians came down upon him and drove off his stock, and his crop went to waste. He is now well fixed, owning the best improved farm in the county. But he has gone through many trials and hardships to get it, and nobody should envy his possession of it.—Eddy Argus.

TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS.

It will not cost you a cent, except the expense of gathering the articles and bringing them here, and the result may be worth many thousands of dollars to your county.

Ernest Langston seems to be renewing his childhood while in the land of steady habits. At last accounts he was recovering from quite a severe attack of measles.

Col. Heman, wife and son, Mrs. Sidney Parker and Mrs. L. W. Stewart have gone for a week's revel in strawberries and cream at the ranch of Mrs. S. E. Barber.

This is the version given of her lesson, by one of the infant class in the White Oaks Congregational Sunday school "A man built his house on the sand, and the rains beat and the flood came and the house was found on top of the center of a rock."

The large water tank of the Pecos Valley Railway company at Black River, was totally destroyed by fire last Tuesday night. It is thought by some that the fire was started by a spark from the pumping engine, located a short distance below it. Others are of the opinion that it was the work of an incendiary. At any rate it is quite a loss to the company and places them to considerable inconvenience.—Eddy Argus.

A few days ago we took a walk through Mr. William Rexford's garden and orchard in the Park. 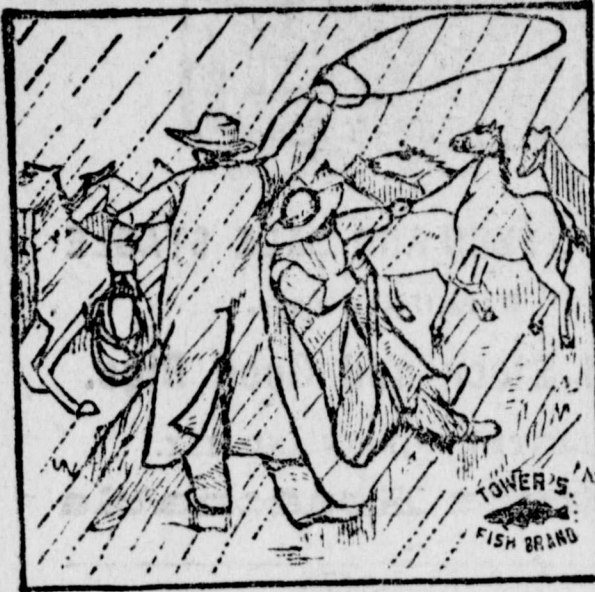
