NORTH & SOUTH R. R.

Preliminary Survey Completed From Boerne to Mason.---Crops Fine in that Region.

Mr. John Fowler reached here this week from Mason. He has been with the surveying crew of the North & South road for the past two months. He says when he left the surveying crew was camped about five miles from Mason and have reached there by this time. This crew was in charge of Engineer Holiday. They had succeeded in locating a route with a one per cent grade the entire distance.

Capt. Streber, who has charge of the surveying crew from Boerne to Fredericksburg, has completed his work and is now at the latter place. Mr. Holiday will return to Fredericksburg as soon as he reaches Mason. The surveyors will then go over their route again for a final or locating survey. When this is completed the company will be ready to let the contracts for grading.

It will not take long to complete this last survey as the way has been opened and the route located.

Mr. Fowler says the road passes two small towns between Fredericksburg and Mason, viz: Royal Valley and Cherrysprings. Royal Valley is a historic old place. It is situated in a beautiful valley that is noted for its fertility. It was founded about fifty years ago and grew to be quite a town, with a number of substantial stone buildings, the partial walls of which still remain. For some cause the town was abandoned, perhaps on account of the depredation of Indians. At present it is surrounded by many prosperous farms.

Crops in that section are fine. Some made as high as 20 bushels of wheat to the acre. Corn and cotton promise to make a splendid yield and the fruit crop is as fine as he ever saw. One farmer who has 700 bearing Elberta peach trees has a canning factory and will put up a large amount of fruit this year.

Mr. Fowler is of the opinion that the Coleman North & South road will be one of the best paying roads in the state when completed. It penetrates a fine stock and farming country that is now entirely without railroad facilities.

The completion of the survey to Mason is about half of the distance to Coleman and the remainder of the work is comparatively easy to what has been done.—Coleman News.

On last Thursday's Fort Worth market Callan & Co. sold a load of McCulloch county calves at \$6.75, averaging 155 pounds. H. W. Atkinson sold 29 cows of 802 pounds at \$3.35, and 33 of 654 pounds at \$3.25.

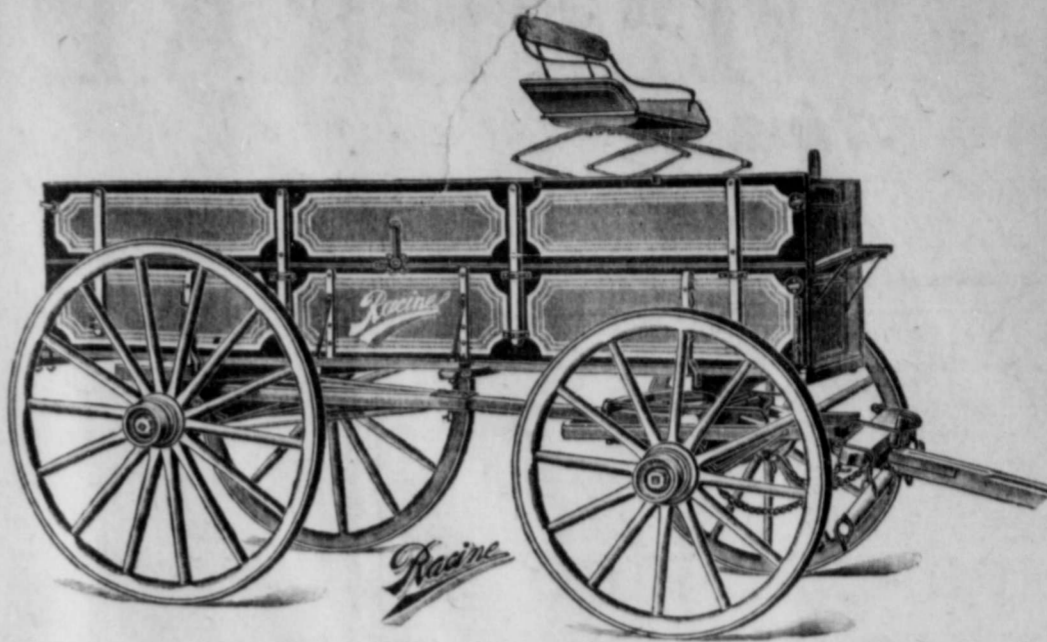

BRADY continues to attract new business enterprises, and more business houses will have to be erected during the coming twelve months. We predict an era of building activity.

SURE, a good rain would be appreciated, but every traveling man who comes to Brady tells us that our farming prospects and conditions are better than elsewhere. A good crop is in sight, and with a general rain within the next three weeks a bumper cotton crop is assured.

THE Brady boosters ought to be on the job seven days in the week now. This is a critical time in the life of Brady, and the work that is done or left undone during the next twelve months will be sure to leave its record throughout the future history of McCulloch county. From Mr. Anderson.

Rochelle Texas, July 27.

Editor Brady Standard:

The Standard failed to do me justice in putting a head to my article of June 6th reading, "Opposed to Good Roads." There is not a word in it which implies that I am opposed to good roads. Nor am I opposed to progress or to the development of McCulloch county as Mr. Finlay intimates. I am a progressive man, believing in real progress at all times. But it is not progress to go in debt out of all proportion to one's surroundings. This rule holds good in communities and counties as well as in individuals.

Now McCulloch county, as far as settlement by a heavy population goes, is a new county. Three-fourths of its people bought their homes on credit within the last five years, and owe for them yet. The high cost of living, the short crops of last year and the present gloomy drouth makes it a matter of grave difficulty to pay either principal or interest on their homes. We are prone to run into extravagance in our private lives. Indeed, the average man has so far lost control of his family expense account that he can't help being extravagant. We want to keep pace with our wealthy neighbor, and if he mortgages his crop to buy a surrey or piano we must do the same. Consequently we are piling up debts, in country and in town, until within a few years the whole financial fabric will fall in and the smash can be heard on the other side of Jordan.

Add to this general tendency to go in debt the amount invested in automobiles in this country, estimated at \$400,000,000. Here is one-fourth to one-third of the liquid capital of the United States invested in a strictly non-productive luxury. It is said that McCulloch county citizens alone have spent \$200,000 for these luxuries, and my contemporary has the audacity to say that

half of the extravagance belongs to the farmers. I do not believe it. However this morbid capital invested in this way is cutting into the available cash of the country more than all other luxuries combined.

It is said that the city of Dallas alone has over \$2,000,000 of good money invested in "chug wagons." The money tied up in these leaves an insufficient circulating medium to move the crops of this year, and this, notwithstanding the high scale of prices, threatens to cheapen the products of the farm. The time is not ripe for the issuance of bonded indebtedness for public roads in McCulloch county. For eleven months in the year our roads are good. True they are not macadamized but we don't need macadamized roads for awhile. I see no reason why the people should be taxed to accommodate the automobile business. I think a move for more real progress consists in holding down our indebtedness, paying as little interest as possible and waiting till we get our homes paid for and a few of the comforts of life.

I think we should consider the financial welfare of ourselves and family. The next generation will have its own problems to solve, and I don't believe it is right for us to saddle a bonded indebtedness upon them, and handicap them in the management of their affairs in any such way. I think we would be much better able to handle such enterprises ourselves if we would get a little nearer back to the simple life. And for the next few years I prefer mankind war upon greed, graft and selfishness, developing the country into higher ideals of honesty and fair-dealings, before exposing the proceeds of a bond issue to the risk of incompetent management on one side and of being gobbled up for a song by tricksters on the other.

It doesn't make any difference if the present proposition does

not effect my precinct. The fever of financial recklessness spreads like yellowjack or meningitis, and I propose to quarantine against it no matter who calls me a "back number" or an "old fogey."

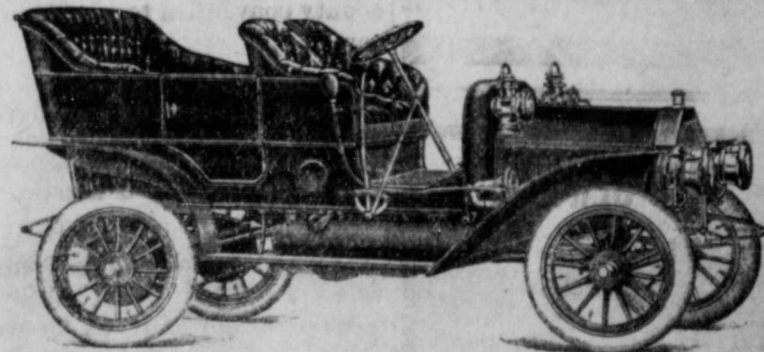

SOME LIVE WIRE FLASHES

The picnic at Fife was pulled off on time—Friday the 15th—and it was a big success. The crowd was not so large as was expected but those who braved the torrid heat were more than repaid for such display of courage by an extremely entertaining and enjoyable day. Although the heat seemed to descend upon the grove like a smothering blanket everybody bore with it cheerfully and smilingly, determined to have a good time. The cold drink stand, with Miss Agnes Finlay as presiding genius, was fortunately supplied with large quantities of ice, ice cream and soda water and the booth was surrounded the live-long day, by crowds in quest of the delightful, cooling beverage. Her assistants came and went; they couldn't stand the pace; and slipping through the ropes in sheer weariness and despair they sought the shade of the trees and rest, but the little girl never retired; through the overwhelming heat of the midday hours she hummed and whizzed on tireless wing; and when the crowd began to melt away in the gloaming, she was as fresh and sweet as if she had just been awakened from an evening siesta. Hypnotized, leaning against the friendly support of a live-oak I watched her, and could not help but think that if that crowd would do simple justice it would wind up the festivities by giving three cheers for Miss Agnes Finlay.

The day was filled with fast following events; short talks by the candidates for county offices and a speech by Judge Adkins for Colquitt and an address by Hon. C. C. Weaver, of Hillsboro, for Poindexter. The boys were in a good humored genial mood and received the telling points of the speakers with much enjoyment. The ladies too were interested and attentive listeners and evinced their pleasure and appreciation by frequent and enthusiastic applause. Judge Adkins made an excellent speech, he was much handicapped by limited time, but knowing this, he wasted not a moment in throwing bouquets and other non-essential preliminaries, but assuming the Jeffries hump, with jaws set and right fist clinched, he began a rapid fire, rattling gun, chain-shot cannonade that made the woods hum. Sometimes he would shell the whole landscape as a momentary diversion, but most of the time his batteries were trained upon a definite target, and when his guns were silenced by his time limit, it was all over but the shouting; the target was riddled; he never missed the mark once; not a shot was wasted. One of the curious things in this campaign is that the young men are largely for Poindexter while the men of middle life and old men are, with few exceptions, for Colquitt. Being struck with this and making inquiry as to the cause of such conditions, I found that the men of family and the old men are influenced by a desire for political peace, rather than any particular interest in the personality or ambitions of Colquitt. They want to let well enough alone. The local option laws being fairly successful and measurably enforced, and having been construed by both the inferior and superior courts of the State—at great cost to the tax-payers—they want them to stand, without change for fear of the confusion, cost and chaos that any change might bring about—Colquitt is for the status quo—as announced in all his speeches—and most of them being local optionists, they believe it is the part of wisdom to hold fast to what they have. I have not seen one but has expressed strong admiration for Judge Poindexter, as an able clean man, whom they would delight to honor were it not for his announced policy of tearing down the present structure of local option laws, to be replaced by another that might prove entirely futile.

But to get back to the picnic; the dinner was great; every good thing to eat imaginable was there in greatest profusion; the barbecued meats were especially fine, and after the crowd had gorged itself upon the brown and juicy joints there was enough left to feed another multitude; and good friend Baldridge was the boss of the fire pits and—well that is saying it all isn't it?

The Mexican trapeze performance was surprisingly, even astonishingly good. I had not dreamed of witnessing anything like such an exhibition. The act of balancing upon one foot, then upon one knee on the high, swinging cross-bar was splendidly done, and the following act of sitting in a chair with the hind legs only resting upon the cross-bar was equal to the best I ever saw anywhere.

But to get back to the picnic! The ladies were out in full force to crown the pleasure of the day with their inspiring presence. The woods were full of the beauty and fragrance of them. But shucks! Why will the women persist in attempting to neutralize the intoxicant effect of nature's chemistry, with the tricks of the druggist art, and douche themselves with perfumes? 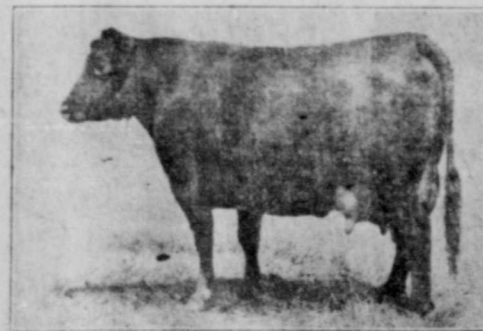

BIG PROFITS IN HOGS

There Are Only Two Classes of Men Who Do Not Succeed in the Hog Industry.

There are, in fact, only two classes of men who can not profitably grow hogs. The first class is composed of those who will make no provision for the feeding and care of their animals; who expect them to pick up a living through the summer and then to be fattened on corn in the fall and winter, or who keep them shut up in a filthy little pen the year round, feeding them on unwholesome slops and high-priced corn that has been shipped from the West. The other class is made up of those men who can not understand that any farm animal, even the pig, is entitled to good treatment, and some consideration of his wants—men who do not realize that if the hog is to produce pork cheaply he must be made comfortable, and that when it is a question of getting a profit out of the pig, the pig's wishes, rather than those of his owner, are the first to be considered.

The pig wants several things, and these he must have if he is to produce pork cheaply; he must have good feed and plenty of it; he must have pure, fresh water to drink; he must have clean quarters and enough range to keep him active and healthy; he must have shade in hot weather and he must be kept free from lice so that what he eats will go to the building up of his own body instead of feeding those parasites.—Starkville (Miss.) Progressive Farmer and Gazette.

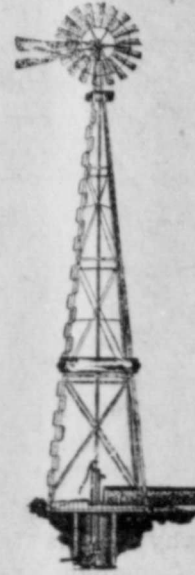
