THREE STORY BUILDING

MANN BUILDING FIRST TO BE BUILT IN BRADY.

Revised Plans Call for Additional Story—Handsome Building in City.

The first three-story building for Brady is an assured fact. The revised plans for the handsome new Mann building call for an additional story, to be used for offices, while the first two will be occupied by Mann Bros., with their furniture and undertaking departments.

While the work already accomplished is prima facie evidence that it is to be one of the handsomest buildings in Brady, it will be, as well, one of the most modern and completely appointed store and office buildings in the South. The building will be provided with steam heat, and will have its own dynamo to furnish power for the electric lights and fans, and for the passenger elevator that will be installed for the convenience of the occupants of the offices on the third floor, and their guests.

After a delay of several weeks, work is again in progress on the building, the steel beams, which had occasioned the delay, having arrived, and the large timbers being expected in a day or so.

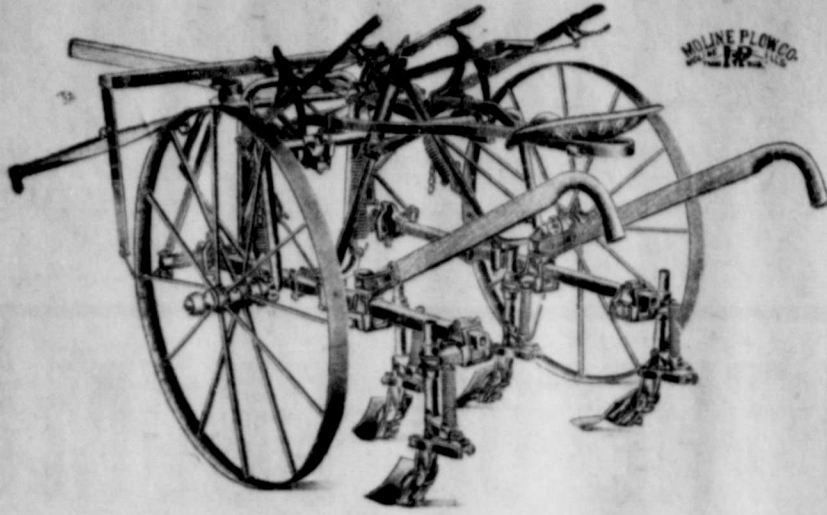

 Crop conditions here are not up to the average at this time of the year. It must be on account of the unusually cold winter and spring. It can't be for the want of rain, for we have had plenty of that.

Corn, at this season of the year, should be waist high, but it is not nearly that high, but the last two weeks' warm weather has brought about a considerable change.
 Cotton is about all planted and up and will soon be ready to work.

I have seen for several years, not only in McCulloch county, but in different parts of the state at about this time of the year, the big jumping grasshopper appears, and they are troublesome and destructive. I have seen entire cotton crops destroyed by them. There may not be any this year; they come only when conditions are favorable for them. Now, for the benefit of those who are troubled with these pests, will say I can give you a sure death for them. Some may know, but some may not, so this is for those who don't: Wheat bran, 10 pounds; arsenic, 1 pound; mix dry. One quart of molasses in enough water to wet bran; pour in water and stir with paddle until all is wet and then drop in dobs; the closer together the better, on the infested sides, but handle carefully, as it is very poisonous, but a sure death to hoppers.

The prettiest depot on the Santa Fe railroad!

That is the outspoken sentiment of M. F. Temple, constructing engineer of the Santa Fe. And it is likewise the opinion of every Brady citizen who has traveled to any extent over the Santa Fe system, or the Frisco system as well.

This handsome structure cost in the neighborhood of \$20,000. It is built of light gray pressed brick, with cut stone trimmings, and tile roof. The projecting roof is painted a sky blue, while harmonizing colors of light and dark brown adorn the outside woodwork.

Nothing could be more inviting than the large airy waiting room, with its high ceiling, its glazed tile wainscoting and its

pretty parks adorn the once rugged hillside. The spaces between the tracks have been paved with brick, while the right-of-way itself has been filled in level with the top of the ties with crushed rock. Between the depot platform and the driveway is a dainty little park. This has been set out in grass, and will be fenced with ornamental concrete posts. The 35-foot driveway is paved with brick, and ends in a graceful spread 105 feet across at the west end of the depot. The space south of the driveway has likewise been parked, sodded and will be ornamented with trees, bushes and flowers. The length of this park is 105 feet. Eight cars of sod were used to set out the parks and terraces.

Comment upon the improvements along the right-of-way would not be complete without mention of the handsome and modern ice plant being installed by Mann Bros., and which will be in operation by the 10th of this month. Too much credit cannot be given these enterprising citizens for this enterprise. The building is of brick, and is said to be as fine a structure of its kind as any in the state. The latest model ice machinery manufactured by the Fricke Co., the largest manufacturers of ice machinery in the U. S., has been installed and will soon be turning out ice at the rate of fifteen tons per day.

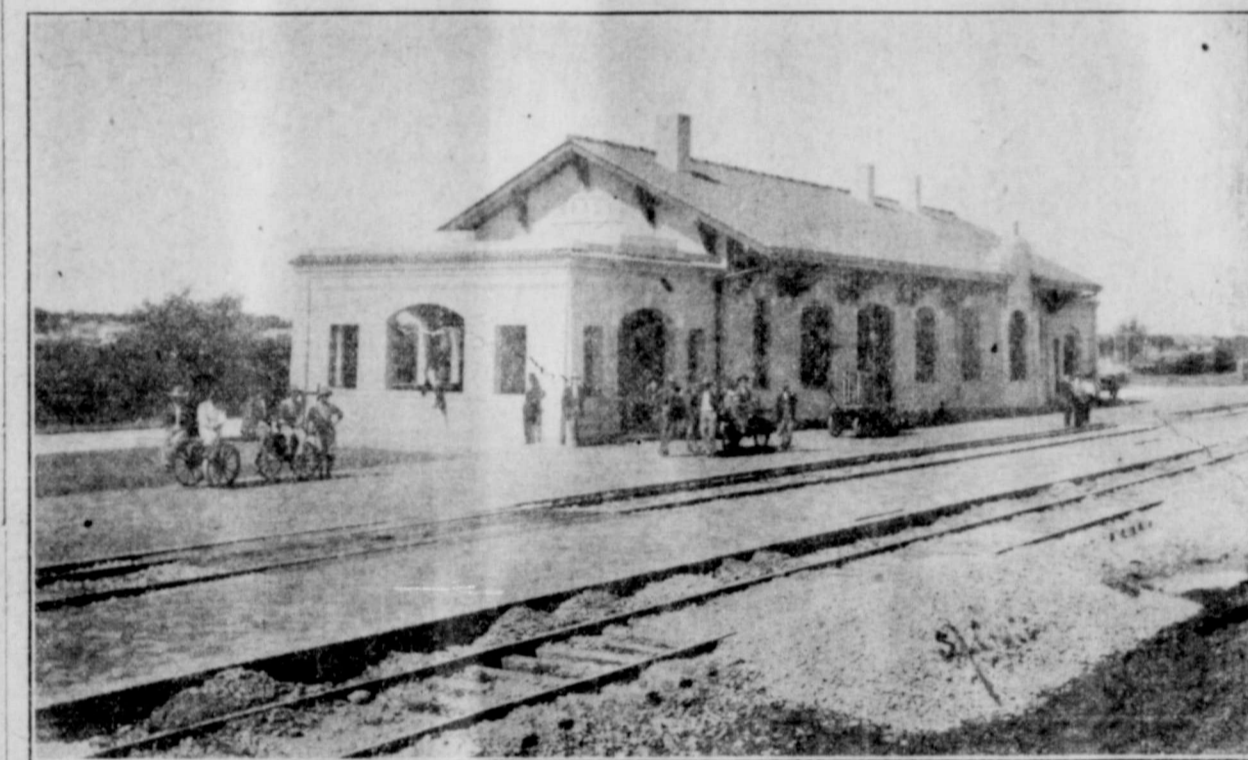

tile floor. The walls are decorated in restful colors of light and dark green, the ceiling is studded with ornamental globes which flood the room with light. In the west end of the waiting room is the ticket office occupied jointly by the Santa Fe and the Frisco. In the east end is an apartment leading to the basement in which is located the heating plant, and hot water radiators conveniently placed will heat the room in the winter.

The door in the east end of the waiting room opens out upon the loggia—the open-air summer waiting room, a feature that is coming into popularity in modern depot building. Protected from the afternoon sun by reason of its location on the east end of the building, the loggia is the coolest place imaginable, and concrete seats and floor add to its inviting appearance.

West of the ticket office is the colored waiting room, and adjoining this on the west is the joint baggage room. The dimensions of the depot building are 330 feet long by 24 feet wide.

What is today acknowledged one of the most beautiful sites in the city of Brady was, a year ago, as unpromising a location as could be imagined. Rough and rocky, an unsightly hill defaced by many gullies, it took a genius to imagine it as suitable for the location of the depot. \$40,000 was spent in making the transformation, but what wonders have been wrought. The hills have been graded, the gullies filled in; the right-of-way is as level as a table, while beautiful terraces and

The curbing is constructed of brick and cement, gracefully curved, and the gutters are likewise of cement. An idea of the expense of construction may be obtained from the statement that it cost \$3,000 to grade Bridge street north of the right-of-way to the top of the hill. This was approximately at a cost of \$4.00 per yard. Ordinarily this work could have been done at a cost of \$1.00 per yard, but owing to the fact that every shot had to be protected and the charges had to be light in order to avoid damaging adjoining property, and the cost was quadrupled.

East of Bridge street is located the union freight depot, erected at a cost of \$8,000. Broad and spacious driveways of crushed rock lead to the building, at the west end of which is located the Santa Fe offices, while the Frisco offices occupy the east end.

These facts considered, Brady citizens have every reason to be proud of the new depots and grounds, and if any further qualification is needed it might be said that the station would be well suited for a town of 20,000. In fact, Beaumont, a city of 25,000, boasts of the Southern Pacific depot at that place, and which does not even begin to compare with the Brady depot. And just as an afterword, the sanitary features have been well looked after, a septic tank built at a cost of \$1,100, being the receptacle for the waste water. The grounds will be in charge of the joint baggageman, and as is usual with the Santa Fe and Frisco railroads, every-

sufficient to take care of every need. The cost of the building and plant will approximate \$17,500, so it will readily be seen that this enterprise has been an undertaking of no mean proportions. With a foresight that is to be commended, the Messrs. Mann have arranged the building so that the plant may be doubled, or increased to any desired capacity, merely by the addition of another boiler and engine. Arrangements have been made in the building for a storage capacity of six tons, which will amply provide for any emergency.

Speaking with Mr. Jim Mann, he stated that their primary object in erecting the plant was to give the people of Brady the much desired service, and he had pledged himself to see that they obtained it. The ice will be the best that up-to-the-minute machinery can turn out, and full weights and fair treatment are assured. The ice plant is the most important smokestack secured by Brady so far, and with these live wires backing the project its unqualified success is certain.

EXPERTS IN LOHN FIELD

THIRTY OR MORE COMPANIES ARE OPERATING.

Thousands of Acres Have Been Leased to Prospectors in the Lohn Field.

D. F. Johnson returned from Brady last night, and says they have succeeded in working up a great big lot of excitement there about the Lohn oil field and that there are some forty or fifty expert oil men at Brady, taking leases and arranging to put down oil wells. There are now four producing wells on one small tract of land, the four of them, it is claimed, producing something like thirty barrels of oil per day, and a small gasoline engine operating each well. These are all shallow wells, and five more rigs can be seen from these, all putting down shallow wells.

The first deep well outfit reached Brady yesterday, and was being taken to the Lohn field, where a deep well will be started at once. It is also claimed that sixteen more outfits are ordered to be shipped to Brady, and will start wells as soon as they arrive.

Stock companies are being organized every day, and stock is being sold, and the people are determined to know whether or not they have oil in that section.

One firm has 180,000 acres of land under lease, and securing more each day.

Other companies are also taking leases, usually paying the one-eighth royalty, though in some instances near the place where the shallow wells are being pumped, they have paid as high as a dollar per acre for the lease, in addition to agreeing to pay the one-eighth royalty.

The oil being found in that section is almost identical with the shallow well oil found in Brownwood, but at somewhat greater depth.

It is useless to talk to any of the oil men about prospecting unless they can get a sufficient acreage under lease to justify it, and the first question asked is, "If we will agree to put down some test wells, how much land can we lease?"

Mr. Johnson thinks that while people are interested in that section, that Brownwood ought to get busy, and get some of those people to come in here and put down some test wells.

We have every surface indication, we have had deep wells put down, some of them known to have been paying producers, but were wrecked for reasons that will never be known.

Local capital in Brady is aiding this in every way possible, one firm paying an expert \$500 a month to engineer the work for them, tell them where to drill and to sublease other land.

While many of our people have grown discouraged over the possibility of finding oil in this section, after talking with many of these oil men, Mr. Johnson says he feels that we have but done a small amount of prospecting, and that while it takes time, he fully believes if proper efforts were made, and accurate records kept of drillings, getting the different dips of the stratus of the earth, that there may without doubt be a large pool of oil discovered in Brownwood.—Brownwood Bulletin.

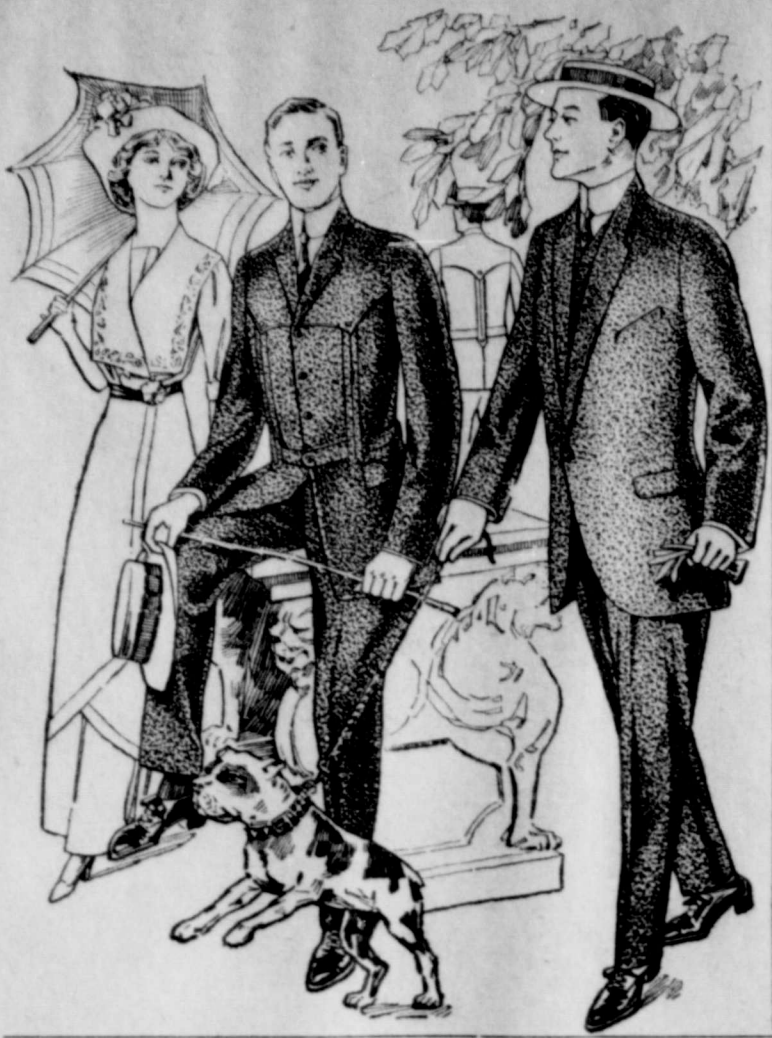

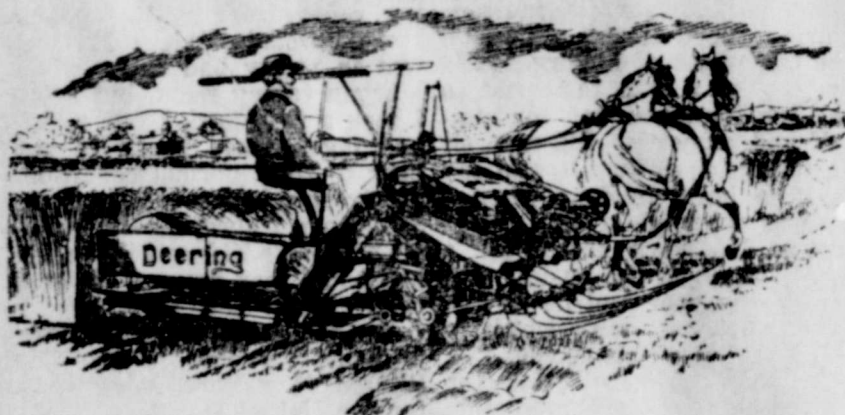

TOM HUNT GUILTY.

Pleads to Second Degree Murder At Lampasas.

A surprise was sprung in the Hunt murder trial at Lampasas last Thursday morning when Tom Hunt, accused of the murder of his brother, Finis, in Lometa on the night of March 11, plead guilty to the charge. The deceased was shot three times with a large calibre gun. Later the gun was identified by the mother of the Hunt boys as a family relic. This and other evidence led to the arrest of Tom Hunt.

The case went on trial Monday, the jury had been selected and witnesses for both the state and defense had testified, when the defendant changed his plea of not guilty to one of guilty of murder in the second degree. There were no arguments, and the judge instructed the jury, turning the case over to them at noon. At 3:00 o'clock the verdict was brought in, and the punishment was fixed at forty years in the penitentiary. Tom Hunt is 22 years of age, while the deceased was 25.

JOINT SPEAKING.

Allison and Rector Addressed Voters Saturday Night.

A goodly number of Brady voters attended the joint speaking of Messrs. Matt Allison and J. K. Rector, Jr., candidates for Representative from the 120th District, at the court house last Saturday night.

Mr. Rector, opening the debate, opposed the initiative, referendum and recall, and favored new court procedure to prevent delays in civil and criminal matters. He also favored local option, but not state-wide prohibition. He made a very interesting talk and favorably impressed his hearers.

Mr. Allison stated that the initiative, referendum and recall was not an issue before the people, and if it should become an issue, it would have to be settled by the people and not by the legislators, in which event he would favor it as a citizen. He also favored facilitating court procedure, and stated that he was a state-wide prohibitionist. He advocated a good roads com-

mission to superintend the building of roads in the various counties of the state, and also the increasing of the funds of the public free schools so as to give high school advantages to all the country districts.

Mr. Rector made a brief rejoinder setting forth his position more fully. Both speakers were well received and their remarks given close attention by their hearers.
