

"One thing that impressed us most of all on the trip is the perpetual anxiety that is felt by the people. We actually believe West Texas people suffer more from anxiety than from the drouths."

We have no fault to find with Brother Cooke's narrative, except that he used the short and ugly word, "drouth" with reference to this country.' So far as we are aware there has been but one "drouth" known to the world, and that was 'way back in Bible times-and in Egypt. We have had a few dry spells in West Texas-this part of West Texas-but drouths are an unknown quantity.


