### IMMENSE CROWD ATTENDS BARBECUE

Visitors Number More Than 5,000 According to a Conservative Estimate---Not a Single Case of Disturbance Reported.

Brady was host (or hostess) yesterday to one of the largest and most orderly crowds ever assembled in this city on any occasion. They came from Mason, San Saba, Brown, Concho, Menard, Kimble and Gillespie counties, as well as from every community in this county. It was one of the most orderly assemblies of the size in the history of Brady, the city marshal and sheriff's department reporting that nothing approaching a disturbance of any kind was had. It was a good-natured, fun-loving crowd, out for a day's pleasure and recreation, and each seemed to vie with the other in making it an occasion long to be remembered by all.

The visitors for the day began arriving early, quite a few coming in Wednesday, and by 9:00

o'clock yesterday morning the business section of the city was crowded with vehicles and pedestrians. A program of speeches lasting from 10:30 to 5:00 o'clock had been arranged by the entertainment committee, and it is estimated that at least 3000 people were on the picnic ground in the beautiful Dutton park when Malor A. C. Baze, who acted as master of ceremonies, arose to introduce the first of the speakers, Judge F. M. Spann of Temple, who spoke for one hour in the interest of the candidacy of Jas. E. Ferguson for governor. He was followed by Hon. O. P. Pyle of Belton, who spoke for Mr. Ball. Both speakers were accorded the closest of attention, and were frequently interrupted by applause.

At the conclusion of Mr.

Spann's 15-minute rejoinder dinner was announced, and the big crowd lined up at the tables, where an abundance of barbecue, bread, pickles and coffee was stacked high. Ladies first was the rule, and it was necessary to reset the 1040 feet of tables the second time before they were all served, 1690 being counted at the first two tables. The barbecue committee had made ample provisions for feeding 5000 people, and, although no complaints of having nothing to eat were heard, although there was quite a number who did not get to the tables at all, and yet every bit of the 3500 pounds of meat and the 2000 loaves of bread was eaten.

After dinner had been served, a short concert by the Brady Booster band was enjoyed, after which Judge Clarence Martin of Fredericksburg was introduced. Judge Martin spoke for one hour in the interest of

Judge M. D. Slator of Llano, candidate for Congress from this district, and his speech was given close attention by the big crowd. He was followed by Hon. Chester Harrison, who spoke for Congressman Slayden. Mr. Harrison took occasion to severely criticize the methods used by some of Mr. Slayden's opponents in this campaign, denouncing many charges made against Congressman Slayden's record as pure fabrications. He was especially bitter in his denunciation of a San Antonio newspaper which has been active against Mr. Slayden.

Candidates for county offices followed Mr. Harrison, being allotted five minutes each in their order.

At 3:30, the time announced for the aeroplane flights by Fred DeKor at the fair grounds, many of the visitors left the picnic

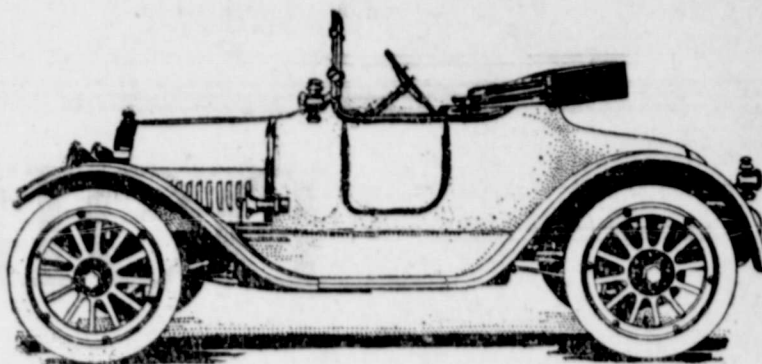
Editor Brady Standard:

### Trades For McCulloch Land.

Manager R. D. Dyer of the McCulloch County Real Estate Exchange, reports having closed a deal last week, whereby R. L. Henley of Stephenville acquires 320 acres of land in the Lohn valley, five miles north of the town of Lohn, the consideration in the trade being \$5,600.00. The land was owned by E. L. Ogden, and is unimproved, although it is said to be located in the most fertile section of the valley and is almost wholly tillable.

In the deal Mr. Ogden becomes the owner of a block of land in Stephenville and a good farm within a mile of the courthouse at that place.

**PROPOSED AMENDMENT TO THE STATE CONSTITUTION, AMENDING ARTICLE XI, SECTION 7A, OF THE CONSTITUTION—PROVIDING FOR THE AUTHORIZING COUNTIES BORDERING ON THE GULF OF MEXICO TO BUILD SEAWALLS.**  
(S. J. R. No. 22.)

**Senate Joint Resolution**  
To amend Section 7 of Article XI of the Constitution of the State of Texas authorizing the counties bordering on the Gulf of Mexico to build sea-walls by adding Section 7a, so as to authorize such counties to build sea-walls and designate sea-wall reclamation districts for the protection of life and property from storm overflow, and to build or condemn land for sea-wall and reclamation districts, the county to have State's title to the roads and bay shore line to low tide within the districts, and the right to issue district bonds for acquiring and developing the district and building the sea-walls, and when district is developed as townsite to sell such portions of the land as not reserved for public use by the county.

**Be it resolved by the Legislature of the State of Texas:**  
That the following amendment to the Constitution of the State of Texas be proposed to the voters of the State of Texas for their adoption in accordance with law, and that the Constitution of the State of Texas be amended so as to add Section 7a of Article XI, and that Section 7a of Article XI shall read as follows, to wit:  
Section 7a. Where protection of against the waters of the Gulf of Mexico is needed for protection of life, health, property or the sea-wall, any county bordering on the Gulf of Mexico may acquire title to the land for said sea-wall or sea-wall reclamation district as designated by the county Commissioners' court by purchase or condemnation of all the land desired for sea-wall and land for the sea-wall reclamation district from the sea-wall to bay shore tide line boundary of the property abutting on the bay, and the State hereby cedes to the county, for such district, for reclamation and general uses of the district, the title to bay shore lands in the district between the property tide line boundary and the low tide line of the bay shore, and any land in the reclamation district that may have been retained by the Republic of (or) the State for roads when the lands adjacent were platted and sold, and the county is given the right to dredge in the bay or gulf for fill for the district, and right to sell the land when reclaimed and laid off as townsite or otherwise, and where condemnation is used to acquire the land the proceedings to be as under the Statutes for condemnation for railroads, provided that the condemnation shall vest the title in fee in the county, and county may issue bonds or other evidence of district indebtedness for acquiring the property, building the sea-wall, reclamation developments and all incident thereto as expenses of sea-wall and reclamation district, with lien on land and such terms and conditions as county, through its commissioners' court may deem best, and the county commissioners' court shall appoint two persons who are owners of land within the district, and who desire to sell for reclamation and buy back from the county when reclaimed, who, with the county judge as chairman, shall continue a sea-wall reclamation district commission, whose compensation shall be fixed by the court, and this commission has power to make all rules and regulations for acquiring the land of district sea-wall building, reclaiming and platting land of district, issuing bonds or other evidence of indebtedness for same, subject, however, to all such rules, regulations and acts of the commission being authorized and approved and ratified by county commissioners' court. The district must bear all expenses of sea-wall and purchase of the land and expense of filing (filling) same and other expenses, and the same shall not in any way involve the county or be a basis for a tax by the county on general lands of the county unless authorized by a vote of two-thirds of the property taxpayers of the county voting at a special election thereof. It is further provided that any owner of land in a proposed district may subscribe and pay for the district commission, when organized, as the pro rata of his land of the expense of the wall, reclamation, platting as town lots on a basis as such area of land is to be the whole land of the reclamation district and sea-wall, and at any time before the completion of the district may surrender the bonds and receive from the county a bond title for his land in town lots, less streets and alleys deducted therefrom, for which on surrender deed may be demanded from the county after the district is walled, filled and platted into streets, alleys and lots, and bonds so bought shall so provide. It is further provided that no district shall be formally designated by the county commissioners' court until owners of at least one-half of the proposed area of district petition thereof and subscribe out for bonds for repurchase from the county as herein provided. This amendment may be acted on without delay of legislation in aid thereof or legislative action may be had in furtherance thereof if desired by the county acting through its commissioners' court.

**Be it further resolved by the Legislature of the State of Texas:**  
That the foregoing proposed amendment to the Constitution shall be submitted to the qualified voters of the State of Texas for their ratification and adoption at an election to be held throughout the State on the second Tuesday in November, A. D. 1914, and at such election those favoring the ratification and adoption of said amendment shall have written or printed on their ballots: "For the amendment to Article XI, Section 7a, of the Constitution providing for the authorizing counties bordering on the Gulf of Mexico to build sea-walls;" and those opposing the adoption and ratification of said amendment shall have written or printed on their ballots: "Against the amendment to Article XI, Section 7a, of the Constitution providing for the authorizing counties bordering on the Gulf of Mexico to build sea-walls." 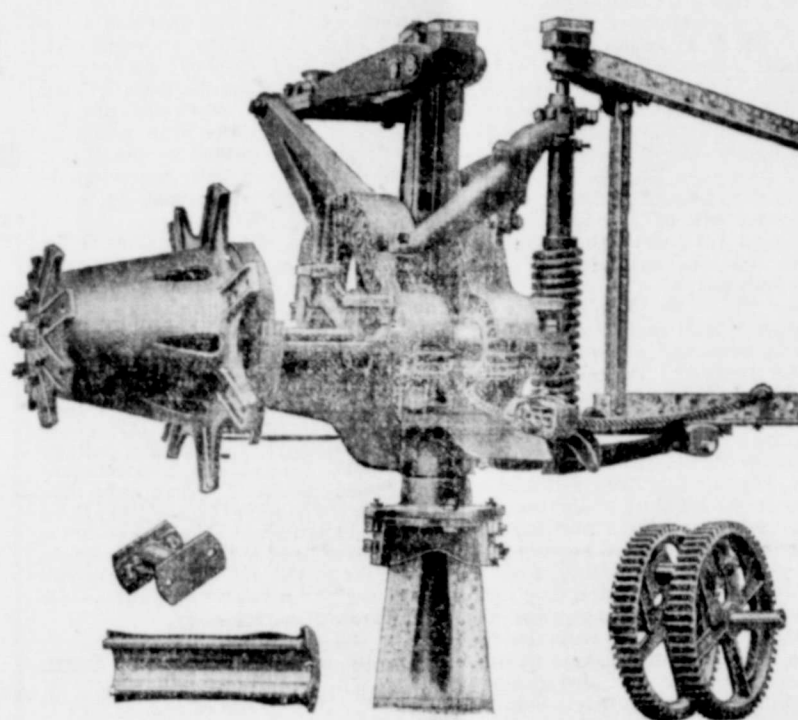

# WAR REMINISCENCES

## TALE OF WINCHESTER BATTLE

Col. Mulligan Met Death During Fight Near Winchester—Several Thrilling Incidents Told.

Comrade B. M. Clayton, Twenty-sixth Ohio, speaks of a fight near Winchester as happening July 20. It was the first or second Sunday in August. The command I was in was on its way back from the battle of Monocacy Junction, near Frederick, Md., through Virginia. We crossed the Shenandoah river near Snicker's Gap, and there got with Mulligan's brigade and the First New York cavalry, which was very good company, writes Wm. C. Eckman of Atlantic City, N. J., in the National Tribune. We went around Winchester and struck the pike at Kernstown on Saturday.

The command to which I belonged was a detachment of Cole's Rangers, under Captain Link. He was in the advance. The First New York cavalry did picket duty that night. On Sunday many were cheated out of breakfasts. Just at that time that old familiar call, "Boots and saddles," sounded. The rebs had sighted us, and opened fire on us with three small guns. We were ordered to charge. We drove them back, but we did not get back to our breakfast. That started the fun for the day. We had a few chargers and skirmishers with Cole's cavalry.

About 3 p. m. the enemy came out of the woods on our left and front, and it was there that Colonel Mulligan was killed and left in the hands of the enemy. He and Captain Link were leading us and the First New York cavalry, but the rebs were too much for us. I did not see any other command but Mulligan's and Cole's men.

On Wednesday of that week some of Captain Link's men escaped, and Mrs. Mulligan, under a flag of truce, went through the lines to Winchester and brought her husband's body to Martinsburg. We covered the retreat through Winchester on the north of town. I was sent along with 25 or 30 men out behind a stone fence to hold the rebs in Winchester until General Averill's cavalry came from Berryville. But we were cut off between the two lines. We had a guide with us, and he led us through woods and brush and swamps till we struck the old dirt road to Mar-

tinsburg. It was night then, and we had not had time to eat our breakfast yet. It was a beautiful moonlight night, very quiet. Lieutenant Wesley Mann was in command. We came in contact with a squad of Imboden's cavalry, and I had my horse killed. Cole's Rangers came in, well armed. I ran along a deep gully until I thought it safe, then I came out. I was not long without a horse. My new mount was an old swaybacked horse, but nevertheless she took me to Martinsburg. I got there Monday about 7 o'clock. I had had nothing to eat since Sunday night except a few pieces of hard-tack. Early's men were leaving there, and I slipped through to Williamsburg, Md., and there I found my comrades. They thought I had been killed or captured.

### Change for the Worst.

Some boys of a Michigan cavalry regiment, revisiting the scene of a scout near the line between Virginia and North Carolina, came to a Cracker's home, which formerly stood within the state of North Carolina, but which, owing to the relocation of the boundary line, was then in Virginia. One of the boys asked the old lady how she liked living in Virginia. She replied:

"Don't like hit. 'Tain't healthy like North Cay'lena. Never used to have no rheumatics; now I got 'em all th' time."

### Japanese Ration.

The rations for a day provided by Japan for each of her soldiers in the field are three little bags of rice and a bunch of dried vegetables. This means rice for all three meals and a vegetable addition for dinner.

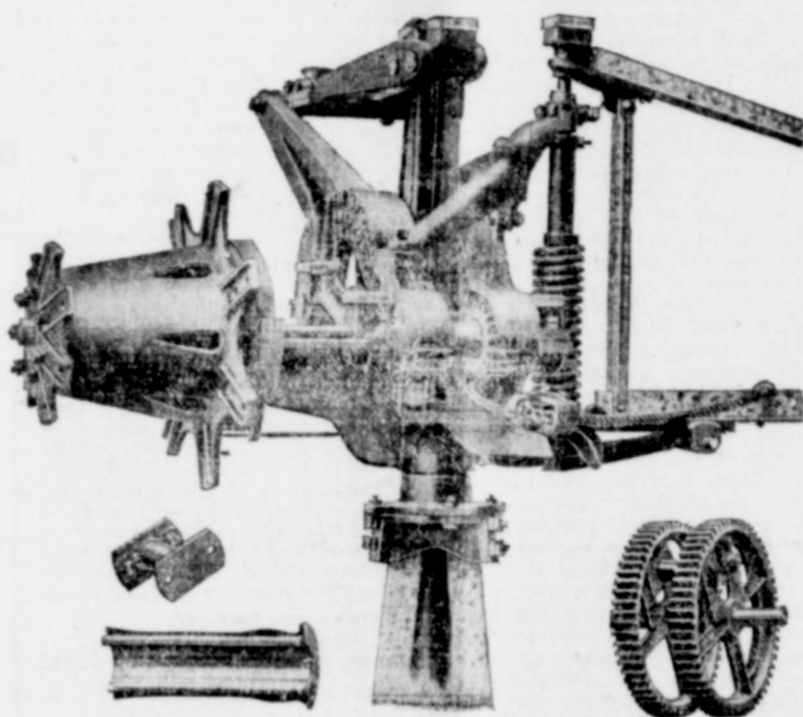

**TALE OF WINCHESTER BATTLE**

Col. Mulligan Met Death During Fight Near Winchester—Several Thrilling Incidents Told.

Comrade B. M. Clayton, Twenty-sixth Ohio, speaks of a fight near Winchester as happening July 20. It was the first or second Sunday in August. The command I was in was on its way back from the battle of Monocacy Junction, near Frederick, Md., through Virginia. We crossed the Shenandoah river near Snicker's Gap, and there got with Mulligan's brigade and the First New York cavalry, which was very good company, writes Wm. C. Eckman of Atlantic City, N. J., in the National Tribune. We went around Winchester and struck the pile at Kernstown on Saturday.

The command to which I belonged was a detachment of Cole's Rangers, under Captain Link. He was in the advance. The First New York cavalry did picket duty that night. On Sunday many were cheated out of breakfasts. Just at that time that old familiar call, "Boots and saddles," sounded. The rebs had sighted us, and opened fire on us with three small guns. We were ordered to charge. We drove them back, but we did not get back to our breakfast. That started the fun for the day. We had a few chargers and skirmishers with Cole's cavalry.

About 3 p. m. the enemy came out of the woods on our left and front, and it was there that Colonel Mulligan was killed and left in the hands of the enemy. He and Captain Link were leading us and the First New York cavalry, but the rebs were too much for us. I did not see any other command but Mulligan's and Cole's men.

On Wednesday of that week some of Captain Link's men escaped, and Mrs. Mulligan, under a flag of truce, went through the lines to Winchester and brought her husband's body to Martinsburg. We covered the retreat through Winchester on the north of town. I was sent along with 25 or 30 men out behind a stone fence to hold the rebs in Winchester until General Averill's cavalry came from Berryville. But we were cut off between the two lines. We had a guide with us, and he led us through woods and brush and swamps till we struck the old dirt road to Mar-

tinsburg. It was night then, and we had not had time to eat our breakfast yet. It was a beautiful moonlight night, very quiet. Lieutenant Wesley Mann was in command. We came in contact with a squad of Imboden's cavalry, and I had my horse killed. Cole's Rangers came in, well armed. I ran along a deep gully until I thought it safe, then I came out. I was not long without a horse. My new mount was an old swaybacked horse, but nevertheless she took me to Martinsburg. I got there Monday about 3 o'clock. I had had nothing to eat since Sunday night except a few pieces of hard-tack. Early's men were leaving there, and I slipped through to Williamsburg, Md., and there I found my comrades. They thought I had been killed or captured.

Some boys of a Michigan cavalry regiment, revisiting the scene of a scout near the line between Virginia and North Carolina, came to a cracker's home, which formerly stood within the state of North Carolina, but which, owing to the relocation of the boundary line, was then in Virginia. One of the boys asked the old lady how she liked living in Virginia. She replied: "Don't like hit. 'Tain't healthy like North Cay'lenia. Never used to have no rheumatics; now I got 'em all th' time."

The rations for a day provided by Japan for each of her soldiers in the field are three little bags of rice and a bunch of dried vegetables. This means rice for all three meals and a vegetable addition for dinner.

### Interurbans Attract Attention

Dallas, Texas, July 21.—The Electric Railway Journal, a publication with a national circulation, is publishing a series of articles on Texas and her interurban lines, and in a recent issue devotes considerable space to the Dallas-Waxahachie-Waco line of the Southern Traction Company. This road is 151 miles long and is by far the longest in Texas, and also has a greater mileage than any other interurban system in the south.

The article states that interurban building in Texas begun in 1900 with a 10½ mile line between Denison and Sherman. This was followed two years later by a 35 mile line between Dallas and Fort Worth. The first interurban construction in Texas on a large scale, however, was in 1906, when the laying of steel on a 75 mile line between Dallas and Sherman was started. Texas now has 550 miles of interurban lines, 215 miles of which were constructed in 1913, which were constructed in 1913, ban building last year and all but two of the principal cities of the state now have interurban connections.

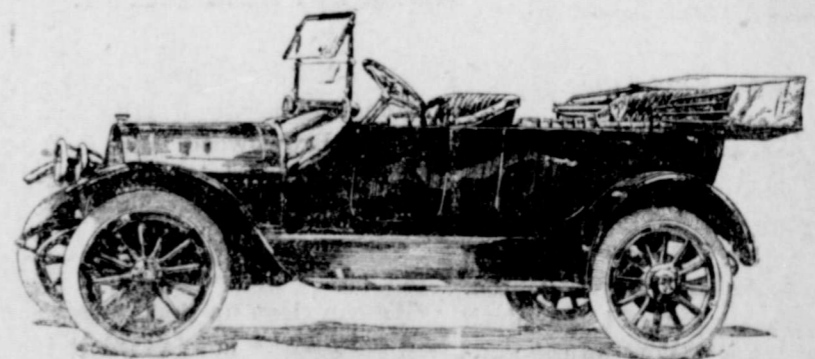

### Hogs An Aid to The Farmer

Mr. Edwin Houston of Wellfare, Texas, a member of the advisory board of the Texas Industrial Congress, and president of the Texas Swinebreeders Association, is an enthusiastic believer in the value of hog raising on the farm and has written to the Congress as follows:

"Some people farm for the love of nature, and some for amusement and glory that they get out of it, but almost everybody farms in order to make a living. This last class,—the farmers of and by necessity are the ones I appeal to.

With them, how to clothe,

feed and educate their families are the prime factors of their life. The grocery bill is their greatest expense and pork or its products, is the largest single item on this bill. If each family will produce its own pork it will materially increase its prosperity.

This can be done, too, with very little trouble and at only a nominal expense, if all the kitchen scraps, damaged grain and other waste products of the average farm are used for this purpose; and at the same time a small piece of tillable land is set aside and fenced for a hog pasture.

A good way to try out the hog business and at the same time a sure way to get a year's pork supply for nothing is to fence about one acre of land hog-proof, also cross fence it so as to make two half acre lots. In these put a small portable hog-house of some kind and plant the lots in whatever crops will make the surest and most abundant pasture in your locality.

If the right crops are used, green foliage of some kind will be in one or the other of these pastures all year round.

A good pure bred sow should be bought and she will raise her owner two litters of big, strong pigs each year. With plenty of green pasture and waste from the kitchen and a very little grain, the sow and litter can be well cared for. Then, if the pigs are fed heavily on grain from the time they are six to eight months old they will be ready either for making the finest home-cured bacon, hams and sausage or to top the local market.

It is usually more convenient to keep your spring litter for your own killing in the winter and sell the fall litter the following spring or early summer. In this way your fall pigs will bring you a hundred or more dollars in cash which will more than pay for running your hog department and you will have the spring pigs left for your year's meat supply.

I have not considered one sow and her profit in order to discourage those who would keep more than one, but because there is no farmer in Texas that can afford to be without at least one. Then another thing, the greatest mistake that is made by the average man starting in the hog business is that he starts with too many before he knows much about the business.

The Texas Industrial Con-

gress is doing splendid work along this line by inducing farmer boys to take one barrow each and feed it and keep careful record of gains made and the cost of these gains. If these boys learn how to make a good profit on one barrow they will soon be able to do the same thing with a lot of them.

Texas imported last year over \$24,000,000 worth of pork products from other states. Is there much honor in our boast, of raising a third of America's cotton supply when we have to trade it off to the other states for pork, especially as cotton is ruining the farms of the South and hog raising is making "corn belt" farms richer.

No state in the Union has as many natural advantages for hog raising as ours and Texans are too much alive to let these opportunities go by. The only question is how long will it take us to learn?"

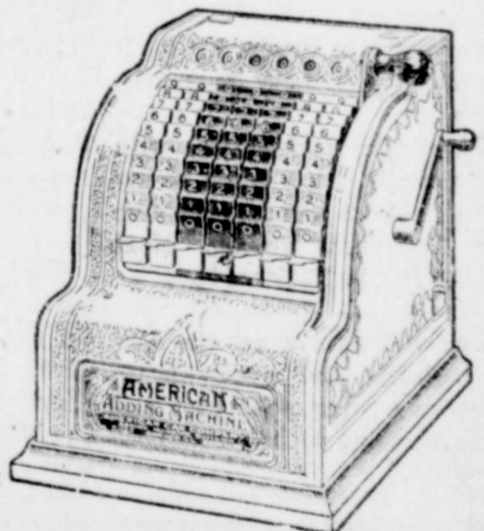

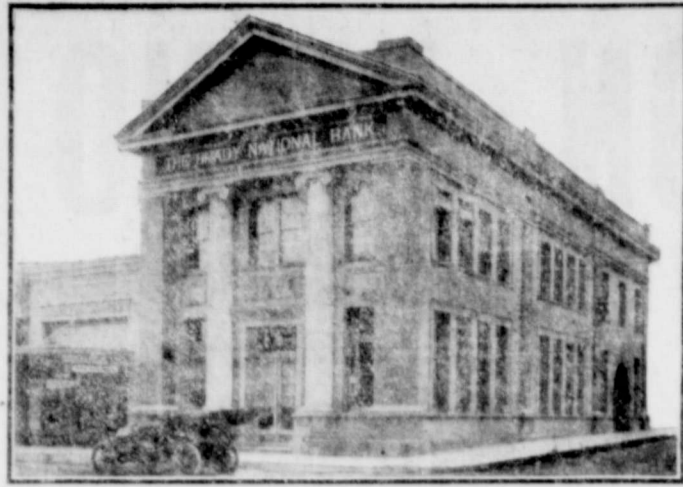

About twenty members were present, and the meeting was enthusiastic and harmonious.

The constitution and by-laws presented by a committee which had been appointed at a previous meeting to draft same, was adopted unanimously.

The temporary officers which were named at the meeting of June 9th were named to serve for the ensuing year, and are as follows: S. M. Richardson, chief; Ben Moffatt, assistant chief; W. E. McKenzie, secretary and treasurer.

The action of the chief in signing a contract with the Dyer Amusement Co. was ratified by the department, and he was authorized to appoint all necessary committees for the successful handling of the carnival.

The second Tuesday night of each month was selected as the time for regular meetings of the department, and the next meeting will be held Tuesday night, August 11th.

### Barn Burned.

Fire Tuesday afternoon completely destroyed A. J. Priddy's big barn a few miles north of the city on the Santa Anna road. The family was not at home at the time of the fire, and the building was a mass of flames before being discovered by neighbors.

The building contained between 3000 and 4000 bushels of oats, as well as a quantity of other feed stuff and farming implements, all of which was destroyed, with the exception of a few hundred bushels of oats. A large stack of maize near the barn was also burned.

The origin of the fire is unknown. The loss on building and contents is estimated at \$3000, with no insurance.

### DISASTROUS FIRE

#### THREE BUILDINGS COMPLETELY DESTROYED

Loss of Approximately \$15,000 Sustained—Brady Auto Co. Heavy Losers.

Fire which was discovered at 2:00 o'clock yesterday morning completely destroyed the big building occupied by the Brady Auto Co., a barn and the building recently vacated by the Brady Bottling works, together with their contents. The total loss on buildings and contents will probably reach \$15,000.

The origin of the fire is unknown, but it is thought to have originated by someone smoking in the barn earlier in the night and carelessly throwing down a match or cigar. When discovered the flames were just breaking through the walls and roof of the building. The alarm was quickly sounded, but by the time the firemen arrived the flames had spread to the big garage which joins the barn on the west, and to the small frame building formerly occupied by the Brady Bottling works on the east.

The garage was one of the largest and best equipped in this section of the state and carried a large stock of cars and accessories. At the time of the fire the company had no cars whatever on hand, but the stock of accessories probably amount to \$4000 or \$5000. In addition to this, the company suffered the loss of their repair shop which is one of the best equipped west of Fort Worth, and which will bring the company's loss up to \$6000 or \$7000.

There were ten or twelve cars stored in the building, and eight or ten of the number were almost completely destroyed. These cars belonged to customers, and most of them were of little value. Judge Clarence Martin of Fredericksburg lost a practically new 1914 model Oakland, valued at \$1500, while, according to manager Hallum of the Brady Auto Co., the combined value of the other seven cars would not exceed a like sum. Those losing cars were Walter Caldwell, Judge Clarence Martin, Julius Levy, Jordan & McCollum, Mrs. J. E. Thompson, C. W. L. Schaeg, Frank Hurd and B. A. Hallum.

The building occupied by the garage was the property of W. D. Crothers, D. F. Savage and Mrs. J. E. Thompson of this city, and was valued at \$4500, while the barn and bottling works building was owned by Mr. Crothers. Insurance amounting to \$1000 was carried on the former and \$600 on the two last named. No insurance was carried on the stock of the auto company, it having been impossible to secure protection on this class of risks up to a short time ago. The bottling works building was unoccupied. A few bales of hay was stored in the barn, which was used by John Shock-

ey, where he kept his saddle horse. The animal was in the barn when the fire was discovered, and it was with considerable difficulty that he was gotten out of the burning structure.

The work of the fire department was seriously handicapped by lack of sufficient hose with which to combat the flames, and had it not been for the fact that there was no wind whatever blowing, the loss might have been much greater. The highly inflammable contents of the barn, together with the oil-soaked timbers of the garage building made the fire one of the hardest to control. Other dangers to the firemen and spectators were occasioned by the explosion of Presto-Lite tanks and hand fire extinguishers in the building. One of these was thrown at least 100 feet in the air when it exploded, but fortunately it fell back almost onto the same spot where it was lying originally.

A small sheet iron building just north of and adjoining the garage was also destroyed, along with its contents. This building was occupied by G. P. Moore's tin shop, who estimates his loss on stock and tools at \$100.

The owners have definitely decided to rebuild, and have already begun clearing away the debris from the lot, and will let the contract for the new building in a few days. The material for the new structure has not been decided upon, but will very likely be of brick or concrete and fire-proof throughout.

The Brady Auto Co., has arranged for temporary quarters in the building occupied by H. P. Roddie & Co., where they will have ample room and will have a new stock of accessories in tomorrow. Manager Hallum and the company is to be congratulated upon their enterprise in re-establishing their business at this early date, and in their efforts to take care of the wants of their customers in their usual satisfactory manner.

Mr. Moore has not yet decided whether he will re-enter business or not.

Before taking any action in the matter, the commissioners court of McCulloch county is desirous of knowing the sentiment of the citizens of the county with reference to the employment of a farm demonstrator for the coming year, and would ask that petitions for and against such employment be circulated and presented to said court at its August term.
