



The Brady Chamber of Commerc has been advised by the Traffic committae of the West Texas Chamber of Cemmerce, that the "Common Point" has been retained, thereby again removing the danger that the loss of this "Common Point" would result in higher freight rates throughout this section of Texas. The following letter addressed to Wm. D. Cargill, secretary of the local Chamber of Commerce, sets forth the final decision of the Interstate Commerce Commission upon this subject:

"Examiner William A. Disque of the Interstate Commerce Commission, in the hearing held in San Antonio, February 12-15, 1923, in which the Common Point was involved, by mutual agreement of the contesting parties, preserved the Common Point. Our Traffic Bureau intervened in this case, tho' we never did believe there was much likelihood of danger in the case. As we pointed out several times, the Texas Railroad Commission thru Rate Expert Hudnall, our own Traffic Committee, and other leading Traveling men contended that the Oklahoma Case would break down at San Antonio. It did.

About \$4,000 is to be spent in improvements and extensions of the Brady exchange of the West Texas Telephone company, according to a statement in the news columns of the Brownwood Bulletin. This expenditure will represent the one-tenth part of the total budget of \$40,000 appropriated by the company. Of the total, \$8,500 is to be expended in the city of Brownwood, where 10,000 feet of lead-covered extensions have feet of lead-covered extensions have become necessary. Ballinger is not included in the 1923 budget that city having been taken care of last year. having been taken care of last year, and now boasting one of the best ex-changes and systems of service in the Central West. About \$2,500 will be expended at Winters, where 3,500 feet of lead-covered cable extensions have become necessary.

The Brady exchange calls for about 2,000 feet of new lead-covered cable in the way of extension, and there is also considerable replacement and improvement on the program for this part of the country. About \$4,000 will be spent for these purposes at Brady.

Improvements at Coleman are mostly in the nature of pole requirements, the replacement and improvement totaling about \$2,500.
