New WIU rates set by PUC

New rates for West Texas Utilities Co.'s retail customers have received final approval of the Public

Winters' tax receipts up 86.58 per cent

The City of Winters has received a check for \$6,544.47 for local tax payments. The checks are sent monthly to the 980 Texas cities that levy the one per cent sales tax. The checks were for taxes collected on sales made in November and reported to Comptroller Bob Bullock by December 20.

Last January, Winters received \$3,507.55. This year Ballinger received \$9,799.06, compared to \$5,608.18 for last year. Miles did not receive a check. Last year their check totaled \$711.12.

Winters' receipts are running 86.58 per cent ahead, while Ballinger's are 74.73 per cent ahead.

About the state's tax payments, State Comptroller Bullock stated, "These checks are up a whopping 39.5 per cent over last January's payments. A big part of that increase came because 15,000 taxpayers who previously only paid taxes four times a year started paying every month and we got their money back to these 980 city halls that much quicker. But some of the increase is due to the economic recovery we're seeing in Texas."

Bullock explained that the 15,000 quarterly taxpayers were converted to monthly payers as part of a program of the last Legislature to get more money into the state's coffers without increasing taxes.

Some other area cities and the amounts of their checks are as follows: Tuscola \$519.62, Abilene \$456,983.63, San Angelo \$264,375.87, Buffalo Gap \$693.58, Brownwood \$46,817.93, Coleman \$18,015.36. All of these cities except Buffalo Gap showed increases over last year.

The rates are designed to provide an annual revenue increase of \$11.97 million. The company, in its rate request filed last June 10, had asked for \$26.5 million.

Although the change means a 5.2

per cent increase in total retail rates, the current effect will be a decrease for customers who have been paying temporary rates the past 21/2 months. Deputies said that a warrant is still outstanding for Larry Ray Freuh in connection with the incident.

Investigators said that the two men had gone to work for Two Rivers Construction Company of

Odessa last week and were members of a work crew working in the Winters area and staying at a Winters motel. Reports said that the pick up was taken sometime between 1:00 a.m. and 4:00 a.m. last Saturday morning after the two were thought to have taken the keys from the pocket of a fellow employee while he was asleep. Also taken were several personal items including clothing, a radio and about \$150 in cash.

Jasper County officials stopped the pick up and learned that the vehicle was reported stolen here. Officers said that southeast Texas officers had been alerted after it was learned that at least one of the men had a Vidor address.

Stark is being held in the Runnels County Jail on the charges.

Council ponders sewer rate increase

The Winters City Council Monday gave thought but took no action on an increase in the rates charges for sewer service in the City of Winters. The rate increase is being considered as a means to cover the cost of the construction of the new wastewater treatment plant to be built soon.

The new sewer plant will put the city another \$80,000 in debt and for the city to repay the bonded indebtedness the rate may very well have to be increased. The council is expected to take action on the matter in its regular session next week.

To go along with the proposed increase in sewer rates, the council formally readopted an ordinance authorizing the issuance of \$80,000 in certificates of obligation for the sewer plant. The readoption was requested by financial advisor Joe Smith in order to get all members of the council to sign the ordinance.

As a routine item the council gave approval to the new rates for West Texas Utilities, as established by the Public Utilities Commission.

Pam Conner was nominated by the council to fill a vacancy on the board of directors of the Runnels County Appraisal District left by the death of Drury Hathaway.

Council member June Hays was named to serve on the board of the Winters Housing Authority for a three year term. J.W. Bahlman was also named by the council for that board.

In her annual report on the Hous-

ing Authority, Vera LaFoon said that everything was in good condition with the housing project. She told the council that there were plans for additional landscaping for this spring and that she was going to check into the possiblity of securing funds for additional housing units.

Before ending the meeting the council formally accepted the resignation of City Administrator Glenn Brown. Brown's letter of resignation was read to the council in its last meeting of last year but no action could be taken at that

Brown is resigning in order to accept the position of assistant city manager in Kerrville.

Commissioners approve 1978 election

The Runnels County Commissioners Court, in their regular meeting Tuesday, canvassed and declared official the returns of a 1978 election and granted approval to a request from the Internal Revenue Service to plug into the computer that maintains the county tax rolls.

In canvassing the returns of that 1978 election, the commissioners declared official an election that consolidated the Buffalo Gap Schools and the Jim Ned Consolidated In-

dependant School District. County Judge Michael Murchison said that the Jim Ned School District covers about 400 acres of land in northern Runnels County. At the time of the consolidation election, there were no polling places in Runnels County and the returns of that election were canvassed and declared official by the Taylor County Commissioners Court. Murchison said that it seemed that no one was aware of a portion of the district in question being in this county

because no one voted in Runnels

The issue was prompted by a recent bond election in the Jim Ned Consolidated Independent School District and the need for that election to be official.

The Runnels County Commissioners quickly gave their approval to the canvass which allows the JNCISD to get on with the business of improving their school district.

In other action, the commissioners approved a request from Western Data, the computer firm that maintains the county's records on computer, to allow the Internal Revenue Service to plug into the computer for imformation from the county's tax rolls and other

information. The court noted that the IRS had access to the information already, by written request, and that to allow it (IRS) to plug into the computer would not change anything. The commissioners also noted that with written notification the permission

could be revoked.

The commissioners approved the Calendar of County Expenses and Operations for 1984. Everything on that calendar, according to Judge Murchison, had already been approved in the 1984 Runnels County Budget.

Three new members were appointed to the Runnels County Salary Grievance Committee from the Grand Jury list. Those ap-(See County page 8)

or older, or anyone married to someone 60 or older. Donations of \$1 are taken in the serving line; younger people must pay \$3. The reason for the latter price, according to Mrs. Bennie, is to avoid taking business away from the local restaurants. The meals actually cost about \$3.55 to prepare.



Big Game Hunter Nears Goal

A home town boy is well on the way to reaching his goal in the unusual hobby of big game hunting. He has already collected 16 animals of the 28 species recognized as big game in North America.

Don is the son of Mr. and Mrs. Earl Roach and now lives in Fort Worth. He began hunting outside of the United States when he took his first trip to British Columbia in 1978. Since then he has been to British Columbia five times, to Alaska twice, and once each to the Yukon Territory, the Northwest Territories and Quebec. In March Don went to the North Pole and lived on the Polar ice cap for 16 days while he was hunting Polar bears. His only companion was the Eskimo guide who also drove the dog sled on which they traveled. They were about 150 or 200 miles from their base at all times, which was on the Artic Bay of Baffin in the Northwest Perritories of Canada, about 100 miles from the magnetic North Pole.

When they were not traveling, the two men spent

their time in hunting and building an igloo each day to sleep in that night. "It was about 10 degrees warmer than outside," Don said.

Food for men and dogs must be provided each day. Their diet consisted mostly of raw seal meat, raw fish and raw caribon. Seals were caught by standing over their breathing hole in the ice until they come up and then they were speared. Raw seal liver is the Eskimos greatest delicacy. Don said that he ate some of the food raw from necessity. A Coleman stove was their only way of cooking and it was used principally in melting snow

for drinking water. Beds in the igloo were made of dried Caribon hides. The first hide was placed with the hair down to the ice and the second with the hair up, this made a warm bed. Don was provided with Eskimo dress of Caribon wind suits and parka wind pants made out of winter Caribon. The footwear was called "Camic" and consisted of three layers all the way to the knees. Inside was summer Caribon with the hair in. The next layer was winter Caribon with the hair out, and covered with seal skin for water proofing. (There is a great difference between summer and winter Caribon). These must be worn on bare feet. If socks are worn the feet will freeze immediately. The mittens are made of seal skin and come all the way to the elbows. The Eskimo wears nothing on his face but Don said that he wore a ski mask when the wind was really blowing.


The Eskimo spoke little English and Don none of the Eskimos' language, but he said there were other ways of communicating - especially when your life depends on it. The life is harsh and the Eskimo lives completely off of nature. He takes the snow to rub the sled runners which freezes immediately and makes them slick as glass. A piece of tin with holes in it is used to smooth the rough

The last five or six days of the trip were spent in total daylight. On the 14th day Don killed his polar bear. It measured 81/2 feet and weighed between 8 and 900 pounds. He plans to make it into a rug.

Each Eskimo village has a Hunters and Trappers Association and each village is allowed only four permits a year. Hunting arrangements were made through the HTA and measurements sent ahead so that the Eskimo women could have the hunting garments ready. They are hand sewn after the hides have been tanned with urine, their only source of tamic acid. Don said that everything was fine about his suit except the camic which were too tight, but the women took care of this by chewing the hides to soften and stretch them.

Travel, itself, in getting to the hunting area - a distance of 6000 miles - is quite an adventure. There are only two flights a week out of Montreal. Don and a hunter from West Virgina took the flight to Frobisher Bay - 2000 miles - and they were having a "white out." The airline set seven hours for the weather to clear and when it didn't they returned to Montreal. The hunters waited three more days for another flight.

After Don returned home he presented a slide show in Dallas to the Safari Club. He called it "The Grand Slam of North American Bear." In addition to the polar bear he had killed three others: the black and grisly in British Columbia and the Kodiak in the Alaskan Peninsula. The first two have been made into rugs and the third was mounted life size. It was 10 feet tall.



Don said he liked to travel because he sees things and meets super people. His most recent trip was in October when he was hunting up the Peace River in British Columbia, where he bagged a trophy size moose and a stone sheep. "Moose and sheep meat are the best," he said.





A sidelight of this last trip was an encounter with a bear when Don and his guide were traveling up the trail

with their three pack horses. They met this grisley and he attacked them which spooked the horses. Don was off his horse and on the ground. He had to shoot the bear three times with a light Caliber gun before he brought him down. The grisly was just 20 steps away when he died. He was an eight footer but Don didn't have a license for bear - so the guide got him.

In addition to the four bears, Don has killed a white tail deer, mule deer, antelope, elk, mountain lion, two sheep, two moose, two caribon, an artic wolf and a wolverine but it is not recognized. Among other animals, Don has to get two more sheep to reach his goal.

He said that sheep hunting is extremely difficult crossing rugged country on foot and climbing mountains daily - it is a young mans game and he hopes to reach his goal by the time he is 50.

Don graduated from Winters High School and left here in 1957 to enter the air force. Later he enrolled at the University of Texas and graduated in 1964. He then established the General Aviation Industries in Fort Worth, where he has been in business for 20 years. He maintained an outlet factory here until the early 70's.

Don is married to the former Carolyn Gerhart of Winters. They have two children, Mark and Shannon, A.U.T. freshman. There are two grand-daughters.

Gas utilities asked to give customers time

Railroad Commission Chairman Mack Wallace has called on all of the state's gas utilities to give customers extra time to pay their December gas bill if they ask for it.

In a letter to the chief operating officers of some 60 gas utility companies in the state, Wallace said, "Texans across the state endured the severest winter weather in more than 50 years...because of the severity of the cold and the need to stay warm, some Texans may have difficulty in paying their December gas bills.

"I would recommend that customers who request extra time to pay their December gas bill be granted as much time as is reasonable," he continued. "Termination of service should be avoided wherever possible, especially during these potentially winter devastating months." Wallace observed procedures.

fort on your part would further demonstrate that Texans are willing to help each other in an emergency and in times of crisis," he said.

Wallace commended the utilities for implementing assistance programs to help prevent the cutoff of heat to elderly or needy customers. He cited as examples Entex, Lone Star Gas Company, Energas, and Southern Union Gas Company, which he said responded to the call he issued last year with a variety of heating assistance programs for disadvantaged consumers in their service areas.

Most of these programs are being continued through this winter, he added.

"A preliminary review of these programs shows that in excess of 5,000 families throughout Texas were helped with more than \$370,000 in voluntary that some utilities have contributions from gas already begun such companies, their employees, and customers," he

The time for filing comments and views has expired, and the application and all comments received have been considered in light of the factors set forth in section 3(c) of the Act (12 U.S.C.

Section 1842 (c)). "Applicant, controlling one banking subsidiary with aggregate deposits of approximately \$37.4 million has applied to acquire Bank (\$7.5 million in deposits). Monday's delicious meal consisted of hamburger goulash, mashed potatoes, green beans, cornbread made from scratch (it would melt in your mouth), peaches, and a choice of milk, tea, or coffee.

Ola Myers and Marguerite Russell, the cooks, make their own rolls, loaves of bread, corn bread, and even the buns for barbecue on a bun. "We have never bought a loaf of light bread but twice, and we're proud of that record," emphasized Mrs. Bennie.

Funding for the program comes from various sources: the City of Winters provides much of the financing, since they pay all the utility bills for the building, which is kept at a temperature of about 72 degrees year-round. The city also pays for the upkeep on the van, which is driven by Marie Allen, outreach worker.

The federal government pays for the groceries, based on the number of meals served. Usually over 100 people eat at the center on serve, with Wednesday being the busiest day, for unknown reasons, Mrs. Bennie said.

The county also helps in support of the Winters Nutrition Program, which is a part of the Runnels Aging Services Program.

The center began operation in the present building which was donated by the Humble Oil Company around 1965. Originally the only activity was a Friday night recreation program.

When the center needed money to expand, the city and federal governments helped, and the building trades class of Winters High School built the annex, which was needed due to increased attendance at the meals. The structure is proudly shown off by the



Guns, coins displayed at Z.I. Hale Museum

A wide range of guns from the Spanish-American War up through World War II were displayed at the gun and coin show held at the Z.I. Hale Museum Sunday.

A set of three U.S.A. Army Springfield Rifles Model 1873 were discovered inside the walls of a house being torn down at Lamesa, Texas in 1964. It is presumed they were placed there when the house was built in 1892. One gun was called a Trowel bayonet - a tri-fold experimental-which included the features of a regular bayonet, an entrenching tool and a trowel, to be used by soldiers who built the forts in the Southwest. Another rifle was used by the U.S. troops in Cuba during the Spanish-American War.

Later model guns were a 25 caliber made in Italy in 1957, a U.S. flare pistol, 1 11/16 guage, used by the United States Army artillery units in World War II, also a USAAF flare pistol, 1 11/16 guage, dated

1943, used by the U.S. Army Air Force B29 crews that bombed Japan during World War II.

The most unusual was a NA 21 Walther flare pistol dated 1941. This pistol was found under the back seat of a Mercedes Limousine frequently used by Joseph Goebbels, Adolph Hitler's minister of propaganda.

Coins included a set of 22 found in the basement of a bank of Korea in Seoul, after units of 1st Marine Division liberated the city from Communist forces during the Korean War.

Other phases of U.S. history were recorded by the Lincoln Memorial coins, the U.S. 20th century coins, the silver story which ended in 1964, and war time coinage.

The next open house at the museum will be held February 12, with a theme of "The Music Goes'Round and 'Round." John Glenn Key will be the exhibits' director. The regular business meeting will be held at 5 p.m., Tuesday, February 7.




