## Nolte sentenced, fined, house seized

Randy Nolte, convicted of 12 different counts of child sexual molestation, was sentenced to a total of 300 years in prison and \$120,000 in fines last week by a 119th District Court Jury in Ballinger. Eighty years of the sentence was levied for the first degree felony of aggravated sexual assault of a child under 14 years of age. On 11 other counts which were second-degree felonies, Nolte was sentenced to 20 years each.

The prison sentences will run concurrently, but the fines are stacked, meaning Nolte is liable for the total of \$120,000. Nolte could be eligible for parole in 15 years.

After taking only 1 1/2 hours to convict Nolte, the jury, following the punishment phase of the trial, took 6 1/2 hours to settle on the sentences.

Defense attorney Stan Brown of Abilene sought probation for his client and presented several witnesses who also requested probation for Nolte.

Special Prosecutor Charlotte Harris of the Edwards & Lupton law firm of San Angelo, suggested to the jury that they levy fines and a lengthy prison sentence. Harris emphasized the need to protect other children and referred to a love song mentioned by one of

the victims during testimony. "Let's not leave the protection of our children to chance," Harris said. "Let's make sure they miss Mr. Nolte's 'Dance.'"

Nolte, 35, former operator of North Runnels Emergency Service, was accused of engaging four Winters boys in sexual activities between 1985 and 1990. The boys ranged in age from 11 to 16 and lived with Nolte or visited him regularly during that time.

In connection with Nolte's conviction, the 119th Judicial District Attorney's office, headed by District Attorney Steve Smith, and the Runnels County Sheriff's Department, seized Nolte's residence at 1102 North Concho in Winters. The District Attorney has filed a civil forfeiture case in Runnels County District Court. A search warrant was issued by District Judge John Sutton on August 7 and at that time the residence was seized.

District Attorney Smith stated that the residence and real property are contraband as defined in Chapter 59 of the Texas Code of Criminal Procedure due to the property being used in the commission of a felony.

Nolte's wife was allowed to remove personal items from the residence under the supervision of Sheriff's deputies.

## 1991 football season tickets on sale Mon.

Tickets for out-of-town games will be available at the business office on Wednesday morning until Friday noon prior to the game being played on Friday. Tickets for out-of-town games will be sold on a first come, first serve basis.

Students may purchase student tickets each week at the Principal's Office. General admission pregame tickets are \$3 for adults and \$2 for students. All tickets are \$3 at the gate. The first home game of the season will be September 6 with Coleman.

## Motorcycle-car accident injures one on Hwy 153

Trooper Scott Warren with the Texas Department of Public Safety investigated an accident involving an automobile and a motorcycle on Saturday night, August 10. The accident happened 4.1 miles west of Winters near Poe's corner on highway 153.

A 1988 Chevrolet Corsica driven by Antonio Soto, 54, of Wingate swerved to miss what he thought was a car, but actually was two motorcycles travelling together. According to Warren, Soto, who was westbound, drove off the right side of the road and overcorrected causing the car to spin around. A 1989 Honda motorcycle ridden by 16 year-old Casey Joe Berry of Giddings struck the rear portion of the car as it spun with its front facing east.

Berry was transported to North Runnels Hospital where he was treated for a broken right arm and lacerations. Soto was ticketed for having no liability insurance.

The Runnels County Sheriff's Department assisted in the investigation.

## Council ok's bid advertising for new fire truck

Winters City Council held its first public hearing on an application for a community development grant at its regular meeting on Monday evening. The application for funds involves a request for funding to upgrade water lines in the southeast part of the city. Six visitors were in the Council chamber for the hearing.

Following that the Council reviewed specifications for a new fire truck in preparation to advertising for bids. After some discussion, Council members voted to advertise for bids for a truck chassis and a 1000 GPM pump unit.

Lee Harrison, LaVera Tharp and Billie Alderman appeared to request their square dance group be allowed to rent the community center at a reduced rate. Their request was for a monthly rental rate of \$80 - \$100 per month for use of the center each Monday

night and the last Saturday night of a month. After some extended discussion Council members voted to allow the group to rent the community center for \$125 per month and use as they requested.

In other business, the Council reviewed and approved a Drug Abuse Policy as required by the new Texas Workman's Compensation Law and heard the first reading of Ordinance 91-03 which would allow for the injecting of septic system contents into the City's sewer system at approved locations.

Fire Marshal Johnny Merrill reviewed with the Council his duties and responsibilities as fire marshal. The fire marshal is a city paid position.

The Council voted to pay routine bills and adjourned until their next regular meeting on August 26.

## Beef Improvement Association to form

Many beef cattle producers in Runnels County are currently producing outstanding calves that are excelling in both the show ring and the auction barn. Many herd sires and replacement females are also produced and sold in the county. Several producers have expressed an interest in organizing a Beef Improvement Association in order to expand and improve their own operations and assist other producers in upgrading their herds.

The primary objective of the Association will be to provide educational programs and assistance in culling, female and sire selection, nutrition, reproduction, fitting and marketing. Through a cooperative effort, which has

worked very well in other counties, and with the good cow herd base that one now has to work with, one should be able to produce more outstanding calves that will demand a premium for the show ring as well as the sale barn. Major emphasis will be placed on marketing quality cattle for a premium.

A meeting to organize the association will be held Thursday night, August 15, at 8:00 p.m. at The Shed Restaurant in Wingate. Tea and coffee will be served.

All beef cattle producers, no matter how small, are invited and encouraged to attend this meeting. For further information, call the Runnels County Extension office in Ballinger at 365-2219.

Randall Clyde Chapman, 40, of Ballinger was arrested for possession of a controlled substance and placed in Runnels County Jail. Bond of \$15,000 was set by Judge Murchison. Chapman has posted bond and been released.

Case officer was Chief Deputy Keith Collom of the Runnels County Sheriff's Department. Agencies involved included the Runnels County Sheriff's Department, the Rio Concho Drug Task Force, and the Texas Alcohol Beverage Commission.

# OIL BUSINESS . . .

It is getting late in the summer, and those in the service industry are wondering how much more summer laziness they can take.

Ask most anybody that reaps some financial reward by assisting, servicing, or just observing the oil industry, and they will tell you the same thing. Things seem kinda slow right now, especially drilling-wise.

Oh sure, there are some who are too busy in some situations, but the overall trend has been one of a hot, lazy summer. With a depressed rig count and no real direction towards aggressive development by any major operator, times have been a little lean for service companies this summer. Seems major oil companies have been contemplating layoffs again, and so have some major service companies. People have been wondering if this was going to be a repeat of the 1986-88 downsizing in the industry that ended careers and lengthened unemployment lines.

It sure makes a lot of similar noises, but the creature lurking out there, threatening layoffs and despair, is in different circumstances this time around. I am a little bewildered at all the pessimism and lack of aggressiveness, personally.

Why the heck is everybody so lackadaisical, anyway?

Oil prices have been in a tight range around \$19-21 for five months. Drilling costs and operating costs are steady. Interest rates are relatively attractive. Sounds like a good scenario for an expansion.

What happened?

I am not really sure, but I have a few suspicions. First, major oil companies are convinced the only place to make a buck is overseas or below the equator. The Gulf of Mexico is being vacated by drilling companies for the high seas and big dollars 'over there.' Projects in the lower 48 states are being shelved in favor of high risk/high reward prospects in foreign coun-

tries. Independent oil companies have their own problems—especially if they have substantial gas production and reserves. Gas prices are in the sink. Cash flow is being strangled, thus development is being delayed until the money is available.

Other sources of financing are hard to come by. I mentioned low interest rates. I specifically said 'relatively' low, which is in the context of rates experienced in the '80's. Banks have kept business and consumer rates as high as possible to maintain profitability as the Fed has pushed their rates lower. Thus, rates are lower but they are not bargains.

Even getting a loan is hard enough. Banks sunk in a sea of bad energy loans in the '80's, so the backlash is here and now. Face it, bankers are a little squeamish about energy loans in the first place (due to their history), so any worthwhile project has to really stand a stiff test before any money will be loaned. After that, the value of the collateral production is discounted for every conceivable reason to bring bankers' comfort level up and the operators' aggressiveness down.

As a result, less money is available for some very worthwhile projects.

Operators, deprived of current cash flow and bank loans, turn to investors as another source. But, the high prices at the end of last year and the uncertainty that is always there in the oil business are causing investors to be timid about investing unless the project is a certified gusher.

Unfortunately, the big checks of last September, October, and November are not the rule in oil field investing. A good solid, above-average return IS the rule, but, sometimes, that fact is lost in the shuffle.

All in all, cash is short right now for independents, and majors are spending it elsewhere. All of this seems to have depressed things on the local level. I don't think it is a long-term trend.

The opportunities are there, and the cash will become more available as time goes on and the economy gets rolling, again. As a matter of fact, I think more opportunities are there as majors are neglecting their domestic properties. Independents have always been able to outdo big companies in return on investment by moving quicker and smarter. So, chin-up, service guys. Better times are ahead.

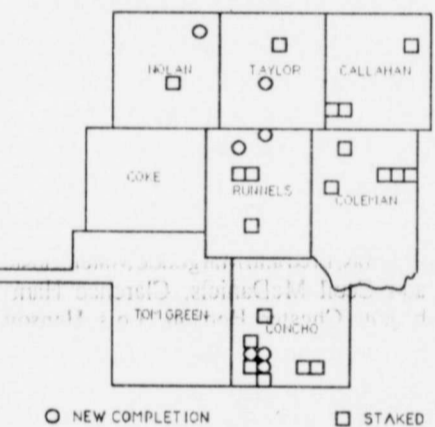

## Poe's Corner

### A sad farewell - Part 5

A continuing series of articles on Johnny Ballew

After Uncle Johnnie's sad farewell to his beloved Runnels County, he didn't say where he was going nor why, but a letter from his daughter, Mary Williams of Fremont, Ca. explained the situation.

It was about 1909 when we moved to Midland. Dad and I shared a breathing problem, asthma, so we moved farther out west to see if it would help us. It did not, so back to Runnels County we came. I don't know how long we were in Midland. He had sold his farm called the "Boley" place, and I think we settled north of there on a black land farm when we returned.

The family couldn't have been gone more than a few months for John Lollar, who was a small boy when his father died, said that Uncle Johnnie taught him to farm and he was with him from the latter part of 1909 until 1915.

After Lollar left Uncle Johnnie he farmed on a place next to him. "Uncle Johnnie ruined more cotton and maize farms, going across my field without raising his plow. He never took his plows out of the ground for anything, not even pastures." Lollar also said that Ballew never had any harness for his team, he used rope and pieces of chain.

Mrs. Court Meeks, the former Lora Conlec, said that when *The Winters Enterprise* came each week her Dad read Uncle Johnnie's column to the whole family, and we always looked forward to hearing what he had to say. Mrs. Meeks had saved a page of the newspaper which told of her wedding in December of 1914, and on the back of it was one of Ballew's articles called "Mazeland Musings." Although he had always promoted cotton, Uncle Johnnie was off in another direction, preaching diversification.

### Mazeland Musings

by Uncle Johnnie

We have always wanted to make a bumper crop and now we have made it. We have enough cotton to last two years.

Now the thing to do is let the cotton business rest and our lands need rest, or a change. We have made more cotton than the world needs. We must raise less cotton and more meat. Meat never was

higher and cotton never was cheaper. To raise meat it is necessary to raise grain. But hogs are not the only things that are high—beef, chickens, turkeys and goat meat are high.

Anything is going to pay better than cotton. If we had made only a normal crop of cotton this year the country would have gone bankrupt. One-fourth of a bale of cotton per acre at present prices would ruin any farmer and when you ruin the farmers you ruin every other avocation. I have figured out what I think any farmer in this section of the country can do next year if he only has the grit and determination.

He can raise: 2 colts worth \$130.00, 10 hogs \$200.00, 100 chickens \$25.00, 2 heifers \$50.00, 50 turkeys \$50.00, 365 lbs. of butter \$73.00, 300 dozen eggs \$30.00, Total \$558.00.

This amount supplemented by some maize, fetcrita, and oats to sell and a small patch of big boll cotton ought to support an ordinary family. Of course we must gather our own cotton. Runnels County will pay out seven hundred thousand dollars this year for cotton picking. A large per cent of this goes out of the county. Of course with this bale-to-the-acre crop we are glad to give the unemployed of other counties employment but while we are in fine shape with this bumper crop we must look ahead for self-protection. We can't raise cotton in a dry country at six cents per pound. Six cents a pound and 1/4 bale per acre, which is a fair average, will bankrupt Runnels County. I am no pessimist by a jug full and a big jug and I'm no alarmist, but just you mark what I say, lkey. If cotton remains at present prices and we continue to depend on it for a money crop there is going to be a yell going up from this country that we have never heard before. We are in fine shape. Responsible parties coming up from down the state are trying to tell us what happened to other sections where short crops have been made and we had better take warning in time. Our cribs are bulging with feed. We have better teams and tools than we have ever had before.

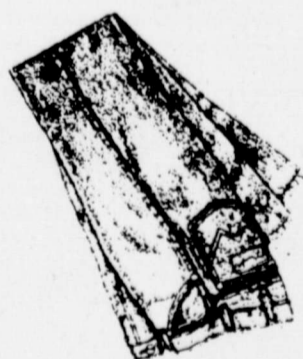

## VETERINARY UPDATE

### Ocular Squamous Cell Carcinoma - "Cancer Eye"

Last time we discussed pink-eye, which all of you have had some experience with at one time or another. One of my last statements was a warning for you not to confuse pink-eye with ocular squamous cell carcinoma, or cancer eye.

Unfortunately, mistaking cancer eye for pink-eye occurs quite often. Maybe by pointing out a few things to you I may be able to help you differentiate between the two conditions.

First of all, cancer eye affects only mature cattle, usually four years of age and older. Also, cancer eye is a slow developing disease, whereas pink-eye is an explosive condition, spreading through as much as ninety percent of a herd in a very short period of time.

Pink-eye, although more common in light-pigmented cattle, can affect any breed, regardless of pigmentation.

Cancer eye is more common in Herefords and Simmentals, although it is not uncommon to see it in black baldfaced. Cancer eye is seen at a higher incidence in females than in males, while pink-eye has no predilection for either sex.

The time to effectively treat and control this condition is best done before it actually becomes an invasive cancer. The precursors to cancer eye can be either a small white plaque or a horn-like growth called a keratoma. Both of these usually eventually become cancer. They are usually found on the eyeball, the eyelids, or the third eyelid located at the inside corner of the eye.

Over a period of time the harmless plaque or keratoma may change into the invasive and debilitating tumor we call squamous cell carcinoma.

When left untreated, the tumor may eventually spread into and behind the eyeball itself, the orbital bones of the head which

surround the eyeball, and finally into the lymphatic system. Once it reaches the regional lymph nodes of the lymphatics, it may continue to spread to other parts of the body.

Treatment is usually rewarding if done early enough in the course of the disease. It ranges anywhere from surgical removal to radiation therapy. Tumors which affect the eyeballs are usually scraped off, then the base of the tumor cauterized with silver nitrate.

Those of the third eyelid are usually surgically removed if they have not invaded the deeper structures of the eye. Double freeze-thaw cycles with a liquid nitrogen applicator are very effective in treating tumors of the third eyelid and eyelids proper if the entire tumor can be frozen.

Surgical enucleation of the eyeball and the surrounding tissues may be necessary if the tumor has been neglected too long. Radiation therapy is highly effective but is actually not feasible under usual field conditions. A small pellet of radioactive material, usually Strontium 90, is placed in the middle of the tumor and left in place until the tumor starts to regress.

Federal law requires that cows with cancer eye be sent to slaughter if they are sold through public auction. If there is evidence of previous cancer eye surgery (a one-eyed cow) or there is a noticeably active tumor in the eye, the cow may be bought as a "suspect." This means that the buyer thinks that the cancer may be too widespread throughout the body for the cow to pass federal inspection and the cow may be "tanked." If this happens, the cow will bring almost nothing.

So it is important that you not let this condition get so far along that the cow is not treatable.

Hopefully, this information will help you save a valuable cow and some money.
