Auto accident kills two Winters men

Two Winters residents were killed instantly in a one-vehicle accident about 10:00 p.m. Sunday, Feb. 27.

Pronounced dead at the scene were Mario Albert Esquivel, 33, and Nicholas Trevino, 31.

According to Scott Warren of the Department of Public Safety in Ballinger, Esquivel was driving the 1994 Ford Ranger pickup at a high rate of speed, heading north on FM 382, about 12 miles east of Winters. At the intersection of 382 and FM 1770 (Novice Road), the vehicle apparently crossed 1770 and left 382. The vehicle struck an embankment, became airborne and landed on its top after going through a fence.

The pickup then caught fire and was noticed by a passing motorist who called via cell phone to 911. The motorist was unable to get close enough to help the victims due to the fire.

Officer Warren said neither men were wearing seatbelts.

Warren was assisted by DPS Officer James O'Shields of Coleman, the Runnels County Sheriff's Department, the Winters Police Department and the Winters Volunteer Fire Department.

Rosary for Mr. Esquivel and Mr. Trevino was held Tuesday evening at Winters Funeral Home. Mass was held Wednesday morning at Mt. Carmel Catholic Church with Father Sam Homsey officiating.

WTU to close 47 payment offices including Winters and Ballinger

Several West Texas Utilities (WTU) employees in the Runnels County area are in limbo following an announcement by the company last week.

The release, which said WTU is announcing operational changes to position the company for the start of retail competition in Texas, broadly outlined some of the changes which will be made in the operation of the company.

Forty-seven communities will be closing their merchandise sales showrooms and payment offices. Of the 47, twenty-one are in the Big Country. In addition to Winters and Ballinger are Abilene, Albany, Aspermont, Baird, Bronck, Cisco, Clyde, Cross Plains, Hamlin, Haskell, and Knox City. Others are Merkel, Munday, Rising Star, Robert Lee, Rotan, Santa Anna, Stamford, and Throckmorton.

Kevin McMahon, area manager for the company, said his job

and those of seven clerks in six towns in his area had been announced as being "affected by the changes."

He said as far as he knew the offices in his area would remain open until September. After that time, no customer transactions will be performed at the offices (this includes bill payments), although the service people will remain at each of the locations. He noted that customers will continue to have company access through its Customer Service Center, which provides service 24-hours a day, 7 days a week via a toll-free telephone number.

"A new organizational chart will be out in April and those of us affected by the changes will have an opportunity to bid for jobs within the new organization at that time," McMahon said.

"We will be discontinuing our merchandise program by the end See CLOSINGS, page 2

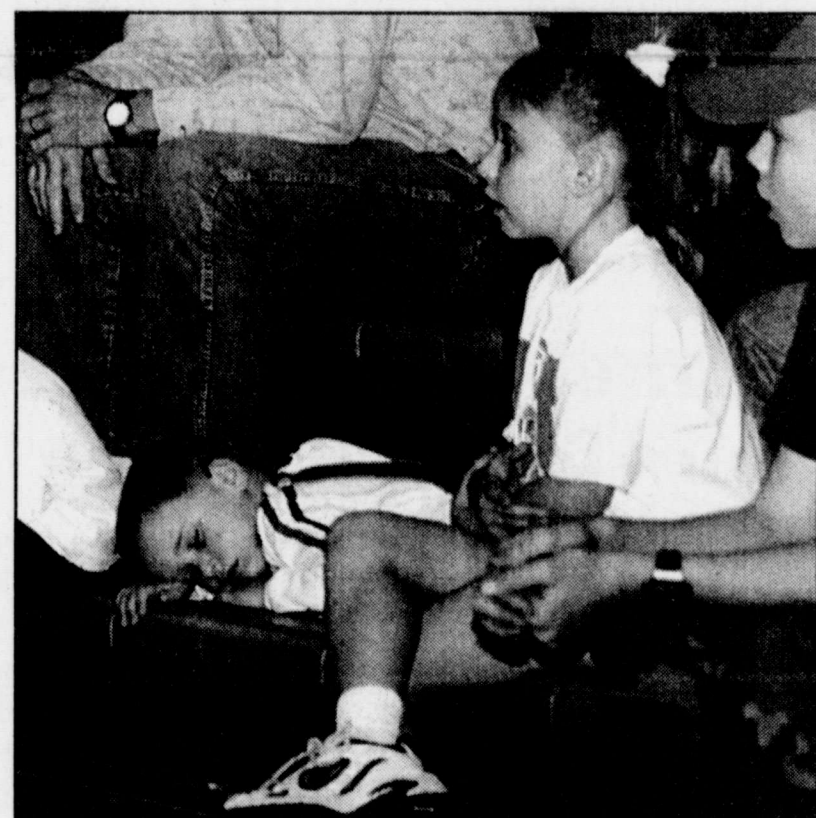

Visitation for grades pre-kindergarten through 6th will be from 6:30-7:30 p.m. in individual classrooms.

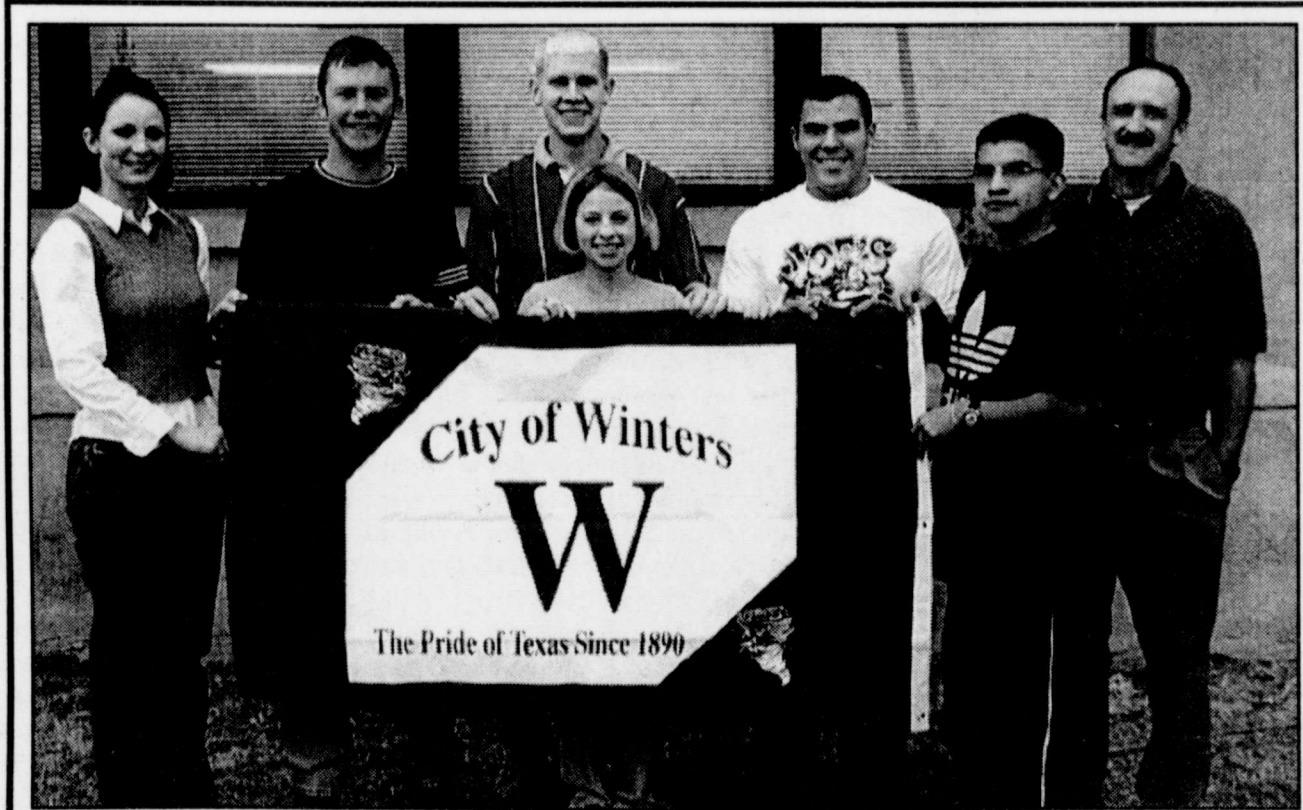

Council approves funds for water wells

In a continuing effort to provide water to the citizens of Winters and the surrounding area, members of the Winters City Council unanimously approved to spend an estimated \$32,026.50 during the regular meeting of the Council Monday, Feb. 28.

Jack Davis, Jr., Water Superintendent, reported that White Drilling of Clyde, Texas, on request by the Winters City Council, drilled twenty holes around Elm Creek Reservoir in an attempt to find water. Of these twenty holes, ten were found to have water. After pump testing, the wells were found to average approximately 25 gallons per minute each for a total of 360,000 gallons per day.

According to Davis, this

amount is approximately a third of the city's water consumption at this time.

After the wells are tested for chemicals and minerals and ap-

proved for human consumption, the test holes will be turned into water wells at a cost of approximately \$2,000 each. Each of the

Oil Bidness

Hey, psssst! Want to hear an investment secret?

No, it's not a "dot.com" IPO, and it's not some obscure emerging market company in the far east.

The secret? Invest in oil and gas producing companies.

Not very glamorous, and not very popular judging by the current share prices of producing companies.

Two things seem to be at work here: (1) many analysts believe that the risk of lower prices makes oil and gas companies a risky investment in any event, and (2) many observers believe current elevated prices are ready for a big fall.

This view has prevailed since late last year. Share prices recovered from lows seen early 1999 when product prices were at their worst, but they never quite reached a level that was commensurate with the level of recovery seen in oil and gas prices. Even while companies reported record earnings, recently, share prices dropped.

Now, as petroleum prices remain stubbornly high despite expectations for additional OPEC production, share prices continue to drop with some barely above Spring 1999 prices (when oil prices were at their lowest). Major companies are lower, major independents are lower, and smaller independents are basically ignored.

Majors are punished because refining margins suffer when prices are higher. Large independents are punished because they have no hedge against lower prices, and smaller independents are below the radar for most analysts. Plus, conventional investments, like oil and gas companies, are suffering from a general lack of investor interest for anything that doesn't rely totally on the internet for revenue.

The offshoot is that many (I didn't say all) oil and gas producing companies are undervalued in the market. That value is not just based on the expectations for share price appreciation (read: growth) but the cash flow and profit poten-

tial of the companies even if product prices moderate for currently high levels.

This is the opposite of the expectations for internet companies which have little profit but huge expectations for growth. For high-tech companies, the lure is the dream. For oil and gas companies, the lure should be the reality of big profits at any price above \$18 per barrel.

No one seems to be biting right now. Maybe that means something...

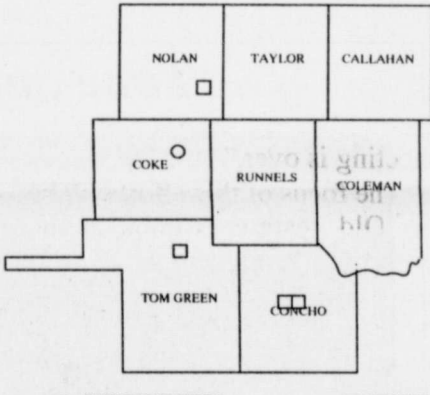

Social Security retirement age to be raised gradually to 67

The Social Security retirement age is going up and the effects will be felt for the first time this year. "Most people do not know changes were made sixteen years ago in the Social Security Amendments of 1983. The full retirement age for those born in 1938 or later was raised in gradual steps from age 65 to 67," said Fredi Franki, Social Security manager in San Angelo.

"The change was part of a package of changes made by a bipartisan Congressional committee to curtail program expenses," Franki said. "People are living longer and are drawing Social Security benefits longer, creating unanticipated costs for the Social Security system."

If you were born before 1938,

you will still be eligible for your full Social Security retirement benefit at the age of 65 and reduced benefits as early as age 62. However, those born in 1938 who retire "early" this year (age 62) will find their benefit amount of reduction increased from 20 percent to 20.8 percent.

Beginning in 2003, full retirement age for those born in 1938 or later will increase. For example, the full retirement age for those born in 1938 will increase to 65 years and two months.

"There are disadvantages and advantages to taking your benefit before your full retirement age, so contact Social Security before you decide to retire," urges Franki.

of September," said WTU President and General Manager Paul Brower.

"A changing business environment and changing customer needs are reshaping our business. WTU will continue to work in partnership with communities through its economic development activities, volunteerism, contributions and customer service. The company is following an industry trend in making use of new technologies to provide more options in customerservice," Brower said.

McMahon said because of the new state law affecting competition, the company must separate its operations. The service people will be employed by the "wires" company and there will also be a "generating" company, along with a company which sells the electricity. "We really don't know for sure how all this will shake out until we are able to see the new organizational charts in April," he said.

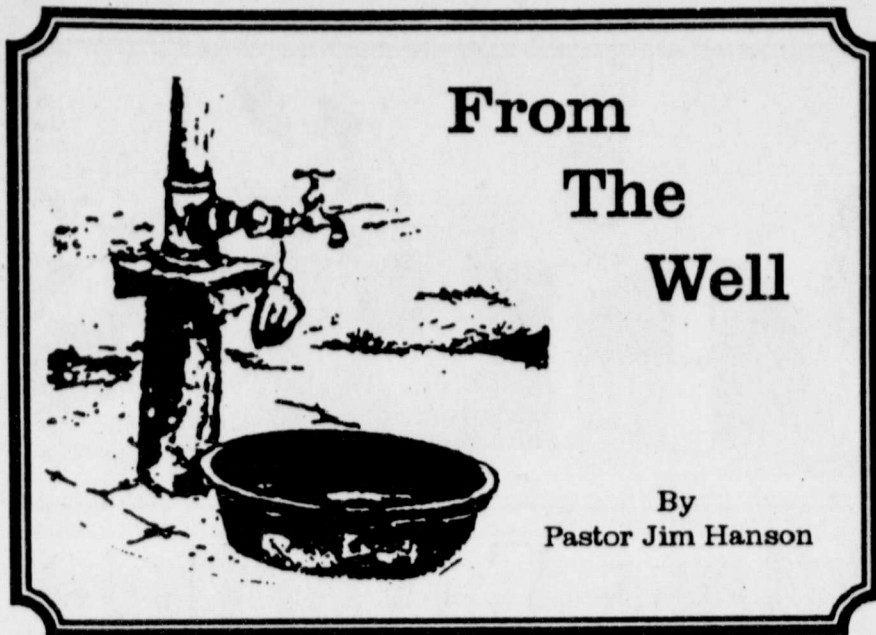

From The Well

The other day I was talking to a man who was concerned about water. Most of us are becoming concerned about water these days. Who owns the water? Who has the water rights? The folks who live in the city — who wash their cars 4 times a week, run their showers for 10 minutes a time, fill their swimming pools, water their lawns, use huge amounts for their industries, wash their streets? Or the folks who live on the farm. On the land. Who are much better at conserving water?

He was concerned. And, so was I. They outvoted us because there are so many more of them. They get the representation. He said, "It's not fair because rural people are water conservationists. They know how precious water is. Their city cousins think water comes from a tap and whenever you turn it on...it's just there."

Well, not so. We know better. We know that "In spite of all its accomplishments humanity exists because of six inches of topsoil and the fact that it rains." We see the land go dry, and the creeks, and the tanks, and the lakes dry up. And it is scary.

When I was a kid, growing up, we had water. But my mother was a water conservationist. When she washed clothes, she started with the washing machine full of hot water. She washed the light and white stuff first. Then put them through the ringer — squeezing the water back into the machine. Then went in the darker, heavier clothes. And, wrung those out too. Last the greasy, really dirty clothes. All with one washer tub full. Two tubs of rinse water — but that water wasn't changed either. And — when the wash was done the water went to the garden.

When we took baths — it was on Saturday night. We four boys would line up — usually the smaller guys got in first. I guess we weren't as dirty. But all four used the same water.

When we were on Aunt Suzie's farm we really learned how to conserve water. For, down on the farm, there was no running water. We had to carry it. In buckets.

From the well to the house. From the well to the barn. The buckets of water were heavy. You didn't throw it around. Same way with drinking water. You drank from the dipper until it was empty. And, after washing dishes, you carried the water outside and watered the flowers and sometimes the trees with it.

When we did get running water, you were taught to always put the stopper in the drain before you turned on the tap. You could not afford the luxury of running the water without catching it and holding it. We were all water conservationists.

I don't remember when it was that we first got a shower in our house. I think I must have been 15 or 16. And mother always reminded me (1) to rinse, (2) turn off the shower and soap and shampoo, (3) turn it back on and rinse. No continuous shower. It wasted water. And water was precious.

Someone once said, "Don't use more water than you can carry." Not so any more.

Maybe that's why it's so dry. We give no thought...or thanks for the water.

The facts are that we are running out of it. And, we need to rediscover how precious it is. By conserving it. Recycling it. Using it carefully.

Can you imagine how much water the city of Winters could save if:

1. We ran just one cup of water. And used it to brush our teeth. Instead of running it down the drain.

2. We showered just 3 times a week, and did it like my mother taught me. (Like the Navy.)

3. We washed our dishes in the dish pan. Rinsed them. And used our dishwashers as drying racks. And then took the dishwater to water our plants and flowers.

4. We didn't wash our clothes after on wearing — but wore them several times before washing.

5. We never ran water down the drain, always plugged the drain. And used the water in the sink.

6. Dry washed our cars. My wife used to be able to wash our car with 3 buckets of water. And then I took over. And practically immersed our car with water. Dumb.

I'm sure there are other things we could do — to conserve and recycle our water. Not only would we be conserving water, but we would be nourishing our souls. This "grass roots" volunteer movement of water conservation would help us nourish the "roots" of our hearts and minds. We would begin to see how precious a gift water is. And, before we took a drink, or washed our body, or cleaned our car, we would automatically say, "Thank you, God...for water." And by blessing Him, we would be twice blessed.

North Main Church of Christ to host meetings on marriage enrichment

The North Main Church of Christ will begin a special class entitled "Making Majestic Marriages" this Sunday. It will begin from 9:30 a.m. to 10:15 a.m. every Sunday for the next three months.

"Every marriage can use a tune up," says Mark Edge, preaching minister for the church. "These enrichment sessions will be especially helpful for making a good marriage even better."

Yet, Edge states that troubled marriages can also find inspiration in these gatherings. "The fact is, even in a town the size of Winters, there will be marriages where there is tremendous pain. One thing that I desire to communicate to the husband or wife who feels trapped in a terrible marriage—there is hope. Besides, one of the basic messages of Christianity is that Christians are wounded healers. I hope that those of us who

have been healed can be allowed to help those who are hurting."

Edge emphasizes that those who wish to visit should not feel pressured to stay for the assembly which follows the marriage empowering discussion. "Obviously, we always love for visitors to join us for worship. But we realize that there are many people in this town who are not members of a church and frankly, don't want to be bothered by one. We want those people to feel comfortable to come and join us for the marriage-building period and then feel free to leave as soon as our meeting is over."

The focus of this effort will be the Old Testament book of the Song of Solomon. "Probably very few people realize that there is a book of the Bible dedicated to the themes of love, romance, marriage, and sex," Edge elaborates. "But the Song of Solomon is that book. Some have said it is the biblical book for our time. I tend to agree."

County to accept proposals on courthouse architectural service

Runnels County Commissioners agreed to advertise for proposals for architectural services in connection with the Texas Historic Courthouse Preservation Program at a special meeting on Monday at the courthouse. Commissioners had heard previously from a firm which is interested in performing the architectural services and applying for a grant for the program on behalf of Runnels County.

Ballinger City Administrator Tommy New discussed with the court a letter from the Texas Military Facilities Commission concerning the National Guard Armory and land surrounding it. The City and County share a communications tower located on the land. The letter indicated the tower would have to be dismantled and moved because the TMFC plans to give the land to the U.S. Housing and Urban Development Commission.

Commissioner Ricky Strube told the group he had contacted James Beauchamp with Congressman Charlie Stenholm's office and he would be arriving to discuss the matter. Following Beauchamp's arrival, Administrator

New and County Judge Marilyn Egan gave him information on the matter. Beauchamp assured the city and county representatives he would check into the proposal and report back to them by the next Commissioners Court Meeting on March 13. No formal action was taken by the court.

Other matters on the agenda and their action included:

- Commissioners agreed to rent the use of a county-owned copier to the Regional Juvenile Probation Department at the rate of \$20 per month.

- Approved a resolution in support of a grant application by West Central Texas Regional Housing Finance Corporation for homebuyer's Assistance for low and moderate income families.

- Entered into a contract with Winters Public Library for payment of \$3,150 in support of their 2000 budget.

- Accepted a bid of \$1,000 on property held in trust for non-payment of taxes located at 802 North 10th Street, Ballinger.

- Approved a request of Coleman County Water Supply for an easement to cross County Road 183.

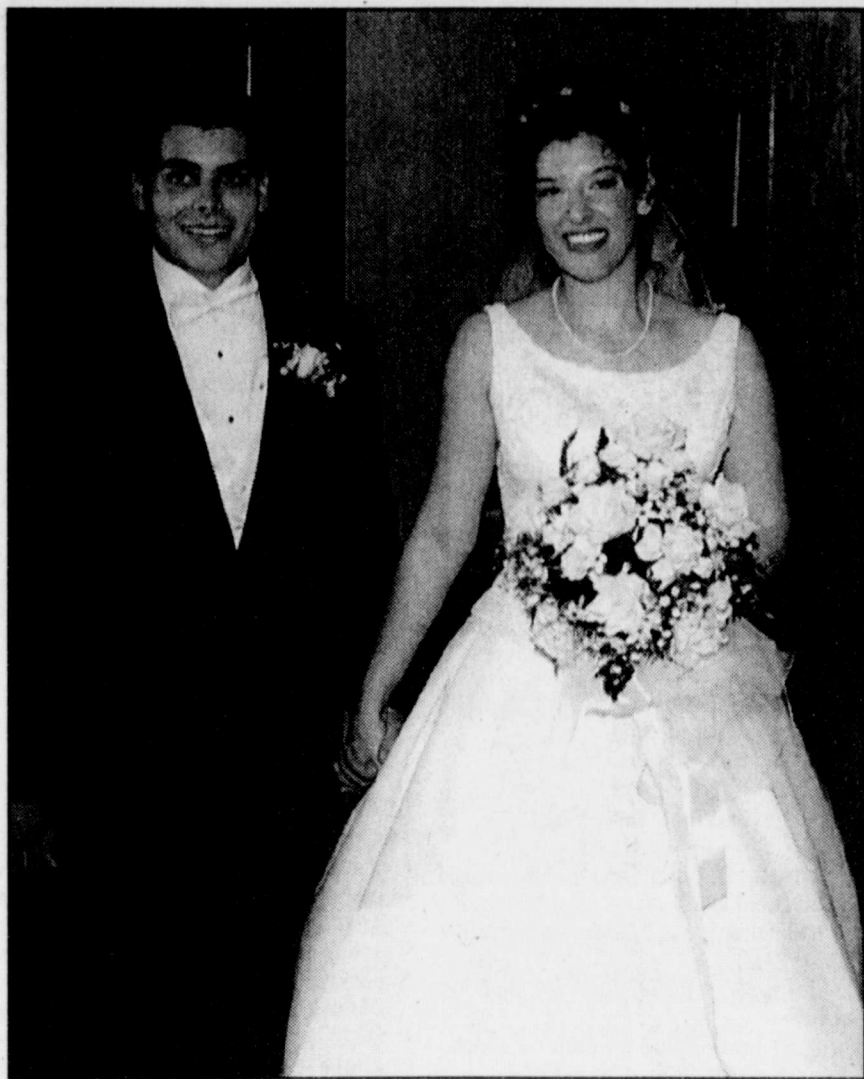

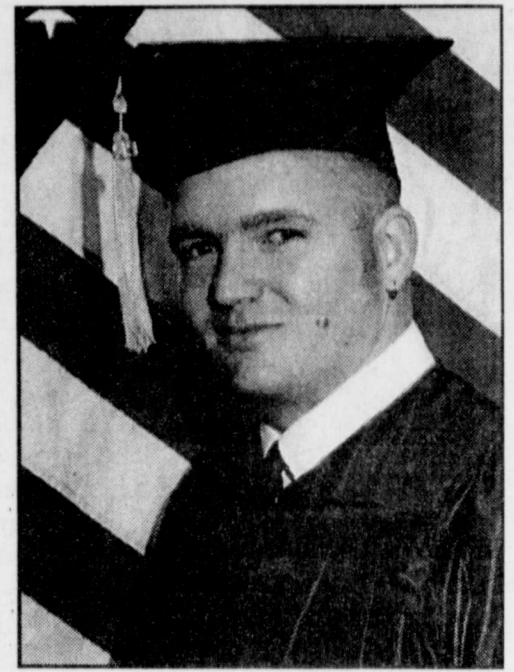
Robert Bedford receives B.S. degree from Tarleton

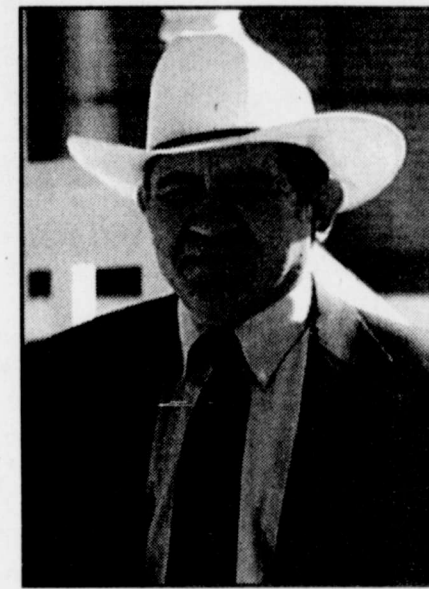
Tony Salinaz announces candidacy for County Sheriff

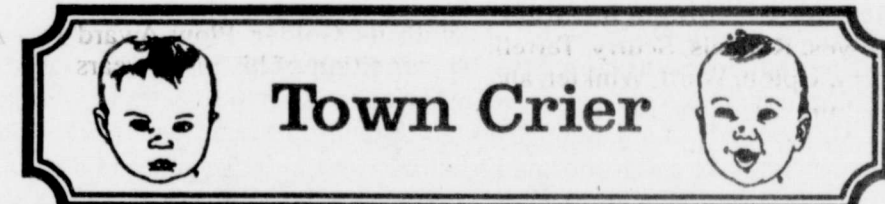
Volunteers wanted for CAC

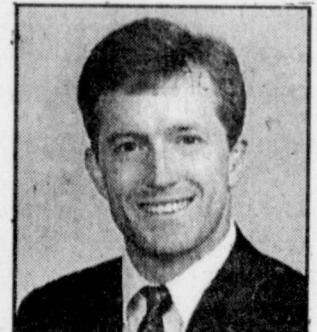

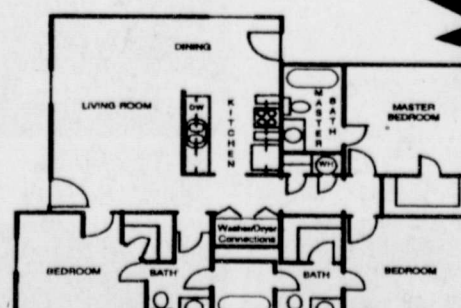

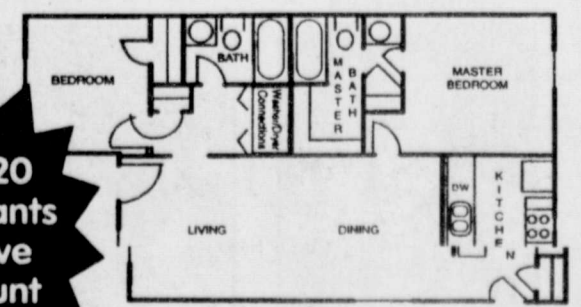

Workshops to analyze calf crop performance

Ranchers interested in completing a Standardized Performance Analysis (SPA) of their 1999 calf crops can attend workshops beginning in March.

The Texas Agricultural Extension Service is giving ranchers in the state the opportunity to complete this production and financial analysis by offering workshops in seven locations.

The workshops are as follows: March 14-15 in Amarillo, April 19-20 in San Angelo, April 26-27 in Ardmore, Oklahoma, May 4-5 in Laredo, May 9-10 in Vernon, May 24-25 in Victoria and June 7-8 in Paris.

The opening session will begin with an overview of the Texas Cow-Calf SPA. According to James McGrann, extension agricultural economist, ranch managers use the SPA to measure performance and manage improvements of their cow-calf operations. Presently, data for 151,000 cows are maintained on 215 Texas herds throughout this analytical tool.

Throughout the day, district extension specialists and county agents will assist producers in organizing their data for the analysis and using SPA production and financial software. Individual conferences will be held with ranchers the following day to interpret the SPA results.

The registration fee is \$150 per ranch and includes the software and educational materials. The fee is \$100 for ranchers who have completed the analysis in the past. Registered operators will be sent forms to organize their data before the workshops.

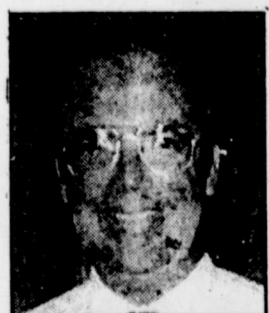
This year's theme is "Agriculture—Yesterday, Today, and Tomorrow," and will address a variety of issues that address agriculture.
