## Bronte Pioneer Business Man Dies After Long Illness

G. L. Bridges, a resident of Bronte for a third of a century, and one of the town's pioneer business men, died, at the family residence, Wednesday at noon, July 29, 1942. His death terminated the most remarkable struggle for recovery from affliction, perhaps, in the history of all this part of the country. It was about twenty years ago that the health of deceased failed him. Of a determined spirit he fought the malady, and lived in hope for a long time that he

would recover. But within a short time he became bedridden and for nearly two decades he endured his sufferings without murmur or complaint.

Deceased was born in Hunt county. He came first to Llano and then in 1909 he came to Bronte. He formed a partnership in a hardware firm which enjoyed a good business. Then deceased came into possession of the business and operated same until his health failed—since that time the business has been under the direction of Floyd Bridges, son of deceased.

Deceased lacked only one day being in his seventy-fourth year. He is survived besides his son, by his widow and a daughter, Mrs. Clint Duncan, and three grandchildren.

Funeral services were held Thursday morning at ten o'

lock, at the Bronte Baptist church. The services were held by Rev. N. W. Pitts, a former pastor of the local church, but now of Coahoma. A large number were in attendance not only in and around Bronte but from other communities.

In the days of his active life, deceased was not only a successful business man, but he always took an interest in the affairs of his town and community. He had many friends among the old timers who will pause and shed a tear at his passing, but will cherish fine and happy memories of him, for his fortitude throughout the long years of his affliction.

## Coke County Will Have Junior Livestock Show in the Spring of 1943

(By H. E. Smith, County Agent)

In spite of the handicaps due to the War Efforts where transportation is concerned the Coke County Livestock Association feels that the importance of more production in our War Effort offsets such handicaps, and in order to encourage the breeders and feeders of Coke county to increase the production of pounds of beef, pork and mutton, and especially those junior feeders, the 4-H clubbers and Future Farmers, they have announced that there will be a junior Livestock Show for the Coke county youth this coming spring. They urge that these young feeders place their demonstration on more of a commercial basis for this year. Plans for the show are being worked out on a classification basis rather than an individual animal competition basis, as has been the custom of past County Shows.

Ribbons and premiums will be awarded. Probably a special award will be offered to the boy producing the largest number of pounds of quality beef, pork and mutton. The directors of the Association in a called meeting, voted to purchase a War Bond with the funds which are in the building fund of the Association, due to the difficulty involved in a building program at this time. The present setup calls for the Association's show expenses and all other activities to be financed by donations from the various livestock producers in Coke county. When this program was initiated in the county it was decided that when the premiums, awards and other expenses incurred in promoting a county show had been paid, all remaining funds should be set aside and used toward a

new in this part of the country and that therefore few experienced workers can be found, Mr. Ruttle said that free National Defense training schools have been established by the state and federal governments for the purpose of providing the necessary training. More than 80 per cent of the jobs already filled in war industry plants, he asserted, have been taken by people who prepared themselves by attending these schools.

"There is and will continue to be a heavy demand for women as well as men in many types of jobs. All local men and women who wish to serve their country and at the same time earn good wages, should enroll in

these training schools and secure the knowledge necessary to perform on these jobs," Mr. Ruttle said.

Machine shop, Aircraft Engine Mechanics, Aircraft Sheet Metal (including Riveting) are the courses offered. The courses are open to men between the ages of 18 and 65 years, and to women between the ages of 18 and 45. The demand for women workers is increasing.

Mr. Ruttle stressed the fact

that the training is entirely free. The only cost to a trainee being that he must support himself during the six to 12-week training period. Even this is not true in all cases, since many younger trainees can be assigned to National Youth Administration war work centers where they will be boarded and paid a small wage while obtaining work experience.



sue the necessary proclamation for said election and have the same published as required by the Constitution and laws of this State. The expenses of publication and election for such amendment shall be paid out of proper appropriation made by law.

#### S. J. R. No. 20

#### A JOINT RESOLUTION

proposing an amendment to the Constitution of the State of Texas by amending Section 33 of Article 16, of the Constitution of Texas so as to permit the accounting officers of this State to draw and pay warrants for salaries to officers of the United States Army or Navy who are assigned to duties in State Institutions of higher education.

Section 1. That Section 33 of Article 16, of the Constitution of the State of Texas, be amended so as to read as follows:

"Section 33. The accounting officers of this State shall neither draw nor pay a warrant upon the Treasury in favor of any person, for salary or compensation as agent, officer or as appointee who holds at the same time any other office or position of honor, trust or profit, under this State or the United States, except as prescribed by this Constitution. Provided, that this restriction as to the drawing and paying of warrants upon the Treasury shall not apply to officers of the National Guard of Texas, the National Guard Reserve, the Officers Reserve Corps of the United States, nor to enlisted men of the National Guard, the National Guard Reserve, and the Organized Reserves of the United States, nor to retired officers of the United States Army, Navy, and Marine Corps, and retired warrant officers and retired enlisted men of the United States Army or Navy who are assigned to duties in State Institutions of higher education."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at an election to be held throughout

the State on the third day of November, 1942, at which all ballots shall have printed thereon:

"For the Constitutional Amendment permitting the accounting officers of this State to draw and pay warrants for salaries to officers of the United States Army or Navy who are assigned to duties in State Institutions of higher education."

"Against the Constitutional Amendment permitting the accounting officers of this State to draw and pay warrants for salaries to officers of the United States Army or Navy who are assigned to duties in State Institutions of higher education."

Each voter shall scratch out one of said clauses on the ballots, leaving the one expressing his vote on the proposed amendment.

Sec. 3. The Governor shall issue the necessary proclamation for said election, and have same published as required by the Constitution and laws of this State, and the sum of Five Thousand (\$5,000.00) Dollars, or so much thereof as may be necessary, is hereby appropriated from any funds in the State Treasury, not otherwise appropriated to defray the expenses of printing said proclamation and of holding said election.

#### S. J. R. No. 21 A JOINT RESOLUTION

proposing an amendment to the Constitution of the State of Texas authorizing the Legislature to appropriate Seventy-five Thousand (\$75,000) Dollars or so much thereof as may be necessary to pay claims incurred by

John Tarleton Agricultural College for the construction of a building on the campus of such college pursuant to deficiency authorization by the Governor of Texas on August 31st, 1937. Be It Resolved By The Legislature of The State of Texas:

Section 1. That the Constitution of the State of Texas be amended by adding a new section, as follows:

"The Legislature is authorized to appropriate so much money as may be necessary, not to exceed Seventy-five Thousand (\$75,000) Dollars, to pay claims incurred by John Tarleton Agricultural College for the construction of a building on the campus of such college pursuant to deficiency authorization by the Governor of Texas on August 31st, 1937."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this State at the next general election to be held on the first Tuesday after the first Monday in November, A. D. 1942, at which all ballots shall have printed thereon: "For the constitutional amendment authorizing the Legislature to pay for building constructed for John Tarleton College;" and

"Against the constitutional amendment authorizing the Legislature to pay for building constructed for John Tarleton Agricultural College."

Each voter shall scratch out one of the said clauses on the ballot, leaving the one expressing his vote on the proposed amendment.
