Swiftettes win 10th state title

"That senior determination made the difference!"

That's what Nazareth Coach Sandy Heiman had to say after her team captured its second straight Class A state championship.

The Swiftettes captured Nazareth's 10th state title Saturday morning by beating LaRue LaPoyner 51-33 at the Frank Erwin Center in Austin before a crowd of 4,000.

"The girls decided this was their last chance and if they didn't do it now, it wouldn't get done. These girls recognize the value of hard work and the results it can bring you," Heiman said.

"Every state title feels good. Every one is special because each one is with a different group of kids. They (state titles) don't get old. When you've sweated and worked as hard as these kids have, it's not taken for granted," she added.

It took a lot of sweat and hard work to win the state title, but the Swiftettes pulled together and when they did, everything clicked.

The Swiftettes pressure defense shut down LaPoyner in the first three quarters, frustrating the Flyerettes.

Nazareth forced the Flyerettes into turning the ball over 19 times, and converted the miscues into 17 points. The Swiftettes also dominated the boards, outrebounding LaPoyner 39-29.

"We played super defense today. I've really got to credit a lot of kids," Heiman said. "We were real concerned about 10, 20 and 22 (Audra Anderson, Natasha Johnson and Delaine Taylor), but Shana (Birkenfeld), Jenny (Brockman) and Stephanie (Brockman) all did a good job."

LaPoyner opened the game with a sagging 2-3 zone defense, shutting down Nazareth's inside game, something the Swiftettes have relied on throughout the season.

Nazareth adjusted its offense early and took control of the game. Adjusting the offense meant going to the outside shot and it worked. The Swiftettes switched to a single post offense with Darla Leavitt inside and senior post Shana Birkenfeld working the baseline.

Senior guard Stephanie Brockman connected on two 18-foot baseline jumpers at the start of the first quarter. Birkenfeld converted a three-point play and added another 18-foot jumper from the baseline to pace the Swiftettes to an 11-9 first quarter lead.

"We just put it all together today. I just decided that this was my last game for Nazareth and if I was going to shoot well it had to be today," Brockman said. "I wasn't afraid to shoot. I just put it up and it fell."

LaPoyner tied the game at 11 with 7:47 left in the first half, and that was as close as they would get in the game.

Birkenfeld hit another baseline jumper with 7:29 left and LaPoyner was forced to change its sagging defense. The Flyerettes moved out to honor Nazareth's outside shooters and that opened the way for Leavitt inside.

The 6-0 junior post nailed a pair of two-foot jumpers to put the Swiftettes up 17-12, then Brockman added a fast break layup and an 18footer to increase the lead to seven points.

LaPoyner found a little spark with two minutes left in the half when Audra Anderson scored from the left side and Natasha Johnson added four points, but they couldn't fan the spark into a flame.

After remaining silent for most of the game, Leavitt went on a scoring spree. She hit three short jumpshots and a 10-foot shot before the half to put the Swiftettes up 31-21.

Leavitt continued her domination into the third quarter, scoring ten points in the stanza. LaPoyner found itself down by 18 points with just eight minutes left in the 1989 season and it proved to be a deficit it couldn't make up.

"I just wasn't hitting at first. I wasn't following through," said Leavitt, who scored a game high 24 points to lead the Swiftettes.

"Darla was having a hard time shooting over their defense because they do jump well," Heiman said. She just wasn't seeing the basket as well as she usually does, but when we'd hit her on a good side pin she'd go in

"I think it was just a matter of continuing to work. It was real similar to last year's game (which Nazareth won 64-28). We had a two point lead at the quarter and pulled away from them just a little in the second quarter. Then we woke up after halftime and finally had a big spurt in the third. I think that's what finally helped us do it," Heiman said.

Absentee voting will be conducted April 17 through May 2. The final day to request a mail ballot will be April 28.

Late Cub blitz stuns Cats

Even those who were there watching it couldn't believe it.

From the time the Bobcats had staged a 10-2 run to end the first quarter with an 18-13 lead, they had been in control of the regional Municipal Coliseum Saturday.

In the second quarter, Brac Wardlaw had ante'd up with a corner shot, then Justin Shultz and Emilio Arce had gone on back-toback scoring binges to hike Dimmitt's lead to 34-22 at halftime. The Bobcats clearly were whipping the top-ranked Brownfield Cubs.

Dimmitt's lead ranged from 10 to 15 points through the third, which ended at 40-30, and fluctuated between 11 and 13 as the fourth quarter ticked past the halfway

point. With a snowstorm blowing outside, Dimmitt fans were fantasizing about Austin's welcome spring warmth-something they had not dared to think about all season,

until now. Then it happened.

Brownfield sharpshooter Zayne McPherson hit a three-pointer from the comer with 3:17 left to cut the lead to 59-51.

After a Dimmitt free throw, Brownfield's Kenneth Lawrence sank a layup to make it 60-53.

McPherson hit another trey at 1:52, then Lawrence stole the inbound pass and put it up four seconds later, and suddenly the scoreboard read 60-58.

"We were trying to get the ball down safely and run some clock out," Coach Ken Cleveland said, but we never had the chance because they'd foul us and we'd have to go to the line."

Arce hit two free throws to hike Dimmitt's lead to 62-58 with 1:46 left. But McPherson came back with another trey from the corner at 1:25, and it was 62-61.

Still leading by a point, Brownfield got the ball downcourt and Clarence Brown put it up. His shot rimmed out, but Brown followed it, got the rebound and put it in with three seconds left to make the final score 67-64.

With the help of the three-point shot and some brilliant foul strategy, the desperate but determined

Cubs had scored an amazing 19 points in the final 3:20, with Mc-Pherson hitting 11 and Lawrence six. The Bobcats, meanwhile, had had to settle for five free throws.

"I'm probably hurting more than I've hurt in a long time," Coach Cleveland said. "If we had been 10 points behind all the way through, or if it had been a see-saw game, I wouldn't mind it so much. But we had the game completely in control for over three quarters. That's what makes it so tough.

"In those last three minutes, it all came down to 'if ... if ... if.'

JUSTIN SHULTZ, junior wing, who averaged nine points, six rebounds and five credits per game, and who was named to the all-

regional tournament team. ROBERT RUIZ, freshman post forward, who had the team's highest field-goal percentage (63%) while averaging four points,

four rebounds and four credits per game. JASON BALL, senior wing, who contributed 74 points, 63

credits and 43 rebounds during the season. JERMAINE WILLIAMS, sophomore wing, who contributed 138

points, 77 credits and 40 rebounds during the season. RICKY SOLOMON, sophomore post forward, who scored 68

points, got 37 rebounds and had 30 credits during the season. ROBERT CASARES, senior wing, who scored 39 points, had 46

credits and got 14 rebounds during the season.

JERRY LOPEZ, junior forward, who scored 26 points, grabbed 18 rebounds and had nine credits during the season.




Both teams finally found the range in the fourth. Arce, Bradley,



Naz dominates Moulton for 44-27 semifinal victory

The Swiftettes might have become a little complacent at the end of the Class A state semifinal contest last Thursday, but they played well enough in the first half to overcome anything.

Nazareth earned the right to advance to the state championship game Saturday by defeating Moulton 44-27 at the Frank Erwin Center in Austin.

The Swiftettes jumped out to an early 14-6 first quarter lead, then extended it to 23-7 at halftime before Moulton knew what had happened.

The Swiftettes were able to do exactly what they wanted—get the ball inside to Darla Leavitt for the short jumper—and Moulton was helpless to stop the play.

"Darla really dominated the first quarter. There's no doubt about it. She was hitting well," said Sandy Heiman, Nazareth's head coach. "We did what we wanted to do. We'd hit Darla inside and when she didn't feel like she had the shot she passed back outside and we'd hit from there.

"We knew we'd have a height advantage over Moulton. (The Kittens' tallest starter was 5-6) They were probably a little bit quicker than we were, but that's why we tried to go inside with it. We felt like even if they were on us, we could still shoot over them because of our height advantage

"I think we had confidence both in our inside game and outside game in the first half. We were really clicking the way we wanted to," Heiman said.

Confidence in its outside shooting ability is something the Swiftettes have had to really fight for this season, but it all came together last Thursday.

Starting guards Jenny Brockman and Tami Ball, and point guard Stephanie Brockman all connected on outside jumpshots in the first half. The Swiftettes were 11 of 23 (47.8%) in the first half, while Moulton managed only two of 11 (18.1%) field goals.

Nazareth's defense stifled the Kittens' offensive attack, with Leavitt and Shana Birkenfeld blocking shots and forcing turnovers inside

"We did a good job plugging up the middle, which is where Moulton likes to shoot the ball from," Heiman said.

Moulton made a run at the Swiftettes in the fourth quarter, outscoring the Swiftettes 14-13, but couldn't overcome the huge deficit.

"I really think we got a little complacent at the end. We were shooting so well the first half. In the second half we missed a few shots and we weren't patient like we should have been," Heiman said. "I think because we had the big lead some of the other kids started taking some chances that maybe weren't there at the time."
