

Schools will feel state budget crunch

School officials in Castro have been County scrambling to find ways to maintain the quality of education as the state cuts their funds.

For the Dimmitt ISD. Superintendent Les Miller said the district is restructuring staff assignments and reducing staff through attrition only so far.

"The principals and I have had frank discussions about cuts and I've sent out memos about no increase in budgets," Miller said. "Now, I want to make sure our taxpayers are aware of what's going on."

And if the Region 16 Education Service Center in Amarillo is hit as hard as seems likely, contracts between the district and the center could increase as much as 51 percent, he said. "We're looking at making major cuts or reshuffling our funds," Miller said. "Regardless, we plan to provide the best education possible here in Dimmitt." Dimmitt is looking at a shortfall of some \$300,000, combined with the fact that the school is running a

deficit budget of \$375,000, along with a decline in enrollment means that "we don't see a rosy picture for Dimmitt, Miller said.

And raising taxes won't be the answer, considering the amount of money involved, he said.

In Nazareth, the picture isn't quite so glum, said Superintendent Marshall Harrison.

"If the House and Senate committee numbers don't change, we'll lose about \$47,537, Harrison said. As long as the student count doesn't drop below 200, the impact will be minimal, and studies projected for the next five years show the district's population won't drop below 223.

Additionally, Nazareth's state funds will drop because property values have increased by \$2.1 million, Harrison said.

Last year the district was able to put \$92,000 back into its reserves, Harrison said, noting that this year "we've been operating on a balanced

"My philosophy has

been to have a smaller staff and have more resources for our students," he said, adding that NISD has an 11to-1 student-teacher ratio. And Harrison is ready to ask for a tax increase to make up the deficit. He said he thinks property owners will understand.

"If you ask for a tax increase to offset a loss of revenue from the state and to keep the budget balanced, I think they'll understand," he said. "We're not out spending money recklessly."

But Harrison said the public should be miffed by actions of Legislature."

"The Governor said 'no new taxes,'but what he meant when he was running for office was 'no new state taxes," he said. "The state, with its cuts to schools has reduced its help from 46 percent to 38 percent and that's a lot of money to make up.

"The state is not stepping up and taking its part of the responsibility for education, so it's important for those of us in the community to let our lawmakers know how we feel."

To that end, Harrison said he encourages citizens to call local lawmakers and make their view known.

"If the state doesn't do its part, it's put back on the local property owners," he said. "Add to that 90

Quilt Show a big success

More than 1,100 quilt fanciers signed up over the weekend at the Ogallala Quilters Society Sixth Annual Festival and Quilt show, organizers said Tuesday.

As visitors packed the Expo Center, Senior Citizens Center and Methodist Church, original estimates of 800-to-1,000 people increased.

"We're hopeful we can keep growing and that we'll be able to expand," said Darlene Collins, one of the original organizers of the show.

Collins said the show couldn't get off the ground without the 100 or so volunteers who spend thousands of man hours doing everything from sending out flyers to setting up quilt displays to decorating the tables at the two banquets held during the show.

"We don't have anyone working on the show who's paid," Collins said. "Our volunteers work thousands of hours."

And the work pays off. Visitors to the three display venues oohed and ahhed over the hundreds of quilts and related displays.

"We go the Dallas and Houston quilt shows, and this one is as good as either of them," said Paula McWilliams of Snyder.

Whether it was a quilt depicting a family tree, a silver fan spread over a black background or a representation of the American flag, cameras and sketchbooks were in

abundance to help those in attendance remember - and replicate - favorite designs. "I love this show," said JoAnn Ham, also of Snyder. "I've got lots of good ideas to take home."

Both Ham and McWilliams said they'll be back for next year's show.

Which is good news for organizers. Return visitors and word-of-mouth has helped the show grow from its inception.

After a trip to Portland, Ore., Collins came back with a mission.

"I contacted quilt shops and quilters in the region and talked about organizing a show," she said. "No one turned me down.

"We formed a board. There were eight of us and we paid \$10 each in dues. So we started out with \$80 and lots of volunteers."

It's obviously been a labor of love that's paid off for quilters from throughout the region.

"There's lots of love and memories that make our life better through quilts," Collins said. "What we are doing is making people aware of the comfort, warmth, the love that quilts



Mr. Braafladt died April 4 in Dimmitt.




Q. My father recently passed away. He had almost no money at the time of his death. His creditors are now calling me to pay his bills. Am I responsible?

A. The only way you would be responsible is if you agreed to pay the bills, for example, by co-signing. In all other cases, your father's estate must pay his bills. If he did not have enough money to pay the bills, the creditors suffer a loss. You cannot be forced







What's the law... **Questions & Answers**

Q. I had a small "fenderbender" with another motorist. Neither of us wanted to report the accident to our insurance company so he just agreed to pay my repair bill. Now he won't pay. The damage to may car is only a couple of hundred dollars. What can I do?

A. This may be a good case for Small Claims Court. I suggest you send him a certified letter asking that he pay, as he promised. Let him know that if you cannot settle the matter, you will consider a claim in Small Claims Court.

If you do not resolve the dispute, file a petition with the appropriate Small Claims Court.





The Internet can't substitute for public notices in the newspaper

For over 80 years, local governments have kept Texans informed about its

business through legal notices published in the local newspaper.

Right now, there are several bills moving through the Texas Legislature that would allow local governments to post legal notices on a state-sponsored Internet web site instead of publishing these notices on the local paper.

While the arguments in favor of this idea seem sound on the surface, they contain a fatal flaw where open government is concerned.

Sen. Jon Lindsay (R-Houston) is the sponsor of SB 1359, which would let school districts post bid notices on the Internet instead of the newspaper. The House Public Education Committee approved a companion bill, HB 443, last week.

Lindsay contends that most of the contractors who bid on government projects look for these notices on the Internet. Posting school bid notices on the Internet would be a more cost-effective way to reach these contractors and might result in more competitive bids on school projects, he said.

This may be true but the argument entirely misses the secondary - some might even say the primary - point of publishing bid requests, calls for election and annexation, tax rate notices and the like in the local newspaper. Posting notices on the Internet may let select contractors know that a school district has a project up for bid but it won't let taxpayers know how their money is being spent. Notice by publication in a newspaper involves citizens in the process of government spending. It should be said that newspapers have a financial stake in this issue. Newspapers get paid for publishing legal notices. But, as part of that service, this newspaper, along with many other newspapers across the state, post these notices to our own web sites at no additional cost.

And, the cost just isn't that high. Lindsay and his supporters say that using an Internet web site for bid notices will save Texas schools \$3.1 million over the next five years. That's an average of \$563.64 per school district per year. Frankly, this is a small price to pay for open government. What's more, most Texans believe that public notices

should be published in the local newspaper.

According to a survey conducted last fall by Newton Marketing and Research, 81 percent of Texans believe that legal notices, paid for by local government, should be published in the newspaper. Even Texans who don't regularly read their local newspaper believe that local governments should pay to publish legal notices in the newspaper rather than relying on the Internet.

Conversely, only 9 percent of Texans said they'd look on for public notices on an Internet site. This doesn't even take into account the digital divide afflicting poor and rural Texans. This digital divide is real. Poor and rural Texans are much less likely to have regular access to the Internet. Using the Internet as the sole means of providing legal notice will effectively shut these Texans out of the process.

Newspapers also serve as an independent third party archive for the acts of local governmental entities, which is another reason to maintain the current notice and posting requirements. Notice by publication in a newspaper provides a permanent record that will never go away and remains available for the public to see. Finally, this newspaper, along with most newspapers across the state, already post legal notices on the Internet at no additional cost. And it didn't take legislative action to make this happen.

If those representing local governments in Austin really believe that posting bid notices will generate more competitive bids, that's fine. There's nothing wrong with

posting them on a state-sponsored web site.

However, it should not supplant the requirement of publishing the same notices in the local newspaper. That would a huge step backward for open government in Texas and it's a bad idea.




Hunter scores in All-Star Game







Know what to do in case of a tornado or lightning storm!

Tornado Safety Rules

Decide in advance on a primary and secondary shelter. A storm cellar is best; there is no universal protection against tornadoes except underground facilities. There are no public tornado shelters in Castro County, however, the courthouse basement is made available during threatening weather. If you can't get to your primary shelter in time, then go to your secondary shelter.

In cities and towns, a tornado alert is signaled by a long, sustained blast of a siren. Safety officials will try to sound the alert in time for you to reach shelter.

IN HOMES: Go to the storm cellar or basement and get under something sturdy.

If an underground shelter is not available, to an interior, well-braced room that does not have windows. Closets, bathrooms and hallways are usually best.

Wrap yourself with blankets, pillows or a mattress for protection against flying glass and debris. IN APARTMENT BUILDINGS AND MULTI-STORY OFFICE BUILDINGS:

Seek shelter in the basement or on the lowest floor, in an interior room-the smaller the better. Stay away from windows. IN MOBILE HOMES:

Abandon the mobile home and go to the nearest shelter or permanent building. If there is no nearby shelter, lie flat in a ditch and cover your head.

If school building is of strongly reinforced construction stay inside, away from windows. Remain near an inside wall on the lower floors when possible. AVOID GYMNASIUMS AND AUDITORIUMS-they usually have poorly supported roofs!

IN FACTORIES AND INDUSTRIAL PLANTS:

On receiving a tornado warning, a lookout should be posted to keep safety officials advised of the tornado's approach. Advance preparation should be made for moving workers to sections of the plant's offering the greatest protection and least hazard. IN VEHICLES:

Get out of the vehicle and go to the nearest shelter

Lie flat in a ditch or low place if shelter is unavailable.

Do not attempt to outrun the tornado.


IN OPEN COUNTRY:

Lie flat in the lowest area possible-such as a ditch or ravine-and cover your head. IN ALL CIRCUMSTANCES:

Keep calm. It will not help to get excited. People have been killed by running out into streets and by turning back into the path of a tornado.

Remember even though a warning has been issued, the chances of a tornado striking your particular home or location are still slight. A tornado's path is relatively narrow and sturdy structures are seldom totally demolished. But give yourself every advantage you can.

Stay tuned to your radio or TV station for latest tornado advisory information. If you have a scanner radio, keep it with you. Do not call the Weather Service, except to report a tornado, because your individual request may tie up phone lines and are urgently needed to relay advisories to radio and TV stations in the critical area.



Lightning Storm Safety Rules

Move indoors immediately.

Do not use hand-held electrical appliances, including the telephone, except for emergencies. Stay away from windows, doors, chimneys and

other connections to the outside. Do not bathe or take a shower until the storm

Do not allow children to play outdoors during

a thunderstorm.

IF CAUGHT OUTDOORS:

Stay away from isolated tall objects and structures, including trees.

Avoid open areas that will cause you to project above the surrounding land surface.

Do not stand near wire fences, clotheslines, pipes or other metal surfaces which could conduct the lightening current from a distance.

If you are in your car, stay there-it offers excellent protection.

Stay away from tractors and farm equipment. In a forest or wooded area, get under a group of SMALL trees.

ON THE GOLF COURSE:

Put down clubs, remove spiked shoes and head for a shelter.

Avoid open areas and trees.

Move away from golf carts.

NEAR WATER:

If swimming, get out of the water immediately and

Boaters should head for shore immediately. Fishermen should put down rods and move away

from the water.

IN ANY LOCATION:

Regardless of your location, a tingling sensation on your skin or hair standing on end may indicate that lightning is about to strike. Drop to your knees immediately but do not lie flat on the ground.

A person struck by lightning may sometimes be revived with prompt first aid treatment. Administer CPR on victims until qualified medical help arrives.







Appropriations committees' membership is from east of I-35, you can see that rural, Panhandle schools are losing out."

Hart ISD Superintendent Digger Elam said he and his staff have been running the numbers - and the deficit could run anywhere from \$50,000 to \$194,000.

"It gets pretty depressing," Elam said. "But we aren't looking at any layoffs. We've been paring our staff by attrition since I got here, so we're in pretty good shape."

A tax increase is probable, he said. How big a burden the schools and tax payers face is up to lawmakers.

Elam said he believes the Governor and Legislature will not leave the students of Texas in the lurch by cutting huge amounts of school funding.

"I don't think the people of Texas would stand for the Legislature abandoning the school children of Texas," he said. "If that happens, there'll be repercussions at

"Of course, I think *April 4 education should come first."

State lawmakers are trying to find a way to make up an estimated \$9.9 billion shortfall in the state's budget.

"We can all tighten our belts," he said.


