A vacancy still exists in the faculty of the Bronte School as a result of the resignation last week of Oscar Dorsey. Dorsey was head football coach and science teacher.


Plans were for the school board to meet the first part of the week and look into the matter, but Board President Hurlin Lee said the meeting was postponed until Thursday night.
