

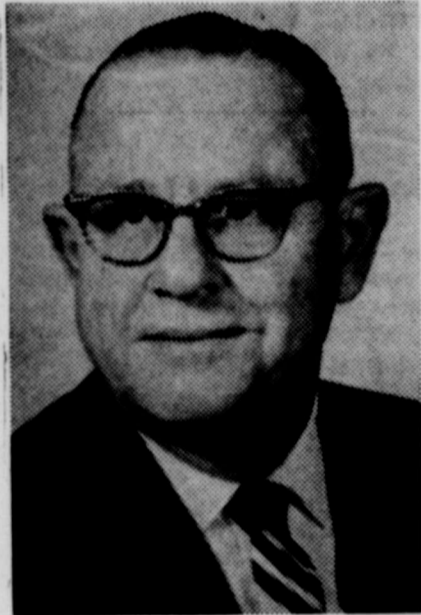

## 18 Seniors Will Graduate Friday Night



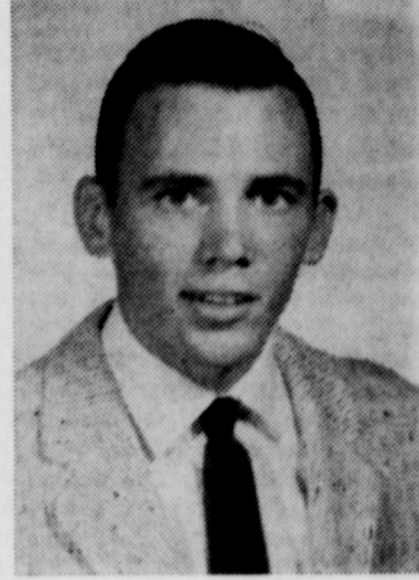
DR. W. A. HUNT

Eighteen seniors will receive their diplomas Friday night at commencement exercises in the Bronte School auditorium. The program will begin at 8 o'clock.

Highlight of the program will be the address of the evening by Dr. W. A. Hunt, president of Howard County Junior College in Big Spring.

Valedictorian of the class is Dana Eubanks who has a grade average of 92.3541. She will give the valedictory address. Gwen Kirkland, whose average is 92.0972, is salutatorian and will also give an address. Bobby Allen is the high boy in the class with an average of 88.8023.

Mrs. LaRue Broussard, class sponsor, will play the processional and recessional music. The invocation will be given by Foy L. Moore, minister of the Robert Lee Church of Christ. Supt. C. B. Barbee will introduce Dr. Hunt. Awards will be presented by Prin-Joe B. Simpson and diplomas will be presented by Barbee and Conda O. Richards, president of the school board. Joe Wolf, minister of the Bronte Church of Christ, will give the benediction.

### Fire Truck Fund Stands at \$1388

Bronte's fire truck fund had reached a total of \$1386.73 up to Wednesday noon. A good sized boost was given the fund this week when West Texas Utilities Co. turned in a \$100 check.

A motion was made in commissioners court last week by Commissioner Howard Brock that the county contribute \$1500 on the truck. Action on the motion is still pending after a question was raised as to the legality of such an expenditure by the county. County Auditor Weldon Fikes has asked for a ruling on the matter from the attorney general's office. Latest information of The Enterprise is that the ruling has not been received.

Members of the Volunteer Fire Department are still optimistic about local residents contributing enough money to pay for the new truck which they have ordered.

### Tennyson Baptist Church Rebuilding To Start Monday

Work will begin Monday on the foundation for the new church building to be erected by members of the Tennyson Baptist Church. The new building, composed of stucco, will be built on the same location where their church burned last fall.

A spokesman for the church said that the foundation would be laid with volunteer labor and that anyone willing to help should be at the building site Monday. Lynn Griffin, San Angelo contractor, will begin construction on the building by June 1, and has the completion date set for ninety days.

The new building will be composed of a 28x48 auditorium and a 20x38 fellowship hall. The fellowship hall will be divided into a kitchen, two baths and four class rooms.

The Tennyson Baptist Church has had regular services on Sunday in the community center since the fire. Reverend Robert Ritchie is pastor of the church. J. P. Arrott and W. T. Green are deacons and in charge of the building program.

### Large Bronte Group At Water Hearing

A large delegation from Bronte attended a water hearing held Tuesday morning in Ballinger.

The hearing was held in the Runnels County courtroom, with Col. R. P. West of the Corps of Engineers, presiding. Information received at the hearing, both oral and written, will be used by the Engineers in making recommendations in a report which Col. West said would be completed not later than a year from the date of the hearing.

Citizens of Bronte did not present a brief at the meeting, but most of those questioned by The Enterprise were of the opinion that local citizens should back Ballinger in its request for a dam on the river below Maverick known as Antelope Site.

Ballinger's brief was presented by County Agent C. T. Parker Jr. It pointed out the flooding problem of the city as well as Ballinger's acute need for another source of water for municipal use.

city which recommended building a dam on the Colorado between Robert Lee and Bronte.

E. V. Spence of Big Spring, general manager of the Colorado River Municipal Water District, talked on that group's plans to build a dam on the river, either in southern Mitchell County or in Coke County a few miles above Robert Lee. The CRMWD built and is operating Lake Thomas in Scurry County. It was built primarily as a source of water for Odessa, Big Spring and Snyder.

Briefs were also presented by representatives from Menard, San Saba, Johnson City and Lometa.

The Upper Colorado River Authority held a luncheon meeting following the hearing. At this meeting it was agreed that the river authority would not oppose either of the dams proposed in its area. The UCRA will draw up a brief for presentation to the Corps of Army Engineers stating its position on the proposals made at the hearing. L. T. Youngblood, chairman of UCRA, presided at the meeting.

## County Agents News Column

The pecan nut casebearer has begun its invasion of the nutlets in most areas of the county. Now is the time to spray for optimum control of the costly pest.

I checked pecan trees in seven locations in the county Monday morning. One of the seven had casebearers already in the nuts. Trees in four other sites checked had from light to medium egg deposits. Two groups of trees had no eggs on the lower branches.

Summing up what I found, I would suggest spraying twice during the next five to eight days. Two applications will be more effective since the casebearer probably will deposit eggs all this week.

I would make the first spray application during the period from Wednesday to Friday, the 23rd to the 25th, and preferably on Wednesday or Thursday. The second application of insecticide should be made approximately five days after the first.

Should you be unable to put on two applications, then one application on Thursday, Friday or Saturday of this week should give the protection you desire.

In order for you to give your trees ample protection, you must use a sprayer that develops enough pressure to part the leaves and wet the nut cluster. The small worms, except in rare cases, never moves over three or four inches from where he hatches on the cluster of nuts.

Also, add zinc to your DDT, malathion, toxaphene or nicotine sulfate spray mix. Zinc is needed by pecan trees in this area to avoid the deficiency called rosette or die back.

The 4-H Club swine program will turn over a new leaf Saturday. Five club members will receive registered Duroc gilts with which we hope they will receive a start in a swine demonstration. The club members will exhibit the gilts this fall then be graded on their swine program, from a management standpoint, next spring in competition for a second prize.

Two members from Robert Lee, Sharon and Rebecca Walker, daughters of Mr. and Mrs. D. J. Walker, Jr., have been selected to receive gilts this year. Also, Bob Wells, son of Mr. and Mrs. James Wells; Mike McKown, son of Mr. and Mrs. Bill McKown; and David Scott, son of Mr. and Mrs. Darwin Scott, all of Bronte, will conduct the breeding swine demonstrations. Jimmy Wells, Bob's older brother, was previously selected to receive the male purchased from Frankie Blair, formerly of Robert Lee and now enrolled in Texas Tech.

Jerry Parker and Bill Sharp of Bronte, Sue Percifull of Robert

Lee and Jimmy Wayne Millican of Silver are completing their year in the program as they return one gilt each to extenuate the program.

Two additional reports on worm samples submitted for identification have been received. One from J. Q. Counts on the Mendenhall Ranch was identified as being a screw worm case, while one submitted by Turney Sparks was reported non-screw worm.

We have a new supply of sample bottles should anyone desire one of the mailing cartons.

Finnell Smith reorted finding a sterile fly carton last week. I hope that others have been found.

With summer and more and more washing to do here are a few tips for caring for wash and wear garments.

(1) Separate white goods from colored goods and wash independently.

(2) Use loads recommended by the automatic home laundry appliance manufacturer. Do not overload your washer or dryer.

(3) Use the recommended amount of good detergent — also use water softeners and conditioners when possible.

(4) Use hot water, 140 degrees or higher.

(5) Use bleaches only in recommended amounts on white household items. Colors change with chlorine bleach.

(6) Remove clothes or household items when the wash cycle is complete, spin, tumble or line dry.

(7) Wash often. Sparkling, fresh wash wear cottons will be your reward.

I have been asked to search in its magic depths until I discover the future that awaits the members of our class, so soon to take their separate ways and, perhaps, never to be reunited. I am about to read the crystal, but before doing so, may I ask for your earnest cooperation? If you will but remain absolutely silent and join me in concentrating upon the future, leaving your mind wiped free of all conflicting impressions, I can promise you the information you desire. I thank you.

...The mists blot out the scene,

and when they clear away, the ground is covered with ice and snow. The wind wails through the tall sentinel pines. A figure rides toward me. He wears a stunning uniform.
