

 Twenty-two school districts in major population and geographic areas will be pilot testing three key facets of the state's emerging plan for special education. These districts will serve as a proving ground for efforts in comprehensive special education, early childhood programs for exceptional children and teaching tailored for children with language and/or learing disabilities.

Even broader changes may be in store for pupils of 16 school districts sued in federal courts at Austin and Tyler for racia' segregation. Districts held conferences at Texas Education Agency last week to prepare plans for conversion to non-discriminatory systems. Plans are to go to courts by Friday (Aug. 21). Hearings may begin Monday. 



All the items and services purchased have been paid for.


