Coke Plane Crash Takes Lives of Odessa Couple

An Odessa couple is dead after crash landing the light Cessna 310 twin engine plane they were flying. According to Dept. of Public Safety officials, the pilot, Everett Clarence Luckie. 55 and his wife, Ivy Price Luckie, 49, were traveling in an east-northeasterly direction when the crash occurred on the Wendland ranch in Coke County late Sunday. The crash site is about 16 miles southwest of Bronte, and 18 miles southeast of Robert

Sheriff J. Lee Ensor, Deputy Sheriff Ron Wetterman and Patrolman Bobby Hart investigated the accident.

Sheriff Ensor reported that the crash probably occurred around 6 p.m. Sunday as the last contact with the plane was made at 5:45 p.m. when they flew over San Angelo but was unable to land because of the heavy fog. At last contact they

reported only 20 minutes of fuel left. It was believed they were attempting to fly to Abilene or Ballinger when the fuel ran out and they were forced to crash land.

Gorman Walker, foreman of the Wendland ranch, found the wreckage about 5:30 p.m. Monday. Mr. Luckie was alive with one leg pinned in the wreckage. He was taken to the Shannon Hospital in San Angelo where he was pronounced dead on arrival.

Mrs. Luckie was pronounced dead at the scene by Justice of the Peace, Earl D. Nutter of Bronte.

The plane apparently landed belly first, traveling some 200 yards before plunging into a gully in the hilly Coke County ranch land. The landing gears appeared to be up and the motors running at the time it crashed.

Investigators and a doctor from the Federal Aviation Adm. were at

the site Monday night and Tuesday to examine the wreckage.

The plane was reported to be on a flight from El Paso to Kerrville when the crash occurred.

Services were at 2 p.m. Thursday in St. Paul United Methodist Church with burial with military rites at Resthaven Memorial Park, directed by Ellis Funeral Home.

Karen Arrott Is 2nd in Contest



Planners Work On Stock Show


Work began Wednesday with plans to be completed for the 1977





AN ORDINANCE FIXING AND DETERMINING THE GENERAL SERVICE RATE TO BE CHARGED FOR SALES OF NATURAL GAS TO RESI-DENTIAL AND COMMERCIAL CONSUMERS WITHIN THE CITY LIMITS OF BRONTE, COKE COUNTY, TEXAS, AND PROVIDING FOR THE MAN-NER IN WHICH SUCH RATE MAY BE CHANGED, ADJUST-ED AND AMENDED.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRONTE:

SECTION 1. Effective with the first gas bills rendered from and after thirty (30) days from the date of final passage of this ordinance, the maximum general service rate for sales of natural gas rendered to residential and commercial consumers within the city limits of Bronte by Lone Star Gas Company, its successors and assigns. is hereby fixed and determined as follows: First 1000 Cu. Ft. or Fraction Thereof

Over 1000 Cu. Ft. @ \$1.965 per MCF No gas bill will be rendered to any residential or commercial consumer served under the above rate not consuming any gas during any monthly billing period,

except that where customer's only use for gas service is in an outdoor grill and/or a fireplace starter, the amount shown for the first consumption block shall constitute a minimum monthly bill.

ADJUSTMENTS The amount of each mon-

thly bill computed at

the above-stated rates

shall be subject to the following adjustments: Plus or minus the amount of any increase or decrease, respectively, above or below the \$1.3488 per Mcf level in the intracompany city gate charge as authorized by the Railroad Commission of the State of Texas or other regulatory body having jurisdiction for gas delivered to Lone Star Gas Company's distribution system for sale to residential and commercial consumers where such changes are caused by increases or decreases in the cost of gas purchased by the Company; plus an amount equivalent to the proportionate part of any new tax, or increased tax, or any other governmental imposition, rental, fee or charge (except state, county, city and special district ad valorem taxes and taxes on net income) levied, assessed or imposed subsequent to July 1, 1976, upon or allocable to the Company's distribution operations, by any new or amended law, ordinance or contract. Company, at its option, may forego the application of any adjustment would result in an increase in the monthly bill; however, failure of Company to apply any adjustment shall not constitute a waiver of Company's right from time to time, or at any time, to make any adjustment, in whole or in part, in any subsequent current monthly bill that may be applicable to such bill. All bills shall be

due and payable when rendered.

The above rate is applicable to each residential and commercial consumer per meter per month or for any part of a month for which gas is used at the same location.

In addition to the aforesaid rates, Company shall have the right to collect such reasonable charges as are necessary to conduct its business and to carry out its reasonable rules

and regulations in effect.

SECTION 2. The rate set forth in Section 1 may be changed and amended by either the City or Company furnishing gas in the manner provided by law. Service hereunder is subject to the orders of regulatory bodies having jurisdiction, and to the Company's Rules and Regulations currently on file in the Company's office. SECTION 3. It is

hereby found and determined that the meeting at which this ordinance was passed was open to the public, as required by Texas law, and that advance public notice of the time, place and purpose of said meeting was given.


