Inspector Says School Building Is Not Adequate

Robert Lee Independent District will have to do something in the immediate future toward getting its school buildings back in repair, according to the report of Joe Umphress, deputy state superintendent, who has filed his report on the condition of the local school.

The school board is well aware of the situation, and at its meeting this week will start making plans for an improvement program. B. C. Goodin, newly elected superintendent, will be present and work with the board on the matter.

Mr. Umphress' report follows: Commendations:

1. Considering the state of instability that exists in the community this year, the deputy feels that the school program has progressed in a splendid manner under the guidance of the superintendent and school board.

2. A good lunch program is being carried on which is commendable.

3. A definite program in Art and Science is being maintained in the elementary schools.

Recommendations:

1. Immediate plans should be made to build a new high school building or considerable repair must be made on the old one. The present building is not adequate for a first class high school and the students of Robert Lee deserve a more thorough education than can be planned in this building.

2. The equipment is insufficient and the heating plant is deplorable. New furniture should replace the old.

3. The attitude of the student body should be improved toward caring for equipment, furniture and the building.

4. All teachers must be English teachers and the written exhibits must be improved. The written exhibits in three subjects were not on file.

5. A more cooperative spirit should exist between the student body, the teachers, school board, and community to receive the maximum educational benefits.

Schooler Named On County School Board

At a meeting of the County Board of Education here this week, Raymond Schooler was named trustee from Precinct No. 3. A vacancy occurred when P. W. Millican failed to accept the office after being elected last month.

Noah Pruitt of Bronte is also a new member of the county board, having been elected to succeed Frank Keeney, who was not a candidate for re-election.

Principal matter of business was the classification of the schools in the county, which appears elsewhere in this newspaper.

Next meeting of the county board will be the first Monday in August.

Silver Votes Bonds; Hires New Principal

Voters of Silver Peak school district carried a \$31,000 bond issue at a special election Saturday by a vote of 28 to 0. At the same time the district voted 25 to 2 to increase the tax levy from \$1.00 to \$1.50 on \$100 property valuation.

Proceeds from the bonds will be used to remodel the school house and teacherage, and the work is expected to be done during the summer months.

At a meeting of the Silver school trustees Monday night H. R. Gassiot was hired as principal for the coming year, and two other teachers will be engaged soon. Mr. Gassiot served as principal and coach at Bronte the past two years and has a fine record as a school man.

The district purchased a new Dodge 24-passenger school bus from the Electra district for \$2,000. The vehicle was not needed following a school consolidation at Electra.

Electric Office Open

West Texas Utilities Co. opened its Robert Lee office the past week, and business of the electric concern is now being handled there. The company has a fine line of appliances on display, and W. D. McAdams is the local manager. Berry's Jewelry Store also occupies a space in the front of the utilities office.

Shamrock's Wendland Flows 254 Barrels Day

Shamrock's No. 1 H. G. Wendland wildcat discovery, 9 miles southeast of Robert Lee, flowed 254 4 barrels of 47.1 gravity oil in a 24 hour test ending Monday morning. Rig has moved to No. 2 Wendland, a quarter mile south.

The wildcat on Rawlings property, 2 1-2 miles west of Bronte was drilling Wednesday night at 4,700 feet.

Al Hunt's No. 1 Harris Estate was drilling at 5,170 feet. Location is at the northwest end of the Harris River Ranch, on the south side of the Colorado River

W. J. Cumbie was improved Thursday after a few days of serious illness.

Ivey Motor Co. reports the sale of a new 2 1-2 ton Ford truck to W. A. Hickman of Blackwell.

Expect Lassiter Wildcat To Make 450 Barrels Daily

A daily production of 450 barrels of high gravity oil is predicted for Al Guiberson's No. 1 Jack Lassiter which struck pay in the Marble Falls a week ago. Location of the wildcat is 3 miles northwest of Sanco, and three miles south and west of Sun's No. 1 Arledge.

Sol W. Sanders of Beaumont, production superintendent for the Guiberson oil interests, said Thursday the well is cutting some salt water. Logs indicate 29 feet of oil saturated Marble Falls lime with a hole bottom of 6,528 feet. Top of pay was 6,495, with about 4 feet of water section in the bottom. Casing was set to top of pay and production will be from open hole.

Sanders said there was a shut-in pressure of 2,000 pounds Thursday morning and the gauge was still going up.

Helmerich & Payne of Tulsa were the drilling contractors, and G. A. Gresham is handling tools. Rig was dismantled Thursday and a new location, not more than a quarter or half a mile away, will be staked immediately. Three 500-barrel storage tanks were being connected Thursday and in the meantime well is shut in.

The location is in the extreme corner of the SW corner of the SE quarter of Section 308 and will give a forced offset to B. D. Gartman and Marvin Simpson, adjoining property owners.

City Employs Water Engineers

At Tuesday nights regular meeting of the Robert Lee City Commission the engineering firm of Parkhill & Cooper of Lubbock was employed to make a complete survey of the town's water problem.

Their study will include a water supply for future needs as well as a new distribution system. Work will begin at once and they expect to have a report ready within 45 days.

Mayor McNeil Wylie has appointed Fern Havins as commissioner in charge of streets, alleys and sanitation, while T. A. McMillan was named commissioner in charge of water and fire hazards.

Commissioner and Mrs. T. R. Harmon went to Dallas last week where Mrs. Harmon consulted physicians in regard to her arm which was broken in a fall on the ice at her home last November. The injured arm is still in a cast but is mending. T. R. says they travelled through heavy rains over toward Dallas, something he hadn't seen for a long time.

Bull Sells For \$575

Marvin Simpson consigned several head of cattle to the Texas Aberdeen Angus sale in San Angelo Wednesday and his offering brought top prices. Simpson sold a 19 months old registered bull to Fred Allison of Corsicana for \$575. Eleven pairs of commercial Angus cows and heifer calves consigned by the Robert Lee man brought \$275 a pair, and 5 pairs of cows and steer calves brought \$252.50. Mr. Simpson has been building up a fancy registered Angus herd and is disposing of all his commercial cattle.

Memorial Day services at the American Legion home Sunday night were well attended, with an impressive program following a fine barbecue supper served free to the public by the American Legion. Harve Wallace was in charge of preparing the feast of young goats.

Judge Bob L. Davis presided over the evening program highlighted by an address by Howell Cobb of Brady. Mr. Cobb is a prominent attorney and Legion leader and is candidate for congress.

Emory Davis, post commander, made a brief talk and musical selections were given by a trio composed of Marie and Mildred Wallace and Betty Jo Mauldin.

Cragin Builds Warehouse

Cragin Lumber Co. is completing a new warehouse for the storage of drilling mud and cement. The structure has dimensions of 20x144 feet and is enclosed with corrugated iron. Loading platforms extend the entire length of the building. Cragin handles oil field lumber and drilling mud and is doing a large volume of business.

Sunrise Memorial

Sunrise Memorial services in charge of the American Legion Auxiliary were held Sunday morning at the Robert Lee cemetery. Graves of the 40 veterans of all wars were decorated with wreaths and American flags. Mrs. Gladys Strickland, Auxiliary unit president, was in charge of the ceremony.

Walker Donates Site for Hospital

J. S. (Jack) Walker this week donated a half block of ground as a site for the new Coke county hospital.

The property is located 4 blocks west of the Looney Hardware on the north end of an acreage which Walker bought a few years ago from Boyd Yarbrough.

At a special session of the county commissioners Tuesday the grant from Walker was accepted, and at the same time the county decided to purchase a half block joining on the south for \$1,000.

County commissioners will engage an architect at their meeting next Monday. Hospital plans have been at a standstill, since prices on sites nearer town have been exorbitant.

Mr. Walker is a public spirited citizen and is to be complimented upon his generosity. His disgust over ridiculous prices asked by other property owners, prompted him to make the gift.

Poppy Sale Nets \$122

The annual Poppy Day sale here Saturday netted \$122.22, according to Mrs. Pearl Rutherford, chairman of the American Legion Auxiliary in charge of the event. Funds will be used for veterans rehabilitation and child welfare.

Sun Moves Out Of Arledge Field; No. 3 Makes Gas

Failing to get a satisfactory production of oil after drilling three holes, Sun Oil company this week moved out of the Arledge field, north of Sanco.

It is thought operations there will be suspended only temporarily.

The Ray-Harris rotary rig has been moved back to the Silver locality and will drill No. 1 Tubbo-Omega, two locations north of No. 1-A Tubbo, a producer one-half mile west of Silver school house. Omega Oil company is said to own a quarter interest in the lease with Sun.

Holding a leased block of 20,000 acres in Coke and Nolan counties, north of Sanco, Sun began exploring the area last winter and discovered a fair production in No. 1 Arledge. Production was from the Marble Falls just below 6,600 feet. The well flowed 95 barrels of oil in an official test, but recently has been producing about 55 barrels daily.

No. 2 Arledge, a northwest diagonal outpost, failed in the Ellenburger, and was plugged back to the Marble Falls. It is pumping three or four barrels of oil per day. No. 3 Arledge, a south offset to No. 1, has turned out to be a gas well with no oil. During a 15 hour test ending at 7 a. m. June 2 it produced 16.3 barrels of distillate through a 3-16ths inch choke, with a gas-oil ratio of 31,100-1. Since the gas cannot be produced, the well has been shut in for the present.

Jameson Field

Homer Jameson No. 8, bottomed at 6,573 feet, in a 12 hour test flowed 58 2 barrels of oil and 10.84 barrels of water. Operators treated hole with 4,000 gallons of acid Thursday through perforations from 6,445 to 6,570 feet. When released on this location J. C. Hawkins rotary rig will move one location north to No. 12 Homer Jameson, just south of the Sun camp at Silver.

Homer Jameson No. 10 set 7 inch pipe to 6,114 feet and will be completed both as a producer and as a gas injection well. Good showings of oil have been recovered and it will depend in open hole.

No. 1 H. L. Bloodworth set 5 1-2 inch casing this week after reaching a depth of 6,420 feet. An electrical survey showed top of the pay at 6,212 feet. Good production is indicated.

No. 2 J. S. Walker was drilling Wednesday at 6,210 feet in lime.

No. 1 Central National Bank, trustee of Blanks estate, was swabbing after acidizing with 4,000 gallons through perforation extending at intervals from 6,590 to 6,660 feet.

No. 2 Central National Bank was shut in waiting on swabbing unit.

No. 3 J. B. Walker spudded at 5 p. m. May 28 and set 9 5-8 inch pipe to 651 feet. It was drilling ahead Wednesday below 1,500 feet. Location is a quarter mile north toward the river from No. 1 J. B. Walker, high producing discovery on the south side of the Colorado River.

No. 1 Ellwood on Spade Ranch in Mitchell county showed some fluorescence in a core from 7,480-88 feet in tight Mississippian formation. CoPng continues and operators expect to strike Ellenburger soon.




