Smith is a resident of San Angelo. He gave a check to Earl Roberts in the sum of \$82 and the check bounced. He made \$2,000 bail following his indictment and will appear for trial Monday.

Also scheduled for trial next Monday is the state case against Paul Davis LaGrone, charged with receiving and concealing stolen property. LaGrone was indicted at the February term of court and has been out under bond.

## Sun Davidson No. 5 Flows 163 Barrels

Sun No. 5 G. W. Davidson, west of Edith, flowed 163 barrels of oil during its official 24-hour test this week. Gauge was through quarter inch choke and gas-oil ratio was 1.100-1.

Tubing pressure was 250 pounds and casing pressure 1,275. The pay section was re-acidized with 8,000 gallons last week, making a total of 14,000 gallons that were used in the treatment.

Another good producer for the Millican field west of Edith is Sun No. 8 Annie L. Cummings, which flowed 139 barrels of oil through 5-16ths inch choke during 15 1-2 hours.

No. 8 Cummings topped the reef at 5,835 feet and was bottomed at 6,001. An official test will be run later this week.

Morris-Hamilton were the drilling contractors. Their rig was released Thursday morning and will be moved to Snyder area where they will do more drilling for Sun. They completed two producers west of Edith since moving back here from South Texas a short time ago.

Sun No. 6 Davidson was drilling ahead Thursday at 3,980 feet in lime and shale.

In the Jameson field west of Silver, Sun Willie I. Tubb B-1 was drilling in shale at 3,580 feet. South of the river Sun No. 8 J. B. Walker was in shale at 5,275 feet.

Sun No. 1 Price Maddox in Nolan county was drilling in shale and lime at 4,708 feet.

## John Shimer New Supt. of Gas Dept.

John Shimer has been promoted to superintendent of Sun's Gas Department at Silver, succeeding Harvey Evinger, who has been transferred to Sun field in Starr county. Company officials announce the changes will be effective July 1.

The transfer is also a promotion to Mr. Evinger, since Sun's operations in Starr county are considerably larger. Mr. Evinger and his family will move to their new station later in the month. Harvey came here from Delhi, La., where he was in charge of a Sun gasoline plant. He has been at Silver 18 months.

Mr. Shimer was the first company man on the site when construction was started on the new gas plant. He had formerly been in Sun's production Department and came here from Starr county.

J. F. Pritchard Co. this week is winding up its contract which has been under way several months. An addition doubled the capacity of the gas plant which is now large enough to process 20 million cubic feet daily. Two new compressors are in operation and one more is to be added, making a battery of six.

Sun is studying the problem of taking care of gas now being flared in the Millican field west of Edith. There was talk of piping this gas to Silver. However, Sun engineers fear the Silver plant may not be large enough to handle the added load and it may be necessary to build a separate new plant at Edith.

### Notes

From The Oil Field



Union Oil Co. No. 1 B Daisy McCutchen, wildcat five miles east of Robert Lee, was drilling ahead in lime early Thursday after encountering salt water in the Palo Pinto formation.

Recovery on a 90-minute drill-stem test from 4,990 to 5,035 feet was 180 feet of salt water and 780 feet of slightly gas-cut salt water.

### Deeprock Cowley Spuds

Deeprock's wildcat test on the Lem Cowley place, 5 miles southeast of Robert Lee, spudded Wednesday and planned to set surface pipe at a depth of 400 feet.

### Copeland Failure

A wildcat test on Chas. Copeland, 3 1-2 miles from Ft. Chadbourne, was plugged and abandoned at 6,052 feet in lime.

## Open House Set For Sunday At County Hospital

Informal open house inspection of the new Coke County Hospital has been set for Sunday, June 18, and a general invitation is extended to the public. Visiting hours will be from 2 to 5 p. m.

There will be no speech making but everyone will be shown through the various departments, and it is rumored there will be refreshments for the visitors. The Hospital began operation June 1 and prior to that date several emergency cases were handled.

C. S. Haselden, hospital administrator, has written personal invitations to all those who donated room equipment, to attend the open house next Sunday. Invitations have also been sent to doctors and hospital staffs in surrounding territory.

A full staff is now on duty and there were eight overnight patients last Friday. Four babies have been born in the new hospital and the first surgery, a tonsilectomy was performed by Dr. McDaniel on Thursday of this week.

A bond issue of \$75,000 was voted by the county and federal aid grant of one-third the cost of the project was approved. Federal money thus far received is \$32,000.

Talk of a county hospital began three years ago. Bob L. Davis, then county judge, was one of early advocates, as was Dr. J. K. Griffith. It was then taken up as a community project by the Board of Community Development, and two elections were held before the proposition was finally settled.

Former Commissioner Henry Varnadore and Commissioner T. R. Harmon were strong backers, as was Commissioner J. W. Service before and after he took office. County Judge Jeff Dean has been chairman of the Commissioners Court during the hospital construction period. He has given the new Hospital first consideration and is to be congratulated for his fine work.

## Robert Lee Wins 12-Inning Game At Forsan, 12-6

Robert Lee won a 12-inning ball game at Forsan Sunday, the final score being 12 to 6. It was a sensational battle. The Oilers ran in four scores to tie up the game at 6-all in the ninth inning. Both sides then tightened up until the Twisters exploded in the 12th frame and put over 6 runs.

Each club made a tally in the first inning and Robert Lee counted three times in the fifth and two in the seventh. Touched for two safe drives in the opening stanza, Frank Tincup held the Oilers hitless until the eighth when Bob Barton came in as a pinch hitter for Miller and drove a home run into left field.

Tincup struck out the next three batters and the Twisters' 6-2 lead looked very comfortable going into the ninth inning. With two men out Heuvel and Shelton hit safely and Heuvel scored on Asberry's single to center. Up comes Mr. Barton and this time he clouted another home run to tie up the ball game. It was a mighty wallop far over the head of John Conley, who was playing deep.

Tincup got through the tenth frame by allowing only one hit and Clarence Tinkler pitched the last two innings. He walked one man in the eleventh and retired the side in order to end the game in the twelfth. Robert Lee threatened in the eleventh when Tincup and Tinkler both singled.

The big twelfth frame opened with Pete Hickman's double into left field. Royce Smith, Joe Phillips, Tincup, Tinkler and Lawrence Higgins also came through with safe wallops and Hickman singled when he came to bat the second time in the inning. Lefty Shelton was tired out from the long game, but he stayed on the hill to the finish.

R. W. Bowman played a great game and drove out four hits in his four trips to the plate. Tincup also got four hits and Phillips banged out a triple, a double and a single. Hickman had a double and two singles and Royce Smith hit safely twice in three times at bat. The Twisters made a total of 22 hits.


The San Angelo contractor is now starting the new \$160,000 county hospital at Sterling City and has a city hall, jail and fire station project under way at McCamey.


A. A. Alves was building superintendent for Joe B. Tharp on the Coke County Hospital project. Alves has been with Tharp three years.



### Most Persons Have Ringworm Infection

Austin, June 14.—It is a 50-50 bet that you have some sort of ringworm infection. Check to see. Chances are it will be in your scalp hair, on your groin, or on your feet—either on the sole or between the toes. If you don't find it, you're lucky, because while it isn't serious, its itching and persistence is very annoying.

A fungus—the same one that causes food to mold—causes ringworm. It's one of the world's most common ailments, with authorities estimating that half of the world's population is affected. It is more common this time of year than any other.

Animals get it too. As a matter of fact, cats, dogs, rabbits, mice, and fowls are frequently the source of infection in man. A child plays with an infected dog, the dog's hair brushes the child, and the child stands an excellent chance of

ringworm infection.

The scales which are formed can cause new infections on the body, so an infected person has to be careful to keep it from spreading. Advanced cases exude a clear, runny fluid—it "weeps," as doctors say, and the fluid can cause breaking out on whatever part of the body it touches. Children are especially vulnerable to scalp ringworm. Epidemics are usually started in schools or institutions.

Swimming pools, locker rooms, and gyms are potent sources of infection. Everyone has heard of "athlete's foot." It is nothing more than a type of ringworm. So is the so-called "barber's itch."

Preventive measures call for avoiding persons and animals known to be infected. Swimming pools, gyms, locker rooms, and the like can do their part toward ringworm control by boiling towels, swimming suits and their other public facilities for 30 minutes. Foot baths are also worthwhile.

The best thing to do is to keep clean at all times. But if you happen to get ringworm, or if you

have it now, it will be better for all concerned if you report to your family doctor immediately. He'll recommend medication designed to shorten the course and lessen the severity of the infection.

## Fire Kills Former Robert Lee Girl and Her Daughter

Robert Lee residents were grieved last week by a tragedy at Junction which cost the life of a former Robert Lee girl and her baby daughter. The victim was Mrs. Henry Saunders, the former Ima Pearl Hurley, daughter of Mr. and Mrs. Elbert Hurley.

Called to Junction by the tragedy were Myrtle and Ada Hurley, aunts of Mrs. Saunders, also the J. C. Wallace family, J. C. Wallace, Jr. and wife, Mrs. Jack Cowley and Mrs. Ned Thomason.

The following account of the terrible happening is reprinted from Friday morning's San Angelo Standard-Times:

JUNCTION, June 8.—An explosion and fire that destroyed a house and took the life of a 17-month-old child here claimed its second victim late Thursday.

Mrs. Henry Saunders died in a Kerrville hospital at 4:50 o'clock, a few hours after flames gutted her home on 16th street here and burned to death her daughter, Kathy Dianne.

The explosion and fire occurred at about 7 o'clock Thursday morning. Mrs. Saunders told investigators that a five-gallon kerosene can beside a wood stove blew up and set fire to the house.

Earl Baker, a neighbor, carried Mrs. Saunders from the burning house. The baby's body was not recovered until the fire was brought under control.

The woman's husband had left home for work on the Robert M. Neal Ranch near Junction before the explosion.

Double funeral services will be held for the 20-year-old mother and her daughter at 5:30 o'clock Friday afternoon from the Church of Christ at 815 College St., here.

Walter W. Leamons, minister, will officiate. Burial will be in the Junction Cemetery with Hodges Funeral Home in charge.

Survivors other than the husband include Mrs. Saunders' parents, Mr. and Mrs. E. J. Hurley of Grassland; five sisters, Mrs. A. V. Andrews of Cleo, Mrs. Carl St. Clair and Miss Mozelle Hurley of Junction, and Miss Viva Mae Hurley and Miss Irene Hurley of Grassland, and two brothers, Bobby and Calvin Hurley of Grassland.

Frank Dickey, Jr. left Monday for Kelly Field near San Antonio where he will take six weeks' ROTC training with the Air Corps. Frank holds a lieutenant commission in the ROTC at Baylor University where he is a law student. He served with the Marines during the war.
