### Sun No. 14 Mathers Rates 156 Barrels; **Acid to Cummings 10**

Flowing 155.86 barrels of 48 gravity oil plus seven per cent water in 24 hours, Sun No. 14 C. E. Mathers has been completed on the northwest side of the Jameson field near Silver.

The flow was through a quarter inch choke and open hole between 6,292 and 6,434 feet, the total depth. Gas-oil ratio was 1,598-1. No. 14 Mathers is in the southeast corner of L. R. Mathers Survey 16. It is west of Mathers No. 13 and north of Brannan No. 11, both produc-

Baker-Taylor rotary equipment had the contract and moved to Sun No. 14 Jewell Brannan where a depth of 1,658 feet in shale and lime had been reached Wednesday.

Ray-Harris drilling Sun No. 10 Fred Jameson, on the east side of the field, had been fishing for eleven drill collars since 9 p.m. Feb. 14. Total depth of the hole is 4,204 feet, top of fish yesterday.

Regular bi-weekly meeting of the Board of Community Development took place Monday noon with a luncheon at the Hattie Day dining room. W. D. Mc-Adams, vice president, presided in the absence of the president, John Harv y. Seventeen were present.

The committee appointed to perfect a means of contacting officials of the telephone company, made a report. The committee composed of B. C. Goodwin,, Jeff Dean and T. A. Richardson suggested that telephone officials be advised of the dissatisfaction which is rampant in the Robert Lee territory, and the company will be asked to send a responsible representative to meet with the BCD at a future meeting.

An inquiry from a dental student at the University of Texas who will graduate in June, was received with enthusiasm. The BCD voted to pay \$25 toward his expenses to come to Robert Lee and look over the Coke county field as a place to set up his practice next sum-

The matter of getting natural gas for Robert Lee was also discussed. ### **Drilling Starts** On Steffey Wildcat 2 Miles From Town

A wildcat test was started this week on the Steffey property, 2 miles north of Robert Lee. The lease is owned by Union, but the well is being drilled on a farmout to Elm Oil Co. and Lloyd Davidson, well known independent op-

Union is reported to have farmed out only the 320 acres included in the Steff y lease which was due to expire Feb. 26, 1951. It involves the southwest quarter of Section 415 and the northeast quarter of Section 440 to the south.

The operation will be No. 1 L. C. Steffey, 330 feet from the north and east lines of the southeast quarter of Section 415, block 1-A, H&TC Ry. Co. survey. Delaware Drillers of San Angelo has the rotary contract and spudded in Tuesday.

The test is scheduled for a depth of 4,500 feet and is intended to explore the Cisco sand producing from 3,960 to 3,998 feet in the McCutchen pool opened by Union four miles east of Robert Lee. It will be three miles northwest of Union No. 4 Jim McCutchen, the nearest producer.

If production is found it will force offsets on Mrs. Arminda R. Runnion to the north, whose lease is owned by Sun. Also J. C. Cobb to the east and Ruth G. Featherston to the northeast. Cobb and Featherston property is under lease

### Tom Fred Conger, 48, And Son, L. E., Are **Auto Crash Victims**

Joint services for Tom Fred Conger. 48, and his son, L. E. Conger, 21, of Tennyson were held Sunday afternoon at the Baptist church in Bronte. Burial followed in the Conger cemetery, five miles southwest of Sterling City.

Conger, life long resident of Sterling and Coke counties, and his son were victims of a highway crash occurring at 4 p. m. Friday north of Wingate.

They had been in Abilene on a business mission and were returning home on highway 277 when their 1949 Studebaker crashed into an empty pipe hauling truck. The accident took place at the corner where Farm to Market Road 53 intersects the main east and west highway.

John Alton Brown of Hermleigh, driver of the oil field truck, was coming north from Winters and pulled in front of the speeding Conger auto without. stopping.

The elder Conger and Brown were killed immediately, while L. E. died a few hours later at a Ballinger hospital. Also killed was Deward Edward Wright of Humble, a student at ACC, who was thought to have hitch hiked a ride with the Congers.

Tom Fred Conger was born at Sterling City June 28, 1903, and grew up in that community. He married Pauline Mayben. For the past five years they have ranched a few miles southwest of Tennyson, and previously lived on the place 14 miles south of Robert Lee now owned by E. H. Schuch.

L. E. was born Feb. 14, 1930, and is a graduate of Bronte High school. He is well known over the county, having helped with acreage surveys for the PMA during the past couple of years. He had scheduled to be inducted into the army

Besides the widow and mother there are three other children. They are Duane Conger of Lubbock and G. W. of Abilene and Mrs. James Fowler (Tommie Jean) of Rotan.

Mr. Conger is survived by a sister, Mrs. B. A. Austin, of Robert Lee; two brothers, Foster Conger of Sterling City and Finous of Hamilton; and a sister-in-law, Mrs. Jack Conger of Uvalde.
