

### SUN FINALS TWO JAMESON WELLS; DRILLING ENDS

Sun finaled two sand producers in the Jameson Field at Silver during the past week, they being located on Homer Jameson and J. B. Walker

Sun Homer Jameson No. 266 flowed 135 barrels of oil through a 1/4inch choke during its official 24-hour test. Pressures were 1,475 pounds on the tubing and 2,075 pounds on the casing. Gas-oil ratio 12,620-1.

Sun J. B. Walker A-4 produced 262.43 barrels of oil in 24 hours, also through a quarter inch choke. Tubing pressure was 525 pounds, with ballots Saturday. Polls open at 8 casing pressure of 425 pounds. Gasoil ration 1,726-1.

### Probably the bigget vote in the history of Coke County will be cast

at Saturday"s Democratic Pramry. Indicating the importance of this year's election is the record breaking number of 232 applications for absentee ballots. Never before has there been as many as fifty.

County Clerk Weldon Fikes, who handles the absentee voting, says 110 applications came from Percinct 2 (Bronte) while Precinct 1 (Robert Lee) has 98. There were 16 in Precinct 3 and 8 in Precinct 4.

Absentee voting closed Tuesday so far as applications are concerned, although some of the ballots may arrive as late as Saturday. A special election board will be named to tabulate absentee ballots.

County Chairman R. B. Allen and other members of the Executive Committee were to meet here Thursday to appoint this group. It will be composed of three men from separate sections of the county. Counting the absentee votes will start at 1 p.m. Saturday, but results must not be made public until the polls

Contests over local offices are responsible for increased interest this year. Races for sheriff, county attorney and county treasurer have been red hot and there are battles for county commissioner in Precinct 2 and Precinct 3 (Edith).

A total of 1,444 poll taxes were paid in Coke County indicating the posibility of 1.500 persons casting a. m. and close at 7 p. m.

## Shivers Agin Auto Inspection Law; 'Shall change it or repeal it' He Says

By Ben Kaplan, Press Staff Writer

Governor Allan Shivers today said that the new auto inspection law should either be modified or repealed.

The Governor told the Press before he left Austin for Houston to make a campaign appearance that he had some ideas for changing the controversial law.

His idea is to take the red tape and confusion out of the

"The law was intended to bring about real safety and not inconvenience," said Governor Shivers.


"We need to stop killings on the highways. Texas has become the number one State in the United States for murder on the highways.

"The Legislature passed this inspection law by a vote of 117 to 12 in the House of Representatives and 19 to 9 in the State Senate, with the thought that it would save more than 200 Texas lives each year. If the law fails to do this and instead causes confusion and inconvenience, it ought to be changed or repealed."

The Governor said that he would recommend to the next session of the Legislature that it re-study and examine this law in view of the experience and either modify or repeal it.

(Several months ago, when it became apparent that the new law was causing inconvenience and confusion, Governor Shivers ordered it suspended until it can be reviewed by the

### Judge Sets Aside Unfair Court Ruling

LOCKHART—Graham Smedley, the courageous judge of the Texas Supreme Court who spoke out for an aged Caldwell County farmer in the famous Hagedorn mule case in 1950, is a candidate for re-election to be voted on in Saturday's democratic primary. The facts in the case were:

William Hagedorn, a 77-year-

old farmer living near Lockhart, was sued for damages when an automobile ran off the road to avoid hitting a stray red mule. The accident happened near Hagedorn's farm, but the mule did not belong to him.

Confused, Hagedorn appeared at the county clerk's office on the day his citation directed him to do so. The judge was holding court elsewhere, Hagedorn left his address with the clerk, believing he would be notified when his case was called for trial. Being ignorant of court procedure he failed to employ an attorney or file a written answer. Judgment by default was rendered against him.

When the facts were discivered by the trial judge, the default was set aside. The trial judge was upheld by the Civil Appeals Court, but a majority of the Supreme court reversed the judgement and ruled that Hagedorn had to pay \$2,632 damages, even though he did not own the mule.

In a dissenting opinion, Judge Smedley termed the judgement a "gross injustice."

Hagedorn used his entire life savings to pay the judgement. But thousands of sympathetic Texans, reading the dissent and agreeing with Judge Smedley, came to Hagedorn's rescue, voluntarily contributing enough to more than replace the farmer's life-time savings.

The course covered forty hours of lectures and clinics in the laboratories of Dr. Salsbury, manufacturer of poultry remedies. The lectures were given by several doctors and specialists who are employed in poultry research.

In the course of their trip they crossed the continental twice, visited Mt. Rushmore and Spearfish, the home of the Black Hills Passion Play.







These figure prove conclusively that the Shivers administration has consistently supported local governments in their efforts to give rural areas paved roads, it was stated.

Governor Shivers has repeatedly said that he favors a paved road within sight of every farm and ranch house in Texas.

A breakdown of benefits received during Governor Shivers administration by this county from highway use tax money further shows that the county has received \$106,769 in license fees, \$40,266 has been paid this county in road bond funds, and \$13,550 paid by the state to retire the bonds for this county.

The figures above do not included money spent by the state to build primary or main highways in this county.




