Mrs. G. C. Farris, Druggist's Mother, Dies at Age of 94

Death came Wednesday at 6:30 a. m. to Mrs. G. C. Farris, who for a number of years had made her home in Robert Lee with a son, Druggist T. W. Farris. She was past 94 years of age.

Mrs. Farris has been in good health until last Friday when she suffered a stroke. Five generations were present when she celebrated her 94th birthday here last November.

The body was taken to Colorado City in the Clift funeral car and Kiker Funeral Home of Colorado City took charge of funeral arrangements. Services were to be held at 3:30 p. m. Thursday from the Baptist Church in Loraine.

Susan K. Hale was born Nov. 29, 1857, in Smith county, Texas. Later her parents moved to Houston county where she grew up. On Oct. 23, 1878, she married George C. Farris.

In 1912 they traded the farm for a Sweetwater drug store, which was operated by their sons 11 years. They moved to Colorado City in 1924 and resided there until the death of Mr. Farris in 1936.

Two sons surviving are T. W. Farris of Robert Lee and Charles R. Farris of Sweetwater, a wholesale drug salesman.

DEFEAT SONORA TO TAKE THIRD IN LOOP RACE

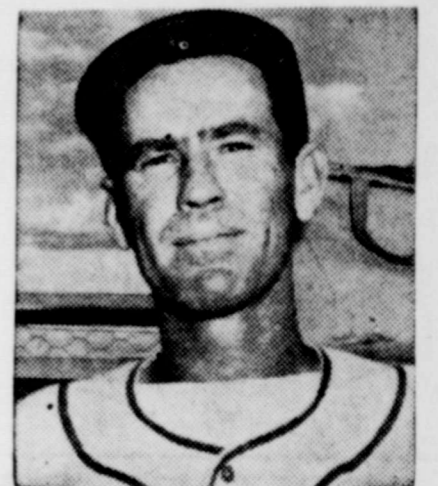

All clubs must play 12 games, and the last contests are slated for Sunday, August 24. Robert Lee has an open date this week and winds up the regular league season with Forsan coming here the 24th.

GOOD GAME AT SONORA: The Twisters played a fine game at Sonora and deserved to win. Johnny Stewart, Sun Oil Co. employee at Silver, hurled for Robert Lee and gave up only six hits.

Johnny had good support, with the combination of Lew Heuvel at second, and R. W. Bowman at short, turning in four double plays. Judge Sandusky in centerfield made a circus catch of a long fly blasted by Sam Mabry.

SUN MATHERS 40 A NEW PRODUCER

Sun Oil Co. No. 40 C. E. Mathers in the Jameson field west of Silver was completed this week at a total depth of 6,458 feet in lime.

Gauge was through a 3/8ths inch choke, with pressures of 300 pounds on tubing and 1,000 pounds on the casing. Gas-oil ratio 2,322-1.

Baker-Taylor's rotary was dismissed and is moving to Sun No. 41, two locations to the northwest. It is 660 feet from northwest and 660 feet from southwest line of J. F. Conner, Jr. Survey.

Three rigs are drilling just outside the Sun block at Silver to the north and west. Rich Oil Co. (Kenneth J. Rich, Midland) No. 1 A. E. Moore was drilling Tuesday at 2,577 feet in shale.

Southwestern Natural Gas Co. No. 1 Pallie Phelan was drilling in sand at 4,000 feet. Lomax Bros. have the drilling contracts on both.

Two miles south F. Kirk Johnson No. 1 J. B. Walker, Jr. was cutting a core Tuesday from 6,358-73 feet. A drillstem test Monday in lime from 6,330-56 feet recovered 9 feet of slightly gas cut mud and 60 feet of oil and gas cut mud.

Operators report the top of the reef at 6,330 feet. Good shows were reported in the Strawn sand at 6,000 feet.

## COKE COUNTY PMA ELECTION SET FOR AUG 20

Community PMA elections will be held in each of Coke County's three farm communities August 20, O. E. Kresta, Chairman of the County PMA Committee, announced today. Ballots were mailed out this week.

At these elections, farmers in each community will vote for three farmers to serve on the community committee, for a delegate to the County Convention to elect the county PMA Committee for 1953 and for alternates. Voting will be by mail or by voting in person on election day. In general, any farmer is eligible to vote if as owner, operator, tenant, or sharecropper he is participating or is carrying out practices in accord with programs administered by the county PMA Committee.

Chairman Kresta emphasizes that the effectiveness of Agricultural Program operations and price support and marketing programs will depend a great deal on the community committeemen who are voted in at these elections.

The concentration of Agricultural Conservation Program operations in 1953 on the problems of individual farms adds to the need for able committeemen. Committeemen will be expected to help each farmer in determining the conservation needs on his farm and in making the most

effective use of ACP assistance and available services in carrying out most needed practices.

Since this program has to do with the protection and improvement of the soil and conservation of water on the farms of Coke County, community committeemen are in a key position in the fight for continued production.

The chairman urges farmers in each community in Coke County to look over the field carefully and make sure that farmers are elected who are best qualified and who will have the time to devote to the job.

### HOUSE JOINT RESOLUTION NO. 20

proposing an Amendment to Article III of the Constitution of the State of Texas by adding a new section thereto to be known as Section 61 to authorize cities, towns, and villages of this State to provide insurance for employees; providing for the submission of the proposed Amendment to the qualified electorate; and providing for proclamation and publication by the Governor.

### BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article III of the Constitution of the State of Texas be amended by adding a new section thereto to be known as Section 61 to read as follows:

"Sec. 61. The Legislature shall have the power to enact laws to enable cities, towns, and villages of this State to provide Workmen's Compensation Insurance, including the right to provide their own insurance risk for all employees; and the Legislature shall provide suitable laws for the administration of such insurance in the said municipalities and for payment of the costs, charges, and premiums on policies of insurance and the benefits to be paid thereunder."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electorate of the State at the General Election to be held on the first Tuesday after the first Monday in November, 1952, at which election all ballots shall have printed thereon (or in counties using voting machines the said machines shall provide for) the following:

"FOR the Constitutional Amendment authorizing the Legislature to provide for Workmen's Compensation Insurance for employees of cities, towns and villages"; and

"AGAINST the Constitutional Amendment authorizing the Legislature to provide for Workmen's Compensation Insurance for employees of cities, towns and villages."

Each voter shall mark out one (1) of said clauses on the ballot, leaving the one (1) expressing his vote on the proposed Amendment; and if it shall appear from the returns of said election that a majority of the votes cast are in favor of said Amendment, the same shall become a part of the Constitution of the State of Texas.

Sec. 3. The Governor of the State of Texas shall issue the necessary proclamation for said election and have the same published as required by the Constitution and laws of this State.

## SUN OIL SENDS SILVER MAN TO JOB IN CANADA

SILVER, Aug. 12. — (Special to The Observer.)—J. B. (Jake) Higginbotham is new superintendent for Sun Oil Co. at Jameson field and other areas handled by the concern's production office in Silver. He was transferred from Hebronville, where he held a similar position.

He succeeds C. C. Bengtson, who is being transferred to Calgary, Canada. Bengtson came here 10 months ago to replace H. D. Smith. Sun is pioneering in the Calgary field where they have extensive acreage under lease. Fourteen wells drilled thus far are reported to be making 14,000 barrels daily.

Mr. Bengtson spent a couple of days the first of the week at his home in Austin, and plans to drive his car through to his new post. Later in the fall he will get a month's leave and expects to return to Texas for a visit.

Higginbotham has been with Sun for 17 years. He went from Dallas to Hebronville 10 months ago. He plans to move his wife and three daughters to Silver within the next week or two.
